



## Cable News.

### BELIEVING THE DESTITUTE.

HALIFAX, April 8. The cry for relief of the hungry and destitute families of the 12,000 miners involved in the conflict between the British Empire Steel Corporation and its employees, rose today above the argument over application of the Provincial Government's grant of \$20,000, and with the purpose of the fund definitely limited to alleviation of suffering among the sick and infirm, fresh appeals for assistance were issued by relief committees of Glace Bay, Sydney Mines and Springhill. Dr. Smith Walker, Red Cross Commissioner for Nova Scotia, spent a busy day at Glace Bay, reporting to-night that the work of organizing for the extension of the Society's work had been greatly advanced. At Halifax the Red Cross announced a further contribution of \$500 to the general relief fund from the organization's own savings. Premier E. H. Armstrong, in the Legislature this afternoon, intimated the grant of \$20,000 might be increased to \$40,000 or even \$50,000 within the next ten days. Up to a late hour to-night the United Mine Workers of America had received no word as to the intention of the International Organization in the matter of relief.

### KAROLYI ON HUNGARIAN MINIS-

MONTREAL, Que., April 8. The Government now ruling Hungary is a menace not only to that country but to the peace of Europe, which will be plunged into a series of wars before many years, if the present Hungarian Administration continues in power, declared Count Karolyi, former President of Hungary, to several newspaper men here this morning, in the Windsor Hotel, when he and Countess Karolyi are staying, prior to their departure to-morrow night for St. John, N.B., where they will sail for England. Prefacing the interview with a statement that he had been waiting three months to speak, Count Karolyi painted a gloomy picture of political conditions in Hungary, affirming that the government which had made him a "political exile," and had consistently "persecuted" him because, as he admitted, he was "extremely radical," was threatening the whole of Europe, not only with another war, but with a series of wars which would be none the less bitter, owing to their political origin.

### PREMATURE EXPLOSION KILLS 6.

SPAZIA, Italy, April 8. Six men were killed and 25 others were wounded, 15 of them critically, when the shell of a 12-inch gun exploded prematurely on board the battleship *Odulio* to-day. Fire broke out immediately, but it was hoped to save the vessel from destruction.

### CONFERENCE IN JUNE.

OTTAWA, April 8. A Canadian-British West Indies conference, with a view to arranging a new trade and transportation agreement between these countries, will be held in Ottawa, June 19, next, according to an official statement to-day.

### ADVOCATES SWEDISH SYSTEM.

FREDERICTON, April 8. Declaring that many of the people of New Brunswick were breaking the present law, and that men must and would have alcoholic stimulants, Hon. Fred Magee, President of Executive Council, urged during his speech on the Budget debate in the Provincial Legislature this afternoon, the adoption in this Province of the Swedish system of controlling the sale of liquor. He pointed out that in Sweden beer could be easily bought but liquors could be purchased only under a system of rations.

### SMOKING CAR FOR WOMEN.

CHICAGO, April 8. A special room in which women may chat and smoke will be provided on a car to be added by the Chicago-Milwaukee and St. Paul's Ojibway express between here and Seattle, the management announced to-day.

### HERRIOT WILL NOT RESIGN.

PARIS, April 8. Herriot Ministry has decided not to resign.

### SAMARITANS

ATTACKED BY ARABS. TIBERIAS, Palestine, April 8. It is reported that two hundred and fifty Samaritan Jews proceeding to Jerusalem for the Passover, were attacked by Arabs while passing through the town of Tiberias, nine of them being injured. Stones were used in the attack on the pilgrims.

### HINDENBURG AS PRESIDENTIAL

CANDIDATE. BERLIN, April 8. Field Marshal Von Hindenburg was nominated to-day as a candidate for the Presidency of the German Republic by the national conservative bourgeois bloc. It was announced the Field Marshal had agreed to stand for office.

### MURDER AND SUICIDE.

WINNIPEG, April 8. Two persons, a man and a woman, are dead, and a 12 year old girl is in the general hospital with a bullet wound in her knee, as the result of a

shooting affray in a block at the corner of Logan Avenue and Fontaine Street this afternoon. The man is believed to be A. W. Berger, and the woman is Mrs. Rose Henderson, 41 years. From meagre details given by neighbors, the police believe the shooting followed a jealous quarrel. The man is said to have shot the woman and her daughter and then turned the gun on himself.

### N. S. SOCIAL SERVICE MEETS.

HALIFAX, N.S., April 8. The Social Service Council of Nova Scotia, representing prohibition forces from all parts of the Province, held a session here this morning and presented three recommendations to the Provincial Government as follows:—(1) to abolish liquor export houses which have been established in Halifax; (2) to limit to the purposes in accordance with the intention of the act the distribution of liquor by board of vendor commissioners, physicians, chemists and druggists; (3) to provide for more satisfactory enforcement of the Temperance Act.

### A SLIM CONFIDENCE VOTE.

PARIS, April 8. The Government's majority of two recorded in the vote of confidence in the Senate to-day, later disappeared when two Senators declared their votes wrongly entered in the records. The vote of confidence of 142 to 140 stands as officially announced, but Premier Herriot, having heard of the changes, summoned a cabinet meeting for 9.30 p.m. to consider the ministry's situation and whether resignation should be offered in the lobbies of the Chamber of Deputies the meeting of the Cabinet was widely interpreted as meaning that the Ministry would resign to-night.

## Current Radio

### Dead Spots On Your Tuning Condenser

EDITED BY JOHN M. CLAYTON.

If you are using a receiving set any coil falls somewhere within the wavelength range of the secondary, whose position in relation to the primary circuit plus the natural wavelength of the antenna is at 250 meters, say. When the secondary is tuned to 250 meters, and the primary closely coupled to the secondary, the antenna circuit absorbs so much energy from the secondary that it is extremely difficult to maintain oscillations in the secondary. Either this will be true or the operation of the regeneration control will be so tricky it will be

no pleasure to operate the set. The solution to this trouble is to shift the natural period of the antenna-primary combination so that it will not be at any wavelength which is within the range of the secondary tuning.

If the dead spot occurs above 50 degrees on the tuning condenser insert a very small condenser in series with the antenna and the antenna binding post of the receiver. This condenser should have a capacity around 100 micro micro farads (0.0001 MFD.). This will shift the dead spot below the minimum wave-length to which the secondary will be tuned in the broadcast wavelengths. If the spot appears below 50 degrees on your tuning dial place a small loading coil in series with the antenna and the antenna binding post of the receiver. This coil should be about 3 to 4 inches in diameter and should consist of some 30 turns of No. 22 to No. 26 B. & S. gauge magnet wire. The loading coil will raise the wave-length of the dead spot section above the maximum tuning range of the secondary. After this is done it will probably be advisable to reduce the number of turns on the tickler. The tickler should have just enough turns to cause the tube to oscillate when the tuning condenser is set at its maximum capacity. Reduce the tickler turns until this condition exists and your set will be much easier to handle and you will get rid of the cranky operation on certain waves.





### Age of Fish Can be Told by Its Ears

Heretofore it has been impossible to tell the age of a fish with any degree of accuracy, but now Prof. W. J. K. Harkness, of the University of Toronto, says that by looking into the fish's ear one can tell its age. In the internal ear of the fish there is a little bony pocket. In this pocket there is a tiny stone called an "otolith," which rolls about as the fish tips this way and that and helps him to know if it is right side up. As the fish grows older the otolith grows larger. Prof. Harkness has made a study of the rate of the otolith growth and can now tell from the size of this "ear stone" just how old the fish really is.

### Rabbits a Pest in Alberta

CALGARY, Alta., April 1.—The Jack rabbit has multiplied so rapidly in Alberta that it has become a distinct menace to several districts throughout the province, according to W. H. Fletcher, of Brant, Alberta, who has petitioned the department of agriculture to encourage their eradication.

Mr. Fletcher attributes the increase of the jack rabbit to the wholesale slaying of coyotes, which animal largely maintained itself at the expense of the rabbit. Mr. Fletcher suggests in his letter that the bounty for coyotes be discontinued, and it be made a criminal offence to kill this beast. He believes that Alberta ultimately will be faced with a serious condition, similar to that which confronted Australia unless something is done to kill the jack rabbit and measures taken to preserve its natural enemies.

### The Law of the Neighbour

"Ever since man began to be neighbour there has been trouble about it. One of the most ancient cures on record is pronounced against the iniquity of removing a neighbour's landmark," says the Daily Telegraph. "The law of neighbours is dangerous stuff. Take the example of the hedge which divides your land from your neighbour's. There are hedges which by law belong to one party, hedges which belong to both, and hedges which, as far as the law can tell, belong to neither and nobody. If your neighbour's apple trees drop fruit on your land you must not eat it. It is still his, and should you decline to give it him, or to let him come and take it, he may come without your permission, but not by force nor causing any damage to your property. If his trees put branches or roots on your side of the fence you may cut them away without a word to him. But should the branches bear any fruit or flowers, you must return these things or pay the value thereof."

The Government in assuming office found themselves faced with an indebtedness incurred by the previous administrations of \$435,500 as a result of the Housing Scheme, the Militia Department, the purchase of naval ships, airships and other implements of this kind...

The Minister reviews the various industries and trade generally, but in a brief summary such

as this, reference to his remarks is impossible and will be made later.

Of particular interest are the statements made in connection with relief work, which this year will cost the country \$320,000 less than the amount expended in 1923-24.

For the year 1924-26 the estimated revenue is \$9,560,000 and expenditure \$9,353,000 leaving an estimated surplus of \$207,000. The aims of the Government are to reduce expenditure to the lowest possible point without causing dislocation of public affairs...

One other matter calls for particular attention, and that is the Railway. In 1920, the loss incurred by that service was \$1,776,128.59. In 1924-25 a profit of \$152,137.68 is shown on the train, steamship and dock services!

Turning to the Resolutions the reader will find much to cause gratification, and perhaps the most important decision is to scrap the previous system of calculating duties.

Bait Freezers Needed Editor Evening Telegram. Dear Sir—I wish to make a few remarks in your valuable paper to help along my country if it is in my power. Therefore I am writing to suggest a way to make our country a better place to live in. We want a cold storage in every bay in Newfoundland. There are along our coast line in the summer millions of tons of caplin that could be frozen and sold for bait to our fishermen in August and September when there is no bait to be got. And there is what the people of this country call the white fish, brim, maiden ray. Thousands of barrels of herring could be frozen, as well as squid for bait purposes. We could get a market for all these fish in other countries. It would not interfere with the codfishery at all. To one who knows the benefits of cold storage in other countries, the need is obvious. **SHOOTING AFFRAY IN WINNIPEG.**

WINNIPEG, April 8. Two persons, a man and woman, were dead and a 12-year-old girl is in the general hospital with a bullet wound in the knee as the result of a shooting affray in a block at the corner of Logan Avenue and Foulaine Street this afternoon. The man is believed to be A. W. Berger and the woman is Mrs. Rose Henderson, 41 years of age. From the meagre details given by neighbours the police believe the shooting followed a jealous quarrel. The man is said to have shot the woman and her daughter and then turned the gun on himself.

**SOUTH AFRICAN BUDGET.**

CAPE TOWN, S.A., April 8. The Minister of Finance, Havensaga, introduced his Budget in the House of Assembly. He announced an adjustment of the British Preferential Tariff on the gold pro quo basis. The revised rebate shown by the budget amounted to £3,000,000 as compared with £860,000. For the first time in history the budget was in Dutch language.

**ANGLO-AUSTRALIAN MIGRATION AGREEMENT.**

LONDON, April 8. Britain's contribution to the Anglo-Australian Migration Agreement, it is reported to-day, will be £7,083,000 over the next ten years, besides the cost of passages which the Imperial and Commonwealth Governments will share equally between them.

**SUBSIDY REDUCED.**

OTTAWA, April 9. The Government's subsidy to Canada-South Africa Steamship Line will be cut this year from \$125,000 to \$100,000, it was stated in the House of Commons to-day.

**BALFOUR'S HOTEL STONED.**

DAMASCUS, Pa., April 9. A mob gathered to-day outside the Hotel Victoria, where Earl Balfour is staying, and stoned the building. Police forces were hastily summoned and prevented further mischief.

**HERRIOTT'S GOVERNMENT RE-MAINS.**

PARIS, April 9. Badly shaken by the onslaught of the Opposition in the Senate on a matter issued yesterday, the Herriott Ministry virtually decided to resign, but yielding to the remonstrance of the leaders of the group making up the majority, and after a lengthy discussion at the cabinet meeting which lasted until the early hours this morning, the Government came to the conclusion that the circumstances of the vote in the Senate did not call for its resignation. In this vote the Government received a majority of 10.





# The Budget Speech

Hon. Sir John Crosbie, Minister of Finance, Reviews the Country's Standing.

Surplus for Current Year Assured; Customs Simplified; Economic Policy Results in Saving of \$1,703,530.11; Huge Amount of Arrears Collected.

Mr. Chairman.—In my Maiden Speech on Ways and Means last year, I expressed great confidence in approaching the subject. I explained that the short time at my disposal rendered it necessary for me to adopt the Estimates prepared for the Session by my predecessor, and made it very hard for me to speak with any degree of confidence and with a personal knowledge of conditions.

I therefore asked the indulgence of Honourable Members for any shortcomings they may have found in that Speech. May I say, however, that although I may not have attained my first birthday as the Colony's Treasurer, I yet feel more competent to address you on this occasion.

Last year I estimated a Revenue of \$5,467,000.00 for the fiscal year 1924-25 as against \$9,150,000.00 anticipated by my predecessor, Hon. Mr. Cave. The actual amount collected was \$5,401,669.00.

As against this Revenue, there was an Expenditure on current account of \$10,022,137.45 for the same period.

My estimate of last year placed the Expenditure at \$10,041,600.00 or \$19,462.55 more than was actually expended. I really underestimated this expenditure by the sum of \$75,302.55 as the following extract from the report of the Auditor General will show. He says on Page Thirteen:—

"Had the rule that all expenditure should be contained in the year in which the liability had been incurred, been observed, and I have to report that it was not, the deficit for 1923-1924 would have been much larger. I find that the following amounts properly chargeable to the 1923-1924 accounts, were charged against the votes for 1924-1925 thus... necessitating a larger Supplementary Supply for the latter year than would otherwise have been required:

I think I have every reason to congratulate the Colony upon its excellent recuperative powers as reflected by the above statement. It is nothing more or less than I predicted in my Budget of July 23rd last. The result is particularly gratifying when we take into consideration the adverse influence that the reduction in the tariff must have had upon Customs receipts.

I feel it is only right to state that the revenue as shown by the above

Some balances also were collected by the Assessor of Taxes which were due from the previous year but as these arrears are paid in every year, the current year's revenue did not profit therefrom to a greater extent than usual.

With regard to the first item on the above list, this sum has been due from the Colony since 1921 and, notwithstanding the repeated reports of the Auditor General on the subject, no effort had apparently been made by previous Governments to collect it. Shortly after taking office my attention was called to this indebtedness and after some correspondence between myself and the British Empire Steel Corporation a settlement was reached resulting in the full payment of the royalties due.

The second item on the list represents old outstanding duties on goods taken irregularly from the bonded warehouses some as far back as 1915. I discovered that in many instances goods had been withdrawn from the Government warehouses without the payment of duty collectable thereon and frequently without reference to the records. The result of the enquiries instituted by me into this Department, netted to the Revenue of the Colony the sum of \$20,581.18. Number three is an item improperly termed current areas and represents the release of goods from Bond by certain firms, who, it is alleged, made it a practice to settle weekly or monthly. This netted the sum of \$29,755.30.

There is nothing to be found in the Customs Act to vindicate this procedure so I have ordered its discontinuance.

Another illustration of the neglect to properly and promptly collect the Colony's revenue, was the release of goods on Temporary Permits and the failure to subsequently redeem these permits by the securing of payment. We collected through the enforcement of the payment of duty on goods so released, the sum of \$38,647.24 to date. I am glad to be able to say that the redemption of these Permits is going on every month. Those that are still outstanding are small as compared with the amount collected, and they are in process of collection.

The whole question of Temporary Permits is now settled for such time at all events as I shall have the honour of sitting in the Custom House as Departmental Head. With the exception of such goods as are perishable, no Temporary Permits are being issued by the Department to anyone. It is hardly necessary for me to point out that the issue of these Temporary Permits (except in the case of perishable goods) was absolutely illegal. It is quite evident, also, that those in authority in the Custom House in the past did not know the Customs Act or were indifferent about its carrying out.

Of the balance of \$119,024.29 remaining due at the close of the last financial year on account of Customs Bonds, the sum of \$23,963.32 has been collected. This leaves an amount of \$95,061.96 still outstanding on this account. Every effort is being made by the Government to collect this balance, but I feel certain that the House will appreciate the position that the Government has taken in connection with these outstanding Bonds. Some of the firms can ill-afford to make full and immediate payment of the amounts due and it is not thought desirable to put undue pressure on individuals who are perfectly willing but yet unable to, under present conditions, make immediate payment. Time has been given to settle up; some are paying by instalment, and I have very little doubt that eventually most of them will be paid in full. A loss, will certainly occur through the insolvency of some of the firms and, although the Government has preferential claims against them, the realization of their estates will not be sufficient to satisfy the indebtedness. In connection with the extension of bonds beyond due date, it seems to me that poor administrative judgment was shown. The procedure that should have been adopted to my

mind was to refuse the giver of a dishonoured bond any extension of time. What did happen, however, was that although the bonds of the persons concerned had been dishonoured,—they were given renewals and extension of the dishonoured bonds,—they were still permitted to issue new bonds. One firm whose indebtedness to the Customs ran as high as \$50,000.00 in these bonds, was still further accommodated in the sum of \$10,000.00, although his neighbours on either hand had to go hat in hand to the Banks for similar accommodation, and were often refused although holding better securities than the firm referred to. The whole Bond question to my mind was a case of discrimination of the most glaring kind. The amount outstanding on these Bonds at the present time is \$49,583.58, some of which will never be collected.

Another stream of shippers from the payment of duties was that opened up by the submission of false invoices and carelessness in the examination and appraisal of goods. Enquiry into this fully proved to me that the presentation of false invoices was a frequent occurrence, especially in certain quarters.

I may cite for the information of the House one particular case in which the delinquent tendered a cheque for the sum of twenty thousand dollars in settlement of short paid duties.

There was another instance of goods being delivered on a Temporary Permit which came under my notice. The goods were delivered in the month of June and in the month of August this particular firm presented invoices covering the same amount of goods to the amount of \$948.61. My demand to see the goods for appraisal purposes was met with the answer that they were sold. Upon presentation of the invoice for \$948.61, we taxed the goods on a value of \$3,000.00 on which sum duty was paid.

As a third illustration certain goods were invoiced in one of the outport stations at \$375.00, and upon appraisal duty was collected on \$145.00. The total savings on these three items alone amounted to \$21,656.29, in cash but the effect is I imagine reflected in the phenomenal increase in the Customs duties both in St. John's and the Outports during the year.

In connection with the direct possible loss on the above three items, had the duty not been collected, I may say that my action in connection with the latter two meant a saving of \$1,656.29. With regard to the first item, that is to say the collection of the \$20,000.00 cheque, it is impossible to say what the Colony's total loss really amounted to, as the payment was a compromise one as already pointed out.

While I cannot attest to the fact, at the same time I am reasonably certain that millions must have been lost to the revenue of the Colony during the past 20 years through the presentation of false invoices and the undervaluing of goods generally. There has been a regrettable absence of details as to the contents of packages which have undergone examination, as a result of which the Loss Room officials have often had to take too much for granted when entries were passing through in respect of appraised goods.

Before leaving the subject of the present year's revenue and dealing with expenditure, I wish to ask the attention of the House to an item in the Auditor General's report, Page 8. Here appears a summary of arrears of revenue due the Colony on June 30th, 1924, amounting to the considerable sum of \$924,541.82, as follows:—

Prominent among these arrears is the sum due the Tax Assessor of \$321,587.32. Every effort has been made to collect the amounts due on this account and at the present moment it is engaging my attention. A very large number of persons have no account in their returns. It is impossible therefore for the Tax Assessor to say definitely the actual amount due the Colony on account of Business Profits and Income Tax arrears. This was felt to be an inequitable state of affairs because of the fact that many

people who were taxable under the Act have escaped for years while the ordinary salaried employee had to pay promptly on due date. It was so unfair in this respect that the Government removed the Act from the Statute Book. I may say, however, that steps are being taken to enforce the payment of these arrears.

The Agricultural and Mines shows a balance of arrears due of \$350,007.00. Of this sum, \$313,000.00 is on account of leases issued on the disputed territory on the Labrador. I am quite in accord with the recommendation of the Auditor General that these leases should automatically lapse when the rents are not paid and the lands for which money is owed revert to the Crown. The sum of \$37,500.00 is due for royalties or for "stumpage," as it is generally called. In the main this is owed by owners of small saw-mills and the Government has placed the amounts in the hands of lawyers for collection.

In the Posts and Telegraphs Department there is an amount of \$88,566.08 due on account of the following:—

There are considerable amounts owing, also, in respect of the shortages discovered in Outport offices, an investigation of which was instituted by me after a tour of inspection last Fall. These matters are now in the hands of the Justice Department and will no doubt be adjudicated upon in due course. This matter of shortages has been found so serious and far-reaching that the Government felt it necessary to appoint auditing inspectors, whose duty it will be to visit and examine all offices without warning. Under the old system it was impossible to tell, through lack of proper inspection, the condition of any office financially, at any given time.

The Finance Department is owed the sum of \$36,282.22 (including interest) by the St. John's Gas Light Company on account of an advance made by the Squires' Government in 1921, for coal. This matter is now being dealt with by the Executive Government. The sum of \$2,761.64 is due by the Imperial Cable Service for balance due on Cable Taxes from the 5th November, 1920, to June 30th, 1924. The sum of \$13,312.00 is owed by the Harbor Grace Water Company, made up as follows:—Eleven years' interest on \$13,700.00 worth of the Company's stock held by the Government at \$548.00 per annum, plus eight years' interest on \$20,100.00 worth of four per cent stock held by the Newfoundland Savings Bank at \$804.00 per annum, plus loan of \$552.00 to pay interest on November, 1923.

The Public Works Department is owed \$15,936.00 on account of fees due by sundry persons for Hospital treatment; also \$134.70 by the Penitentiary for sale of brooms, etc.



### The Budget Speech

of fees during the year ended June 30th last, \$27,639.00 was paid by the Department of Public Charities for patients who stated they were unable to pay the modest charge of \$1.00 per day for medical attendance, board and (in many cases) operations.

And again in the present year's report I make the following comment: "It is only necessary to say that records of the patients admitted to the General Hospital are admitted under applications made in forma pauperis. As to the so-called patients, a glance at the list of unpaid fees, mostly collectible, would lead to the belief that the number of paying patients has been a very small proportion of the number admitted for treatment."

This statement appears somewhat contradictory inasmuch as he infers that the total revenue will lose, but there is a truth behind the argument which I imagine is this: We pay into the Pocket of Exchequer what we receive from the other, namely, the Exchequer side of the accounts, and that is actually collected from real sources is negligible.

To illustrate this fact: On looking at account in the Estimates for Capital Fees, I find that the amount for this service of \$25,000.00 is actually nearly \$5,000.00. This means we spend at least \$30,000.00 on a cost of paper relief which proportion should have been paid by people

honorable Members will gather from the above statement of expenditure that a reduction of \$364,759.74 occurred in favour of the present year. This result is most gratifying inasmuch as the Government's reduction is not unwarranted.

In regard to expenditure, it will be remembered that in my last Budget speech I stated that the great necessity, if we were to make ends meet, or adopt some measures to ensure the maintenance of economy by the several departments. In this connection I say that the introduction of the audit in certain paying departments has been a step in the right direction. It was very helpful in effecting the reduction above mentioned and has helped put the curb on extravagance and acted generally as a deterrent.

And here I must express my thanks to the several departmental heads for their co-operation in this respect and, generally, with regard to the finances of the respective departments. They have been of great assistance and it has been impossible to attain more than satisfactory results without their capable and willing co-operation. As is doubtless well known, indifference has for years been shown in the matter of departmental finance. The Audit Department, as it is noted and reported, was unable to provide the remedy; it could do nothing beyond report irregularities to the Legislature. While on the one hand it cannot let this opportunity pass without giving special thanks

often able to pay but wont. That this is wrong is quite evident, but as a Commission has been appointed by the Executive Government to enquire into matters pertaining to the Department of Charities and the charitable institutions, I reserve comment. As already pointed out, we find the Poor Commissioner paying two-thirds of the bills, besides a considerable sum from the Naval and Military Pensions Board, and yet there are arrears to the extent of \$15,000.00 approximately, owed by persons well able to pay. The amount of \$578.23 due the Department of Justice on June 30th last represents fines imposed by Magistrates. I understand that most of these have since been paid if not all, and Boller Inspectors' Fees \$175.00 are due the Marine and Fisheries Department; some as far back as 1920.

It seems to me that if proper attention had been paid to the enforcement of these arrears in the past, or, rather, if prompt action had been taken instead of a dependence upon promises to pay, a large amount would unquestionably have been collected; but as we are all aware, the steady accumulation of a debt makes for greater difficulty in its eventual payment.

This exhausts what I have to say on the subject of these arrears and the general revenue of the Colony for the period under consideration.

We shall now turn to its expenditure up to the date of the last figures available, viz., February 28th last, and the following statement shows the expenditure of the Colony on current account for the eight months of 1924-1925 as compared with the same period of the previous year:

to the Ministers of Posts and Telegraphs, Public Works, Marine and Fisheries and Agriculture and Mines (as heads of the departments in which pre-audit has been instituted) for their active and willing co-operation in assisting me at all times.

Under the pre-audit, before payment is made that Auditor has to pass the voucher and initial the cheque in payment thereof. Furthermore, he is compelled by the Act to refuse payment in respect of any account overdrawn. We hope to include the other paying departments in the pre-audit later on, for the reason that it acts as a sort of brake in the matter of expenditure; secondly, it sees that the intentions of the Legislature are carried out in effect; and, thirdly, it ensures the fact that no vote of the Legislature may be overruled without Executive sanction, and even in the latter contingency, this House is acquainted of the fact by the Auditor General in his annual reports.

Reviewing the above statement of expenditure, I again call the attention of the House to the fact that according to Mr. Berteau's report quoted by me, we had to pay legacies left by the late administration amounting to, roughly, \$100,000.00 chargeable to current account only. To go further I would say that we also had to pay for the ill-advised recommendations of the late Government on capital or loan account; but as this has been referred to in my speech of last year, it will not be necessary to make further comment here. As I pointed out already, that if, on the other hand, we benefited to the extent of \$209,206.37 by the addition of amounts due but not collected in the past, I have this much to say, that it was due entirely to the efforts of this Government that we did collect the amount referred to. And I am firmly convinced that but for the firm policy adopted by the Monroe Government these debts would never have been collected. On the other hand, the bills left unpaid when we took office had to be met and we had no option but to pay.

Apart from the sums that I have already noted, the Monroe Government had to shoulder the responsibility for the following indebtedness of the Colony, viz: Balance unpaid of P.H. Prop. Account . . . . . \$180,000.00 Housing Scheme, Guarantee and Interest . . . . . 60,000.00 Due Imperial Government via Department expenditure from September 22, 1922, up to time of closing . . . . . 90,000.00 Due Imperial Government for fitting up "Lobelia", "Watchful" and "Daisy" . . . . . 50,000.00 Expenditure in connection with Baloons . . . . . 5,000.00 Short voted in the 1924 Loan on account of deficit on current account for 1923-1924 . . . . . 20,500.00

The only means I see of paying off this indebtedness is to collect all we can by the sale of the houses built under the Housing Scheme and to pay the rest by economies on our current account.

**LOAN ACCOUNT EXPENDITURE.**  
I am glad to be able to report also that we have spent considerably less on Loan Account during the eight months under observation as compared with our predecessors expended during the same period. This will be seen by the following statement:—

From this comparison Honorable Members cannot fail to draw the conclusion that the Government have exercised the strictest economy in making allocations on Loan Account during the current year. Such expenditures as have been made for 1924-1925 as shown above, were incurred for absolutely necessary requirements, the need for which was carefully considered by the Government before the expenditure was authorized.

Considering now the balance sheet as between Revenue and Expenditure for the period indicated, that is to say from July 1st, 1924 to February 28th, 1925; our revenue amounted to \$5,832,376.36 and our expenditure to \$5,571,893.29. In comparison with 1923-1924 we received as revenue \$31,354.75 more and we spent \$264,763.74 less than in the same period last year.

Adding our increase in revenue to the decrease in current expenditure, we find an advantage to the Colony of the sum of \$1,046,154.49 in eight months only.

But this is not all, for we have yet to add the decrease in Loan or Capital expenditure. As shown on page 18 this amounted to the tremendous sum of \$659,375.62.

To sum up, therefore, we find that the result of the present Government's economic policy works out at a total saving to the Colony of \$1,705,530.11 as compared with last year. These are the actual official figures and I can truly assure this House that it gives me the greatest gratification to present them. As I have no doubt they will be received by the Legislature and the Colony generally.

It will be noticed moreover, in connection with this eight months comparison, that including the half-year's interest ending December 31st paid in February last, the current account of the Colony already shows a surplus of \$312,924.67 for the period under observation.




of the Lobster Fishery presented a problem which had to be serious, and promptly dealt with by the Government. Recognizing the importance of the Fishery Board, after due deliberation, recommended a close season for three years, dating from January, 1925.

are, or consider themselves, adversely affected, the conservation of the Lobster Fishery as a whole had to be considered if we were not to be faced with the absolute extinction of the lobster in our waters.

I may add that according to the report submitted by the Fisheries Department, the 1923-1924 lobster catch is one of the lowest on record, and those who claim to know place the responsibility on the fall pack of the previous year for which special permission had been given.

### CANNING OF FISH PRODUCTS.

While on this subject, I think it well to inform the House that the Government has under consideration the matter of promoting the canning of fish goods. The idea is to have the fish packed at central depots under supervision of the departmental inspectors instead of the present method of packing in badly equipped and often unsanitary outhouses.

The Minister of Marine and Fisheries is of opinion that Permits or Licenses to pack should not be granted indiscriminately, but should be limited to factories of a certain capacity and with an equipment which has been passed by the Inspectors as efficient.

### GENERAL TRADE.

From information received from different sources, I observe a clear improvement in our industries generally. Sales are increasing, payments are becoming more regular and industrial strength is showing signs of increasing strength. The retail trade of the Colony in 1923-1924 increased \$8,470,096-90, caused mainly by the activities on the West Coast. While it is true that we cannot expect to maintain the benefits derived from the Humber project as when construction was at its peak, yet the Plant will have to be maintained and thousands of workmen of all grades employed as at Grand Falls.

There is the Gender proposition also in course of organization, and Grand Falls is steadily extending its

plant and increasing its output.

These several industries, not to speak of the minor ones that now exist in Newfoundland, must necessarily furnish employment permanently for an increasing number of people annually. Profitably employed these workmen will have an enhanced value as consumers; greater consumption will mean increased importations and naturally increased revenue.

I shall now lay before this Committee some information upon Loan expenditures and those under Section 33 (b) of the Audit Act; also a statement of the Public Debt.

### LOAN EXPENDITURES.

The expenditure on account of the several Loans for the fiscal year 1923-1924 were as follows, viz:

This is really the Debt as on the 31st December, 1924, inasmuch as the Sinking Fund operations include the cancellations up to that date.

To this amount will have to be added the sum of \$4,000,000.00 which has been raised under the Loan Act of last Session.

Referring to the raising of the last mentioned amount I may say that the Loan was raised in London through the Dominion Securities Corporation, Limited, at 97.88 for £232,000 sterling.

Under an arrangement with the Trade Facilities Board in Great Britain, it was provided that if some of our purchases were made in England and the Loan was raised there, a certain amount would be borne by the Imperial Government as a quid pro quo. It was decided in view of this satisfactory concession and the higher rate offered, that the English tender would be accepted.

In compliance with this decision, the order for new rails for the Newfoundland Government Railways was placed in England.

The arrangement with the Trade Facilities Board provides that an al-

In connection with these payments, it must be noted that this administration had to provide \$1,000,000 on account of the notorious Pit Prop Account.

Appropos of the said Pit Prop Account, I may say here that the Colony still owes somewhere in the neighborhood of \$180,000; as I have just said this is another payment which it will be difficult to meet.

The expenditure on account of Loans and the present position of Loan Account is exhaustively treated in the last two reports of the Auditor General, and these I beg to refer Honourable members for further and more detailed information.

lowance of three and three-quarters per cent on all purchases made in England by the Newfoundland Government will be granted. With this in view and a natural desire to place the Loan in London everything else being equal, the Dominion Securities Corporation tender was accepted.

Deducting charges for expenses incurred in raising the Loan, such as bonds, etc., the net realization of the Loan will be \$95½ to 96.

As promised by me in this House, the Loan was advertised for in London, New York, Montreal and Toronto. Tenders were opened in the Bank of Montreal in St. John's in the presence of the Honourable the Prime Minister, Mr. C. A. C. Bruce, and the Assistant Manager of the Bank of Montreal, Mr. B. C. Gardner, and myself.

### EXPENDITURE UNDER THE AUDIT ACT.

During the eight months ending February 28th, 1924, the sum of \$171,359.41 was expended under Section 33 (b) of the Audit Act. A comparison of the expenditure by Special Warrant under this Act for the same period last year and this shows as follows:

From the above statement it will be seen that we spent \$122,958.70 less in the present year than in 1923-1924 under authority of the Audit Act. The total expenditure on this account in 1923-1924 amounted to \$418,530.64. This year to date it amounts to \$48,400.71, and I estimate a further sum of \$50,000.00 will cover our requirements in this respect to the end of the fiscal year.

Admitting this estimate to be correct, the total Audit Act expenditure for 1924-1925 will be \$98,400.71, or over \$200,000.00 less than was spent on the same account in 1923-1924.

Before proceeding to lay before you my estimate with regard to the finances of the Colony for the coming fiscal year 1925-1926, I deem it advisable to make a few remarks relative to the cleaning up of the Government Departments.

Perhaps very little may be said here in relation to the Customs Department, as the publicity with which

As the Customs Department is being investigated thoroughly, I shall content myself with stating that there was something lacking in its general conduct, that there was a regrettable absence of esprit de corps in the several branches and that the general indifference of many of the officials meant a substantial loss financially to the Institution.

Shortly after his appointment to the office of Minister of Posts and Telegraphs, Hon. Mr. Woodford called upon the Auditor General and me to assist him in enquiring into the condition of his Department, the accounting system and organization, the morale and discipline of its officials, its interior structural arrangements and sanitation. He wished also to formulate a general plan by which any or all of these could be improved. If, upon investigation, it would be found necessary to make such improvement, we undertook and carried out this enquiry, and I can do no better in the matter of presenting the conditions to this Committee than to quote from our report to the Executive Government.

"With the exception of the Money Order Department which proved to be satisfactory (except for the Out-port check) we found the accounting system until recently, to be entirely inadequate as to efficiency, co-ordination and in respect of the safeguarding of the Department's revenues. We say recently, for when we commenced the enquiry, we found that the system of accounting which the Auditor General had planned and referred to the Government, had been approved by the Executive and had been put into effect. This system and the institution of the pre-audit directed by the Government, had proved most satisfactory. The accounting system provides a triple-check, co-ordinates the work of the several sub-departments and provides a central control which is under constant supervision and audit, which pre-audit renders irregular payment impossible. This places great responsibility on the Audit Department."

"We found not organization but disorganization. Clerks who evidently were unaware of what their duties were, officials in positions for which they were not fitted, while other officials, unfit for the positions they held were in many cases suitable for the offices held by incumbents who did not measure up to their particular work; in other words, 'round pegs in square holes' and vice versa.

"We also noticed a great lack of discipline and an entire absence of that esprit-de-corps which should obtain in food work and proper combination is desired, and that such is not only desirable but essential in all public offices, is evident.

"As far as was possible we have corrected this, but the Honourable the Executive Council will appreciate the difficulties which impede any

effort to achieve an organization which will be perfect. With the material at our disposal we have, we hope, done the best possible.

"We found the interior structural arrangement to be very inconvenient both to the public and for the proper carrying out of the duties of officials as laid down by the attached organization. We realized this early in the course of our enquiry and therefore asked the permission of the Executive to effect some necessary structural changes in the plan of the Post Office building. This permission was given. These alterations have been made with the result that, as far as possible, proper provision has been made for the several offices. These have been rendered more accessible to those having business with the Department, and by utilizing the whole of the grillage enclosed space on the second floor, the whole work of the officials located therein can be under constant view.

"The expenditure for alterations and repairs and for the cleaning and painting is being borne by the balance in hand of the allocation from the 1919 Loan for alterations and

repairs General Post Office' with a small appropriation by the Government-in-Council from the 1922 Loan, should the same be required.

"We found the sanitary condition of the building anything but satisfactory. The whole building was 'dirty to a degree; dust and accumulation of rubbish were to be found everywhere. Plaster had fallen from the walls, which in addition were scribbled over and otherwise soiled. The basement was made the resort of all sorts and conditions of people who had no official connection with the Post Office and, generally, the condition of the building was a disgrace to any community. This has been all changed. The Post Office basement has been cleaned from roof to basement and is being painted. Rubbish has been removed or burnt. The accumulation of mail bags and other valuable material capable of use found scattered with large quantities of rubbish in the loft has been cleaned up, all that was of value having been placed under the charge of the Storekeeper for use in outport offices. In this connection we may say that much of



**The Budget Speech**

"this—such as tables, desks, pigeon holes, etc., might have been used in fitting up outport offices instead of purchasing new material as was frequently done.  
"It will be noticed that we have elaborated a system of inspection in respect of the several outport offices. We cannot too strongly emphasize the necessity for a thorough inspection, conducted at irregular intervals. To a lack of this inspection in the past is due the many defalcations which have occurred and are still occurring in outport offices. These irregularities cannot be discovered in the central offices for the reason that outport Postmasters can falsify their returns. They can and do take credit for cash in hand pay Money Orders, to pay which money has been transmitted

"Furthermore, a number of new appointments were made to the Department as well as several increases to salaries, all of which were made without Executive authority and without the necessary legislative provision therefor. All payments in respect of these have naturally been disallowed by the Audit Department and will be reported to the Legislature as coming within a fiscal year for the administration of the votes of which the present Minister is responsible. He has therefore been obliged to obtain an Order-in-Council legitimizing these irregular appointments, and he will have to ask for Supplementary Supply to cover expenditures for which he is not really accountable.  
"In connection with expenditure, we beg to advise that the practice which has obtained in the past of ordering enormous quantities of stock sufficient to last for years, should be discontinued. There are now in the department hundreds of thousands of envelopes sufficient to last for years which apparently have been overlooked while new stocks have been purchased, and four large boxes of twine which are absolutely useless to the Department. These are only a few of the many instances which came under our notice.  
"We venture to think that with the introduction of an improved accounting system, the adoption of a pre-audit, the changes in interior structural arrangements, the cleaning and painting of the building and the application of the organization suggested by us, together with the adoption of our recommendations as to general guidance, the Postal Telegraph Department will compare satisfactorily with any Government Department, and we trust that its Executive will see to it that it does not lose on that comparison in future."

I make no apology for quoting thus lengthily on the investigation held by us into the Department, for I consider it desirable to acquaint Honourable members of the condition into which physically, morally and from a financial point of view past administrations had permitted this Department to fall. I fear the question of Post and Telegraph work has not been given that serious attention which such an important Department requires.  
I understand from the Auditor General, who was associated with myself and the Minister of Posts and Telegraphs in the conduct of the enquiry, that his Department had no authority in respect of the taking of stocks or other internal audit and that the matter of inspection of outport offices was one which was so colossal in its survey that with the small staff at his command it could not be attempted.  
As a result of this want of inspection of outport offices, I decided to have a personal inspection last fall, the result of which revealed an utter want of method in the accounting system with regard to the offices visited. There was never a complete audit of these offices taken, so that any Postmaster handling Money Order, Telegraph, Customs and Stamp cash in the one office (and most of them do) might very easily cover a shortage in cash on Money Order by cash from any of the other accounts, and the same thing applied as far as the other accounts were concerned. In other words, there was no concurrent effort on the part of the several inspectors of the Service; the Customs' Inspector simply inspected the Customs; the Money Order Inspector, the Money Order; the Telegraph, the Telegraphs and so on. Of course it will be evident to Honourable members that an audit inspection of this kind was useless insofar as the cash check of any combined office in the outports could be taken.  
Immediately upon my return to St. John's I arranged with the Minister of Posts and Telegraphs for a complete audit of several offices which had not satisfied me upon visiting

to them, when they have used such cash for their personal use. Again, the receipts for the first week of a month can be and are transmitted to cover the balance in hand at the end of the previous month. It is quite evident, therefore, that without direct inspection, these irregularities are likely to continue.  
"Before concluding we deem it advisable to ask attention to the position of the Minister (in connection with the financial affairs of the Department) in respect of its appropriation votes for the current fiscal year and this we do in common justice to him and to the Executive Council which will have to bear the responsibility of asking the Legislature for Supplementary Supply.  
"We refer to the very large expenditure on account of the last fiscal year which, by reason of the exhaustion of that year's votes, had to be carried on this year's expenditure. Among the many important items of this are the following, viz:

them. The reports of the two Inspectors sent to Corner Brook and Deer Lake proved that my suspicions were unfortunately too true. Further inspection has proven that speculation on the part of Postmasters in respect of cash receipts has not been confined to these stations, but exists in other parts of the country. It is only fair for me to say, with regard to Corner Brook and Deer Lake, that the conditions existing there were disgraceful from what I saw. The officials were overworked, they had no facilities despite the fact that they had placed themselves on record as requiring office furniture on several occasions. No notice was taken of their repeated requests for assistance and the blame for the sad condition of affairs in these stations (Corner Brook and Deer Lake) can only be laid to Headquarters at St. John's. To give the House an idea of the facilities, I need only say that the Deer Lake cash drawer consisted of a biscuit box improvised as a cash drawer by Postmaster Boland and that he frequently threw considerable sums of cash under a brin bag in the office as the most unlikely place for a possible thief to discover it. While I can

only deplore the neglect displayed by the responsible officials in St. John's, I cannot but express to Honourable members the idea which occurred to the Honourables the Minister of Justice, Mr. Sullivan (who were my companions) and myself, and that was that Newfoundlanders were the most honest people in the world.  
Upon return to St. John's I took immediate steps to have all these matters rectified and happily, to-day things are somewhat better than in September last. Arrangements are being made to have suitable offices at both Corner Brook and Deer Lake and I think the Government may feel assured of no recurrence of this state of affairs.  
Subsequent to the above discoveries, Colonel Ross, who has had a lifelong experience in Canadian Postal matters, was appointed by the Government to go further into Postal, Telegraph and Money Order matters. He has made his report to the Government through the Minister of Posts and Telegraphs but the Executive have not had time to consider same up to the present, owing to other important matters engaging their attention. I may say that it will receive consideration as quickly as possible.  
The accounts and management of the Public Charities, including the public institutions thereunder, are at present in the hands of a Committee of Council for enquiry. Upon submission of their report, executive action will be taken, the necessary arrangements made and pre-arranged
