An Act to prevent the fraudulent conveyance of real estate charged with hypothecs, after proceedings have been instituted to enforce payment thereof.

WHÈREAS it often happens that debtors, with the view of defrauding their creditors, sell or alienate their real estate after their creditors have taken proceedings at law for the recovery of debts for which such real estate has been hypothecated, thereby exposing them to the inconvenience of commencing new proceedings, and often to the loss of their debts, and it is expedient to provide for the prevention of frauds of this nature; Therefore Her Majesty, &c., enacts as follows:

I. Every sale or alienation of any immoveable charged with hypothec, Sale, &c., after after proceedings shall have been commenced for the recovery of the proceeding debt, with the payment of which such immoveable is charged, shall be for recovery null and void as regards the creditor, who may proceed to the seizure of hypothec- and sale of such immoveable as though such sale or alienation had never eary debt to be void. taken place.

II. This Act shall apply to Lower Canada only.
