An Act to alter the boundaries of the Counties of Joliette, Berthier and Montcalm, for Electoral and other purposes.

**W**HEREAS it is expedient to correct the boundaries of the Counties of Joliette, Montcalm and Berthier for electoral and other purposes, in so far as respects the Parish of St. Félix de Valois, in the County of Joliette, and that of St. Ligouri, in the County of Montcalm,—a portion of the said Parish of St. Félix de Valois being in the Township of Brandon, in the County of Berthier, and a portion of the said Parish of St. Ligouri being in the Township of Kildare, in the County of Joliette,—and as to the Township of Joliette which is partly in the County of Berthier and partly in that of Joliette; Therefore Her Majesty, &c., enacts as follows:—

1. The sub-sections or paragraphs sixteen, seventeen, and twenty of the first section of chapter seventy-five of the Consolidated Statutes for Lower Canada, intituled “An Act respecting the sub-division of Lower Canada into Counties,—and the boundaries of certain Cities and Towns for the purpose of representation in the Legislature,” shall be read and have effect for all electoral and judicial purposes, as if no part of the said Parish of St. Félix de Valois was in the Township of Brandon, and that part of the said Township which is in the said Parish, is hereby attached to the said County of Joliette, for the purposes aforesaid,—and as if no part of the said Parish of St. Ligouri was in the said Township of Kildare, and that part of the said Township which is in the said Parish, is hereby attached to the County of Montcalm, for the purpose aforesaid;—and the East part of the Township of Joliette, now in the County of Berthier, is hereby annexed to the County of Joliette, so that the whole of the said Township shall be in the said County of Joliette for all purposes whatsoever.
