UNITED STATES.
Jails [are bad] enough without having ghosts in them. The fall in Joliet is haunted by a specter that is most unpleasantly seen and felt. Whipped into Line.
The struggle over at least. The temper-tossed mariner has found repose. Lazarus is at rest in the bosom of Isaac. After a desperate and pitiable attempt to differ from the Grit Ministry as to whom it should support for Parliament in the City, so that it might claim some show of independence, the Telegraph has been rudely dragged into the ranks, forced into the traces, whipped into line. It has been treated harshly and ungenerously by its new party associates. After it had done all the damage it could to the Liberal party by slinging its skirts and making public confessions of wrong-doing on its behalf it had a right to expect some consideration from the victors—to expect that it would be let down into the Grit camp as gently as possible. In this it was mistaken. It called pitilessly to its new allies that Mr. Tilley was all that was good and honorable and worthy of all imitation, politically, and must not be abused for its sake. The answer came from its new allies—Tilley is "a braying ass in a lion's skin," a "great political criminal," etc., etc. It called upon the Grit party, to nominate a brother renegade, so that it might support him with seeming decency. The party responded by nominating Mr. DeVeber, the old-time opponent of the Telegraph's party, the standard-bearer of Anti-Mackenzieism, the very man against whose aspirations for a seat in Parliament the Telegraph thundered one short year ago. The dose was too bitter. The insult was too great. It was not used to such treatment from political associates. It would show proper respect to itself and self-respect by protesting against the very thing supporting the Liberal candidate in the City. Then the party whip was cracked, Ministers shook their heads wondrously, and the party's Own Organ hoisted Mr. DeVeber's name to the mast-head, announced that he was the Mackenzie candidate, and that no other candidate could be supported by anybody that expected Government favors. This was enough. The struggle was over. The Ministry and the Liberal party were so far apart that they could not be brought together. The chasm was an awful one to cross, but it was a still more dangerous one to straddle, and we drop the argument with a sigh, and no longer pretend to speak for the Liberal party of St. John, we shall leave it in peace to struggle with the regular Ministerial organ for the first place in the confidence of the Cabinet. It deserves well of Mr. Blake, whom it puffed with such extravagance in a column and a half on the Monday of the other day; it deserves well of Mr. Mackenzie, whose sectional record it began to whitewash this morning; it deserves well of the party for the docility with which it has submitted to the insults heaped upon it and the submission with which it has obeyed the check of the Ministerial lash. Farewell.

The Candidates.
J. S. Boies DeVeber is the Ministerial candidate for Parliament, pledged to give the Government of Alex. Mackenzie liberal support, a "heavy support," an unquestioning support. He has been nominated and is openly supported by them for the sole purpose of voting in the House as they see him to vote. He is to be the dumb door, the silent supporter of Ministerial mandates. The agents of his party openly and unblushingly ask the electors of St. John to elect him for this single purpose. Charles N. Skinner is the candidate of the Liberal party, standing on the broad platform of New Brunswick Liberalism, unpolluted, free to act as his conscience dictates, and free to vote as he sees fit. He is to be the dumb door, the silent supporter of the Opposition, free to vote as he sees fit in general or in his constituency in particular.

Circuit Court.

The arguments in the case of Smith vs. Getow were continued yesterday afternoon. Mr. Palmer contended against Mr. Thomson's altering his declarations, while Mr. Thomson argued in favor of his right to do it under the act. Just before the adjournment the judge decided to allow Mr. Thomson to alter and amend his pleading. The jury were, therefore, dismissed, and each party ordered to pay his own costs. The case will have to be returned for trial.

The next case before the court was that of Owen and Lavinia Kenny vs. Michael and John Bradley.

Allen Esq., for plaintiff, S. R. Thomson Esq., for defendant. It is an action for injuries received by an assault said to have been committed by the defendants on Lavinia Kenny, aged 16, in the Parish of Simonds, on the 31st April, 1872. The plaintiff claims that she was ejected forcibly from a house by the defendants, and that the defendants (as set forth in the declaration), "beat, bruised, pushed, dragged, pulled about, wounded, and ill-treated her, whereby she became and was sick, sore, lame and disordered, and so continued for a long time, to wit, one month following, during which she suffered great pain and other wrongs."

The plaintiff, therefore, claims \$3000 damages for the assault on Mrs. Kenny. The defence claims that the house which the plaintiff was ejected was theirs, and that Mrs. Kenny was taken out without any force or violence, that her property was lawfully removed, and that the statements of Mrs. Kenny are entirely false. The case for the plaintiff was finished this morning, and the defence was not finished when the Court adjourned at 11 o'clock.

The next case proved how much it costs to call a woman a "house," in Portland. Thos. Garnett was charged with calling Miss Garnett that name, and he was fined the costs of Court, \$1.50.

Matthew Garnett called the same woman some worse names, took his fist in her face, and maltreated some of her relations, for which he was fined \$25.
