An Act to amend the Act respecting the division of Lower Canada into Counties, as regards representation in the Legislative Assembly.

WHEREAS it is expedient to alter the limits of the counties of St. John, Napierville, and Laprairie respectively, for the purpose of representation in the Legislative Assembly and to amend chapter seventy-five of the Consolidated Statutes for Lower Canada in that behalf:

Therefore, Her Majesty, &c., enacts as follows :

1. For the purpose of representation in the Legislative Assembly, but for no other, the Parish of St. Jacques Le Mineur, now comprised for such purpose in the County of Laprairie, shall hereafter be comprised in the County of St. John; the Parish of Lacolle, now comprised for such purpose in the County of St. John, shall be comprised in the County of Napierville; and the Parish of St. Rémi, including the Village of St. Rémi, now comprised for such purpose in the County of Napierville, shall be comprised in the County of Laprairie; and chapter seventy-five of the Consolidated Statutes for Lower Canada is hereby amended accordingly.
- Boundaries of the Counties of St. John, Napierville, and Laprairie altered for representation only.
