### CHEESE

OTTAWA, April 24, 1918.

J. U. VINCENT, Esq., K.C., B.A., L.Ph.,  
Deputy Minister of Inland Revenue,

SIR,—I beg to hand you a report, covering 172 samples of Cheese, purchased in October, November and December, 1917.

With a single exception (No. 76235, sold as skim-milk cheese) these samples were purchased as *Cheese*, which is thus defined by Order in Council of November, 1910 (published as circular G. 934): "Cheese is the sound, solid and ripened product made from milk or cream by coagulating the casein thereof with rennet or lactic acid, with or without the addition of ripening ferments and seasoning, and contains, in the water-free substance, not less than forty-five (45) per cent of milk fat. Cheese may also contain added colouring matter of harmless character."

In 166 samples analyzed (5 samples were lost in the disaster at Halifax, and one by breakage in transit) the following results were obtained:—

Samples containing over 60 per cent fat.. . . . .	2
" " from 55 to 60 per cent fat.. . . . .	27
" " from 50 to 55 per cent fat.. . . . .	91
" " from 45 to 50 per cent fat.. . . . .	39
" " less than 45 per cent fat.. . . . .	6
" skim-milk cheese.. . . . .	1

166

Of six samples showing less than 45 per cent of fat, five samples contain above 44 per cent, and as falling within 1 per cent of the limit, I have recommended that these be permitted to pass. The actual findings for fat are 44.33, 44.45, 44.95, 44.76, and 44.39.

One sample (No. 68547) contains only 40.26 per cent fat, and must be judged adulterated.

A sample of skim-milk cheese (No. 76235) contains 39.14 per cent fat.

None of these samples contain any other fats than milk fat; and in this respect they fulfil requirements of the standard.

The standard for fat in cheese, as defined in Circular No. 19, U.S.A., Department of Agriculture, dated 26th June, 1906, is 50 per cent, calculated upon the dry substance; as against 45 per cent required by Canadian Standards. The present report shows that 120 samples out of 165, or 73 per cent of the collection, contain above 50 per cent fat; and it is open to question whether the legal standard for fat in cheese might not, advantageously, be raised. In 1909 (Bull. 171) I suggested the adoption of 48 per cent.

Our last systematic inspection of Cheese was made in 1912 and is published in Bulletin No. 247. Of 141 samples examined, only 43 were found to contain above 50 per cent of fat; and the results herein furnished appear to justify the inference that Canadian Cheese has improved in quality, so far as fat content is concerned, within the last six years.

Advantage was taken, in 1912, of the opportunity to study the normal moisture content of Cheese; and the results indicated a mean of 30.90 per cent for 141 samples. Earlier results had indicated about 30 per cent.

The average percentage of moisture for 165 samples in the collection now reported is 33.68. These samples were all furnished to the analyst in moisture-proof containers, so that the water content reported is that for Cheese as sold.

I am not aware that any legal limit for moisture in Cheese has been suggested earlier than my own of 1909 (see Bull. No. 171), when I proposed 30 per cent as reasonable. It is possible that later experience might justify the adoption of 35 per cent as a maximum limit for moisture in ripened cheese. This limit was suggested by me in 1913 (Bull. 247) based upon work then reported. Canadian Hard Cheese is essentially of the Cheddar type; and for this type of Cheese, at five months old, Van Slyke (Bull. 146, Bureau of Animal Industry, U.S. Dept. of Agriculture, 1911) reports moisture as below:—
