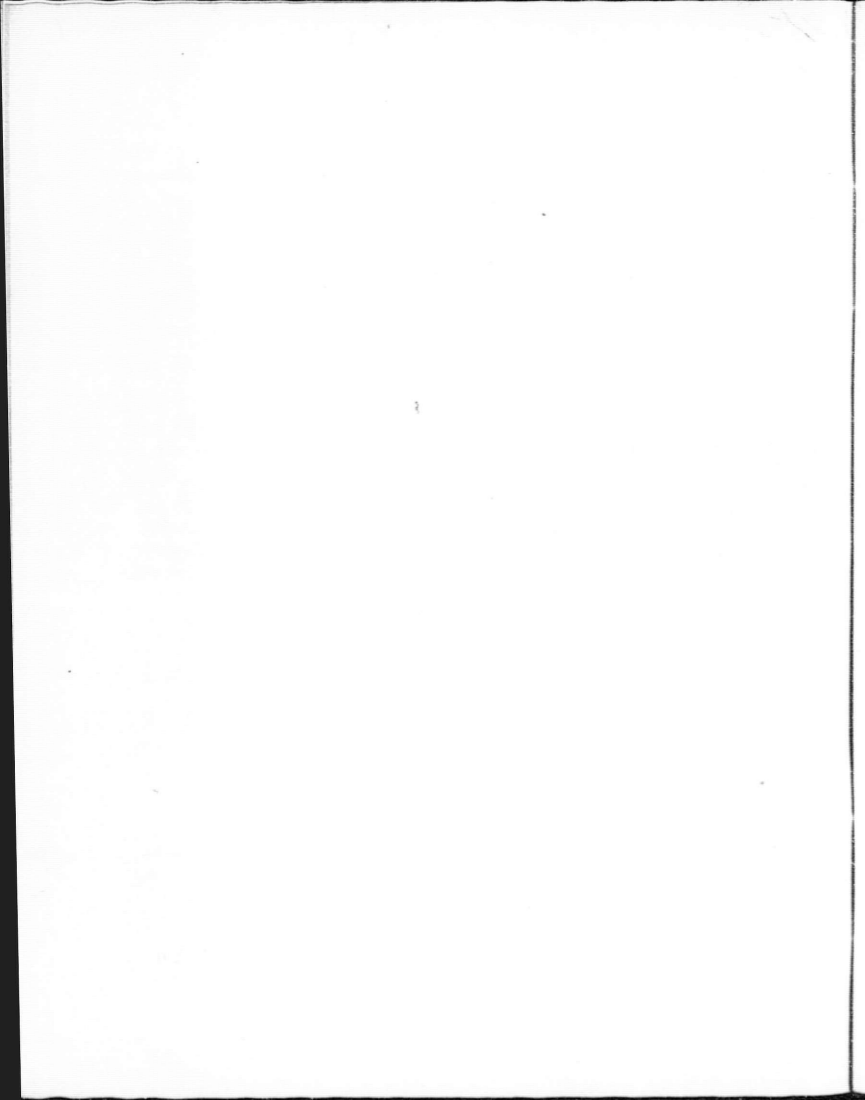

THE OTTAWA GOLF CLUB

CHARTER

7 EDWARD VII. CHAPTER 131, PROVINCE OF QUEBEC.

An Act to confirm the charter of the Ottawa Golf Club and to extend its powers.

(Assented to 14th March, 1907).

WHEREAS a petition has been presented by The Ottawa Golf Club, which was incorporated in 1901 under article 5487 and the following articles of the Revised Statutes, praying for an act to confirm its charter, to change its principal place of business and to increase its powers;

And whereas it is expedient to grant such prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

1. The corporation known as "The Ottawa Golf Club" (hereinafter called "the Club") shall, by that name, continue to be a body politic and corporate and shall have perpetual succession and a common seal. It shall continue to own the property, both moveable and immoveable, now belonging to it and to be responsible for its debts and obligations.

2. The object of the club shall be to establish, maintain and conduct a club for the promotion and playing of the game of golf and other lawful games and for social purposes, and to hold, purchase, provide, erect and maintain convenient club-houses, links, buildings, lands, premises and other conveniences for the accommodation of members of the club and their friends, and of the servants and employees of the club, and for the

purposes aforesaid or for any purposes incidental thereto; and generally to afford the members of the club and their friends all the usual privileges, advantages, conveniences and accommodations of a club for such purposes.

3. The principal place of business of the club hereafter shall be at its club-house, situate on the Aylmer Road in the township of Hull in the county of Wright in this Province.

4. The club shall consist of the members now constituting the said club and those who may be hereafter elected as such with such rights and privileges and subject to such conditions and restrictions as are now or may hereafter be granted and imposed by the by-laws, rules and regulations of the club; and the present committee of management and officers of the club shall continue in office until replaced in accordance with the by-laws, rules and regulations of the club.

5. The club by its said name shall at all times have the power to receive, acquire, exchange, hold, lease and enjoy both moveable and immovable property necessary for its actual use or occupation and the said property to pledge, hypothecate, sell, alienate and dispose of and to acquire other instead thereof, but the club shall not hold immovable property exceeding the value of five hundred thousand dollars. All acts of the nature above set forth already done by the club are hereby ratified, without prejudice to the rights of third parties.

6. The club shall have the power to borrow money, and to draw, make, endorse and accept cheques, bills of exchange and promissory notes necessary for the purposes of the club, and every contract, agreement, engagement or bargain made, and every bill of exchange drawn, accepted or endorsed and every promissory note and cheque, made, drawn or endorsed, on behalf of the club, by any agent, officer or servant of the club, in general accordance with his powers as such under its by-laws rules and regulations shall be binding upon the club.

In no case shall it be necessary to have the seal of the club affixed to any such contract, agreement, engagement, bargain, bill of exchange, promissory note or cheque, or to prove that the same was made, drawn, accepted or endorsed, as the case

may be, in pursuance of any by-law, rule or regulation, or special vote or order.

The party so acting as agent, officer or servant of the club, shall not hereby be subjected personally to any liability what ever to any third party therefor.

7. The club may, for the management of its affairs, pass and adopt such by-laws, rules and regulations (not inconsistent with the laws of this Province) as it may deem necessary respecting the admission and expulsion of members, the classification and the respective rights and privileges of such members, the fees, subscriptions and dues which it may deem advisable to impose, the number, constitution, powers and duties of its officers and of its committee of management, and generally for the administration and management of its affairs; and may also, from time to time, in accordance with its by-laws, rules and regulations alter or repeal all or any of such by-laws, rules and regulations as it may see fit, and may also delegate to its committee of management all or any of its powers of passing, adopting, altering and repealing such by-laws, rules and regulations. The by-laws, rules and regulations of the club now in force shall continue to be its by-laws, rules and regulations until altered or repealed as aforesaid.

8. No member of the club shall be personally liable for any of the debts or obligations thereof.

9. Any member of the club, not being in arrears and not otherwise indebted to the club, may retire therefrom, and shall cease to be such member on giving notice to that effect in such form as may be required by the by-laws, rules and regulations of the club, and every member expelled or retiring from the club, or whose name shall have been struck off the list of members for any of the reasons mentioned in the said by-laws, rules and regulations, shall *ipso facto* forfeit all rights of membership.

10. The club, upon a resolution adopted by two-thirds of such members present at a special general meeting specially convened for the purpose, as by the by-laws, rules and regulations of the club are entitled to vote at such meeting, may issue bonds or debentures to such amounts and payable at such

dates and bearing such rate of interest and containing such terms and conditions as the resolution may determine, and may pledge or sell such bonds or debentures for such sums and at such times as may be deemed expedient; and to secure the payment of such bonds or debentures the club may, by its duly authorized officers, grant to one or more trustees a hypothec upon the immoveable property of the club mentioning the issue and amount of the dates of payment of such bonds or debentures, the rate of interest payable thereon, and the terms and conditions upon which the same are issued; and, upon the registration of such hypothec in the office of the registration division in which the immoveable property covered by the said hypothec is situate, the said bonds or debentures shall constitute a privileged claim in favor of the holders thereof against the club and give a right of preference thereto over all debts and claims against the club posterior to the issuing of such bonds or debentures and such hypothec shall, when duly registered as aforesaid, be a valid security in favor of the holders of such bonds or debentures, whether issued before or after the execution of such hypothec, notwithstanding article 2017 of the Civil Code.

11. This act shall come into force on the day of its sanction.

(Added by 9 Edw. vii, Cap. 145).

12. Sub-section 3 of section 46 of the act 63 Victoria, chapter 12, shall not apply to the club, but the club shall be treated as coming under sub-section 2 of the said section 46.

BY-LAWS, RULES AND REGULATIONS

MEMBERS OF OLD ASSOCIATION.

1. All existing ordinary (active and non-active), transient, junior, honorary and lady associate members respectively of the unincorporated Association known as "The Ottawa Golf Club," are hereby declared to be ordinary (active and non-active), transient, junior, honorary and lady associate members respectively of the incorporated club known as "The Ottawa Golf Club" (herein in these by-laws called the Club), with the status respectively hereinafter mentioned, and shall henceforth be deemed to be members of the Club, within the provisions of Article 5488 of the Revised Statutes of the Province of Quebec, without any further formality or entrance fee: Provided, however, that in case any such member is now in arrears for fees or dues to the old Association known as "The Ottawa Golf Club," he shall not be entitled to exercise his privileges as a member of the Club until he shall have paid all such arrears of fees or dues. (Passed 15th January, 1902.)

MEMBERSHIP.

2. The Club shall consist of not more than three hundred and fifty ordinary members, exclusive of transient, junior, casual, honorary and lady associate members, and no person shall be eligible for ordinary membership until he has attained the age of twenty-one years. From and after the 1st of January, 1904, non-active membership in the Club shall be abolished, and all present non-active members shall have the option of joining the active list of ordinary members, should they so desire, and upon exercising such option shall be deemed ordinary members without further election.

ELECTION OF MEMBERS.

3. Upon the occurrence of a vacancy, candidates for membership shall be balloted for in their order, as follows: Each candidate for ordinary, transient, or junior membership shall be proposed and seconded, in writing, by ordinary members of the Club in good standing, such proposal, together with its date and a statement of the candidate's name, residence and occupation, signed by the proposer and seconder, shall be entered in its order of date in a book to be kept for the purpose at the Club House. If approved by the Committee, the name of the candidate, with his proposer and seconder, shall be posted in the Club House for one week before being balloted for by the ordinary members. Candidates will be passed upon in the order of nomination, but no ballot shall be taken on any day other than a Saturday. No election shall be held without the votes of fifteen ordinary members having been recorded. One black ball in six shall exclude. A ballot is in order on each Saturday and shall close at 6 p.m., unless the number of ballots deposited in the box on that day shall be insufficient to secure an election in which event the ballot shall remain open until the following Saturday. Means of balloting shall be provided by the Committee. Ordinary members only shall have the right to vote. The ballot box shall, after the time of voting has expired, be opened by at least one member of the Committee and the Secretary, or by two members of the Committee. No person who has been rejected shall be eligible for election within twelve months.

ORDINARY MEMBERS' FEES.

4. Ordinary members shall pay an entrance fee of \$200.00 within thirty days of election, and an annual subscription of \$35.00.

By-law No. 5 respecting "Transient Members," was repealed on the 9th February, 1907.

JUNIOR MEMBERS.

6. Candidates for membership under the age of twenty-one years shall be eligible for election in the manner provided by By-law No. 3 as Junior Members. The Committee may

limit the number of Junior Members from time to time. Junior Members while under the age of 18 years shall pay an annual subscription of \$10, and while over the age of 18 years shall pay an annual subscription of \$15, but shall pay no entrance fee. When a junior member shall attain the age of 21 years his name shall be placed at the foot of the list of candidates then waiting for election as Ordinary Members, but he shall continue a Junior Member until his name has been reached in due order and has been balloted for. During the interval between the attainment of 21 years and such balloting, the Junior Member shall pay the same annual subscription as Ordinary Members. Junior Members under 18 years of age shall have only such privileges as may from time to time be determined by the Committee.

This By-law shall be deemed to apply to all present Junior Members from and after the 31st day of December, 1905.

CASUAL MEMBERS.

7. The Committee may allow the introduction of any gentleman non-resident of Ottawa, or within 15 miles thereof, upon payment in advance of 50 cents per day, or \$2.50 per week and provided he is nominated by an Ordinary Member, who shall be responsible for all fees, and for the observance of the rules of the Club. Members so introduced shall be known as "Casual Members."

PRIVILEGED MEMBERS.

7a. Consuls-General of any foreign country, with their wives, sons and daughters, members of the Governor-General's staff with their wives, sons and daughters (not permanent residents of Ottawa or Hull), and Officers in His Majesty's Army and Navy and of the Active Militia while on service or full pay with their wives, sons and daughters (except those Officers permanently stationed at Ottawa or Hull and their wives, sons and daughters), and Ministers of the Crown in the Government of the Dominion of Canada, who prior to their appointment have not become residents of Ottawa, and their wives and daughters, shall be eligible for election as Privileged Members for such time as the Committee may from time to time determine. All candidates for Privileged Membership shall be

nominated in the same manner as Ordinary or Lady Associate Members as the case may be and shall thereupon be admitted to Privileged Membership by the Committee of the Club upon a two-thirds vote of the whole Committee in favor of such admission. Privileged Members shall pay no entrance fee, but Gentleman Privileged Members shall pay the same annual subscription as Ordinary Members, and Lady Privileged Members shall pay the same annual subscription as Lady Associate Members, and in case of a Gentleman Privileged Member the further annual sum of \$15.00 and in case of a Lady Privileged Member the further annual sum of \$5.00 in addition to such annual subscription. Privileged Members shall not be entitled to vote or to hold any office in the Club. Privileged Members becoming permanent residents within fifty miles of Ottawa or Hull shall cease to be Privileged Members at the end of the then current year, and shall then either withdraw from the Club or be put up for election as Ordinary or Lady Associate Members, as the case may be. The Committee shall have power from time to time to limit the number of Privileged Members.

Any Privileged Member who was elected a Privileged Member prior to the 9th February, 1907, because of his or her residence being more than fifty miles from Ottawa or Hull shall be placed at once at the foot of the List of Candidates now waiting for election as Ordinary or Lady Associate Members, as the case may be, but shall nevertheless be entitled to remain a Privileged Member until his or her name has been reached in due order when he or she shall be entitled to become an Ordinary or Lady Associate Member as the case may be on payment of the usual entrance fee, but until then shall be otherwise subject to all the provisions of this By-law as amended on said 9th February, 1907.

HONORARY MEMBERS.

8. Honorary membership may be conferred upon any person for life, or for a limited period, by the unanimous vote of the Club, at any general meeting thereof, and such honorary member shall, for the period so elected (without payment of any fee whatever), enjoy all the rights and privileges of an ordinary member, except that of voting or holding office in the Club.

Such Honorary membership may be conferred upon the Governor-General for the time being, and his wife and daughters,

and upon the Premier of Canada for the time being, and his wife by the Committee alone.

LIFE MEMBERS.

8a. A further class of members to be known as "Life Members" is hereby constituted. Any Ordinary Member may become a Life Member at any time upon paying to the Club the Life Membership fee hereinafter mentioned. Any other person may likewise become a Life Member upon being nominated, approved and elected as such in the same manner as Ordinary Members under By-law No. 3. Life Members shall not be included among the list of Ordinary Members, and an Ordinary or other member on becoming a Life Member shall thereby leave a vacancy in the class of membership to which he previously belonged. The fee for Life Membership shall be \$500.00 in the case of an Ordinary Member becoming a Life Member, and \$700.00 in the case of a person elected a Life Member, and in the case of a person elected a Life Member shall be paid to the Club within one month after notification of election, otherwise his election shall forthwith become null and void. Life Members shall be exempt from all membership fees during life, but shall otherwise be bound by all the present and future By-Laws of the Club (including those relating to expulsion) and shall be entitled to all the rights and privileges (including those of voting and holding office) of Ordinary Members. Upon the death, expulsion or resignation of a Life Member, neither he nor his personal representatives shall have any claim against the Club for or in respect of any fees paid by him to the Club.

All fees received for Life Memberships shall be devoted towards reducing the Club's indebtedness on capital account or be otherwise expended on capital account, and shall not be used for current expenses.

PLAYING STRENGTH.

9. In addition to the Ordinary Members the Committee may admit to the privileges of membership in the Club, upon payment of the same annual subscription as Ordinary Members, such persons who may become residents of Ottawa or Hull (at no time exceeding ten in number), as they may, from time to time, deem to be a valuable addition to the playing strength.

of the Club. Any such person shall at the same time be proposed for Ordinary Membership, under the provisions of By-law No. 3, and his membership under this by-law shall continue only until his name has been reached in due order, under the provisions of said By-law No. 3, and has been balloted for.

SUPERNUMERARY MEMBERS.

9a. Any Ordinary or Lady Associate Member who shall remove his or her residence to a greater distance than 50 miles from Ottawa or Hull (all subscriptions then due being paid) may give notice in writing to the Secretary of such removal, and of his or her intention not to make use of the Club thenceforward. Thereafter, so long as such member continues to reside at such distance and does not use the Club, the annual fee payable by such Ordinary Member shall be \$5.00, and by such Lady Associate Member, \$3.00. Such member shall be called a Supernumerary Member, and his or her name shall be so entered in the Membership Book, and a vacancy shall then be deemed to exist in the list of Ordinary or Lady Associate Members, as the case may be. Supernumerary Members shall nevertheless be entitled to be introduced as visitors under By-Laws 15 and 41. A Supernumerary Member on returning to reside within 50 miles of Ottawa or Hull, shall within three months thereafter notify the Secretary of such return, and shall thereafter be entitled to be restored to Ordinary or Lady Associate Membership, as the case may be, without election. On such restoration the current year's fees shall be forthwith paid to the Club. Failing such notification as aforesaid, such Member shall be deemed to have withdrawn from the Club.

This by-law shall be deemed to apply to any Member who has resigned since the 1st January, 1904, and to whom had it then been in force it would have been applicable, provided that all arrears of subscriptions which would have been due had this by-law been in force at the date of such resignation, are paid to the Club within one month after notification to such Member of the coming into force of this by-law.

LOCKERS, BEDROOMS, ETC.

10. The fees and charges for the use of lockers, dressing-rooms and bedrooms shall be regulated from time to time by the Committee.

PAYMENT OF SUBSCRIPTIONS.

11. All annual subscriptions are payable in advance, on or before the 1st of April in each year. Any member in arrears cannot vote or take part in the discussion of any motion or question before the Club, or hold office in the Club, or compete for any prize. The names of all the members whose subscriptions are unpaid on the 1st of June shall be posted in the Club House by the Treasurer, and any member leaving his subscription unpaid for one month thereafter shall cease to exercise any of the privileges of membership, and his name may, at the discretion of the Committee, be erased from the books of the Club, but may be replaced with the consent of the Committee, upon his giving satisfactory reasons for his default, and on payment of all arrears.

(See also By-law No. 45).

WHEN ACTUAL MEMBERSHIP BEGINS.

12. A member, on paying his annual subscription, is considered thereafter to have submitted himself to the By-Laws and Rules of the Club, both as to restrictions enjoined and penalties imposed. No person shall actually become a member of the Club until he has paid the entrance fee (if any) and the first annual subscription. These fees must be paid within one month after notification of election, otherwise his election shall forthwith become null and void. Members elected after the 1st of August in any year shall pay one-half only of the annual subscription for the unexpired portion of the current year up to the 31st December following.

RESIGNATIONS.

13. All resignations of office or membership shall be in writing, addressed to the Secretary, and shall be submitted by him to the next meeting of the Committee which shall be held thereafter. All dues must be paid in full before a resignation shall be considered. If resignations are not received before the first of April, the fees for the current year must be paid.

EXPULSION.

14. In case the conduct of any member (wherever it may occur, and whether as a member of the Club or otherwise) shall, in the opinion of the Committee, or of any member of the Club, who shall certify the same to the Committee in writing, be injurious to the character and interests of the Club, the Committee shall be empowered to recommend such member to resign. If he does not resign within ten days from the date of such recommendation, a special general meeting of the ordinary Members of the Club shall be called to consider the conduct of such member, and in the event of two-thirds of those present at such meeting voting that the name of such member be removed from the roll, he shall then cease to be a member and shall forfeit all the privileges of the Club, and shall thereafter be ineligible for re-admission as a member or to be introduced as a visitor.

INTRODUCTION OF VISITORS.

15. Any Ordinary Member may introduce a gentleman not residing in Ottawa or within 15 miles thereof (except an expelled member under the preceding By-law) to all the privileges of the Club House and Links for two consecutive days, or to the privileges of the Club House alone for seven consecutive days; but such visitor shall not be introduced under this By-law more than twice during the same year. The name of such visitor shall be entered in the Visitors' Book by the member introducing him, and such member shall be responsible for his visitor's observance of the rules of the Club and for any indebtedness to the Club incurred by such visitor. The introduction of a visitor under this By-law shall not interfere with his introduction as a Casual Member under By-law 7.

COMPLAINTS.

16. Complaints in writing, signed by the member complaining, may be filed with the Secretary, who shall submit such complaints to the proper sub-committee, and their decision (if not contrary to the by-laws of the Club) shall be final, subject only to an appeal to the Committee, who shall have power to dispose finally of such complaints.

CHANGE OF ADDRESS.

17. Any member changing his address must notify the same to the Secretary in writing. Failing such intimation, all notices sent to such member's previous address on the books will be deemed to have been duly delivered.

ANNUAL MEETING.

18. The annual general meeting of the Club shall be held on the second Saturday of February in each year, at such place and time as the Committee may appoint, to receive a statement of the affairs of the Club, and of the income and expenditure for the past year (certified by the auditors of the Club), to elect the Committee for the ensuing year, and for other general and special purposes relating to the management of the Club. Ordinary Members only shall have the right to vote at any meeting. No voting by proxy will be allowed.

FINANCIAL YEAR.

19. The financial year of the Club shall end on the 31st day of December of each year.

SPECIAL GENERAL MEETING.

20. A special general meeting may be called whenever the Committee deem it necessary, or on a requisition being presented to the Secretary, stating the matter to be discussed and signed by at least seven Ordinary Members.

QUORUM.

21. At all meetings of the Club fifteen Ordinary Members shall be necessary to constitute a quorum, and if within one hour of the time set for any meeting there shall not be a quorum the meeting will stand adjourned for one week, at the same place and hour.

NOTICES OF MEETINGS.

22. Notice of all general meetings shall be mailed by the Secretary to each Ordinary Member at least four clear days

before the date of meeting. No public notice or advertisement shall be required. Notices of special general meetings shall specify the matters proposed to be dealt with at such meetings.

CHANGE IN BY-LAWS.

23. Notice in writing of any change in the By-laws of the Club, to be moved at the annual or any special general meeting, must be left with the Secretary at least eight clear days, and a copy thereof mailed to each member of the Club four clear days before such meeting. At such meeting the same shall be discussed, and, if approved by two-thirds of those present qualified to vote, shall be adopted. The Committee, by a two-thirds vote of the whole Committee, may, from time to time, make, repeal, amend or re-enact all or any By-laws, but such change, unless in the meantime confirmed or repealed by a special general meeting duly called for the purpose, shall only have force until the next annual general meeting, and if not then confirmed by a two-thirds vote of the members present, shall from that time cease to be in force.

MANAGEMENT OF CLUB.

24. (1) Management of all matters connected with the Club shall be vested in a Committee consisting of seven Ordinary Members, one of whom shall be the President of the Club, and another the Vice-President. The President and Vice-President shall be elected by ballot at each annual general meeting. The other members of the Committee shall also be elected by ballot at each annual general meeting in the following manner:—Five members shall be elected at the annual general meeting to be held on the 18th day of January, 1905, and the two members so elected receiving the highest number of votes shall hold office for a period of two years, and the other three for a period of one year. At each successive annual general meeting three members only shall be elected to replace the three then retiring from the Committee (who shall nevertheless be eligible for re-election) and the two receiving the highest number of votes shall hold office for a period of two years and the third for a period of one year. In the event of a tie or of the nominations not exceeding the number to be elected the rotation of office shall be determined in such manner as the meeting may direct.

All the rules and regulations of the Committee shall be binding upon the members unless revoked at a general meeting of the Club. Three members of the Committee shall form a quorum. Committee meetings may be held at any time without formal notice, if all the Committee be present, or if those absent have signified their consent to such meeting and their inability to attend. Special Committee meetings may be called by the President, or any two members of the Committee, at any time, and notice thereof shall be sufficient if delivered or mailed by the Secretary to each member of the Committee, at his last known post office address, at least two clear days before the meeting is to take place. Such meeting may be held at such place as the President may direct. The Committee shall meet forthwith after the annual meeting of the Club, and shall at such meeting elect a Captain, and elect or appoint a Secretary-Treasurer, or a Secretary and a Treasurer, who may or may not be a member of the Committee.

(2) Nominations for President, Vice-President and members of the Committee shall be made in writing and placed in the hands of the Secretary at least eight days before the date of the annual general meeting. The Secretary shall, with or as part of his notice calling the annual general meeting, include the names in alphabetical order of all such nominations. In the event of their being sufficient names so nominated to fill the vacancies no other than those so nominated shall be eligible for election to the respective offices; otherwise further nominations may be made at the meeting.

VACANCIES.

25. In the event of vacancies occurring during the year, in the Committee, from any cause whatever, the remaining members of the Committee shall have power to fill the same from among the Ordinary Members of the Club, until the next annual general meeting.

PRESIDENT.

26. The President shall be the chief executive officer of the Club. He shall preside at all meetings of the Club and the Committee, and ex-officio be a member of all sub-committees. In the event of a tie he shall have an additional or casting vote.

VICE-PRESIDENT.

27. In the absence of the President all his duties shall be performed by the Vice-President, and in case the office of President becomes vacant from any cause, the Vice-President shall become President until the next annual general meeting.

SECRETARY.

28. It shall be the duty of the Secretary to keep correct minutes of all meetings of the Club and of the Committee, to conduct the correspondence of the Club, and to carry out the instructions of the Committee.

TREASURER.

29. The Treasurer shall receive all moneys and pay all accounts passed by the Committee, and generally attend to the financial affairs of the Club.

The Committee shall take a bond of indemnity to the extent of at least \$2,000.00 for the due performance of the duties of the Treasurer. If such bond is taken from a Guarantee Company the annual premium therefor shall be paid by the Club.

SEAL.

30. The Seal set to or impressed on these By-laws shall be the Corporate Seal of the Club, and until otherwise ordered by the Committee, the said Seal shall be kept in the custody of the Secretary.

DOCUMENTS.

31. Unless the Committee, by resolution, otherwise direct, all documents sealed with the Seal of the Club shall be countersigned by the President or Vice-President and by the Secretary.

CHEQUES.

32. Any cheques drawn shall be signed by the President or Vice-President, or in their absence by a member of the Com-

mittee, and countersigned by the Treasurer or Secretary; but cheques for deposit may be endorsed by the Treasurer or Secretary alone and cheques so drawn or endorsed shall be binding on the Club.

SUB-COMMITTEES.

33. The Committee shall appoint a Green Committee and a House Committee, or other sub-committees, from their own body, or with the addition of other Ordinary Members of the Club, as they shall see fit. The names of such Committees shall be posted in the Club House. All sub-committees shall be subject to the Committee, who shall have the power to decide any question of jurisdiction, and to define the duties and powers of the sub-committees, and shall approve of all new rules before they are put in force. The transactions of each sub-committee shall be reported to the Committee at their first meeting held thereafter.

HOUSE COMMITTEE.

34. The management of the Club House, the administration of its internal economy, and the rules and regulations relating thereto, are vested in the House Committee, and they shall have power, subject to the Committee, as occasion may require, to make new rules relating thereto.

GREEN COMMITTEE.

35. The Green Committee shall, subject to the Committee, have charge of the grounds and the green, and of all contests and competitions, and may make local rules of play, and shall have power to set apart the course on any occasion for any particular match, and generally at all times to regulate the play thereon.

QUORUM.

36. A majority of any sub-committee shall form a quorum.

EXPENSE.

37. No expense of any kind shall be incurred by any sub-committee, unless the same shall have first been approved of by the Committee.

AUDIT.

38. The books, vouchers and accounts of the Treasurer shall be audited before each annual meeting by a duly qualified chartered accountant, to be appointed by the Committee. Such accountant may or may not be a member of the Club.

RULES OF PLAY.

39. The rules of play shall be the rules of golf as approved by the Royal and Ancient Golf Club of St. Andrews, except as modified from time to time by the local rules made by the Committee or the Green Committee.

N.B.—*By-laws 40, 41, 42 and 43 relate to Lady Members only. Other By-laws affecting Lady Members are: Nos. 1, 7a, 8, 9a, 10, 11, 12, 13, 16, 17, 39, 44 and 45.*

LADY ASSOCIATE MEMBERS

40. Lady Associate Members may be admitted to the number of two hundred and twenty-five. The lady members shall, at a meeting called for the purpose on the fourth Wednesday in January in each year, elect, by ballot, from their number, a President, Vice-President and Captain and a Committee of four, and the Committee so elected shall elect or appoint a Secretary, who may or may not be one of their number. Admission to membership shall be by nomination and election by the lady associate members, under rules to be provided by the Ladies' Committee. The management of all matters connected with the lady associate members, and their meetings, play and rooms, shall be vested in the Ladies' Committee, subject to the general rules of the Club and the Committee of the Club. Lady associate members must conform to the rules of the Club, and directions of the Ladies' Committee and of the Committee of the

Club, and any wilful infringement of such rules may be followed by expulsion from membership, if a two-thirds majority of the Ladies' Committee so determine. The President, Vice-President and Captain shall ex-officio be members of all committees.

LADY ASSOCIATE MEMBERS' FEES, ETC.

41. The entrance fee payable by each lady associate member shall be \$50.00, and the annual subscription shall be \$15.00. Lady associate members are not allowed to play on the course on any match day, or on any other special day that the Committee of the Club or the Green Committee may appoint, and (except during July or August) they shall not play on Saturday afternoon after 2 o'clock, or on any holiday. Lady visitors non-resident of Ottawa, may be introduced to the privileges of the Club House and links for six consecutive days by any lady associate member; but such visitor shall not be introduced more than twice during the same year. A lady non-resident of Ottawa may be introduced for a period not exceeding two months upon payment of a fee of \$1 per week. Lady associate members shall be entitled to use all the club-rooms and verandahs, except those set apart for gentlemen by the Committee of the Club.

PLAYING STRENGTH.

42. In addition to the number of Lady Associate Members above mentioned, the Ladies' Committee (but only with the approval of the Committee of the Club) may admit to the privileges of Lady Associate Membership in the Club upon payment of the same annual fee as that payable by Lady Associate Members, such ladies who become residents of Ottawa or Hull (at no time exceeding five in number), as may be deemed from time to time to be a valuable addition to the playing strength of the Club. Any such lady shall at the same time be proposed for Lady Associate Membership under the provisions of By-law No. 40 and her membership under this By-law shall continue only until her name has been reached in due order under the provisions of said By-law No. 40 and has been balloted for.

LADY LIFE MEMBERS.

43. Any Lady Associate Member may become a Lady Life Member at any time upon payment of the Life Membership fee hereinafter mentioned. Any other lady may likewise become a Lady Life Member upon being nominated and elected as such in the same manner as Lady Associate Members under By-law No. 40. The fee for Lady Life Membership shall be \$300.00. Except as aforesaid, all the provisions of By-law 8a respecting "Life Members" shall, *mutatis mutandis*, apply to Lady Life Members.

CAPITAL ACCOUNT.

44. All entrance fees and life membership fees shall hereafter be applied upon capital account and not for current expenses. (Passed 12th May, 1910.)

NON-PAYMENT OF SUBSCRIPTIONS AND OTHER DUES.

45. The Committee shall be empowered, after giving one week's notice of its intention to enforce this By-law to any member of the Club who is in arrears for annual fees, locker fees or any other moneys due to the Club, to suspend such member from all or any of the privileges of the Club for any period which the Committee may fix but not exceeding six months. If the arrears are paid before the period of suspension has expired such member shall be entitled to resume such privileges. If at the expiration of the period of suspension such member shall not have paid the arrears the Committee shall be empowered to expel such member from the Club and his or her name shall then be erased from the books of the Club, but may be replaced with the consent of the Committee, upon satisfactory reasons being given for the default and on payment of all arrears.

HOUSE RULES

1. The Club House shall be open every day for the reception of members, but it shall be closed at 12.30 a.m., except on Saturdays and Sundays, when it shall be closed at midnight. No member or guest shall remain in the general rooms of the Club after the hour of closing, unless specially permitted by the House Committee.

2. The introduction of visitors shall be regulated as follows:—

(a) **NON-RESIDENTS.** Under By-Laws 15 and 41 persons residing more than 15 miles from Ottawa may be introduced as Visitors to the privileges of the Club House only, for a period not exceeding 7 consecutive days, and to the privileges of the links for a period of 2 consecutive days in the case of a gentleman visitor, or of 6 consecutive days in the case of a lady visitor. This privilege can be granted to the same person not oftener than twice in any one year. If more extended privileges are desired the Visitor must be introduced as a Casual member upon paying the fees provided by By-Laws 7 and 41.

(b) **RESIDENTS.** Persons residing in Ottawa or within 15 miles thereof cannot be introduced to the Club House or Links as Visitors except under the following circumstances:—

Any member (other than a junior member under 18 years of age, or a casual member) may at his or her own expense introduce guests to Breakfast, Luncheon or Dinner, (and during the Winter season from November 1st to March 31st only, to Afternoon Tea), and may also at any time at his or her own expense introduce members of his or her family actually residing with such member to all privileges of the Club House and links, but no person so introduced shall be entitled to play Golf. Guests so introduced must be accompanied by the member introducing them.

(c) **VISITORS' BOOK.** The names of all visitors and guests introduced under this House Rule, or under By-Laws 15 or

41, must be entered in the Visitors' Book by the member extending the introduction, immediately upon entering the Club House.

(d) The Committee on special occasions (such as Championship Meetings, Matches with Visiting Teams, etc) may extend or restrict the foregoing privileges, as the occasion may require.

3. Any member introducing a visitor shall be responsible for all debts he or she may incur to the Club, and for any damage done to the Club property.

4. The playing of cards and other games in the Club House shall be under the control of the Committee.

5. No dogs shall be allowed in the Club House or on the Verandahs.

6. No wines or liquors of any kind shall be served in the bedrooms, dressing rooms or locker rooms and no game of cards shall be played in these rooms.

7. All provisions or liquors used or served in the Club House must be obtained from the Club.

8. Members shall not wear Boots or Shoes with spikes or hob-nails in any room on the ground floor of the Club House except in the locker rooms and on the verandahs.

9. Members are requested not to reprimand servants. No member or visitor shall give, under any pretense, money or any gratuity to any one in the employ of the Club. Any servant who receives a fee will be dismissed from the service of the Club.

10. All requests and complaints shall be made in writing, addressed to the Secretary of the Club.

11. The charge for meals, wines, liquors and cigars, the use of bedrooms, and the amount to be paid therefor, and all rules regarding same, shall be under the direction of the Committee.

12. Any member using a lock on his or her locker should leave a duplicate key with the caretaker.

13. Junior members under the age of 18 years shall not be entitled to any of the privileges of the card rooms or the Men's smoking room.

14. In the Club House, members shall use the Club cards. The charge for cards will be 15 cents per player for new cards, or 5 cents per player for cards which have been used before. The cards remain the property of the Club and will be taken up by the Steward immediately after play has ceased.

15. Hours for meals shall be:—Breakfast, 7.30 to 9.30 a.m., Luncheon, 1 to 2.30 p.m.; Dinner, 6.30 to 8 p.m. During these meal hours sandwiches, biscuits, tea and toast, etc., will not be served outside the dining room. Orders for sandwiches must be given at least an hour before a meal hour.

16. Members inviting more than three guests to luncheon or dinner on any day must give the Steward at least three hours notice thereof and during the winter season when Club meals are not regularly prepared, members requiring luncheon or dinner must give due intimation.

17. Smoking in the Main Dining Room will not be permitted.

18. Crockery, glassware, furniture or other articles, the property of the Club, broken or damaged by a member must be paid for by such member.

19. Books, magazines and papers belonging to the Club must not be mutilated or defaced in any way and shall not be taken away from the Club.

20. Carriages and automobiles waiting for passengers must not remain at the entrance, but must retire to the grounds and sheds at the rear of the Club House until notified their passengers are ready to depart. Drivers and chauffeurs will not be permitted to use the Club House or the verandahs or to receive refreshments from the Club.

21. House accounts will be rendered at the end of each month and are payable before the end of the following month. The names of members who are in arrears for house accounts will be posted in the Club House, and further credit refused until such arrears have been paid.

22. The foregoing rules are subject to change or addition from time to time by the Committee.

N.B.—Members are earnestly requested to exercise the greatest care in the disposal of lighted matches, live ashes, cigar and cigarette stubs in and around the Club House, in order to minimize the danger of fire, or damage to furniture, floors or rugs.
