The Second Annual Session of the Grand Lodge, A. O. U. W., of British Columbia, was called to order at 10:45 a. m., Grand Master Workman Leiser in the Chair.

On motion, the Grand Lodge took recess to meet again at 1 o'clock.

Afternoon Session.

The Grand Lodge was called to order at 1 p. m., Grand Master Leiser in the Chair.

On roll call the Grand Officers and Representatives were all reported present.

The Committee on Credentials reported Bro. L. Paisley entitled to a seat as representative of Chillawhack Valley Lodge, No. 10.

REPORTS OF OFFICERS.

ADDRESS OF GRAND MASTER WORKMAN GUSTAV LEISER.

SECOND ANNUAL SESSION, 1893.

*To the Officers and Representatives of the Grand Lodge,
A. O. U. W., British Columbia :*

BROTHERS :—In compliance with the constitution of our beloved Order it becomes my duty to render you an account of my official acts as Grand Master Workman, during my term of office.

CHANGE OF PLACE FOR THIS MEETING.

I received a petition signed by the majority of members of last Grand Lodge Session asking that this meeting be changed from Chilliwack to New Westminster, giving good substantial reasons for the change. Through the objections of some of the representatives from Chilliwack Valley Lodge, No. 10, the change could not be made.

DISTRICT DEPUTIES.

On July 31st last, I appointed Bro. M. Bate, P. M. W., as District Deputy Grand Master Workman for Nanaimo and vicinity.

Also on Aug. 1st last, Bro. W. H. Keary, P. M. W., for the Mainland of British Columbia.

BRO. WM. ROSS.

On April 16th, 1892, I received a communication from Bro. Wm. Ross proposing to organize subordinate lodges in several places on the mainland. I replied to him on the 20th April, as follows :

Wm. Ross, Esq.,

DEAR SIR AND BRO:—Replying to your favor of the 16th inst., I shall be pleased for you to take the field on the mainland in the interest of our Order. In organizing new lodges I would ask you to carry out the following rules.

(1.) Do not organize with less than 25 charter members.

(2.) Do not take any bad risks, as the success of our new jurisdiction depends on good risks.

(3.) Do not engage a doctor that you cannot depend upon, as we must have a reliable man.

(4.) I also would not advise you to try such places that can not give us a good working lodge, it would be spending money without doing any good. I think, however, that from the places you mentioned, Ladner's, Surrey, and Langley, can be worked successfully. I would therefore ask you to take these places first. Allow me to state to you here that I can allow you only fifty dollars for each lodge that will be organized through you getting the required number necessary, and can allow or pay for no other expenses you may have. Should you be satisfied with those conditions please answer at once and I will see that the necessary papers are forwarded to you.

On April 25th, I met Bro. Ross at New Westminster, where he agreed to organize at Ladner's Landing, under the above conditions. I assisted at the organization of Delta Lodge, No. 12, on May the 9th last, and paid Bro. Ross the fifty dollars.

Bro. Ross, in a letter dated August 4th, informed me that the formation of several lodges would take place as follows: Cloverdale, August 15th; Langley, August 17th; Aldergrove, August 19th; Maple Ridge on or about August 22nd. I met Bro. Ross a few days later at New Westminster, when I informed him that we would allow him seventy-five dollars for each organization, and we agreed that I should be at Cloverdale the 15th August, to organize the several lodges as mentioned. On arriving at Cloverdale with Bro. De Wolf Smith, G. M. Examiner, we found that Bro. Ross had as yet no applicant examined, and that in other places nothing had been done to organize as agreed. With great difficulty, with the assistance of Bros. Hoy, Johnson, and Adams, I obtained sufficient applicants and organized Cloverdale Lodge the same evening. Bro. Ross had in the meantime received in all, \$87.50, which amount had been advanced to him, he therefore received more than amount due him for Cloverdale organization.

I received however on October 17th last, a letter from Bro. Ross stating that he had forwarded a claim against the Grand Lodge to our Recorder, which will in due time come before you and I would ask you without further comment to allow the matter to have a full investigation, and therefore attach all letters referred to, with my report.

DISPENSATIONS.

I have on many occasions granted dispensations to several lodges to confer both degrees the same meeting night upon a brother.

On October 14th, to Sullivan Lodge, No. 6, to hold a social under the auspices of the Order.

On December 24th, to Delta Lodge, No. 12, for the same purpose.

DECISIONS.

1. Every representative of the Grand Lodge is entitled to receive the Grand Lodge Degree.

2. A Master Workman serving part or end of a term on account of Death, resignation or inability of the previous Master Workman, becomes a P.M.W. at the expiration of the term.

3. All representatives of the Grand Lodge must be Past M.W., or members who have served three consecutive years as Recorder, Financier or Receiver.

It would be irksome to give you all my decisions, as a great part of them are well known and established rules of the order.

BY LAWS.

I recommend that a more uniform scale of admission fee for all subordinate lodges be adopted.

MORTALITY.

During the past year three deaths have occurred, which required eleven assessments, and I am pleased to state that all claims were paid promptly.

A report of our departed brethren will be furnished you by the Grand Recorder.

GROWTH OF THE ORDER.

I am pleased to say this has been very satisfactory, the following lodges having been organized since our last annual meeting.

Making a total of 17 lodges in the Jurisdiction, with a membership of 705.

It is to be regretted that the increase in membership with some of the lodges has been either none or very small. We have, I am sorry to say, so many brethren in our ranks who will accept all the benefits of the Order but otherwise take no interest in the same. They pay their dues and assessments, because they know that they have a first-class Beneficiary Certificate for \$2,000, which cost them very little, but they are never seen at the lodge room and seldom ask an acquaintance to join the Order. This is not as it should be, I think we should legislate upon the question of each subordinate lodge to secure and maintain a percentage of increase, that is to say, to keep up the proper ratio of percentage of net increase over losses, so that the assessments will not increase and become burdensome upon the members, and I hope that the Supreme Lodge will find some way out of this much discussed question.

In May last I issued the following circular to every member of this Jurisdiction.

VICTORIA, B. C., 1892.

Office of Grand Master Workman, A. O. U. W.

DEAR SIR AND BROTHER :—The deep interest that I feel in the future welfare of the Jurisdiction of British Columbia prompts me to address you personally.

It is unnecessary for me to refer to the past. You know it better than I do. We are more concerned now with British Columbia's future than its past. What that future shall be depends upon your individual efforts. The Supreme Lodge fixed your maximum rate at 20 for the ensuing year. The sole purpose of this concession was to enable British Columbia to build up; to become self-supporting; to attain a place among the leading jurisdictions. It only requires a little effort upon your part to accomplish this result. It is only necessary that each member in British

Columbia shall bring in one new member through the coming year to settle the question of British Columbia's future once and for all. Will you not take an application and get one new member at once? You can easily do it if you will. I sincerely hope that you have enough interest in the success of the Order in your jurisdiction, in the prosperity of your own Lodge, to make this effort without delay.

You can say to your friends on behalf of the A.O.U.W. what no other member of any other fraternal beneficiary can say.

1st. That the A. O. U. W. is the oldest and largest society of its kind in the world.

2nd. That it is the only society of its kind that gives to each member a guaranteed maximum annual cost.

The age and strength and the annual guarantee are unassailable arguments in favor of the A. O. U. W.

My Brother: Your own interest is at stake in this matter. An increasing membership means a decreasing cost, and self-interest should prompt you to make an effort to increase the membership in British Columbia.

But more than this: If you do not make the necessary effort now, if British Columbia through the effort and work of her members does not become self-supporting during the time-limit of this concession, you cannot expect the Order at large to bear longer any portion of your burden. Whatever the cost may be, you will have to bear it hereafter. It will be small or large just as you make it by your work or by your neglect.

The Order at large through the medium of the Relief Law has shown to you that the fraternity of the A. O. U. W. is a reality. Will you not respond in the same fraternal spirit and prove to your Brother Workmen everywhere that the Workmen of British Columbia know how to appreciate a

fraternal act, and stand ready to show forth their appreciation by active and aggressive work for the Order ?

RECOMMENDATIONS.

1. The Supreme Lodge at its last session adopted the report of the Committee on Laws, fixing the maximum age limit, viz. : "The Grand Lodge may at their option reduce the maximum age limit to 45 years." I would strongly recommend the adoption of this limit for our jurisdiction.

2. Also that we should not encourage extra hazardous risks, such as coal miners and sealers. An accident causing the death of several members at one time would be a very serious matter and in justice to our organization we should discourage the admittance of such risks.

GRAND LECTURER.

There is great need of a Grand Lecturer being placed in the field, but the financial standing of our small jurisdiction does not as yet allow such a venture. I think however that the Supreme Lodge should aid in the extension of the Order in the several jurisdictions, by appointing lecturers in the interest of the Order.

APPOINTMENT OF G. M. EXAMINER, PRO. TEM.

On January 3rd last, I appointed Bro. H. E. Langis, M.D., Grand Medical Examiner, pro. tem., until the recovery from a severe illness of our esteemed G. M. E. Bro. W. A. De Wolfe Smith.

BRO. JOS. JOHNSON.

Bro. W. H. Keary, D. D. G. M., was very fortunate in securing the services of Bro. Johnson for the organization of

new lodges on the mainland of British Columbia, and I cannot but highly recommend Bro. Johnson for the work, and I take this occasion to express my thanks to Bro. Johnson for the efficient services rendered so willingly to the jurisdiction on so many occasions.

CONCLUSION.

During my term of office I have visited nearly every subordinate lodge within the jurisdiction, and while my work has at times been trying it has been performed with pleasure, always in remembrance of the great good to be accomplished. I cannot close without returning thanks to the Grand Recorder, who I have always found at his post doing his duty to the Order faithfully. To our Grand Receiver my most sincere thanks are due for his many courtesies and services rendered so willingly. I also desire to express my thanks to the officers and members of the Grand Lodge who have so often assisted me in my work.

Thanking you for the trust you have placed in me, and wishing our great Order unbounded success in the future.

On motion, the report of Grand Master Leiser was referred to a special committee, consisting of Bros. Wolfe, Kelly and McGregor, except his decisions and recommendations which were referred to the Committee on Laws.

GRAND RECORDER'S REPORT.

*To the Officers and Representatives of the Grand Lodge,
A. O. U. W., of British Columbia :*

BROTHERS—The time has arrived when I am called upon to give an account of my duties during the past year. To me it has been one of anxiety, as I believe upon our first year or two years will depend, in a great measure, the success of our Grand Lodge in this Province.

To make our Order in this jurisdiction a success it requires the help and assistance of every true and loyal brother. To increase our membership it will be necessary for us to reach every home in British Columbia which will offer us a suitable candidate for membership.

Our increase during the past year has not been all that we expected, and the officers wish to see a greater effort on the part of our members. Personal canvassing is the most successful way of adding to our numbers and advancing our order.

My correspondence on account of many new lodges being formed, and many of the officers being new to the work, has been extensive, and taken much time. This part of my work has always been a pleasurable duty, and if I have not answered every communication promptly, it has been because some other lodge business was more pressing.

The case of Brother Roland Green is one which has caused the Grand Officers no small amount of thought and anxiety. The case may be briefly stated as follows:

Before the law was enacted by the Supreme Lodge making it compulsory for every member to make his Beneficiary Certificate payable only to one related to him or one dependent upon him. In the year 1884, Brother Green made his beneficiary payable to a friend, John Graham.

This friend has paid all dues and assessments, keeping him still in good standing.

Grand Master Workman Leiser received a note from Brother MacLaughlan, who is acting in the interest of Mr. Graham, to which I was instructed to reply as follows:

VICTORIA, October 13th, 1892.

J. H. MacLaughlan, Esq.,

DEAR SIR AND BROTHER:—Your favor of 6th September, *re* payment of Beneficiary Certificate in favor John Graham, I beg to say: That I consider the Grand Lodge of British Columbia liable for all Beneficiary Certificates issued strictly in accordance to the then existing laws by the old jurisdiction, and I am of the opinion that in the year 1884 there was nothing in our laws prohibiting the payment of a Beneficiary to any one except a relative or a person depending upon him, which is now the case.

We cannot issue new beneficiary certificates to Brother Roland Green, only in accordance with the laws of our order as they now stand.

I give this as my opinion and cannot guarantee to you what action the Grand Lodge will take when the claim becomes payable.

This reply did not satisfy Bro. Joshua H. MacLaughlin, and at his request I wrote to Supreme Recorder Sackett, stating the case very fully and closed my letter by extracts from

Grand Master Leiser's letter and said: What he wishes to know seems to me is this. If he continues to pay Brother Green's assessments and dues to his Subordinate Lodge, and Brother Green does not change his beneficiary certificate, which is now payable by the Oregon and Washington jurisdiction, will we, that is the British Columbia jurisdiction, have to pay the claim to him or his heirs at Brother Green's death? Supreme Recorder Sackett replied:

DEAR SIR AND BROTHER: The question which you ask is one that should require an official reply, if it is to be of any service to you. I therefore have referred the matter with the letters to Supreme Master Workman Burt, asking him to take an early opportunity to make an official reply.

Supreme Master J. Edward Burtt replied:

DEAR SIR AND BROTHER:—In answer to your enquiry of Bro. Sackett, Supreme Recorder, referred to me by him, it is extremely difficult to give you an opinion, the case being one which most likely will get into the courts, and as the decisions, so far as they have been made in similar cases, are somewhat at variance, it appears to me that some course should be taken to compromise the case if possible.

The laws of the Order are very decided upon the question of Beneficiary, and my predecessors have decided that it could not be pledged to secure a debt.

To bridge over the difficulty of obtaining the present certificate, the member can file an affidavit that his certificate has been lost, or is withheld from him, upon which affidavit a duplicate certificate can be issued to him, and upon that certificate he can authorize a change of beneficiary, in accordance with the laws of your jurisdiction.

I assume that your Grand Lodge authorized you to call in all certificates for which your jurisdiction is liable and to issue new ones in place of them, if such should be the fact, I am clearly of the opinion that the member could have charges preferred against him, tried, and if found guilty, expelled from the order. Of course a demand must first be made upon him to surrender his old certificate.

The laws of this State regarding life insurance would give his heirs the benefit, in case of his death in good standing.

One reason why we have been so particular in this case is, there may be other beneficiary certificates in some of our older lodges, which are payable to friends (or as per will etc.) and while we are issuing new certificates in lieu of those now held by some of the members, which are payable in the Oregon and Washington jurisdiction, we must issue them only as the laws of our Order now direct.

There has been some unpleasant duties to perform in connection with work of my office, to which I will not refer but briefly. One of the most prominent of these was the unreasonable delay which occurred by the Washington jurisdiction neglecting to promptly settle our death claims which occurred between our separation from Oregon and Washington jurisdictions, and the formation of our Grand Lodge.

We received the usual notices and they accepted of our assessments, but neglected or rather refused to pay our death claims. Several letters passed between Grand Recorder Steinback and myself on the question. The officers of the subordinate lodges appealed to the Grand officers of this jurisdiction, with the express wish that we bring this matter to an issue by bringing it with all our correspondence to the Supreme Lodge for adjustment.

I am pleased to say these claims were at length settled without our applying to the Supreme Lodge.

REPORT OF G. M. EXAMINER.

NEW WESTMINSTER, B. C., March 13th, 1892.

To the Officers and Members of the Grand Lodge of British Columbia, A. O. U. W. :

BROTHERS :—I beg herewith to submit the report of the transactions of my office for the year ending March 12th, 1893.

During this time I have received and passed upon 266 Medical Examiner's reports, and of these have accepted 248 and rejected 18. The causes of the different rejections were as follows :—

The average age of the 266 applicants was 35.88 years.

The average age of the 248 accepted applicants was 35.65 years ; and of the 18 rejected applicants, 39, years.

It will be noticed that nearly one-half of the total number of rejections were on account of some family or personal history of consumption, or a tendency thereto. In making these rejections I have simply followed out the printed rules on the back of the medical reports, without going so far as the jurisdiction of Massachusetts, where, according to a letter I received from the late Supreme Physician, Dr. Hugh Doherty, (who was also Grand Medical Examiner in that jurisdiction) they rejected any applicant whose family history showed even one member who had suffered from consumption. I believe this to be a sound view, for not only is consumption, or rather the tendency or liability to it, inherited, but it has been proved that the disease is directly communicable from one person to another.

Fortunately we have to record no death from small-pox during the past year, although that disease was more or less prevalent in this Province all the year. I beg that no one be accepted a member of the Order in this jurisdiction who has not been vaccinated successfully since his 15th year. The mortality of small-pox among the unvaccinated is so great that this jurisdiction cannot afford to include such persons in its membership.

Thus, to quote a few figures during the epidemic of small-pox in Montreal in 1885-86, 1474 cases were admitted in the Civic Hospitals, and of these cases 463 died. Of the 1474 cases 920 were not vaccinated, and 17 cases were second attacks. Of the 920 not vaccinated, 358 or 38.91 per cent. died, while of the 537 who were vaccinated, 105 or only 19.55 per cent. died.

I would also ask this Grand Lodge to consider the advisability of reducing the age limit from 50 to 45 years, and also the question of whether coal miners shall be considered

eligible for membership. I am of the opinion myself that persons engaged in under-ground mining should not be accepted as members—not on account of any extra liability to disease, but on account of the frequency and severity of accidents among such men.

Fortunately for us as a jurisdiction, the number of deaths which have occurred amongst us is too small to deduce any practical lessons from, and I hope that next year will give us as favorable a showing.

In concluding this meagre report, I have to tender my thanks to the grand officers, particularly District Deputy Grand Masterworkman W. H. Keary, Esq., and Grand Recorder H. Jewell, Esq., for much assistance and advice, and

REPORT OF THE REPRESENTATIVES TO THE SUPREME LODGE.

*To the Grand Master Workman, Officers and Brothers of
the Grand Lodge A. O. U. W., British Columbia :*

We, your representatives, having attended the twentieth stated meeting of the Supreme Lodge, held in the city of Helena, Montana, June the 14th to the 22nd, beg leave to submit our report.

After being delayed three days at Missoula through a washout on the railway. We reached Helena on the 17th of June, the Supreme Lodge had then been in session three

days transacting principally routine business, the more important work of the session took place after our arrival.

That part of the Supreme Master's report referring to British Columbia was referred to a special committee. Supreme Master Workman Kingsly, Bro. Sullivan, your representatives, and the delegates from Washington and Oregon, attended the meeting of the committee giving every explanation necessary with regard to setting British Columbia apart as a separate jurisdiction. Showing to the committee that what has been done was perfectly satisfactory to the three jurisdictions directly interested, nevertheless the committee's report to the Supreme Lodge did not approve the action of the Supreme Master. When the report came before the Supreme Lodge an additional clause was moved, and carried (almost unanimously) endorsing the Supreme Master's action, and instructing the Supreme Lodge to grant a Charter to the Grand Lodge of British Columbia.

Section 44 of the Supreme Lodge Constitution was amended, giving Grand Lodges the power to change the maximum age of applicants for Membership from Fifty to Forty-five years.

The Maximum Assessment for British Columbia was fixed at twenty until the next re-adjustment.

A copy of our Constitution was presented to the Committee on Laws, who reported their adoption, which report was sanctioned by the Supreme Lodge.

The Supreme Lodge will hold its next session in the City of Toronto, Ontario, commencing on the Third Tuesday in June, 1893.

Your Representatives wish to place upon record their appreciation of the treatment they received from the Brethren and Citizens of Helena. Their attention and hospitality being without a parallel.

We also found in Bro. James Sullivan the same earnest

worker for the welfare of British Columbia that he prove to be while with us last year.

In conclusion we would mention that every jurisdiction was represented, and that harmony and a spirit of enthusiasm characterized the session. Consideration was shown your Delegation, each of your Representatives having a place on some committee.

DEAR SIR AND BRETHREN:—I very much regret that pressing business precludes my attendance at the annual meeting of Grand Lodge.

Much as I would wish to join in the deliberations and work of the first gathering of Grand Lodge Officers and Members, my regular duties here will not permit of my leaving home at the present time. I must therefore beg that my absence be excused.

Since the date of the appointment as D. D. Grand Master, for Vancouver Island, with which the Grand Master honored me, I have not made a journey to Victoria, nor have I been able to go north, as far as Comox, and have not consequently made any official visit to a lodge at either of those places. The welfare of the Order at the capital city and vicinity has, I am advised, been well guarded and promoted by zealous brethren in that section.

At Nanaimo lodge we have added a few members to the roll, as the Recorders report will show; but the increase in

members has not been as large as we would like to have seen it, or what might have been expected with its efficient and attentive officers. One or two reasons may be ascribed for this. First: Benevolent and other societies—some of them having an insurance or endowment branch—are very numerous in Nanaimo. About thirty different lodges are advertised, and as all are doubtless seeking recruits we seem unable, so to speak, to take a sudden jump, or to make any rapidly great accession to our ranks. Nevertheless we may confidently, I think, look forward to a steady augmentation of membership.

Again, the question of unrestricted admission of miners is perhaps a cause of hindrance to our progress, a cause which in my humble opinion should be entirely removed. In this district, populated as it is mostly by miners, we could make only poor headway in our lodges without their support. As a class they are, as a general rule, alike worthy, steady, and healthy, and it will not I firmly believe in any way militate against the interest of our Order to have it freely understood that miners will be always acceptable among the brethren of the Ancient Order of United Workmen. It is given as a fact that the death rate among miners in this neighborhood, notwithstanding their supposed extra liability to accidents underground, is no greater than that of tradesmen and others. In any case I trust the Grand Lodge will decide to leave the selection of candidates to the various lodges and Medical Examiners, subject, of course to the requirements and provisions of the Constitution.

Hoping sincerely that the business to be transacted at the Grand Lodge will be of much advantage to the Order, and conducive to its growth and prosperity,

BRETHREN,—Your Finance Committee beg to report that they have examined the books and audited the accounts of the Grand Recorder and Grand Receiver up to 31st December, and find them correct.

The Recorder's books are made up to the end of the Fiscal Year. This has evidently been done for the purpose

of enabling him to make his report to the Supreme Lodge; consequently they include many of No. 10, 11 and 12 Assessments received during January and February. After making the aforesaid deductions, we find the balances from the books of the Grand Recorder and Grand Receiver to correspond, balance as follows :

Your committee would call attention to the increase in the duties of the Grand Recorder which call for almost his entire attention as well as for a special ability in the discharge of his official duties. 1. We recommend that the decisions of Grand Master Leiser in his annual report be approved by the Grand Lodge.

3. We recommend that the matter of Bro. R. Green's Beneficiary Certificate be governed by the present laws of our order and no certificate be issued in favor of John Graham.

5. We recommend document No. 1 amending sec. 2, art. 7, of the Grand Lodge Constitution as follows: "No person shall be admitted to membership in this order who is engaged in the sale or retail of intoxicating liquors as a beverage," be adopted.

9. We recommend document No. 5, amending sec. 1, art. 2, "That the maximum age be reduced from 50 to 45 years," be adopted, and all other sections touching this question be governed by this amendment.

10. We recommend document No. 6 amending sec. 1, art. 3, be not adopted.

11. We recommend document No. 7 sec. 4, art. 6, page 71, should be sec. 4, art. 12, be adopted.

12. We recommend document No. 8, amendment to sec. 1, art. 4, be not adopted.

13. We recommend document No. 9, not approved.

14. We recommend document No. 10, approved.

15. We recommend document No. 11, not approved.
