**An Act to change the limits of the Township of South Halifax.**

**W**HEREAS certain parties of the Townships of Ireland, South Halifax and Wolfestown, have already been erected into a parish for canonical and religious purposes, under the name of the Parish of St. Ferdinand d'Halifax, and whereas it is expedient that the said parish as erected by 5 civil proclamation should also be erected under the name of South Halifax for all civil purposes whatsoever; Therefore, Her Majesty, &c., enacts as follows :—

Preamble.

I. From and after the passing of this Act, all that part of the Township of Ireland, in the County of Megantic, and all that part of the 10 Township of Wolfestown, in the County of Wolfe, in the District of St. Francis, now forming part of the Parish of St. Ferdinand d'Halifax referred to in the preamble to this Act, shall be detached from the said Townships of Ireland and Wolfe, and form part of the Township of 15 South Halifax, in the County of Megantic, in the District of Arthabaska, for all School, Municipal, Judicial, Electoral, Registration, and other Civil purposes whatsoever, to all intents as though the parts of Townships above referred to had always formed part of the Township of South Halifax.

Parts of Ireland and Wolfestown included in St. Ferdinand to be also included in South Halifax.

II. This Act shall not have the effect of discharging the parts of the 20 Townships of Ireland and Wolfe, so annexed to the Township of Halifax, from any school or municipal debts contracted during the time they formed part of such townships respectively; and further this Act shall not affect any action or proceeding pending in any Court of Justice, but such action or proceeding shall be continued to judgment and execution and as to the proceedings after execution, as though this Act had 25 not been passed.

III. This Act shall be a public Act.
