Introduction

This market guide contains descriptive and statistical information as well as mode by mode analyses of transportation links between Canada and Mexico. It has been prepared to provide an overview of transportation services between the two countries and to highlight unique circumstances new exporters to Mexico should be aware of when making decisions to move merchandise south. Due to their fluid and negotiable nature, rates are not discussed.

This guide cannot be exhaustive; individual circumstances, interests and needs will dictate how companies make their particular transport decisions. In light of constantly evolving circumstances, users of this guide are cautioned to confirm information when deciding on transport options.

Overview

As in many markets, doing business in Mexico requires a degree of patience and perseverance. Some trading activities are affected by Mexico's developing economic infrastructure and some by its government regulations. The situation has improved, however, especially with regard to transport. Companies should not be dissuaded from exporting due to challenges in making logistics arrangements. Reforms and improvements to Mexico's customs procedures and transport legislation have introduced greater competition in the domestic transport industry and improved transit times and services. In today's climate of trade liberalization, conditions for exporting have never been better.

In the case of Mexico, transport industry spokespersons report that exporters are generally more concerned with freight rates than with transit times. The exception is air transport which maintains its niche as the primary mode for express shipments.

Road transport is the primary mode for the movement of goods to and from Mexico [see Appendix A]. Trucking has expanded significantly in recent years although rail remains a viable transport option. Over long distances, rail generally becomes rate competitive with road transport; hence, shipping decisions start being influenced by transit times and the overall service package.

Trucking:

- The road mode is well-developed and adaptable although certain Mexican transport regulations and customs delays continue to be bothersome.
- Refrigerated cargo moves almost entirely by truck.
- Regulations governing the Mexican transport industry have recently been liberalised, but trucking operations in Mexico must still be performed by a Mexican driver and truck. At present, there are no known interchange agreements between Canadian and Mexican trucking companies. This leads to time delays at the border as trailer to trailer cargo transfers are carried out. Certain American trucking lines do have interchange agreements with Mexican carriers or have established subsidiary companies in Mexico and this improves their border crossing times.

-
- There is currently no customs preclearing system in place for motor transport across the Mexico-U.S. border.

Rail:

- The new customs preclearing ("despacho previo") system through the San Antonio corridor to Laredo/Nuevo Laredo is greatly improving rail efficiency and border-crossing times. All along the border, American railway companies' cars and, in some cases locomotives, now cross into Mexico. As a result, rail shipments can clear the border as fast or faster than truck shipments.
- Rail services and traffic are increasing. More and more scheduled intermodal trains (transporting containers and trailers), double-stack trains, express trains and dedicated trains are coming into service. These trains all originate in the United States.

Marine:

- The marine mode is rarely used for shipments of general merchandise as there are no direct, scheduled services between Canada and Mexico. Bulk and specialized cargoes make up the vast majority of shipments. This lack of scheduled marine services arises because, in most instances, road and rail are more timely and price/service competitive.

Air:

- Air services between Canada and Mexico have improved with a greater number of direct scheduled flights in both directions. Montreal, Toronto and Vancouver enjoy direct commercial services with Mexico City. The majority of air traffic, however, still consists of charter operations and is likely to remain so, at least on the passenger side. Passenger charter operations are not normally conducive to cargo movements as space is restricted and flights are irregular.

Freight Forwarding:

- Freight forwarders can arrange shipments by any transport mode for Canadian exporters to Mexico. They offer a unique service package to first-time exporters as well as to established ones. In many instances,

and especially for new exporters, freight forwarders are indispensable as they can simplify the overall business of exporting to Mexico, taking care of details and problems otherwise left up to the exporter.

Further Comments:

- Mexican transportation regulations stipulate that the transport, brokerage, insurance and managing of freight in Mexico must be performed by a Mexican company.
- A 15% V.A.T. (value-added tax) on total freight charges within Mexico must be paid to Mexican authorities at the Mexico-U.S. border.
- In past cases, significant delays were experienced in obtaining Mexican import licenses. However, under recent trade liberalization legislation, the number of items requiring import permits has dropped from 11,950 to 325. In addition, the former Mexican official import price system has been eliminated. While delays can occur, they are becoming less frequent.
- Despite customs inspection delays by Drug Enforcement Agency and United States Department of Agriculture officials, transit times are better moving north from Mexico than south into that country (fewer regulatory, documentary or technical problems are encountered in the United States or Canada).
- Mexican transport regulations were dramatically liberalized in January 1990 leading to increased competition and improving transport services inside Mexico. The details of these changes are discussed in the different transport mode sections.

Buying Transportation Services to Mexico

Exporters can purchase transport services to Mexico in two ways. The trucking company, railway sales office, airline cargo office or marine shipping agent can be contacted directly, or a freight forwarder can be used to arrange the whole transportation package. In many instances, and especially for new exporters, the services of a freight forwarder are recommended. The freight forwarder can consolidate shipments as needed, advise on the mode of transport best serving the exporter's needs, and arrange for customs documentation, the services of a Mexican customs broker, and transport, warehousing and distribution within Mexico if required. While individual transport companies can in some cases make similar arrangements, they are geared more towards exporters with large, frequent shipments and will not always offer the full range of services provided by a freight forwarder.

The terms of sale determine the complexity of an export transaction. Exporters will be inclined to quote terms of sale that limit the seller's responsibilities to delivery at the Mexico-U.S. border (e.g. c.i.f. Laredo) as this simplifies transportation requirements. Depending on the terms of sale, customs clearing, import licensing, import duties, and transportation, warehousing and distribution within Mexico could be left up to the Mexican importer. Increasingly however, the exporter is asked to offer terms to a Mexican destination (e.g. c.i.f. Mexico City). In this case, the services of a freight forwarder are especially useful. Mexican transportation regulations stipulate that the transport, brokerage, insurance and managing of freight in Mexico must be performed by a Mexican company and the freight forwarder should have the necessary contacts in Mexico to arrange for these services. Freight forwarders should also be able to alert exporters to important transport details such as, for example, the 15% V.A.T. (value-added tax) on total freight charges within Mexico that must be paid at the Mexico-U.S. border.

As regards the actual process of transportation, trucking companies with affiliates in Mexico or interchange agreements with Mexican carriers can often provide better services as they experience less delays at the border during transshipment. Likewise, exporters should seek to tie their shipments into the double-stack, express or dedicated trains originating in the United States as these trains have generally better transit times and less customs delays. These factors are important because depending on the terms of sale, delays at the border can entail delays in the exporter receiving final payment.

Above all, the exporter should question his freight forwarder, trucking company or other transport company to ensure that the firm has *experience* in moving goods to and within Mexico. Experience and established contacts (or actual local offices) are key to the successful handling of shipments to Mexico. If a transport company possesses these qualities, this is the best guarantee available that they will be able to satisfy the exporter's needs.

The section entitled "Transportation Selection Check List" contains additional points exporters should ask themselves before and after making transportation decisions.

Trucking

Trucking is the primary transport mode used to move goods between Canada and Mexico. Approximately 40% of shipments moving from Canada to Mexico go by road [see Appendix A]. Within Mexico itself, 60% of all freight haulage goes by truck.

A comprehensive range of goods are shipped by road, with only bulk commodities being really outside the domain of truck transport. Nearly all refrigerated cargo bound for Mexico is carried on specially equipped trucks. Substantial cold storage facilities can be found in Brownsville and Laredo, Texas. Trucking is also the principal mode of transport for small, less-than-truck-load (LTL) shipments of general merchandise. Rail caters mainly to carload shipments and air targets high value goods.

In general, road transport from major Canadian cities to Laredo takes 3 to 7 days and once customs have been cleared, 1 to 2 days are needed to reach Mexico City. Laredo is the principal border crossing between Mexico and the United States, but trucks have several other points to choose from (see Map, page 47). In fact, the ongoing flurry of infrastructure developments (new bridges, expanded lanes, etc.) at numerous border crossings bodes well for increased motor traffic.

Numerous trucking companies will transport goods down to Laredo but most do not have an affiliated Mexican network and must arrange for a Mexican trucking company to take over the cargo at the border. This can involve lengthy time delays (from 2 to 6 days) as customs procedures and transshipment occur. Some companies have the means (and willingness) to simply transfer their trailer to a Mexican tractor which decreases the time spent at the border. Others lose even more time as their cargo is moved from one trailer to another. At present, there are no known interchange agreements between Canadian and Mexican trucking companies. Some American firms, including companies operating in Canada, already enjoy the benefits of interchange agreements with Mexican firms or have established subsidiary companies in Mexico. In any case, Mexican regulations state that a Mexican driver and truck/tractor must transport all goods within that country, so some form of transfer is inevitable.

Trucks carrying bonded shipments to the maquiladoras (i.e. Mexican export-assembly plants in free-trade zones along the U.S. border) are an exception. They are cleared through Mexican customs faster than normal shipments and within 24 hours (including transshipment) goods are usually on their way into Mexico.

There is currently no customs preclearing system in place for motor transport across the Mexico-U.S. border. Depending on customs and transshipment delays, total transit times from major Canadian cities to Mexico City can range between 6-15 days.

On January 24 1990, the Mexican government enacted new federal transport regulations which dramatically liberalized the domestic transport industry. The trucking sector was opened up to new competition, licensing procedures were simplified and route and freight restrictions were eliminated. Shippers are now free to book transport services with the carrier of their choice, exclusive agreements with carriers are no longer mandatory, freight rates are set by market forces and the maximum length of semitrailers has been extended from 40 to 48 feet in order to match U.S. standards and avoid unnecessary transshipment at the border. Lastly, the system of granting exclusive licenses for freight handling in the border zone was eliminated, although to date no American trucking lines have obtained operating licenses to service the maquiladoras directly. All told, these sweeping changes bode well for the improvement of trucking services in Mexico.

Several factors render it difficult to identify all of the many trucking companies operating in Canada which could handle Mexican-bound shipments. First, no detailed data is kept by any association or agency on trucking companies handling said shipments. Second, shipment destinations are difficult to determine because most Canadian trucking companies haul cargo down to transshipment points in the United States and interline with a U.S. carrier, rather than bringing it directly to the Mexico-U.S. border themselves. Lastly, numerous trucking companies are involved in providing direct or transshipment services. These companies include a diverse range of Canadian and American common carriers, contract carriers and private carriers.

Appendix B provides a list of certain organisations that exporters can contact to obtain information on trucking companies operating out of Canada handling Mexican-bound shipments.

Rail

There are ten border points in the United States from which rail shipments can cross into Mexico (see Map, page 47). The primary three crossings are in Texas: Laredo, El Paso and Eagle Pass. Laredo handles the largest amount of annual traffic (an estimated 50% of total rail traffic between Mexico and the United States/Canada). *Ferrocarriles Nacionales de Mexico (FNM)*, Mexico's principal railway company, has improved and expanded rail services at Nuevo Laredo, just opposite Laredo, Texas. Most Mexican importers prefer that shipments be routed through Laredo.

The majority of Mexican exports are priced f.o.b. Laredo. *Union Pacific Railroad*, which through its *Missouri Pacific* line handles the majority of rail traffic at Laredo, has also expanded its own Laredo yards. *Texas Mexican Railway* is the other carrier operating through Laredo. *Southern Pacific Railroad*, a major competitor, has pushed for the development of El Paso and Eagle Pass, backing this up with new lift facilities at both sites. For the moment, however, Laredo remains the primary point of entry into Mexico.

Rail transport to Mexico consists mainly of "piggybacking" (TOFC, trailer on flat car) although COFC (container on flat car) and double-stack (2 containers on flat car) shipping are becoming more popular. Both *Union Pacific* and *Southern Pacific* offer double-stack train services into Mexico. Virtually no mechanical refrigerated cars operate into or out of Mexico due to low rates of return on investment and servicing problems.

Transit times from major Canadian cities to Laredo can take anywhere from 7 to 12 days depending on the originating city and the routing. However, several days can be added to this transit time when lines are congested near the border or in Mexico. In general, TOFC and COFC train shipments are faster and are given higher priority than box cars shipments of bulk goods.

Upon reaching Laredo, customs procedures and the transfer of railcars to FNM for transport to destinations within Mexico used to take an average of 5 to 6 days. Since January 3 1990, however, a new mandatory system of preclearing ("despacho previo") has been implemented for all goods crossing into Mexico by rail at Laredo. Before entering the San Antonio-Laredo corridor, railcars are premanifested (with an important 10 day grace on their import permits) allowing for railcar crossings seven days a week (even when customs brokers are not working), less switching by FNM at Nuevo Laredo as many trains are delivered in precleared Mexican destination blocks, and a significant overall improvement in border-crossing times. *Union Pacific* has been instrumental in organizing this new system.

Provided the correct preclearing procedures have been followed, shipments can now move across the border in less than 24 hours.

In an effort to maintain and encourage this efficiency, *Union Pacific* gives customs brokers 72 hours to clear trains once they reach San Antonio, after which demurrage charges are levied. The entire "despacho previo" concept represents a significant change in Mexican customs procedures and a positive move by the Mexican government in the spirit of the current free trade talks. It should be noted, however, that certain high priority trains, like those moving automotive parts from Chicago-Laredo, have benefitted more from this system than others. Trains carrying products which are not given high priority by the rail carrier or the Mexican authorities, or which are not usually classified as "just in time" shipments (for example, milk powder, scrap paper or chemicals) may still experience delays despite the implementation of preclearing.

The new Mexican federal transport regulations mentioned in the previous section also impact favourably on the rail industry. Freight rates on intermodal containers are now set by market forces, without any price fixing arrangements.

Rail traffic congestion is being confronted both in the United States and Mexico. New facilities are being constructed on the American side, but the Mexican authorities and rail companies in general lack the necessary funds to significantly upgrade their services. The Mexican rail system requires more passing tracks, yard tracks and locomotives, is burdened by overly labour intensive loading/unloading procedures, and lacks a computerized tracking system. This infrastructure problem is a serious source of concern to all rail carriers. Recent encouraging events, however, have been FNM's upgrading of its Nuevo Laredo facilities and the purchase of a computerized tracking system from *Union Pacific* (to be phased in during the next few years).

Once through Laredo, an average transit time of 2 days is required to reach Mexico City.

Shippers should also note that a 15% V.A.T. (value-added tax) on total freight charges within Mexico must be paid to the Mexican authorities at the border.

The following summarizes the services offered by principal Canadian and American railways. Note that in nearly all instances, *Canadian Pacific (CP)* or *Canadian National (CN)* will handle the Canadian portion of a rail shipment before handing it over to an American rail carrier. For final shipment down to Laredo and on into Mexico, CN and CP move goods to major interchange centres in the United States. Currently, both Canadian carriers do not favour their rolling stock crossing into Mexico. The

American carriers do not have such constraints. The following total TOFC and COFC transit times to Laredo were provided by CN and CP in Toronto (CN, Tel.# (416) 860-2098; CP, Tel.# (416) 622-9931). Please note that these transit times are approximations and exact shipping and routing information must be obtained from the different rail carriers on a case by case basis:

<i>From</i>	<i>Total Transit Times to Laredo, Texas</i>
Vancouver, B.C.	via Chicago: 10-11 days
Calgary, Alta.	via Chicago: 9-10 days
Toronto, Ont.	via Detroit: 6-7 days
Montreal, Que.	via Detroit: 7-8 days

Comparable transit times can be achieved for traffic originating in British Columbia and Alberta via *Burlington Northern (BN)*, from Vancouver, B.C. or Sweetgrass, Montana. Shipments with BN would transfer to *Southern Pacific (SP)* at Eugene, Oregon for border destinations like Mexicali, Nogales or El Paso or at Chicago, Illinois for Eagle Pass or Laredo.

The *Union Pacific (UP)* office in Toronto (Tel.# (416) 757-0295) offers similar transit times from major Canadian cities to Laredo in conjunction with CN and CP. UP is the principal railroad handling Mexican-bound shipments through the United States. It runs shipments through Laredo, Brownsville and El Paso, Texas. Approximate UP transit times within the United States are Chicago-Laredo in 4 days and Detroit-Laredo in 5 days.

Southern Pacific (SP) operates lines as far north as Portland and as far east as Chicago (Chicago, Tel.# (312) 434-1576). SP is *Union Pacific's* main competitor for Mexican-bound traffic, operating six of the ten rail crossings into Mexico (El Centro, California, Nogales, Arizona, Douglas, Arizona, and El Paso, Eagle Pass and Brownsville, Texas). SP also routes through Laredo with *Texas Mexican Railways*. In two recent moves, SP has sought to heighten its share of the market by initiating a twice-weekly double-stack service from Los Angeles to El Paso and by signing an agreement to loan FNM locomotives running on specific SP/FNM transportation corridors in Mexico. FNM has long suffered from a lack of locomotive power and this move, along with FNM's purchase of 100 locomotives from General Electric and its continued leasing of *Union Pacific* locomotives is expected to improve services on the Mexican side.

The *Santa Fe (Atchison Topeka and Santa Fe) Railroad* is a third company that offers service from Chicago to Mexico (Chicago, Tel.# (312) 890-5530). It routes traffic through Kansas City and/or Dallas crossing into Mexico at San Diego, California, Presidio, Texas and El Paso, Texas.

Interamerican Transport (Toronto, Tel.# (416) 821-8700), an intermodal transport company, offers bookings on a scheduled express double-stack train service (40', 45' or 48' containers moving on *Union Pacific* trains) running from Toronto to Laredo in 9 days with preclearing at the Mexican border. Montreal shipments can connect into this service for a total transit time to Laredo of 10-11 days, while Vancouver shipments can only go by piggyback, taking 12-13 days regular service or 10 days express service.

Marine

On the marine side, there are no direct scheduled services for general merchandise between Canada and Mexico. In most instances, rail and road rates are competitive with marine rates although marine shipping is substantially slower. For some shipments however (e.g. bulk grains, oil, etc.), marine transport is highly suitable and for particularly large shipments of any kind, marine transport rates can be very competitive.

For general cargo entering Mexico by sea, exporters can expect a 4 to 5 day delay, in addition to transit times of 10-20 days, as goods are custom cleared and moved to an importer's warehouse. Most marine shipments are transferred to trucks at Mexican ports for shipment into the interior (see Map, page 47).

The following list details the general cargo carriers or shipping agents that will connect through to Mexican ports:

Inducement sailings from Montreal to Tampico for cargo of several thousand MT.

Hoegh Lines, Tel.# (212) 246-0562, Jersey City, NJ.

Container and break bulk vessel sailings every 3 weeks from New York to Tampico. Transit time of 14 days.

Mexican Line (TMM), Tel.# (201) 750-1881, New York City.

Sailings every 10 days from Los Angeles to Mexican Pacific ports (including Guaymas, Manzanillo and Salina Cruz). 8 days transit time down to Manzanillo. 2-3 day trucking into Mexico City from coastal ports can be arranged. Container cargo can be unloaded at San Fransisco, then go by rail or road to Los Angeles.

Arvida Shipping Ltd., Tel.# (514) 866-6521, Montreal.

Inducement sailings of 2000-5000 MT from Montreal to Coatzacoalcos, Progreso, Tampico or Vera Cruz. Roughly 21 days transit time. From Vancouver, *Arvida* offers inducement sailings with *Vancouver Anchor Shipping Lines* to Mexican Pacific ports.

Redburn Inc., Tel.# (514) 861-0511, Montreal.

Inducement sailings of at least 2000 MT from Montreal, Toronto, Halifax or Vancouver to any major Mexican port.

Navicana Lines, Tel.# (604) 689-3129, c/o Greer Shipping, Vancouver.

Inducement sailings between Vancouver and Mexican Pacific coast ports via Los Angeles on shipment contract of \$US 100,000 value and up. Does not normally extend up to Vancouver.

Air

Air transport is used for the movement of high-value items (e.g. electronics, aircraft parts, pharmaceuticals, precious stones and metals, flowers, etc.) between Canada and Mexico. At present, most direct air traffic between the two countries is charter vacation traffic which does not lend itself well to cargo transport (lack of capacity and irregular scheduling). Commercial airlines, however, have increased the frequency of direct scheduled flights between the two countries in the last six months. Montreal, Toronto and Vancouver enjoy direct commercial services with Mexico City.

Canadian Airlines International (CAIL) operates a direct flight three times per week between Toronto and Mexico City. *Iberia* flies direct twice weekly from Montreal to Mexico City. While *Iberia* has upgraded past operations by flying Boeing 747's, the amount of cargo space that will be available on *Iberia's* flights for Canadian shippers is uncertain as the flights originate in Madrid and may already be well loaded with freight when they arrive in Montreal. *Japan Airlines (JAL)* flies direct twice weekly from Vancouver to Mexico City and *Aerovias de Mexico* plans to initiate a similar service. Other commercial carriers, like *Air Canada*, *Delta* and *American Airlines*, operate out of Toronto or Vancouver to Mexico City via Dallas or Miami.

There are also several all-cargo airlines which fly to Mexico from various points in the United States. For example, *Airline Services International*, an airfreight wholesale operation based in Toronto, books freight onto *Amerijet Airlines* from Miami to Mexico City after moving goods down from Toronto or Montreal with *Air Canada*.

With all the uncertainties facing the international airline community, it is difficult to project the future of air routes to Mexico other than to say that charters will most likely continue to dominate the market, at least on the passenger side. One should also note that flight schedules to Mexico have historically been subject to frequent change by commercial carriers.

Administrative and customs clearing procedures at Mexican airports take approximately 3-4 days.

Freight Forwarders

Freight forwarders can arrange shipments by any transport mode for Canadian exporters to Mexico. They offer a unique service package to first-time exporters as well as to established ones. For example, exporters whose shipments do not fill a truck trailer, railcar or marine container will often use a freight forwarder to consolidate shipments bound for Mexico. This can also lead to cost savings. Freight forwarders can advise on the mode of transport best serving the exporter's needs, and arrange for customs documentation, the services of a Mexican customs broker, and transport, warehousing and distribution within Mexico if required. In many instances, and especially for new exporters, freight forwarders are indispensable as they can simplify the overall business of exporting to Mexico, taking care of details otherwise left up to the exporter.

With the recent reform of Mexican transport regulations, the system of granting exclusive licenses for freight handling in the border zone has been eliminated and freight forwarders (through Mexican affiliates) are increasingly active in Mexico. Increased competition has also led to better services. Finally, under recent trade liberalization legislation, the number of items requiring import permits has dropped from 11,950 to 325 and the former Mexican official import price system has been eliminated.

Appendix C, provided by Industry, Science and Technology Canada through its Business Opportunities Sourcing System (BOSS), lists active freight forwarders in Canada who have agents or offices in Mexico.

Warehouse Facilities

As unit transportation costs can often be lowered if shipment sizes are increased, the availability of reasonably priced, secure, duty-free warehousing in Mexico is important. At such facilities, merchandise shipped in quantity can be stored for short periods of time before distribution in Mexico. In addition, exporters can use warehouse stocks to shorten order response times. This is especially important when shipments are being caught up in congested border crossing. Appendix D lists several warehouse companies in Mexico which should be able to provide Canadian exporters with the facilities and services best suiting their business requirements. The Commercial Division of the Canadian

Embassy in Mexico can be contacted for more details on these companies. Further information on warehousing and entry of goods into Mexico can be found in the departmental publication *Shipping Documents and Customs Regulations for Selling to Mexico* mentioned in the foreword.

Mexican Transport Entities

As was discussed earlier, the transport, brokerage and managing of freight in Mexico must be performed by a Mexican company. In many instances, the trucking, rail or freight forwarding company the exporter is dealing with in Canada will know how and with whom to arrange shipment of goods in Mexico. For the exporter's information, however, Appendices E to H contain lists of Mexican trucking companies, freight forwarders, customs brokers and bonding companies. The Commercial Division of the Canadian Embassy in Mexico can be contacted for more details on these companies.

Insurance in Mexico

Exporters should be aware that if goods are being sold to a Mexican destination (e.g. c.i.f. Mexico City), Mexican regulations stipulate that insurance covering transit in Mexico must be purchased from a Mexican insurance company. Exporters may be inclined to quote terms of sale that limit the seller's responsibilities to delivery at the Mexico-U.S. border (e.g. c.i.f. Laredo). When, however, it is necessary to quote the aforementioned delivered terms, Appendix I provides a list of Mexican insurance companies. The Commercial Division of the Canadian Embassy in Mexico can be contacted for more details on these companies and the freight forwarder or carrier being used by the exporter should also be able to provide additional information.

Transportation Selection Check List

The following list of questions is designed to help exporters assess their transportation needs and make transportation decisions:

Questions for the Mexican customer:

- Is the customer willing to pay for freight and duty charges on top of the cost of the goods or does he want an all-inclusive delivered price quote?

-
- Does the customer prefer to arrange and pay for the transportation himself?
 - How urgently (within how many days) is the shipment required?
 - Will the customer slightly increase or decrease the order size to fit standard shipping sizes such as pallets or containers?
 - Does the customer have space available in his own private fleet of trucks returning from having delivered his own products in Canada?
 - Can the customer recommend a good transportation organisation with which he is already doing substantial business and receiving discounts?
 - Does the customer have his own rail siding or is he located near an airport?

Questions exporters should ask themselves:

- Have you checked with all your production departments and sales people to see if there are several shipments going to Mexico which can be consolidated into a larger load?
- Is there a nearby company that might be interested in pooling shipments with you to get a better rate?
- Do your sales forecasts allow you to offer carriers large and regular volumes over time in return for lower rates?
- Have you prepared an accurate description of your goods so that they may be properly classified by carriers?
- Is your product susceptible to damage and does it require special packaging or crating and insurance for a long distance haul?
- Can your product be knocked down and packaged as compactly as possible?
- Is your plant equipped with a rail siding or located near an airport?
- If you are unsure as to which mode of transportation to use, have you checked with colleagues in your industry or with transportation consultants in the federal and provincial governments?

-
- Can you prepare all the necessary export documentation yourself or would you prefer having an intermediary do it on your behalf for a small fee?
 - If you have your own fleet of trucks, can you spare one for a long haul and will you be able to arrange a return load?
 - Is your own fleet of trucks available to haul the goods short distances to carriers' local or American border terminals?
 - If you are thinking of using your own fleet, have you worked out a "per mile" truck operating cost to compare to rates charged by carriers and intermediaries?

Questions for or about carriers:

- Is the carrier well established and experienced (i.e. does it have a track record)? Can it provide references?
- Is there more than one company offering service on a particular route and, if not, are alternate routings and carriers available?
- Have you sought out carriers who would normally return to Mexico or the Southern U.S. empty and who are willing to offer attractive rates on backhauls?
- Does the carrier have legally licensed operating authority to haul goods on the route?
- Does the transportation company offer:
 - through rates and bills of lading?
 - proper equipment on demand?
 - computerized shipment tracing?
 - a guaranteed delivery schedule?
 - sufficient insurance coverage (liability)?
 - discount plans?
 - customs brokerage and export documentation services?
 - other unique services?
- Will the goods be shipped directly from origin by the carrier, and if not, how many (and which) carriers will be involved?
- If several carriers are to be involved, who has responsibility (liability) for the safe delivery of the goods?

-
- Has the company quoted you an all-inclusive rate and guaranteed delivery time? (Avoid companies that will not commit themselves to a rate or that will let you know how much the cost is after the fact.)
 - What extra costs (if any) will you have to incur beyond the cost quoted?
 - Are you satisfied that the transportation company rather than your company will be fully liable for the safe delivery of the goods?
 - Have you checked with more than one carrier before making a decision to ship?

Questions to ask after the initial movement:

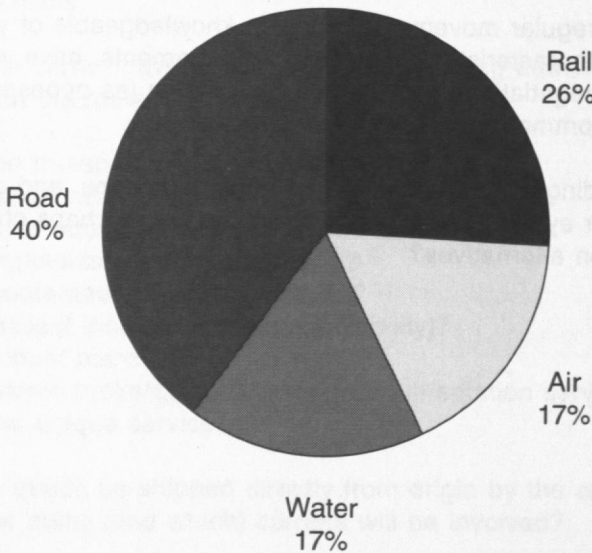
- Did the customer receive the shipment on time and in good order?
- If you used an intermediary for your first few shipments, are you now familiar enough with the territory, or are your sales volumes growing enough for you to deal with carriers directly?
- After a few shipments, are you still comparing rates between carriers or current rates to past rates to make sure you are getting a good deal?
- If you have regular movements, and are knowledgeable of your commodity characteristics and service requirements, have you considered negotiating specific commodity rates (as opposed to class rates) with common carriers?
- Are you reading trade and transportation publications, and generally keeping your eyes open for new, innovative and perhaps cheaper transportation alternatives?

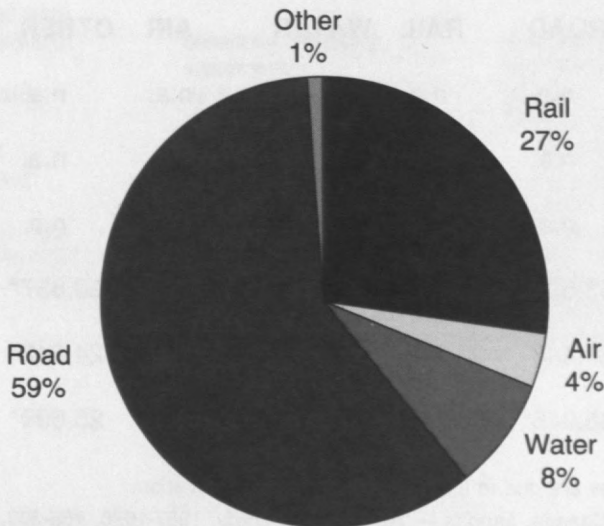
