DEAR SIR AND BROTHER :—Your letter of May 7th would have been sooner answered but for my absence from town.

You submit for my opinion the following question :—  
 "A revised Constitution for Subordinate Lodges submitted by a Special Committee was under consideration, when it was moved by P. G. M. Waller (*vide page 866 of Proceedings*) to amend Section 1, Article V, by adding the words 'Lodges may be permitted by a two-thirds vote of the members present to confer the degrees in less than four weeks after initiation;' this motion on being submitted to the vote was declared to be lost. Bro. Waller, P. G. M., then moved to amend the same section by striking out the words 'four weeks' and inserting 'two weeks' in lieu thereof. The Grand Master ruled this amendment out of order under the following Rule of Order of the Grand Lodge (*vide page 895 of the Proceedings*). 'No more than two amendments to a proposition shall be entertained at the same time, that is an amendment, and an amendment to an amendment, and the question shall be first taken on the latter.'

In reply I would say that the ruling of the Grand Master was erroneous. The question under consideration was not even an amendment to an amendment. One amendment to wit, that the section be amended by adding certain words had

been submitted to a vote and lost. Thereupon another and distinct amendment was offered to the Section and the Grand Master ruled this amendment out of order. In that I think he committed an error.

I have answered your question because the matter was submitted to me by the action of your Grand Lodge. As to the effect of my decision, if it can be called a decision, I say nothing.

MY DEAR SIR AND BROTHER :—I desire an official expression of your opinion as to the advisability of making the condition for obtaining and holding membership in the

Patriarchs Militant Degree more liberal, by changing the present requirement so as to include "Scarlet Degree" members of the Order. Such a change would undoubtedly superinduce a large increase in the membership of the Patriarchs Militant and work a great advantage to the Subordinate Lodge branch of the Order, without injuring the Encampments. The adjunct influence of the Militant Degree is often lost, because of the greater expense required to place a young man not a member of the Order, in a condition to obtain it, as compared with similiar requirements of other secret societies. Oblige me with a frank and concise opinion at your earliest convenience.

In reply I informed him that in my opinion although it might prove beneficial to Subordinate Lodges it would injure the Encampment Branch. I advised him instead, to enlarge the area of his recruiting grounds by admitting the flower of our youth at 18 years of age.

Received a communication from the Grand Master of Washington, enclosing a claim from the General Relief Committee, of Seattle, on Dominion Lodge, No. 4, Victoria, for \$90, nine week's Sick Benefits advanced to Bro. Cowan, a member of said Lodge. Requested and obtained an explanation from 'Dominion' Lodge, No 4, from which it appears that the Brother did not report himself to the Committee during his sickness, but furnished a medical certificate after his recovery, on the strength of which the Committee paid the benefits, without reference to the Lodge, and on these grounds the Lodge declines to pay. Furnished the Grand Master of Washington with a copy of the statement of Dominion Lodge, since which have received no further communication.

## APPEALS.

Bro. Bredemeyer of Vancouver Lodge, No. 8, appealed to me against the action of the above Lodge in refusing to accept his nomination for the office of Vice Grand, on the ground of his being elected as Permanent Secretary for one year.

Called on Lodge to furnish a statement of facts, copy of minutes and statement of Bro. Bredemeyer's services. Having received this information and satisfied myself that the brother was fully eligible and not disqualified by any reason, I sustained his appeal, declared the election of Vice Grand null and void and directed the Lodge to hold a fresh election for that office, and to include the name of Bro. Bredemeyer amongst the candidates with those in nomination at the previous election. This direction was complied with and the Lodge now appeals to this Grand Lodge against my action.

Bro. Edmunds appealed against the decision of D. D. G. M., District No. 7, in granting dispensation to Tatnai Lodge, No. 9, to elect a third degree member to the office of Noble Grand, all qualified members refusing to serve. I sustained the D. D. G. M., Bro. E. T. W. Pearse, power being conferred on him to do so by Art. 6, Sec. 3, Constitution Subordinate Lodges.

## INSTITUTIONS.

April 23d, 1891, commissioned as Special Deputy Grand Master, Bro. W. McColl, P. G. M., to institute Mizpah Rebekah Lodge, No. 2, Vancouver.

July 20th, 1891, commissioned as Special Deputy Grand Master, Bro. H. Waller, P. G. M., to institute Miriam Rebekah Lodge, No. 3, at Nanaimo.

Aug. 6th, 1891, accompanied by Bros. H. Waller, P. G. M., J. Pope, P. G., and Sisters Mrs. Waller and Mrs. Carne, I proceeded to Chilliwack and dedicated a new and hand-

somely furnished hall. The brethren of Excelsior Lodge, No. 7, deserve great credit for their enterprise.

The dedicating ceremonies being concluded, Bro. H. Waller assisted by Bro. Pope, Sister Carne and Sister Waller, in a very able manner conferred the Degree of Rebekah on 19 brothers and sisters

After recess instituted Ruth Rebekah Lodge, No. 4, and installed the Officers, and I predict for that Lodge a grand future. Our business over we were banqueted at the Grand Hotel, Bro. Webb, D. D. G. M., P. G. Henderson, and P. G. Peers, and all the members in Chilliwack treated us royally, and their kindness will long be remembered.

Nov. 9th, 1891, accompanied by Bros. Waller, P. G. M., Meldram, P. G. M., Sisters Walier, Carne, Dempster, Meldram, and Grand Instructor Sister Bishop, of Colfax Rebekah Lodge, No. 1, instituted Benlah Rebekah Lodge, No. 5, at New Westminster, which started with a large number of members. With the assistance of the above named Brothers and Sisters the Degree of Rebekah was ably conferred on several applicants.

Nov. 14th, 1891, instituted Acme Lodge, No. 14, at Victoria, assisted by Bros. J. E. Phillips, D. G. M., F. Davey, G. S., T. C. Gray, G. T., and other members of the Victoria Lodges. This Lodge has already a large membership. I think their prospects are good to become a strong and prosperous Lodge.

Dec. 10th, 1891, instituted Cloverdale Lodge, No. 15, Cloverdale, in company with H. Waller, P. G. M., from Victoria, and about 30 brothers from New Westminster, among whom were P. G. Welsh, D. D. G. M., District No. 2; W. McColl, P. G. M., B. W. Shiles, P. G. M., and J. E. Phillips, D. G. M., to whom I feel grateful for assistance. There were five Charter Members, initiated and conferred the 3 Degrees on 16, making a total membership of 21. I in-

formed the brothers that their hall was not a proper place to hold their meetings, and was informed that they intend to hold their meetings in the school house.

Jan. 5th, 1892, commissioned as Special Deputy, Bro. Hawley, of Selkirk Lodge, No. 12, to institute Kootenay Lodge, No. 16. This Lodge was instituted on the 22nd January, 1892.

Jan. 23rd, instituted Duncan Lodge, No. 17, assisted by that untiring and hard worker, Bro. H. Waller, P. G. M., (to whom I am specially indebted for valuable assistance given me during my term of office,) and about 16 other members of the Victoria Lodges, also several Brothers from Nanaimo. Nine Charter Members and 3 initiated. After instituting and installing the officers we retired to the present N. Grand's, Bro. Dickie's, where we sat down to a banquet, and a most sociable evening was spent.

There has been considerable correspondence in regard to the formation of other Lodges in this Province.

I recommend that this Grand Lodge grant Charters to the above named Lodges.

July 28th, 1891, to New Westminster Lodge, No. 3, and Royal City Lodge, No. 13, to hold an Excursion and appear in public in Regalia, on the 4th August, 1891.

Aug. 20th, 1891, to Victoria Lodge, No. 1 ; Columbia Lodge, No. 2 ; and Dominion Lodge, No. 4 ; to hold an Excursion in the name of the Order, and wear Regalia in public, on 22nd August, 1891, on which occasion I accompanied the brethren to Seattle. On our arrival we were waited on by members of the Lodges in that city, who hospitably entertained us. I think that those Excursions are most beneficial to the Order.

July 29th, 1891, to Vancouver Lodge, No. 8, and Western Star Lodge, No. 10 to hold an excursion and appear in Regalia, 4th August, 1891.

September 28th, 1891, to Union Lodge, No. 11, to hold Anniversary ball and supper on 16th October, and to wear Regalia.

October 29th, 1891, to Selkirk Lodge, No. 12, to hold ball on 27th November, and wear Regalia.

November 30th, 1891, to Tatnai Lodge, No. 9, to hold ball and wear Regalia, on December 4th

January 15th, 1892, to Acme Lodge, No. 14, to confer 3rd Degree on Bro. J. McLennan, in less time than allowed by law. I did this in the absence of the D. D. G. M.

January 7th, 1892, to Dominion Lodge, No. 4, to ballot for and if elected, initiate and confer the 3 Degrees on 12 persons, applicants for charter, at Duncans.

### SPECIAL PERMISSIONS.

Dec. 10th, 1891, received a communication from Ridgley Lodge, No. 12, Butte, Montana, asking permission to solicit aid in this jurisdiction to liquidate a debt on their property. The merits of the case did not justify me in granting such permission. Notwithstanding this refusal, the said lodge did apply to lodges in this jurisdiction for aid. I thereupon reported their action to the Grand Master of Montana.

Refused Columbus Lodge, No. 24, Algiers, Louisiana, permission to apply to subordinate lodges in this jurisdiction for help to build a hall.

Refused May Lodge, No. 10, Stark, Florida, permission to appeal to lodges in this jurisdiction for aid to rebuild their hall, that had been destroyed by fire.

Granted permission to Lynden Lodge, Wash., No. 71, to initiate C. Packard and A. Broe, residents of British Columbia, but residing within  $4\frac{1}{2}$  miles of Lynden, but 35 miles from nearest lodge of this jurisdiction.

Refused Lynden Lodge, No. 71, Lynden, Washington, permission to initiate two persons, residents of British Columbia, since Cloverdale Lodge, No. 15, was instituted; however, I have asked for further information, and if those persons reside much nearer Lynden, and after getting consent from Cloverdale Lodge, I would recommend that permission be granted by my successor.

### QUESTIONS.

1. It is competent for a Lodge to review and set aside

a ballot before the result is announced on the fact being brought to its notice that members had voted who were not legally qualified to do so.

2. A lodge cannot elect a member to any office who has not received the third degree.

3. The Noble Grand is the only person authorised to communicate the A. T. P. W., or in his absence the Vice Grand. A Past Grand has no right to receive it from a visiting brother or to communicate it to a member.

4. The Grand Master has no power to grant a dispensation to hold the installation of officers on the last regular meeting night of a term.

5. It is not necessary to ask any P. G. of a lodge to accept the office of N. G. before electing a Scarlet Degree member to that office, all qualified brothers having declined to serve.

6. The Grand Master is not empowered to grant dispensations to install officers at special meetings of lodges.

A number of questions have been submitted which are fully covered by the digest or the local law.

I declined to answer questions submitted by individual members.

On receiving news of the fire at New Westminster, which destroyed their beautiful hall, involving a great loss to the brethren of that city, I immediately telegraphed the lodges, extending to them the sympathy of this Grand Lodge in their misfortune. I am pleased to learn that in all probability a much finer building will shortly be erected to replace the one destroyed.

I cannot close this report without calling the attention of this Grand Lodge to the inadequate remuneration paid to our Grand Secretary. We are continually increasing in lodges and members; this involves a greater amount of work for this officer, and I think the time has arrived when this Grand Lodge can afford to pay him sufficiently for his ser-

October 22nd, 1891, received an application from Selkirk Lodge, No 12, for dispensation to hold their second annual ball on November 27th; and to wear regalia at the same.

January 7th, 1892, granted a dispensation to confer three degrees in one night on Bro. H. Corrigan.

January 7th, 1892, installed the officers of Selkirk Lodge, No. 12.

GRAND SECRETARY'S OFFICE,

VICTORIA, B. C., 8th February, 1892.

To the Grand Lodge of British Columbia, I.O.O.F.,

DEAR SIRs AND BROTHERS.—It affords me much pleasure to present you with a report of this office for the year 1891, and to be able to point to the satisfactory progress the Order has made in this jurisdiction during that period.

Since we last met four Subordinate Lodges have been instituted, Acme Lodge, No. 14, Victoria; Cloverdale Lodge, No. 15, Cloverdale; Kootenay Lodge, No. 16, Nelson; and Duncan Lodge, No. 17, Duncan. The two latter have been instituted since 31st December last, so that their membership is not included in this report.

I have also received, through Bro. E. T. W. Pearse, D.

D. G. M. District No. 7, the Charter Fee and an application for a Charter for a lodge to be located at Vernon, but as it was not accompanied by the cards of the members, I have written to the applicants pointing out the requirements of the law and expect shortly to receive the requisite cards.

Four Rebekah Lodges have also been instituted during the year : Mizpah Lodge, No. 2, Vancouver ; Miriam Lodge, No. 3, Nanaimo ; Ruth Lodge, No. 4, Chilliwack ; and Beulah Lodge, No. 5, New Westminster. I regret I am unable to furnish you with information as to the aggregate membership, &c., of these lodges, owing to the failure of Ruth Lodge, No. 4 and Beulah Lodge, No. 5, to forward their reports.

I am sorry to again have to complain of the unnecessary delay of some of the Subordinate Lodges in forwarding me their reports at the proper time, causing me considerable inconvenience in compiling my report. Excelsior Lodge, No. 7, sent me its annual Relief Report in an incomplete state so that I had to return it for correction, but although sufficient time has elapsed, it has not yet been returned. I am therefore prevented from presenting you with an accurate report on the matter of Relief, &c., paid.

By the institution of the two lodges since 1st January last, and from letters I have received, I feel confident our membership at this date cannot be less than 1,500.

The increase of 228 in the membership in the past year, has been contributed to by all the lodges in the jurisdiction with but one exception.

The instruction of last session to the Grand Master and Grand Secretary to submit a question to the Grand Sire as to the ruling of Grand Master Quennell, was complied with, the answer of the Grand Sire will be communicated by the Grand Master.

A memorial was prepared and forwarded to the Sove-

reign Grand Lodge, urging the admission of members at 18 years of age, but the desired legislation was not effected.

The direction to procure a new set of regalia for the Grand Lodge Officers, has not been carried out for the reason that no price was named, nor any appropriation made, and as there is so great a disparity in the prices of regalia, your officers would ask that you would stipulate the amount to be expended for this service.

The recommendation of the Special Committee on Constitutions, etc., at page 847, Proceedings of last session, have been complied with, and 1000 copies of the Subordinate Lodge Constitution, printed in book form, of a size suitable to be bound with the by-laws of Subordinate Lodges, and are now offered for sale at three cents per copy.

The Constitution of this Grand Lodge, adopted last session, has been approved by the Sovereign Grand Lodge.

At the session of 1884 it was decided to furnish each D. D. G. M. with a copy of White's Digest for his official use, and this direction was carried out. At that time there were only three districts, but now there are nine, with an immediate prospect of being further increased to thirteen. The books supplied are now obsolete, to a considerable extent, and I have had repeated applications for the new edition, besides which there are several Deputies who have never been furnished with one. In view of the expense involved, I submit the matter for instructions.

On the 19th July last, Selkirk Lodge, No. 12, forwarded all the documents required in appeals, covering the case of Brother Brown, who had been expelled from membership in that lodge. As no appeal had reached this office, and the time within which the appeal should be lodged, had expired, I returned the documents to the lodge.

The finances of the Grand Lodge are in a very satisfac-

tory condition. The receipts of the past year exceeded the estimate by \$299 50, and the balance in the hands of the Grand Treasurer is \$246 20 more than was anticipated.

### AUXILIARY ENDOWMENT BENEFIT ASSOCIATION.

There has been a slight increase in the membership of this association during the year, but it does not keep pace as it should with the membership in our lodges.

Three beneficial members have died, Brother W. H. Edwards and Brother S. T. Mackintosh, P. G. of New Westminster Lodge, No. 3, and Brother W. Edmunds, P. G. of Tatnai Lodge, No. 9. The sum of \$206 75 was paid on the death of Brother Edwards from the reserve fund, and \$208 40 on death of Brother Mackintosh, being the amount realized from Assessment No. 9. Two assessments have been levied payable on the 15th instant, to meet the claim on Bro. Edmunds' death and to have the necessary amount in hand to meet the next call.

Since its organization in 1884, this association has paid 12 death claims, (nine from the Endowment Fund, \$1,734 70, and three from the Reserve Fund, \$638 70), a total of \$2,373-40. It has cost the average age member of 40 years, from its commencement, \$13 50 for assessments, and \$12 for dues, a total of \$25 50 in eight years, or an average of \$3 19 per year, so that it cannot be charged that it is an expensive institution. The amount it has paid to the beneficiary of the deceased member has in almost every case proved a great assistance at a time when every dollar is needed. If from no other motive than benevolence, it claims the support of our membership. I commend it to your most favorable consideration, not only at this meeting, but in your respective Lodges.

The following abstract of the Subordinate Lodge Reports shows the position of the Order at the end of 1891, and the progress we have made during the year.

Brother H. Waller, P. G. M., presented and read the following report from the Grand Representatives, which was, on motion, ordered to be received and printed with the Proceedings of this session :

## REPORT OF GRAND REPRESENTATIVES.

*To the Grand Master and Representatives of the Grand Lodge of British Columbia, I. O. O. F.—*

Your Representatives to the Sovereign Grand Lodge beg leave to submit their report, as follows :

The sixty-seventh annual session was held at St. Louis, Mo., on September 21st, 1891, and continued through the week until the 26th. There were present 169 Representatives.

The Grand Sire being absent through illness, the Dep-

nty Grand Sire, Cl. T. Campbell, Past Grand Master of Ontario, presided and filled the office with ability and dignity.

After roll call, and the Grand Marshal had declared all the Representatives duly qualified, the Acting Grand Sire read the following dispatch from the Grand Sire, to which the following replies were sent :

SOVEREIGN GRAND LODGE OF THE I. O. O. F.  
OFFICE OF THE GRAND SIRE.  
RALEIGH, N. C., September 17th, 1891.

DR. CL. T. CAMPBELL,

*Deputy Grand Sire, I. O. O. F., St. Louis, Mo.*

DEAR SIR AND BROTHER :—Will you please convey to the members of the Sovereign Grand Lodge the assurance of my deep regret at my inability to be present at this session. It is to me a grievous disappointment.

I presume that you have incorporated in your report my official actions up to the time I was taken ill. I regret that, owing to my illness, I have been unable to prepare any report for myself.

Rep. Orendorff, of Illinois, moved the following, which was unanimously adopted by a rising vote :

*Resolved*, That the Sovereign Grand Lodge has learned with feelings of deep regret, of Grand Sire Busbee's affliction by the hand of disease, which prevents his attendance at this session, and desires, at this its first opportunity, to express its heartfelt sorrow and loving sympathy, together with the earnest hope and prayer that he may be soon restored to health, and the performance of the duties of the high office which he has adorned by eminent services.

Bro. Underwood, Past Grand Sire, moved the following which was unanimously adopted :

*Resolved*, That the Grand Secretary be directed to immediately transmit to Grand Sire Busbee a copy of the resolution just adopted.

Please express to the Sovereign Grand Lodge my heart-felt appreciation of its kind and sympathetic resolution.

C. M. BUSBEE, Grand Sire.

Your Representatives would state here, that from a communication recently received from the Grand Secretary, Theo. A. Ross, that we are pleased to be able to inform you that our Grand Sire is improving very rapidly, and no doubt will be present at the next communication of the Sovereign Grand Lodge.

The following are a few extracts from the Acting Grand Sire's and Secretary's Reports.

Acting Grand Sire on State of the Order :

I am pleased to be able to announce that the returns which will be submitted to you show a most prosperous year. During 1890, no less than 68,295 men were initiated into Odd Fellowship under your jurisdiction—the greatest number in any year in our history. And the net increase for the same period was equally unprecedented, reaching 37,442. On December 31st, 1890, our male membership in the United States and Canada, and related jurisdictions, was 649,702. The returns from Australasia give 19,746, while the German Empire has 2,891, making the total number no less than 672,339.

If our increase during this year has been at the same rate, and we have no reason to doubt it, we may safely assume that our membership on the 1st of September, 1891, was not less than 700,000. If to this number be added the 69,661 Daughters of Rebekah, reported December, 1890, with the probable additions they have received this year, a moderate estimate will give, at the present date, a grand total of not less than 775,000.

Not only numerically, but financially, the record is gratifying. With an aggregate revenue from Lodges and Encampments of \$7,244,227, we have expended for the purposes of relief through the ordinary channels of the Order, \$2,917,688. When we add to this the relief expenditure of Australasia and Germany, together with the payments made to widows and orphans by the large number of Relief and Endowment Associations, operated in connection with our

society, we can place the pecuniary benevolence of Odd Fellowship during the year 1890, at the magnificent sum of \$4,000,000.

The following are some of the most important of the Grand Sire's and Acting Grand Sire's decisions, which were approved by the Sovereign Grand Lodge :

BY THE GRAND SIRE—

3. A Subordinate Lodge cannot legally call a special meeting for the purpose of receiving propositions for membership, and appointing Committee of Character thereon.

5. In raising and seating a Lodge on the occasion of a public installation, it is not permissible to use the gavel as it is used in a regular Lodge meeting.

7. Under Section 672, Digest (election of members before withdrawal), it is necessary that the Lodge to which a brother applies for membership should notify the Lodge issuing the Visiting Card of his election; and thereupon the brother must apply for the necessary Withdrawal Card or Dismissal Certificate; but the Secretary of the Lodge may apply for such card or certificate, at the instance and by the authority of the brother.

9. A "masque ball," held under the auspices of a lodge is not necessarily an affair which may scandalize the Order. It would depend on the character and surroundings of the hall.

19. A Patriarch ceasing to be a member of a Subordinate Lodge, may retain membership in his Encampment for one year, at the end of which period it terminates. Subsequently regaining membership in a Lodge, he can only regain membership in his Encampment by applying for reinstatement therein, and being admitted with all the formalities connected with a reinstatement.

BY THE GRAND SIRE (ACTING).

3. A Grand Master or Grand Lodge has no right to confer Past Official Degrees on a brother from another jurisdiction, at the request of the Lodge of which said brother is a member; it should only be done at the request of the Grand Lodge having jurisdiction over the Subordinate in which the Brother has earned the degrees.

6. Decision 99, (Journal 1890, p. 11,908), to the effect that "with the exception of the Officers and Grand Representatives constituting the Sovereign Grand Lodge, no one can obtain the Degree of Rebekah through means other than by application to and initiation in, a regularly constituted Degree Lodge of the Daughters of Rebekah, (Secs. 1183-4, Digest, repealed, Journal, 1891, pp. 177-223), does not alter or conflict with the law in Section 1184, Digest, which allows the degree to be conferred on an applicant without his becoming a member of the Lodge conferring the degree.

We submit for your perusal two of the most important appeal cases.

The first is a question which often arises in the Lodges. The second has never happened in this jurisdiction and we hope it never will :

#### FIRST APPEAL—

Your Committee on Appeals, to whom was referred the appeal of G. Rep. Gwinn against the Grand Lodge of Idaho, beg leave to report thereon as follows :

At the eighth annual session of the Grand Lodge of Idaho, the following question was received and referred to the Judiciary Committee :

"The Noble Grand of a Lodge having served eleven

nights of a term and is called away on account of the serious illness of his father, being excused by the Lodge from serving the remainder of his term, can he receive the past official degrees?"

The Judiciary Committee reported that "no authority is found for such action." They cite Section 289 of the Digest, and construe the word "sickness," occurring therein, to mean personal sickness, and not that of a parent or friend.

On the presentation of this report in the Grand Lodge of Idaho, it was resolved that the report be amended so as to read "that the Brother is entitled to the honors of the office." From that action of the Grand Lodge, this appeal is taken.

It is laid down in Section 289 of the Digest, that "leave of absence for a majority of the nights of his term, works a forfeiture of the honors of the term to the officer to whom leave is granted;" and "unless an officer is present in the Lodge room, a majority of the meeting nights of his term (unless excused, from sickness), he is not entitled to the honors of his office."

It seems clear to your committee, that what is meant in that section is that the sickness, by reason of which he is excused, must be that of the officer himself or some providential interposition affecting himself personally, and preventing his attendance, over which he had no control; and that although the Lodge might excuse him on account of the illness of his father, such excuse would not be sufficient to entitle the officer to the honors of the office where he did not serve a majority of the nights of his term.—Approved.

#### SECOND APPEAL.

Your Committee on Appeals have carefully considered the appeal of L. N. Billings, P. G., from the action of the Grand Lodge of California, and beg to submit the following report: Charges were preferred against Past Grand Billings, in Eureka Lodge, No. 4, I. O. O. F., of California, of conduct unbecoming an Odd Fellow, specifying that said Billings on the 1st day of March, 1889, in the county of Sacramento and State of California, did then and there unlawfully, wilfully, and with malice aforethought, kill and murder one Francis D. Lightall. The Brother was tried upon said charge and

expelled. He appealed to the Grand Lodge of his State, and the action of Eureka Lodge, No. 4, was there sustained. From the action of the Grand Lodge of California, he now appeals to this Grand Body. The record is very lengthy, embracing all the testimony in the trial below. In his appeal to the State Grand Lodge, the Brother assigned a great many errors and we have carefully considered them.

The acquittal of a Brother, on such a charge, in a civil court, is not of itself a sufficient defence in a trial by the Lodge.

If there was any ground for his objection to the appointment of certain Brothers on the Trial Committee, on account of their bias or prejudice against him, the Grand Lodge of California certainly cured said wrong by a full investigation of all the facts upon the record, which embraced all the testimony taken in the trial below.

The specification certainly embraced an offence against the laws of the Order.

The Subordinate Lodge certainly had the right to be represented before the Trial Committee by a Brother appointed for that purpose. In the vast amount of testimony submitted, there appears to be considerable conflict, but both the Subordinate Lodge and the State Grand Lodge having passed upon the facts, and there being sufficient and ample testimony upon which to found a conviction, your committee does not feel warranted in disturbing their finding. They therefore submit the following resolution and ask its adoption :

*Resolved*, That the appeal of L. N. Billings, from the action of the Grand Lodge of California be dismissed, and the action of the Grand Lodge of California be sustained.—  
Approved.

#### NEW LEGISLATION.

*Resolved*, That it be, and is hereby made obligatory, upon each Subordinate Lodge of the Order, to pay from its funds, during the continuance of the disability, a weekly benefit of not less than two dollars to every member who shall be disabled, by sickness or bodily injury, from following his usual occupation, or otherwise earning a livelihood for

himself, provided such disability be not the result of his own vice or immorality; *provided*, however, that Subordinate Grand Lodges may provide that where a member shall receive one full year's benefits, the weekly benefit thereafter to such member may be fixed at not less than one dollar per week.—Approved.

WHEREAS, The Rebekah Degree Lodges are now composed of Brothers as well as Sisters, and as we deem the word "Daughters" to be superfluous and unnecessary, we, therefore, recommend the adoption of the following resolution :

*Resolved*, That hereafter the legal title of Rebekah Degree Lodges shall be "—— Rebekah Lodge, No.——, I. O. O. F."—Approved.

*Resolved*, That any Sister member of the Degree of Rebekah, who has been a member in good standing of a Rebekah Degree Lodge for fifteen consecutive years, shall be entitled to wear a jewel, to be designated, "The Veteran Jewel, I. O. O. F., of the Daughters of Rebekah."—Approved.

The Grand Lodge of the Kingdom of Denmark was made an Independent Sovereignty in Odd Fellowship, reserving certain rights as to ritual, etc.—on the same terms as Australasia.

The Grand Lodge of the Republic of Switzerland was made independent on the same terms.

The Constitution, By-Laws, Rules of Order, of British Columbia, were approved.

We are sorry to inform you that the Constitutional Amendment, the "eighteen-year-old" question, was again defeated. The vote on it was about the same as last session, but there are no less than five notices submitted for next session. Be not discouraged; no great Constitutional change is carried without a very hard struggle. We must and will win, eventually.

Your Representatives were placed on the following com-

mittees, viz.: Brother Shiles on the Committee of Bodies not Represented, and Brother Waller on the Committee of Foreign Relations.

#### NEW REPRESENTATIVES.

One hundred and seventy Representatives are accredited to the present session. The Grand Encampment of British Columbia, and Grand Lodges of Denmark and Switzerland, have not furnished certificates. The addition of five Representatives since last session has increased the membership of the Body (Representatives, Officers and Past Grand Sires), to 193.

The next communication of the Sovereign Grand Lodge will be held at Portland, Oregon.

The question whether the obligations should be memorized or read from the Ritual, is left entirely to the Subordinate Lodges.

A committee of five was appointed to consider the expediency of the removal of the head-quarters of the Sovereign Grand Lodge to Baltimore, the committee to report next session.

#### CONCLUSION.

We respectfully submit the foregoing report of the important matters of legislation that affect both Subordinate, Grand Lodge, and Grand Encampment in this jurisdiction, that was enacted at the last session of the Sovereign Grand Lodge.

Report read from Committee on Laws of Subordinates which was on motion received and adopted.

To the Grand Lodge of British Columbia, I.O.O.F.

Your Committee on Laws of Subordinates have examined the following By-Laws of Subordinate Lodges in the jurisdiction during the past year, and beg to report thereon as follows :

WESTERN STAR LODGE, No. 10.—Amendment to Art. XX, Sec. 1. Providing for the payment of \$1 per week to members of the Initiatory Degree. Approved.

Additional Article XXV. Setting aside 5 per cent. of the receipts of the Lodge to form a Contingent Fund. Not approved. This Grand Lodge not having enacted the permissive Legislation for the purpose ; 5 per cent. of the Dues only being allowed by the Sovereign Grand Lodge to be devoted to this purpose.

HARMONY LODGE, No. 7.—Approved Amendment to Sec. I. Art. XX, of By-Laws, reducing Sick Benefits for 1st week to \$2.50.

VICTORIA LODGE, No. 1.—Approved Amendment to Sec. I. Art. XIX, regulating the hours at which a sick member shall be out of his house during sickness, except by consent of his Medical Attendant.

SELKIRK LODGE, No. 12.—Approved Amendments to Art. XVII, forming a Contingent Fund to be used for any legitimate purpose the Lodge may direct, to consist of monies in hands of Entertainment Committee, and surpluses from future entertainments, also proposition fees of candidates who fail to present themselves for initiation within twelve weeks from date of election.

COLFAX REBEKAH LODGE, No. 1.—Approved a complete code of By-Laws for the Lodge.

VANCOUVER LODGE, No. 8.—Approved a revised code of

By-Laws of this Lodge with the following exceptions :—Clause 39. Providing for the Assessment of \$1.00 per member to form a Contingent Fund. Clause 43. Payment of \$1.00 per week to members for first weeks Sick Benefits. Legislation of Sovereign Grand Lodge, 1891, making it obligatory on all Lodges to pay not less than \$2.00 per week, *vide* P. P. 12,620, 12,621, 12,670, 12,707, Proceedings Sovereign Grand Lodge, 1891.

HARMONY LODGE, No. 6.—Approved a revised set of By-Laws of this Lodge : We observe that provision is made to pay only \$2.50 per week to members of the Third Degree for 1st week's sickness, whereas the payment to members of the lower degrees is \$5.00, we think this has probably been overlooked by the Lodge, and only needs to be pointed out to be rectified.

MIZPAH REBEKAH LODGE, No. 2.—Approved a code of By-Laws for this Lodge with the following exceptions :

Art. 3, Sec. 2, makes provision for the election of "Representatives to the Grand Lodge," as Rebekah Lodges have no such privilege, these words should be struck out.

Art. 3, Sec. 3, provides that officers elected to fill vacancies must serve a majority of nights in the term, in order to be entitled to the honors of the office. This is contrary to White's Digest, Art. 985.

RUTH REBEKAH LODGE, No. 4.—Approved new code of By-Laws for this Lodge.

EXCELSIOR LODGE, No. 7.—Amendment to Art. IX., defining duties of Outside Guardian. Approved.

ACME LODGE, No. 14.—Approved new code of By-Laws for this Lodge with the following exceptions : Art. 4, Sec. 2, Provides for the payment of Sick Benefits only to Scarlet Degree members. This Grand Lodge decided last Session that subordinates must pay Benefits of some amount to all their members irrespective of their rank.

Article IV, Sec. 6.—Provides that no greater sum than \$2000 shall be paid to any member on account of his membership, except by a two-third vote of the members present at any regular meeting. This provision is contrary to Secs. 6, 10 and 28 of the Digest which provide that weekly continuous Sick Benefits must be paid, but that reduced benefits may be paid at the expiration of a certain time, or after receiving a certain amount.

Article 7, Sec. 7.—Provides that, "any Brother being twelve calendar months in arrears shall forthwith on due report to the Lodge, be declared by the N. G. to be suspended from membership." This is contrary to Sec. 1, Clause 1, Art. VII, Constitution Subordinate Lodges, which stipulates that the fact of a Brother being in arrears twelve months must be announced in open Lodge at two regular meetings before suspension after having been notified when he owes eleven months dues; further, that a member residing more than 50 miles from his Lodge shall receive two months' additional time to pay his indebtedness.

Article 7, Sec. 9.—We recommend that the motion of the Lodge to reinstate an expelled member must be subsequent to obtaining the consent of the Grand Master to this course.

Article II, Sec. 1.—Strike out the word "majority" and insert "two-thirds" vote in order to conform to Art. VI, Sec. 7, of the Subordinate Lodge Constitution respecting removal of officers for absence at three successive meetings.

Article XI, Sec. 3.—Strike out the words "in case of one candidate being nominated for the office" so as to agree with Sec. 8 of Art. VI, Subordinate Lodge Constitution, which provides that in all cases election to fill a vacancy in an elective office must lay over for one week after nomination.

Article XIII, Sec. I.—Strike out the words "nor shall they be suspended except for special purposes and then only

by a four-fifths vote," being in conflict with Sec. 155, White's Digest.—"A By-Law cannot be suspended on motion."

DEAR SIRs AND BROTHERS :—Your Committee on Appeals have had under consideration, the appeal of Vancouver Lodge, No. 8, Vancouver, against the decision of the Grand Master, in declaring the election of V. G. by said Lodge, on 29th May last, null and void, and directing a fresh election to be held, on the grounds that the Lodge refused to accept the nomination of Bro. W. Bredemeyer for this office, he being duly qualified for the same, and beg to report as follows :

From the documents submitted, the facts of the case

appear to be, that at the first night of nomination for officers, on the 15th May last, the name of Bro. W. Bredemeyer was offered in nomination for the office of V. G., he being at the time Permanent Secretary, and installed into this office for twelve months ending 31st December last. This nomination was ruled by the acting N. G. out of order, on the ground that the Brother had been installed as Permanent Secretary for twelve months. At the next meeting Bro. Bredemeyer appealed against the decision of the Chair in thus ruling his nomination out of order, but the Chair was sustained by the Lodge; the Brother then gave notice of appeal to the Grand Lodge, but this was also ruled out as illegal; he then resigned the office of Permanent Secretary, which the Lodge accepted from the 30th June ensuing. Bro. Bredemeyer then appeals to the Grand Lodge, and the Grand Master acting on the powers conferred on him by Art. IV, Sec. 1, of the Grand Lodge Constitution, to "receive and act on all complaints which may be made to him against his deputies or Lodges," over-rules the action of the Lodge, declares the election for V. G. null and void, and directs the Lodge to proceed to the election of a V. G., and to include the name of Bro. Bredemeyer as a candidate for that office. This command was obeyed by the Lodge, and at an election held on 26th June last, Bro. D. Menzies was elected V. G.

The grounds of the appeal are :

1st. "The appeal to the Grand Master was not properly taken, the Lodge not having been furnished with a copy of the appeal."

2nd. "The appeal from the decision of the Chair to the Lodge was not taken till one week after said decision was given, which is contrary to the law,—see White's Digest "Sec. 1059, 1320 and 1622."

3rd. "The decision of the Grand Master was not in conformity with the Constitution (see Art. VI. Sec. 6, "Constitution of Subordinate Lodges for B. C.) and laws of

" the Order, or with general Parliamentary usages, which are  
 " the basis of our rules of order, (White's Digest 1329, page  
 " 12100 journal of 1890, C. A. Killer vs. G. L. of Texas.")

The fact that the Brother was fully qualified by previous service for the office of V. G., is not disputed by the Lodge.

With respect to the first ground, we cannot find that any law, organic or local, requires that a copy of the appeal shall be furnished to the Lodge in cases of this character. The Code of Procedure laid down in Sec. 5, Art. VII, for appeals arising from Trials where charges have been preferred against members, provides a form of " notice of appeals " (form 7.) in which the ground of the appeal must be stated in such cases, and it appears Bro. Bredemeyer did give such notice on the 22nd May, 1891, which notice the Lodge declined to accept. The Grand Master, also, in his communication to the Lodge, fully states the ground of the appeal, so that in our opinion the Lodge had ample notification, which appears to us all the law requires in the premises.

2nd. The appeal of Bro. Bredemeyer from the decision of the acting N. G., on the 15th May, to the Lodge on the 22nd May, was received and acted on by the Lodge on the latter date, and the question as to whether that appeal was in order, cannot affect the question of his right to appeal to the Grand Lodge on the main issue involved. If it was not in order, it should not have been entertained by the Lodge at the time it was made, but having then admitted it, and waived the right to challenge it, the Lodge is now debarred from raising it as a vital defect.

3rd. We are of opinion that the decision of the Grand Master was strictly in conformity with law and the usages of the Order. It is not necessary for a Brother to resign an office in order to be nominated to another, " the law is satisfied if the officer elect is found eligible at the time of induction into office." (Sec 999 White's Digest.) It is also the invariable usage to nominate a V. G. to the office of N. G.,

whilst holding the former office without requiring him to resign.

From a review of the whole circumstances of the case, we are of the opinion that Vancouver Lodge, No. 8, acted improperly and illegally in refusing to accept Bro. Brede Meyer's nomination as V. G, that the Brother has not forfeited his right of appeal, and that the action of the Grand Master was fully warranted in the premises ; we therefore recommend that the appeal be dismissed and the action of the Grand Master sustained.

The Grand Lodge then adjourned.

## EVENING SESSION.

The Grand Lodge re-assembled at 8 o'clock p. m.

The Grand Marshal reported all present duly qualified.

The Grand Secretary reported a quorum present. The Roll was called and all the officers and representatives answered to their names.

The Grand Marshal retired and introduced the following Past Grands on whom the Grand Lodge Degree was conferred. G. Gavalsky, J. Hilbert, J. Aitkin, and J. Baker of Black Diamond Lodge, No. 5. B. Shearing and H. Mitchell of Harmony Lodge, No. 6.

The Grand Treasurer gave notice that to-morrow he would move the amendment to the Grand Lodge Constitution, notice of which was given last Session by the late Brother W. Edmonds, P. G. The Grand Master ruled that Brother Edmonds' notice did not conform to the law and therefore could not be dealt with.

The following report was read from the Committee on Petitions, which was, on motion, adopted.
