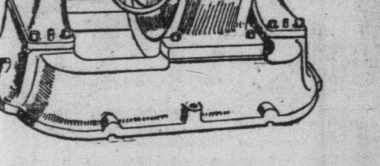

Desks, drawers and boxes were opened by him, much to the annoyance of the merchants.

In the store of Robert McKay, it is claimed, Floody made a search without even showing his authority for so doing, but he did not secure any tobacco. His next visit was to the restaurant of A. J. Gilboe, where he searched the numbers of cigar boxes for smuggled tobacco. An American manufacturer, which Mrs. Gilboe claimed her husband had purchased for her, was shown to her. Floody, who is the collector of inland revenue, was in the store when the officer returned, and a quarrel ensued. Floody was struck, and bloodily accosted by the police, and he was admitted to jail, and his examination was set for today.
