CANADA'S SHAVE

Sir Wilfrid Laurier is in receipt of telegrams from Conservatives as well as from Liberals, and from people in England as well as in Canada, expressing indignation at the manner in which he was treated by the Borden government when it refused him a hearing in the house of commons on Wednesday.

THE PAY OF TEACHERS

The provincial board of education has set a good example to the school boards of this province by granting an increase of salary to the teachers of the provincial model school. One of the most regrettable features of the westward movement has been the migration of numbers of the most capable teachers from New Brunswick to the western provinces.

HERE IS THE PROOF

The strongest evidence of the need of prompt action by the citizens of St. John to ensure the provision of additional steamship accommodation at West St. John before next winter is found in the new columns of today's Standard. It is as follows: "Evidence of the enormous business being carried on in St. John through the winter port is to be found in the fact that at present there are twelve Atlantic liners in port, namely, the Montreal, Ruthenia, Hopetown, Saturnia, Manchester Importer, Manchester Commerce, Victoria, Sicilian, Trento, Bengore Head, Bray Head and Rhodesian. The majority of these are berthed at Sand Point, and the crowded condition there clearly points to the necessity of larger accommodation.

Next winter the business will be larger than it has been during the season now drawing toward its close. There will be greater pressure upon the accommodation for steamers, and, unless more berths are ready, the port must suffer in business and in reputation. Moreover, it may be decided to have some of the mail steamers come direct to St. John, which would make it all the more necessary to have the very best accommodation possible.

TO DISCUSS HOUSING

The need of better housing accommodation in St. John is admitted, and many citizens are casting about for a feasible scheme by which the need may be met. Obviously if a housing association of financial strength and properly managed, could be organized, it would be of great benefit in the effort to solve the problem.



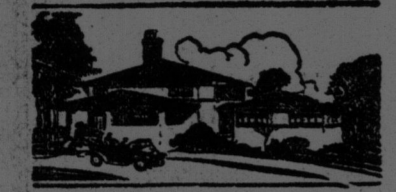

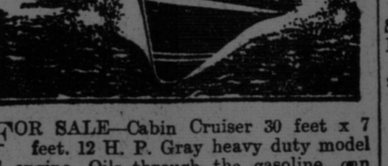

There is no middle course. This is the position that faces us, and it is the problem to be solved, and to be solved now. Which shall it be? It will be as we determine now. This is the reason that we—every one of us—have presented such strenuous opposition to the government measure. This is the reason that we must go on. If, as I have said before, Britain were in danger—may, if she were even on trial—we would not hesitate to vote, cheerfully and enthusiastically, this money or twice the sum. But we know, every one knows, that there should be ample and untrammelled consideration of the great question, and the Canadian people should be given an opportunity to pronounce upon this thing before we launch ourselves on the wave of this new departure. We have nothing to conceal. We believe what we advocate; we believe—may, we are convinced—that our view is best for Canada, best for the empire. We ask that the Canadian people shall determine the great issue for themselves. We ask the pronouncement of the Canadian people as to whether it shall be autonomous organization or imperial contribution. We believe in our position. With us it is a conviction—but if the people think otherwise let us know it, and we will abide by the verdict. 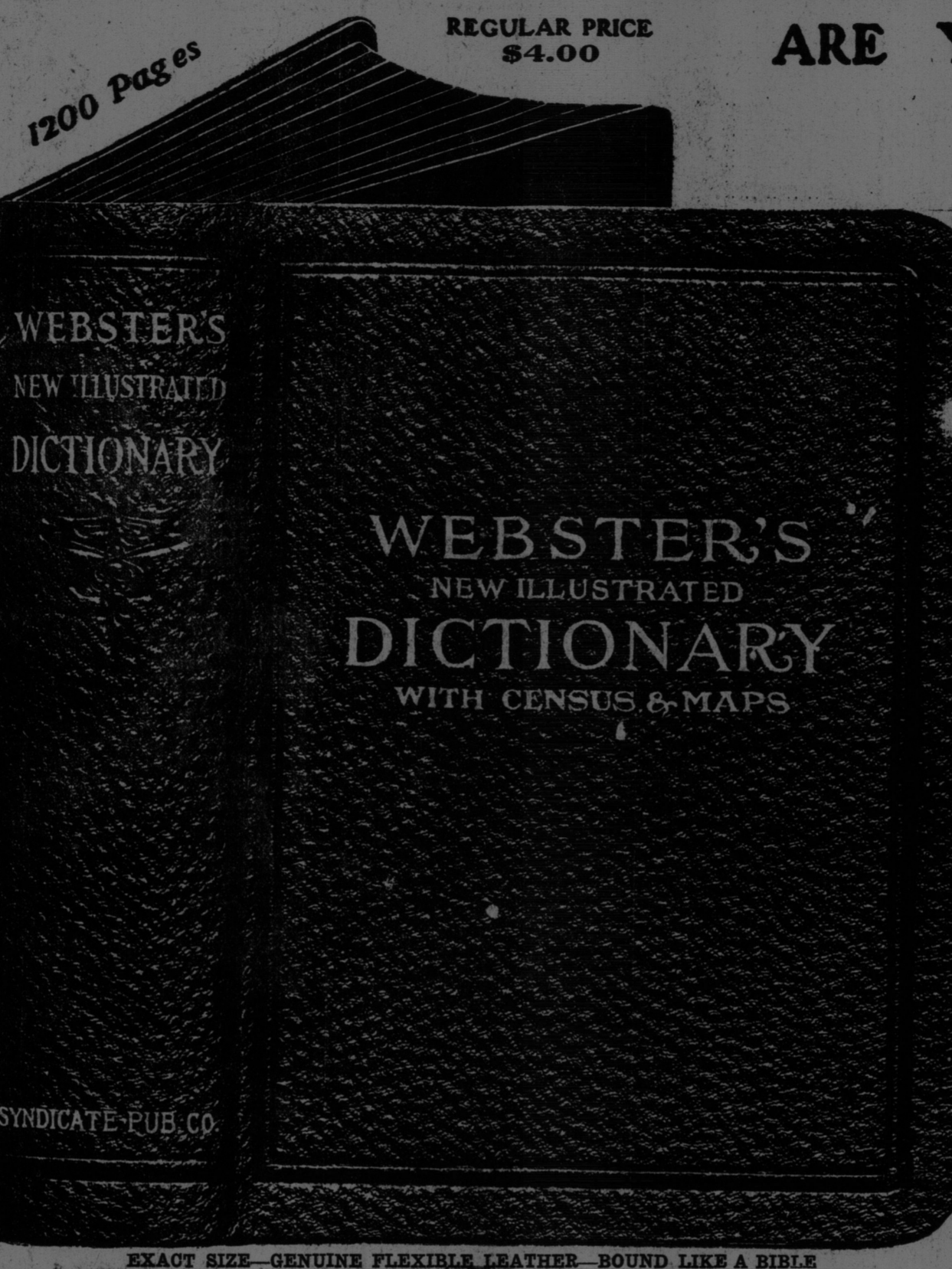

GREAT TASK TO FIX THE TAX ON MORGAN ESTATE

One of The Hardest New York Controller Has Faced

INTERESTING QUESTIONS

Much Depends on Location of Property and in the Manner in Which It Has Been Devised in His Will

New York, April 11.—Appraisal of the estate of the late J. Pierpont Morgan and the ascertaining of the inheritance tax will be one of the greatest tasks ever undertaken by the controller's office of this state.

Although the report of the executors of the will may not be filed for weeks, there is much interest in official and legal circles concerning interesting questions of the estate.

Thomas L. Chrysis, formerly an appraiser in the office of the deputy controller and a lawyer who has had extensive experience in tax inheritance matters, said that under the amended law of July, 1911, the commonwealth could collect only on tangible personal property now in the jurisdiction of the state.

"Works of art," he added, "which are not situated in the state at the time of the death of Mr. Morgan, are not now taxable in this state, including bonds and mortgages and stocks of both foreign and domestic corporations, which are actually within a week.

An interesting question arises in the case of residents of New York dying possessed of steam yachts which may not be at the moment of death in the harbor of New York.

This point is being considered in connection with the estate of Joseph Pulitzer, but has not been decided.

Mr. Morgan's yacht, *Consair*, was in this country at the time of his death.

"Another section of the law," continued Mr. Chrysis, "provides that gifts to educational institutions and charities shall not be subject to the inheritance tax. Thus the works of art Mr. Morgan might bequeath to the Metropolitan Museum of Art or to other institutions would be exempt from tax.

Under the old law institutions even of an educational or charitable kind which were not situated in the state where the decedent had his legal residence were obliged to pay the tax."

It was found on examination of schedules of other large estates that the inheritance tax on the estate of Mr. Morgan would average about four per cent.

If the testator leaves not more than \$5,000 to one beneficiary the amount is free from tax.

In fact a man might dispose of a vast estate in \$5,000 bequests and the state would collect no tax, as it is held that the wealth in that event have a wide distribution.

Estimates vary concerning the Morgan estate. Great fortunes are often less than they are popularly supposed to be, as was the case with the Hartman estate.

Inheritance Tax Graded.

If for the purpose of illustration the Morgan estate be considered to be \$100,000,000 and that it was given largely to the son, J. Pierpont Morgan, Jr., and those in the immediate family, the inheritance tax would be a little less than four per cent.

On the first \$50,000 there would be a tax of one per cent, on the next \$50,000 a two per cent tax, and on the next \$1,000,000 three per cent. On \$1,300,000, or anything in excess thereof, there would be a tax of four per cent.

This is provided the estate so taxed went to wife, son, daughter or lineal descendants. The state would thus have approximately \$3,625,000 on the basis of a \$100,000,000 estate to be distributed to those in the immediate family.

If, however, the property be willed to others the inheritance taxes would run from 5 to 8 per cent, according to the amount. Under the old law which has been referred to as the "Reign of Terror," there were instances in which the state exacted as much as twenty-five per cent.

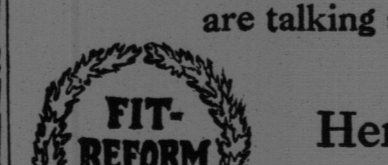

BRITAIN WAS NEAR TO MAKING A RECORD

Empress on Way Here From Halifax—Other Steamer News

The mail steamer Empress of Britain, of the C. P. R., made port at Halifax this morning at 2:30, and docked at six o'clock. The trip across was made in fine weather and the time was almost a record. The passengers numbered 1566. Sixty-four landed here. The steamer left soon for St. John.

Royal Mail Steamer Victorian sailed this afternoon for Liverpool via Halifax with fifty saloon, 100 second cabin and 230 third class passengers and a large cargo of flour, grain and general freight and express.

Allan line steamer Hesperian sailed this afternoon with a full cargo of grain, deals and general freight. Her passengers were transferred to the Victorian, which also sailed today.
The Rhodionian, of the Allan line, is due in Halifax today and will reach this port on Sunday morning.
Donaldson liner Saturnia will sail today for Glasgow with 108 passengers and a fair cargo of general freight.

Manchester liner Manchester Importer will sail tonight for Philadelphia to load cargo for Manchester.
The Rhodionian of the Pilsford & Black line will sail this afternoon for the West Indies via Halifax.
C. P. R. liner Mount Royal, from London and Antwerp, is expected to arrive here tomorrow.
Elder-Dempster steamer Borna will appear today for the Money with a large cargo of deals.
Donaldson liner Letitia is due here tomorrow, with about 1,300 passengers and a large general cargo.

The steamer Clara Menzies in port in ballast this morning and docked at the Ballast wharf at 1 o'clock. She is under charter of W. M. Mackay and will load deals for the west coast of England.

CLOCK CASE DISMISSED

Evidence of Interest in Connection With a Sand Point Matter

William Hickey, who was arrested yesterday charged with stealing six alarm clocks from a case in the hold of the steamer Montreal, now unloading at the west side, elected to be tried before Judge Ritchie in the police court and the case was heard this morning. F. R. Taylor appeared for the prosecution and K. J. MacRae for the defence.
Thomas Dalton, special C. P. R. constable, said that he roomed with Hickey and on Wednesday morning he, witness, noticed an alarm clock on the mantel. He asked the defendant where he got it and was told that he had won it in a lottery. He identified a clock which was produced in court as the one he had seen in his room.
Frank Duff, a timekeeper for the C. P. R., said that the defendant was working at No. 6 hatch on the Montreal until 1 o'clock on Wednesday morning but would be away from the ship between midnight and 1 o'clock.
Herbert Charley, a longshoreman, acting foreman on No. 6 hatch on the night of Wednesday, said he knew nothing of a case of clocks being in the hold.
John Sutherland, head officer of the Montreal, said that on Wednesday morning one of the watchmen reported that a case had been broken open and the contents pilfered. He went into No. 6 hold and found the case as the watchman had reported. He cooperated the case up and had it put into a C. P. R. car. A note on his sheet showed that there were only forty-four clocks while the case was supposed to contain fifty.
George Maynard testified that he examined the case while it was in No. 1 shed on Wednesday and found forty-four clocks and there was evidence that six had been removed.
Inspector Thomas B. Skidmore said that he saw the case in the car and there was an apparent shortage of six paper cartons. The witness said that he and Constable Dalton went to the defendant's room on Thursday and the defendant told them that he had found the clock near the stock yards on his way to lunch. Hickey told them that the clock was in a paper box but he had thrown the box away.
Policeman Lee corroborated and identified the clock found in the defendant's room, as he had marked it when he found it in the room.
The defendant, sworn, said that he was going to lunch just after midnight and when passing the stock yards his foot struck an object and he picked it up. It turned out to be an alarm clock in a paper box. He removed the box and put the clock in his pocket. He went to his boarding house, got his lunch and went back to work, returning to the house the next morning. Constable Dalton, who rooms with him, asked him where he got the clock and he replied in a joking way that he had won it at a raffle. The constable left the room before the defendant could explain. He then went to bed and slept till 3 o'clock that night and went to work soon after, without thinking further about the clock until the constable and the inspector came into his room on Thursday about noon and woke him up.
After lawyers for the defence and prosecution had presented their arguments, Magistrate Ritchie said that he thought the defendant's sworn statement of the manner in which he came into possession of the clock raised a reasonable doubt and he would give Hickey the benefit of the doubt. He dismissed the case.

DISPUTE OVER \$17,000

Court Action in Connection With Will of William Richards

Hearing was had before Mr. Justice MeLeod this morning in the case of Sanson et al v. Richards et al on application of H. A. Powell, K.C., for the plaintiffs to amend by adding the executors of the late William Richards as co-plaintiffs. The action arises out of a dispute over \$17,000 originally the proceeds of life insurance on the life of the late William Richards, and involves the construction of a will and other intricate complications. The court considers M. G. Fred, K.C. and P. J. Hughes of Fredericton, appeared for the defendants.

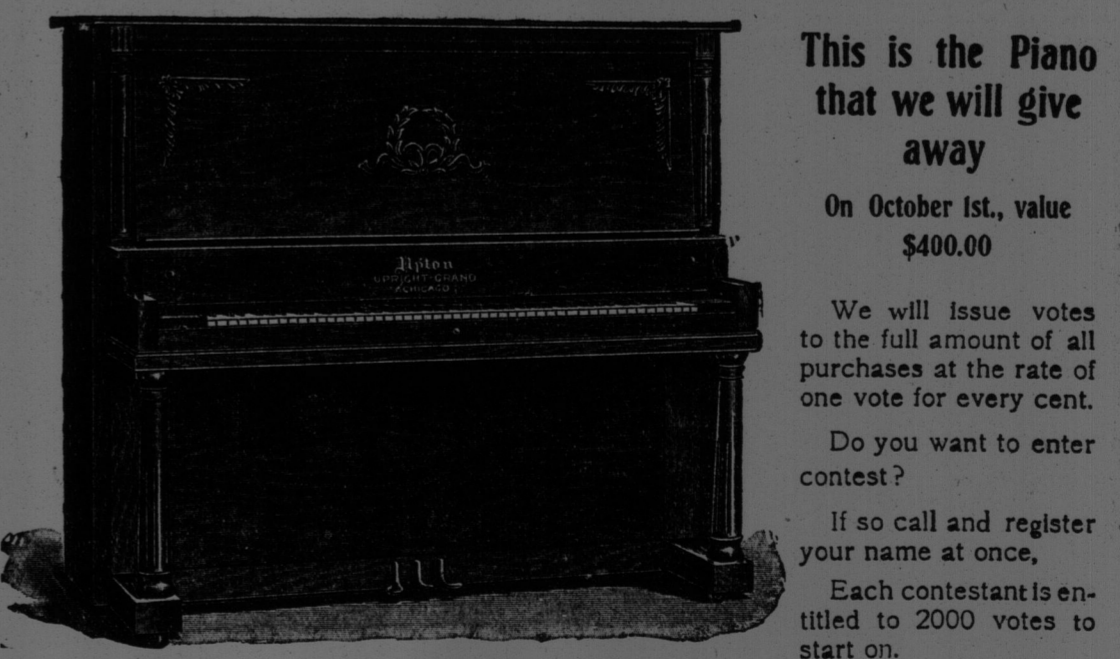
