



Supreme Court

From the conclusion of the Mc-Donald manslaughter case, to the calling of the Montalbetti perjury case, the time of Judge Harvey's court was occupied mostly in considering small debt cases.

Smith vs. the Massey-Harris Co., was tried on the 11th inst. This was an action for the recovery of money paid into the Massey-Harris office at Macleod, by the plaintiff under the mistaken idea that it was being paid to the Deering Co. for a plough. It appeared from the evidence that some time ago the son of the plaintiff had purchased a plough from the defend. ants and had given a note for the same, but as the plough did not work and it was returned. The company had no record of the return and refused to pay back the money. It was argued that the money could not be recovered as it was mixed with law and fact. It was argued for the plaintiff that there could be no ground for the contention of the defendants, as there was an absolute failure of consideration for the note of the son, and also that he was not a party to the action. His Lordship held that the contention was proper and gave judgment for plaintiff.
