SPEAKERS' PROGRAMME - 1981/82

Each year, the Department of External Affairs, under its Academic Relations Programme, draws up a list of officers who are prepared to give talks or participate in seminars at the invitation of universities, community groups, clubs, associations and organizations interested in international affairs. We therefore encourage you to think of Canadian diplomats when you require an expert in the areas of departmental activity outlined in this booklet. You may view this as returning to Canadian universities dividends on the training received from them. Since speakers talk best about topics with which they have worked for years, the booklet is arranged by subject, to help you select the most appropriate speaker. The list need not be regarded as exclusive in terms of topics or individuals. Special requests are always welcome.

While the formal type of lecture is not excluded, a preference is expressed for the informal type of gathering, such as seminar and working group consisting of approximately 25-50 persons. Such gatherings are generally found to be more satisfying to the participants and to yield better results. Although our speakers are not expected to perform as spokesmen in the official sense, they will refer to government policies, comment on subjects of Canadian interest and analyse world affairs drawing on their professional backgrounds. The speakers would be prepared to answer questions during ensuing discussions. Unless prior consent from the Department has been obtained, these talks are not to be reported or attributed in the media. In this way, it is hoped that a more frank and effective dialogue can be developed.

Requests for speakers, preferably in writing, should be directed to the Academic Relations Division; if possible, several weeks in advance. Travelling expenses required to implement the program are normally met by the Department. In most cases it would be desirable to make arrangements for the speaker to visit several centres or universities on a circuit, as this would represent a more economical use of resources and might help to meet requests more equitably. At times we cannot meet the original commitment; however this is exceptional and we always strive to provide a substitute. We have also listed at the end of the brochure the names and addresses of the Foreign Service

Visitors who have been assigned to certain universities for the current academic year. They will be in a position to provide guidance and, as requested, to accept "regional" invitations to talk about subjects in their fields of expertise or careers in the Department.

We would also like to draw your attention to the services provided by the Department's Domestic Information Programs Division. This Division has, as one of its prime functions, the fostering of a greater awareness of foreign policy matters among the Canadian public and the media. In this regard, the Division is prepared to provide written and other information material on Canada's external relations to members of the public, on request (telephone (613)593-7025).

Dans le cadre de son programme de relations avec les universités, le ministère des Affaires extérieures dresse, chaque année, une liste d'agents disposés à donner des causeries ou à participer à des séminaires sur invitation des universités, des groupes communautaires, de clubs, d'associations et d'organisations intéressés aux affaires internationales. Nous vous encourageons à penser aux diplomates canadiens si vous avez besoin d'un expert dans les domaines d'activité inscrits dans cette brochure. C'est pour eux une façon de remercier l'Université canadienne de la formation qu'ils y ont reçue. Comme les conférenciers sont nettement plus à l'aise lorsqu'ils abordent des sujets sur lesquels ils se sont penchés pendant des années, la liste est divisée par sujet afin de vous aider à choisir le conférencier qui convient le mieux à vos besoins. Cette liste n'est pas exhaustive, en termes de sujets ou de personnes. Nous sommes toujours disposés à acheminer les demandes spéciales.

Sans exclure la causerie de format habituel, nous avouons préférer les séminaires ou les groupes de travail de 25 à 50, formule plus souple et ordinairement plus enrichissante et profitable. Nos conférenciers ne parlent pas à titre officiel: ils traitent néanmoins des politiques du Gouvernement, commentent des sujets d'intérêt canadien et analysent les affaires mondiales, à la lumière de leur expérience professionnelle. Les conférenciers répondront également aux questions qui leur seront posées à la suite de leur exposé. A moins d'accord préalable avec nous, il ne doit pas être fait état de ces exposés dans les médias; ceci permet un dialogue plus franc et plus fécond.

Les demandes doivent être adressées, de préférence par écrit, à la Direction des Relations académiques, dans la mesure du possible plusieurs semaines à l'avance. Le Ministère assume les frais. Dans la plupart des cas, il est préférable qu'un conférencier visite plusieurs centres ou universités lors d'une même tournée, ce qui permet d'utiliser les ressources d'une façon plus économique et de répondre aux demandes d'une manière plus équitable. Il advient que nous ne puissions remplir un engagement donné, mais c'est l'exception et nous tâchons toujours de trouver une solution de rechange. Nos Diplomates en résidence dans les universités pour l'année académique 1981-82, dont vous

trouverez les noms et adresses à la fin de la brochure, sont également en mesure de vous orienter et, le cas échéant, d'accepter des invitations "régionales" touchant à leurs domaines d'expertise ou à la carrière diplomatique en soi.

Nous attirons également votre attention sur les services rendus par la Direction des programmes d'information au Canada. 
