After a while, His Excellency the Governor General having come, and being seated upon the Throne,—

The Honourable the Speaker commanded the Gentleman Usher of the Black Rod to proceed to the House of Commons and acquaint that House that,—

“It is His Excellency the Governor General’s pleasure that they attend him immediately in the Senate Chamber.”

The House of Commons being come,

His Excellency the Governor General was then pleased to open the Session by a Gracious Speech to both Houses, as follows:—

Honourable Members of the Senate:

Members of the House of Commons:

You have been summoned at this time because of the serious international situation arising out of hostilities in the Middle East and the events in Hungary.

Members of the House of Commons:

You will be asked to provide expressly that the provision for defence expenditures in the Appropriation Act No. 6, 1956, be used for the purposes of Canada's participation in the United Nations Emergency Force for the Middle East in fulfilment of our country's obligations to the United Nations Organization under the Charter. You will also be requested to authorize the provision of relief for the victims of the recent tragic events in Hungary.

Honourable Members of the Senate:

Members of the House of Commons:

May Divine Providence continue to protect this nation, and to guide the Parliament of Canada in all its deliberations.

The Commons withdrew.

His Excellency the Governor General was pleased to retire.

The Honourable Senators stood in a minute of silent prayer for those brave Hungarians who have died in the last few weeks fighting for the freedom of their country against a foul and brutal tyranny.

Ordered, That all the Senators present during this Session be appointed a Committee to consider the Orders and Customs of the Senate and Privileges of Parliament, and that the said Committee have leave to meet in the Senate Chamber when and as often as they please.
