## ANNUAL REPORT FOR 1852.

PRESENTED 5TH JANUARY, 1853.

ON retiring from office, the Committee of Management are desirous of placing before the Members a brief account of their administration of the affairs of the Society during their term. One of the first duties of your Committee was to carry out the often expressed wish of the Society in procuring a Diploma and Seals. The work has been well executed by Messrs. Standidge, of London, and the diplomas are now signed and ready for delivery to such Members as are not in arrears this day. St. George's Day was celebrated by the Society attending Divine Service. Prayers were read in the Cathedral by the Revd. Geo. Mackie, D. D., and an excellent sermon delivered by the Revd. A. W. Mountain, B. A. An admirable musical service was performed by the late S. Codman, assisted by the ladies and gentlemen of the voluntary choir. The collection on the occasion amounted to £14 10s. After service, the Society marched to Russell's Hall to witness the presentation by the Right Revd. Lord Bishop of Quebec, (Patron of the Society,) on behalf of the Members, of a gold watch and chain to Robt. Symes, Esq., as an acknowledgment of his services as Treasurer to the Society for a term of 16 years.\* Owing to the small number of Members offering to subscribe, there was no dinner on St. George's Day.

The Report of the sub-Committee of Charity will prove to Members that the Society has not been backward in affording

\* Connected with that pleasing circumstance, Mr. Symes presented to the Society, a collection of its Records, from the foundation of the Society 1835, to the end of the year 1851, carefully arranged and bound into three Volumes. These books are valuable, containing as they do, all the early proceedings and the names of the Originators of the Institution, with much other curious information connected with the Society. Mr. Symes presented three Sets which are placed in the custody of the President, Secretary and Treasurer, for the time being, open to the inspection of any Member upon application to any of the above named officers, and to be handed over to their successors in office for ever; a fourth Set of the same documents Mr. S. has retained in his possession. The papers above alluded to are the more valuable in consequence of the loss by Fire of the greater part of the early proceedings of the Society.

relief to distressed natives of England and Wales during the past year. The number of cases in which relief has been granted, amounts to 40; the amount so distributed during the year is £79 14s. 4d. The arrears due for subscriptions this date amount to the large sum of £64 5s.

The Society has to deplore the loss of three Members during the past year—William T. Kimlin,\* S. Codman,† and

\* William Thomas Kimlin, M. D., native of Knightsbridge, London, came to Quebec in 1834, having been appointed to a clerkship in the Post Office Department, in Canada. After having filled this situation with credit to himself for several years, he resigned it, and became Editor of the *Quebec Mercury*. Upon the establishment of the Quebec Building Society, Dr. Kimlin resigned the Editorship of the *Mercury*, and was appointed Secretary-Treasurer, which situation he held at his decease.

He died on the 19th July, 1852, at the age of 36 years, regretted by a large circle of friends, to whom he was endeared by his amiable disposition and affable deportment.

† Stephen Codman died on the 6th October, 1852, aged 56 years. He was a native of Norwich, England, where he received his Musical Education under the celebrated Dr. Beckwith. For the last 36 years he was Organist of the Cathedral Church of this City, he possessed musical talent of the highest order, united with refined taste, as is abundantly evinced by his compositions; and his powers of performance were equal to his natural gifts. But he was distinguished not for professional ability only: for the pursuits of literature he displayed a keen relish and a cultivated taste, and his memory will be long cherished by a numerous circle of friends to whom he endeared himself by his many excellent qualities. After the performance of the burial service in the Cathedral, during which the choir sang with solemn effect to the burial hymn, "Dust unto Dust." Words by the Rev. Dr. Mackie, music composed by Mr. F. H. Andrews, both Members of the Society. His mortal remains were conveyed to their final resting place at Mount Hermon Cemetery, the Lord Bishop, Patron, several of the clergy, select vestry, and the President and Members of the society, being among the followers, and to perpetuate the respect of the Congregation for his memory, the Select Vestry have erected a Marble tablet in the Cathedral, with the following inscription:—

IN MEMORY OF  
STEPHEN CODMAN, ESQ.,  
A NATIVE OF NORWICH, ENGLAND,  
WHO WAS FOR 36 YEARS ORGANIST OF THIS CHURCH;  
HE DIED ON THE 6TH OF OCTOBER, 1852,  
AGED 56 YEARS,  
AND IS BURIED IN THE "MOUNT HERMON CEMETERY," NEAR THIS CITY  
THIS TABLET IS A TRIBUTE FROM THE CONGREGATION,  
TO RECORD THE SENSE OF THEIR LOSS.

\* Captain Austin, served upwards of twenty years in the army, and was present in several different campaigns, and participated in a number of engagements, for some of which a medal and clasps were awarded him.

In 1803, at the age of 16, he was appointed to an Ensigney in the West Middlesex Militia, where he remained till 1807, when he joined the 76th foot and accompanied the force under the late Sir John Moore throughout the retreat which terminated in the victory at Corunna.

In 1809, he assisted at the siege and capture of Flushing in the Island of Walcheren.

In 1813-14, he served in Spain and France under the late lamented Duke of Wellington, and was at the storming and capture of San Sebastian, the crossing of the Bidassoa, the battle of the Nive, Nivelle, San Juan de Luz, the fight on the road to Bayonne, and the siege and sortie at Bayonne.

He then embarked at Bordeaux in France for this country, and served in part of the last American war. In 1828, he retired from active service in the army, and settled in this City, where, in the year 1837, he was appointed to the Office of City Treasurer, which he filled with efficiency, zeal, and integrity, until declining health compelled him again to withdraw into private life.

His remains were deposited in the Mount Hermon Cemetery, St. Lewis Road.

## REPORT OF THE SUB-COMMITTEE OF CHARITY.

---

THE Charitable Committee of the St. George's Society in making the usual statement of its proceedings at the close of the period for which they were elected to conduct that department, beg to congratulate the Members on the continued prosperity of the Institution, and of the future prospect of a long extended sphere of usefulness.

The Committee have to report that they have granted relief to forty applicants during the past year, among whom a sum of £79 14s. 4d., has been distributed. This amount of assistance, as the Committee feel assured, has been rendered in every instance, to parties who were considered as having a just claim on the funds of the Society, and worthy to participate in the benefits which it confers.

Among the persons relieved are several sailors who were discharged as convalescent, from the Marine and Emigrant Hospital, in the course of the season of Navigation. These cases have formed a considerable charge on the funds of the Society, at the disposal of the Charitable Committee, as, although convalescent, the men were in all cases unfit for duty and unable to work.

The Committee would strongly recommend to Members the necessity of being very cautious in signing applications for relief, in order that the funds of the Society may be judiciously applied.

**THE YEAR 1852.**

---

IN presenting the Seventeenth Annual Account of the Finances of the St. George's Society, the Treasurer has much pleasure in adverting to the steady increase of its resources, more particularly as exhibited in the increase of the Permanent Fund, and that notwithstanding that the usual expenses of the Society have been largely augmented this year.

The increase of the Fund this year has been £28 13s. 4d., and the total amount is now £1,305 14s. 6d.—£1,300 of which is invested in Bank Stocks and other Securities, and £5 14s. 6d. is deposited in the Saving's Bank.


The receipts from the Annual Subscriptions, Donations, and Entrance Fees during the past year have been £44 10s.—£5 of which is due to the liberality of William Jackson, Esq., M. P. The Treasurer must, however, draw the attention of the Members to the large amount of subscriptions outstanding, an amount which is annually increasing, to the prejudice of the interests of the Society.

The large increase which has taken place in the expenses incurred during the past, arises from the Resolution of the Society that Diplomas of Membership should be furnished to the Members—the cost of the plate and of 500 copies of the Diplomas, with two seals engraved on steel has been £49 8s. 9d. cy.; notwithstanding the large increase of the usual expenses of the Society, the object for which the Society has been formed has not been interfered with, £79 14s. 4d. having been expended in aiding and assisting those of our brethren who have called upon the Society for aid.

Five Ordinary Members have become Life Members during the past year, and three Members have joined as Life Members during the same period.
