A Conservative daily congratulates the Militia Force upon the fact that the estimates submitted to the House this year provide for an increase of \$25,000 in the allowance for drill pay, etc. Our esteemed contemporary is apparently unaware that for some years past the estimate for this particular purpose has been considerably exceeded, a fact to which attention has regularly been drawn by the Auditor-Gen-The amount now asked for is eral. nothing more than what it has been found necessary to spend for several years past, and is no increase in fact, but merely a question of book-keeping, other items being decreased to adjust this apparent increase.

General rules established to meet special cases or remove specific grievances not infrequently work more injustice than that sought to be removed. An illustration is afforded by the provision made a couple of years ago, that graduates of the Royal Military College not having joined any corps, but becoming attached for certain service at camp, should after five years be promoted from their Militia rank of Lieutenant to that of Captain. But no such step in rank is allowed those who regularly join any corps of the Militia, and the effect of this is that graduates who have put in more than five years constant service are still only Lieutenants in the absence of regimental promotion, through resignation of their seniors, while others who have served only a few weeks in camp as attached officers, have got their captaincies. The anomaly should be removed without delay.

TORONTO, March 22nd, 1892.

Dear Sir,—It will be remembered that at the annual meeting of the Canadian Rifle League the appointment of a Secretary was left to the Executive Committee. Efforts have been used by me since the meeting to induce Mr Pringle to act for at least one more year, and I have had some reason to hope these efforts would Recently, however, for be successful. purely business reasons, he has positively declined, and another man must be selected. There are many riflemen who would fill the bill very well, but I desire that the duties shall be undertaken by some one who can see me or be consulted by me without any inconvenience, and the name of Major Delamere is suggested by me for the position for this year. He will not be available for re-election at the next annual meeting. As a member of the Executive Committee do you concur in Major Delamere's appointment?

In sending me your reply please let me also have your views on one or two points of vital importance to the League :--

1st. What do you suggest with a view to a more satisfactory system of checking and verifying the scores? I intend to send out a very strong letter on the subject to the C.O.'s of all competing corps before the first competition takes place; but if I receive from each of the members of the Committee his well considered views on this difficult question 1 may be able, with the Secretary's assistance, to adopt some sort of a system that will at least be an improvement on the past.

and. Do you think any higher entrance fee can be imposed without danger of a falling off in entries?

3rd. Do you think it necessary to provide so large a number of prizes in the shape of cups? The badges have been recognized by the Militia Department, and of course will be appreciated all the more from that fact, but perhaps there is not any necessity for the tremendous array of cups which we have hitherto presented.

4th. What, if any, suggestions have you to make for improving the programme of last year?

Please let me hear from you as soon as possible, so that at the termination of the session of the Legislature I may be in a position to have all necessary arrangements made and announcements published.

DOMINION RIFLE ASSOCIATION.

The annual business meeting of the Dominion Rifle Association was held on Wednesday, the 16th inst., with the usual average attendance, although some familiar faces were missed; among whom was the late Capt. Macnachtan of Cobourg, who for many years was a very regular

Lt.-Col. Hon. G. A. Kirkpatrick occupied the chair, and on his right was His Excellency the Governor-General, attended by Viscount Kilcoursie, A.D.C.

The annual report having been received as printed, accepted as read, and adopted, Major Hughes, 45th Battalion, moved the usual vote of thanks to His Excellency for his presence and continued patronage of the Association.

His Excellency in replying remarked that on glancing at the cover of the report the thought occurred to him that the title might be aptly changed from Dominion Rifle Association to Dominion Smoothbore Association - It was a source of regret that year after year passed without any improvement in the arm with which the force is equipped.

Lt. Col. Massey moved the vote of thanks to the Minister of Militia, whose presence at the meeting afforded much pleasure to the members present, and might, he trusted, be accepted as an augury of good omen for the force, as evidencing the interest which the Minister intended to take in everything connected with his Department.

Lt. Col. the Hon. Mackenzie Bowell responded in a most felicitous strain, and recalled, amidst considerable amusement. the first occasion on which he had met the Hon. President of the Association; on which occasion, acting as A. D. C. to the D. A.G. at one of the Brigade Camps, he had been detailed to convey an order to the President, then commanding his regiment. Upon delivering the order he was asked to repeat it, and having done so, was asked it he could tell how to do it, to which he was forced to reply, "Lord no; it was hard enough to remember how to deliver it."

He assured the members that whatever it was in his power to do to improve the position of the force, having due regard to the limited means placed at his disposal, would be done, and he would always endeavour to secure the co-operation and approval of the other members of the Cabinet in any scheme to improve the force.

The thanks of the Association having been tendered to the Major General commanding, Major General Herbert on rising expressed his thanks to the members of the Association for the kind manner in which the mention of his name had been received. He assured them that everything he had been able to do had been not only a duty but a pleasure, and that |

interest taken in their work by all ranks, the very satisfactory progress made, and the good results attained considering the limited opportunities afforded them, the greater pleasure it afforded him to work for and with the Militia of Canada. It was the same way with the rifle shooting, and this made him all the more anxious that a weapon might be put in their hands more efficient than that with which they are at present armed.

Last year was a red letter year for the riflemen of the Dominion, not only at Bisley but at the D.R.A. also, for which he thought we owe a great deal to the Military Rifle League, and he was pleased to announce that he had just given authority for the winners of badges in the League to wear them when in uniform in a similar manner to the badges won at Bisley or at the Dominion Rifle Association meeting.

He had read with great interest the report of Major Weston, commandant of the Bisley Team, whose recommendations were practical and of considerable value. With reference to the suggestion that the Association endeavour to obtain permission for the team to practice on the Pirbright range, he feared there would be difficulties in the way which would be hard to overcome, as the whole brigade of Guards had to do their firing on this range, and it was usually fully occupied; but if the Council determined that it would be desirable to endeavour to obtain permission to use it, he would communicate with the military authorities if the Executive would wish him to do so, and do his best to secure the needful permission.

Lt.-Col. Turnbull, M.G.A., moved, seconded by Lieut. Laurie, I.S.C., the thanks of the Association to the several donors of prizes to the Association.

Major Blaiklock moved a hearty vote of thanks to Lt.-Col. Roberts for his continued kindness to the Bisley Team of 1891. Major Blaiklock stated that on the arrival of the team at Cambridge they found that no arrangements whatsomever had been made for their board or lodging, and they were indebted to Col. Roberts for most unremitting kindness and attention in endeavouring to secure suitable quarters for them, as well as in granting them the use of the Cambridge University rifle range for practice during the week preceding the Bisley meeting.

Lieut. Sutherland moved that inasmuch as the National Rifle Association authorities have determined to open their matches under certain restrictions to retired volunteers, and it is usual for our D. R. A. to follow in the footsteps of the parent institution, that provision be made by the Council in this year's programme for the admission of retired volunteers to all matches under certain restrictions to be imposed by Council. Captain O'Grady announced that Mr. J. W. McRae, President Ottawa Electric Street Railway, Mr. J. R. Booth, lumberman, Otiawa, and Mr. F. X. St. Jacques had each announced their intention of contributing \$50 to the funds of the Ass > ciation, and that Captain S. Maynard Rogers, 43rd Bat. O. & C. R., had given \$40 for the same purpose.

The election of officers followed and resulted in the re-election of the President and Vice-Presidents, as last year, with the exception of Lt.-Col. Allan Gilmour, who is replaced by Lt.-Col. J. M. Gibson as

Vice-President for Ontario.

The Council, with one or two exceptions, is much the same as last year. The most notable change is the election of Lt.-Col. Henshaw as a representative from Quebec, and his subsequent choice as Chairman of the Council in succession to L'.-Col. Hon. J. A. Ouimet, who had expressed his desire to be relieved of the position.

NOTES OF THE MEETING.

It felt as if a portion of the routine proceedings had been omitted when the Deputy Minister of Militia, who has always taken a deep interest in the welfare of the Association, was not called upon to apologize for the absence of his Minister.

His Excellency the Governor-General and the Major General are entitled to very warm corners in the hearts of all Militiamen for their unceasing efforts to stir the Government into providing more modern arms for the use of the force than the old gas pipes now in their hands.

Colonel Mackenzie Bowell is winning golden opinions in his new portiolio. Militia officers from a distance who had business to transact with the Department were astounded to find that it was possible to obtain definite and decisive answers

inside of 48 hours.

The D. A. G. of Military District No. 2 was, we think, the only officer present from points west of Ottawa who came to the city specially for the meeting. This does not evidence great interest on the part of western riflemen in the proceedings and ought to be remedied. Hamilton used to send two very favourite faces, Lt.-Col. Gibson and Major Mason, but of late years we have missed them, and no one seems to replace them.

The Executive had a long discussion as to whether or not Lieut. Andrews should be allowed a place on the Bisley team. He shot as a Retired Officer Then taking a commission in the 5th Royal Scots, his appointment was antedated to a time before the matches. The rule is that Retired Officer are ineligible for Bisley, but because his commission had been antedated an unsuccessful attempt was made by personal friends on the Executive to have him declared eligible.

THE DOMINION ARTILLERY ASSOCIATION.

The annual meeting of the Dominion Artillery Association was held in the Tower Room of the House of Commons, on Thursday, 17th March, commencing at 12.15, with a very slim attendance. The president, Lt.-Col. Stevenson, was in the chair, and among those present were: His Excellency the Governor-General and Capt. Walsh, A.D.C.; Lt.-Col Hon. Mackenzie Bowell, Minister of Militia; Major-General Herbert, Commanding the Militia; Col. Walker Powell, Adjutant-General; Col. C. E. Panet, Deputy-Minister; Lt.-Col. Irwin, Inspector of Artillery; Capt. Donaldson, Secretary; Lt.-Col. Hon. Geo. A. Kirkpatrick, M.P.; Lt.-Col. F. C. Denison, M.P.; Lt.-Col. E. G. Prior, M.P.; Lt. Col. Otter, D.A.G.; Lt.-Col. Turnbull, M.G.A.; Major Cole, v.G.A.; Lt.-Col. John Macpherson; Capt. Bliss, O. F. B.; Lieut. Gilmour, O.F.B.; Dr. R. J. Wicksteed, and Mr. J. D. Taylor. The proceedings opened ! with an address from the chairman, who ! in moving that the report as printed and presented be taken as read, expressed regret at the small number of officers present. This might be because of the general satisfaction with the manner in which the affairs of the Association were condu ted, or to a feeling of indifference, but if the latter were the cause it was certainly confined to the attendance at the meeting, as during the year great interest had been shown in the practical working of the Association. Col. Prior seconded the resolution in a brief speech in which he expressed his conviction that the small attendance was by no means due to indifference to the welfare of the Association. The motion was carried.

THE EXECUTIVE'S REPORT.

Lt.-Col. Irwin, as Chairman of the Executive, moved the adoption of their report, and dwelt briefly upon each of the subjects there dealt with. With respect to the range finding practice, which it is proposed should be continued next season, he said that whilst in former years, with the smooth bore guns in use and the targets plainly visible, very careful laying was not a necessity, the adoption of rifled guns has made the case entirely different, the ranges being so great that the most careful observation is called for. The Dominion Association had in a humble way endeavoured to imitate the example of the Royal Artillery, and commencing with range finding practice with one gun, they had gone on to two, and then the whole battery.

The competitive gun practice at Kingston had been carried out with good

Thd drill and driving competition was also exceedingly well carried out, and the beautiful cup offered by Col. Sir Casimir Gzowski had been finally won by the Durham Field Battery, as winners two by a rising vote.

years in succession. They richly deserved the victory, their record for several years having been exceedingly high.

A GARRISON MEET AT HALIFAX.

With respect to the Garrison Artillery practice, usually carried out at the Island of Orleans, a change was proposed with a view to meeting the claims of the Maritime Province gunners for a meeting nearer home. Lt.-Col. Montizambert, Assistant Inspector of Artillery, had examined the range available at Bedford Basin, Halifax, and having found it in every way suitable for garrison gun practice it was proposed that next year's meeting should be there. Col. Ry in and the other officers of the Imperial troops at that station had promised to do all possible to assist in carrying out the arrangements; and the expected facilities for practice with the modern improved guns of the Imperial garrison would be an inducement to the Ontario and Quebec members to visit Halifax.

A deplorable and fatal accident had occurred at the shifting ordnance competition at the Island of Orleans, but this was the first accident since the inception of these competitions, and was the single exception to the rule that when properly conducted they are quite safe. accident could not have been foreseen and no one could be held blameworthy.

THE EFFICIENCY SCHEME.

As to the efficiency competitions he could not speak too highly of the good effects they had upon the whole artiflery force. His Excellency had been kind enough to continue his presentation of cups, and they were the objects of the greatest emulation. The credits in these competitions had been doubled in value, in order to assist the inspecting officers in making their awards relatively accurate, and the plan had worked well. A specially noteworthy fact was the manner in which the questions were answered by the members of the leading batteries, showing a thorough study of the subjects.

The prize list had been increased by \$304, making a total of \$1,334 offered last year, besides which all had been paid for the time spent in camp in connection with the competitions.

Capt. Bliss seconded the resolution, and the report was then adopted, and the accounts as audited were passed.

THE GOVERNOR-GENERAL'S ADDRESS.

Lt.-Col. Turnbull moved a vote of thanks to His Expellency the Governor-General. He felt that this motion represented the sentiments of the Artillery all over the country, who had noted with great satisfaction, the interest His Excellency had taken in the meetings at Orleans and elsewhere. Lt. Col. John Macpherson seconded the resolution, and it was carried

Lord Staniey of Preston in reply thanked the mover for the kind words just spoken, and said that whatever efforts he had made in connection with the artillery meetings had occasioned him sincere pleasure. On every occasion except one since he had come to Canada he had attended the meeting at Orleans, and his impression was always fayourable. The Camp Commandant and Quartermaster were entitled to great credit for the arrangements made, and the range itself could not be improved upon in that part of the country. He was glad to hear that a concession was to be made to the Garrison Artillery of the Maritime Provinces, in the way of holding the next meeting at Halifax. He felt quite sure—and General Herhert would hear him out—that the Regulars there have every desire to facilitate the camp arrangements. Sir John Ross had expressed his willingness to give opportunities for practice with the improved guns at Halifax, and anything sanctioned by the authorities he would gladly carry out.

Since the last meeting of the Association, there had been a change in the office of Minister of Militia, a gentleman well known as the most efficient head of an-Ather department having been placed where he could be of immense advantage to the militia force. He was glad to see the new Minister present, and would direct his attention to the small appropriation for rifled ordnance made every year, though no advantage was taken of it. He would not advise any but the most cautious investment in this connection, but thought we should have the most improved guns of position. If, however, our present weapons are not as perfect in equipment as they might be, practice with them is of great advantage and he trusted it would not be neglected during the

coming year.

The field batteries so far as he had seen had maintained an excellent record, and he congratulated the Durham Battery upon their exceptionally proud position. As to the Association generally, so long as the spirits now inspiring prevails, it could claim and should receive the utmost attention from all good citizens.

THE MINISTER OF MILITIA.

Major Cole moved a vote of thanks to the Government, to Parliament, and to the Minister of Militia; and that Lt. Col. the Hon. Mackenzie Bowell be elected a Vice-Patron of the Association. He felt sure, he said, that the new Minister of Militia would afford them all assistance in his power. Lt.-Col. Otter seconded the resolution, which was declared carried.

Lt.-Col. Hon. Mackenzie Bowell, replying, thanked the Association for the resolution, and Lord Stanley for the kind reference made in his address. He could promise His Excellency and the head of the Council that whatever advice he might tender them his desire would be to do

He knew that in the days of his active military connection there were very great demands on its behalf, and he anticipated that in this as in the Customs Department the demands would be rather more than could be granted. He invited, however, representation of all desires, and if any could not be granted he would frankly tell them so, and why (applause). This he had found to be the better way for all concerned On the subject of weapons, he thought it highly desirable that the best arm procurable should be had for each branch of the service, and he should do his best to render the Artillery and the whole force as effective as possible.

A NEW RULE.

In accordance with notice given Lt.-Col. Irwin moved the following resolution affecting the Rules of the Association :-"That the following be made a rule; Officers who compete for prizes must be life or annual subscribers to the Association.'"

He desired also to make an explanation which would have been made by Major Stewart, the President of the Council, had he been present. This related to the reference to the Morris tubes, which the Council had reported as not forthcoming. These, he was happy to state, had been received, and were now ready for issue to those field batteries in a position to make intelligent use of them. The duck suits also had been received, and would be issued in time for this year's dill.

The motion carried, after endorsement by the chairman, who said he would like to see every officer a subscriber to the Association.

Capt. Donaldson moved a vote of thanks to the Hamilton Powder Co., for their continued donation of \$100 to the funds of the Association, and that Dwight Brainerd, Esq., be elected a life member. He wished it particularly noted that this was the only mercantile firm contributing to the funds. The resolution carried.

THE PRESIDENCY.

General Herbert moved that Lt. Col. Curren, H.G.A., be elected President for the coming year. This choice, he pointed out, would be particularly apt in view of the intention to hold the next Garrison meeting at Halifax. As the Maritime Provinces furnish so large a proportion of the competitors and the Halifax Brigade is one of the most efficient in the Dominion it would be a graceful act this year to move the meeting down to Halifax. He knew there would be no difficulty about the arrangements. There were at Halifax some of the most modern specimens of artillery, and this opportunity of seeing the really scientific application of artillery knowledge would give a decided impetus to our force.

THE GENERAL'S RECOMMENDATIONS.

He thought it not out of place here to make some few remarks on the Canadian

which he thought was largely due to this Association. As he had already intimated in a General Order, he considered the Artillery the roost efficient arm in the Dominion, and this he attributed to the system of inspection carried out in connection with the work of the Dominion Artillery Association Inspection had thus been prevented from degenerating into a mere parade and march past, for while the. effect of inspection what is efficiency and what is not-had been largely lost sight of in many instances, such was not the case here. Even here, however, he considered that too much importance had, been attached to some things and not enough to others-for instance, discipline and interior economy appeared to be slighted—and he had discussed with the Inspector plans for improvement, with the result that he thought they had struck upon a plan for keeping the ledgers in better order, thus securing that the batteries should get their equipment in proper time. He blamed the officers of the batteries for the hitherto faulty administration which had permitted the matter of equipment to be neglected until the last moment.

THE PERIOD FOR DRILL.

In the Report of Council, at Paragraph. 8, he noticed a strong recommendation that a longer period than twelve days should be allowed, for the annual drill of the Artillery. This he could not support, so long as he saw a third of the Militia not drilled at all. He would, however, recommend the grant of pay by the Department to such detachments as go into camp for practice under the auspices of the Association. Personally, he would: like to see the period of drill increased, but feared this could not be done; the other he thought could be done.

THE VICE-PRESIDENTS.

Lt.-Col. Prior, M.P., seconded the motion and the election of Lt.-Col. Curren as President was unanimously carried, Lt.-Cols. Armstrong, Prior, and Turnbull were re-elected Vice Presidents, and Lt.-Col. Moore, P. E. I. G. A., was elected a Vice-President in place of Lt.-Col. Curren, Lt. Col. Stevenson, Capt. W. McCrae, and Capt. D. C. F. Bliss were elected members of Council.

Capt. Bliss moved, and Lieut. Gilmour seconded, a vote of thanks to the Auditors, Lt Col. John Macpherson and Mr. F. E. Knight, which was carried unanimously.

THE RETIRING PRESIDENT.

The chair having been taken by Lt.-Col. Turnbull, a vote of thanks to the retiring President, Lt. Col. Stevenson, was moved by Lt.-Col. Irwin, who feelingly referred to the various capacities in which Col. Stevenson had served the Association for many years past, and the regret all felt that ill health had caused his absence from last camp. He knew it was very what was best in the interest of the force. Artillery in general, and its efficiency, hard for Col. Stevenson to dissociate him. self from his battery and the Association, and that they could always count upon him as a warm friend,

Lt.-Col. Stevenson returned thanks. He had always taken a deep interest in and appreciated the importance of the Association. He was glad that his suc cessor was an officer from the Lower Provinces, and hoped that Col. Curren would be able to inspire greater interest in the Association there. Seeing that His Excellency, the Officer Commanding, and the Minister of Militia, had found time to be present on this occasion, he thought the Artillery officers generally might be aroused to the necessity of devoting one day in the year to the business of the Association. He called upon the press to make a note of this—if indeed General Herbert would not issue a General Order on the subject. (Laughter,)

The meeting then adjourned,

A. Moren, R.A.; Capt. F. M. Gaudet, Regt. C.A.; E. T. Gilmore; B. H. Fraser; H. A. Panet, C.E.; G. A. Hamilton; J. A. Gunn; Lieut. Burstall, Regt. C A.; J. F. Johnstone.

VanStraubenzee; Secretary-Treasurer, Capt. E. F. Wurtele, 8th Rifles; Committee, Messrs. Macpherson, Denison, Cochrane, Leonard, D. C. Campbell. Votes of thanks to retiring officere were passed.

THE DINNER.

The annual dinner took place in the dining room of the British American, where a sumptuous repast had been provided in Mr. Dunham's best style.

The list of invited guests was as follows: Hop. Mackenzie Bowell, Minister of Militia and Defence; Col. C. E. Panet, Deputy Minister; Major-General Ivor Herbert, C.B., Commanding the Militia; Capt. E. Streatfeild, A.D.C.; Col. Walker Powell, Adjutant General; Lt. Col. B. VanStraubenzee, D.A.G.; the Commandant and Staff of the Royal Muitary College; Lt.-Col. Cotton, Regt. The toast list was: "The Queen," "Army and Navy," "Royal Military College, "Royal Military College Club," "Our Guests," "The Press," "The Ladies."

The health of the Queen having been drunk, Capt. Denison rose to propose the toast of the "Army and Navy." In a few words he commented upon the pleasure he experienced in seeing so many distinguished friends of the college present, especially the commandant, Gen. Cameron. Coupled with this toast were the names of Col. Cotton and Capt Husskis-

Col. Cotton, replying for the Canadian Militia, said that he had always taken the greatest interest in the Royal Military College, having known cadets the time of its foundation, and meeting them in the remotest parts of the country. Undoubtedly the day was not far distant when graduates of the R. M. C. would occupy foremost places in the Dominion.

Capt. Husskisson replied briefly for the ' Army.

On behalf of the "Dead Marines" Capt.

Gaudet replied for the Navy.

The next toast was that of "The Royal Military College." Major Gen. Cameron, on rising to reply, was received with great applause. He expressed great pleasure in meeting so many ex-cadets, and had the most sanguine hopes for the future of the college. Nevertheless, some things required to be remedied, and he thought that greater encouragement should be given to graduates of the college by the granting of more than four commissions in the Imperial service, and especially by our own

Government, who should not fail to secure the services of highly trained cadets for our own permanent force, and in the civil service. This statement was loudly applauded. The speaker also thought that some modification might be made in the college course. The graduates of the college have distinguished themselves all over the world, and proved themselves worthy of occupying the highest posts. It was the daty of the ex-cadets to watch jealously over the welfare of the college, and assist in upholding the high position attained by that institution. The highest authorities in England agree in saying that the college course is superior theoretically and practically to that of Woolwich and Sandhurst. This is proved by the fact that young officers, who enter the Royal Engineers, invariably pass through Chatham in a shorter space of time than their Woolwich brethren. The General stated that he was of opinion that all staff appointments in Canada should be given to graduates of the Royal Military College. In support of his argument he would refer his hearers to the last paragraph in the regulations for the R.M.C., which although it had the force of an order in council, still was ignored entirely and was practically a dead letter. In conclusion, the General regretted that he could not, for various reasons, accept the honour tendered him of becoming honorary president of the club, and after thanking the members of the club for the courtesy done him he retired amid great applause.

Lt -Col. McGill, the genial staff adjutant of the R.M.C., was the next speaker, and by his bright and witty remarks kept the whole room in fits of laughter. He also furnished some valuable and interesting statistics in reference to the college.

Battalion Sergt.-Major Dumble said that all the cadets manifested the greatest interest in the club, and maintained in a neat little speech that he did not agree with those who said that the college was ! going down. On the contrary he thought the college was making great progress in the right direction.

Doctor R. T. Walkem, Q.C., proposed ! the toast of "The Royal Military College Club." He said that he had followed closely the career of the college since its foundation, sixteen years ago. It had been his privilege to know intimately the founder, a man who was universally esteemed by those who knew him, and the fruits of his labours were visible in the achievements of the graduates of the R. M. C., and the high position occupied by: that institution. A great point in favour of the method of instruction at the college was that it caused cadets to form habits of self-reliance, which were simply | invaluable to them in after life. It was juty, calling attention to the fact that in our duty to endeavour to retain in the country as many of the cadets as possible, and not allow them to drift towards the republic to the south of us. The 9th Battalion commenced their annual training on Monday evening the 14th instant.




