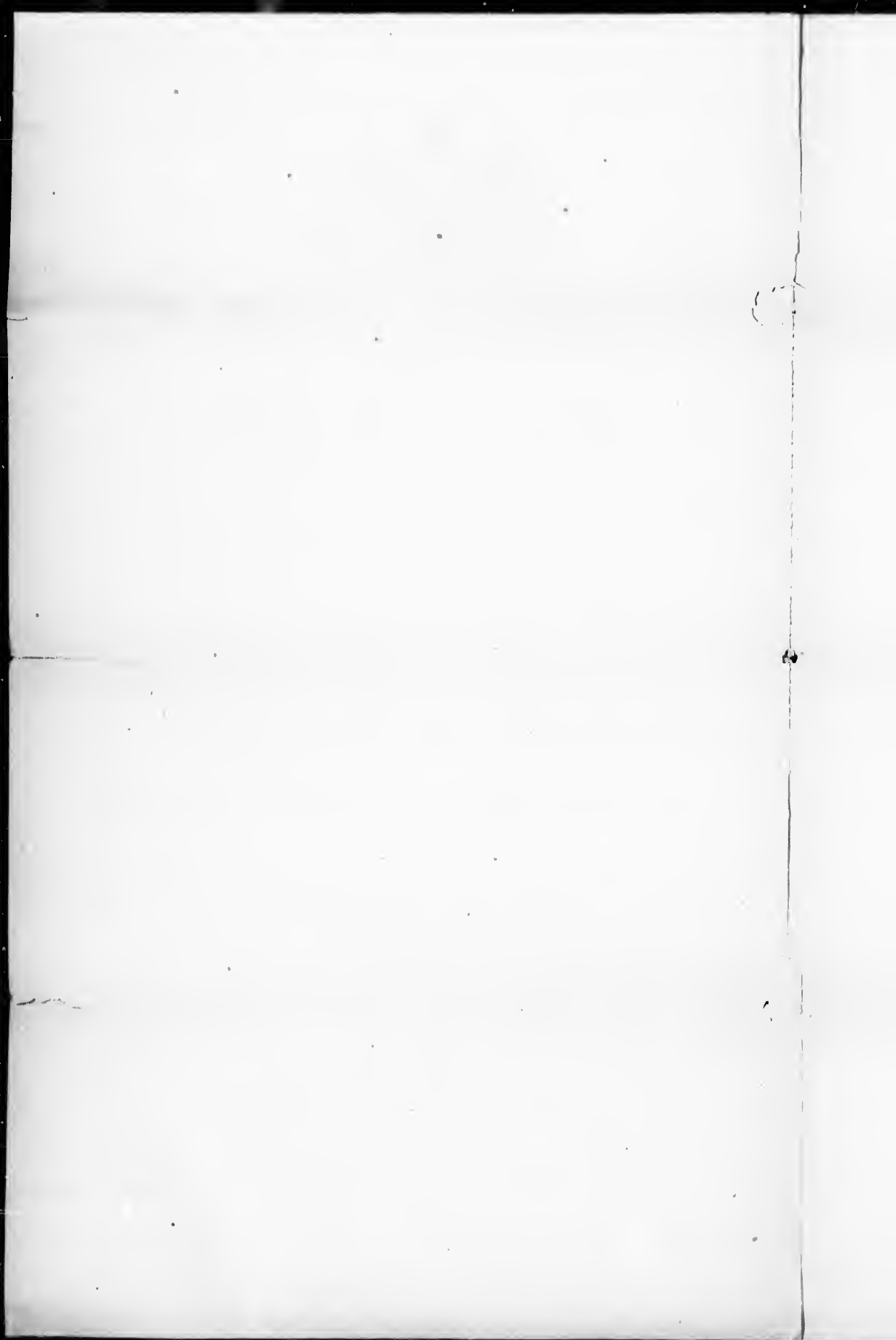
JUDGE'S CERTIFICATE.
