An English view of the Lobster Question.

The London Standard of 18th ult., in an article based on the fact that a few live lobsters were recently shipped from Miramichi to England by the S. S. Clifton (and which, by the way, died before reaching their destination) furnishes an illustration of the ingenuity with which a leading London journal can look up long and not uninteresting legends when there is a dearth of the exciting and absorbing subjects in which the average English reader is interested. The opening sentence of the article is pregnant with the great ideas of almost every English undertaking—

of British trade interests. It is as follows:— "Should an experiment be presented to the Government in the form of a bill for the purpose of introducing a trade in lobsters from Miramichi to England, it would be a most important one, and one which would be likely to have a profound effect on the trade of the country." The next bit of information furnished is that every year between six and seven million tins—each containing three or four lobsters—are sent to Great Britain and the United States at a profit of \$5,000,000, which profit would be vastly increased if the crustacean could be carried across the Atlantic alive. As we all know, the tin referred to is a 1 lb. tin, and it is filled them with the lobster preservers in boxes of forty-eight each; and it will be refreshing to those honest and hard-working toilers along our coast to know that there is, at least, one able writer in England who believes that they have a right to be so treated. The siding was not long enough for this working train and the freight train, and two or three cars of the latter—coal laden, we believe—struck the main line, when driver Dalton's train came up at a lively rate. He appears to have seen his danger, as he whistled for brakes and the men in his train had put on less than eight on, when his engine crashed into one of the projecting cars of the other train, left the rails and capsized. Poor Dalton, no doubt, jumped from the front of his engine, as it was natural for him to do, but he was struck on the back of his head which was crushed and the tender fell upon him, holding him down, breaking his body in two. His trunk, McMillan, was also found on the same side with one foot caught between the engine and tender, but otherwise unharmed.
