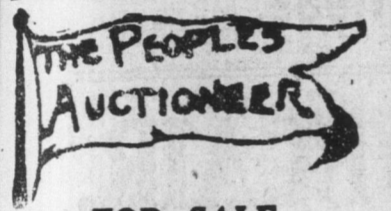

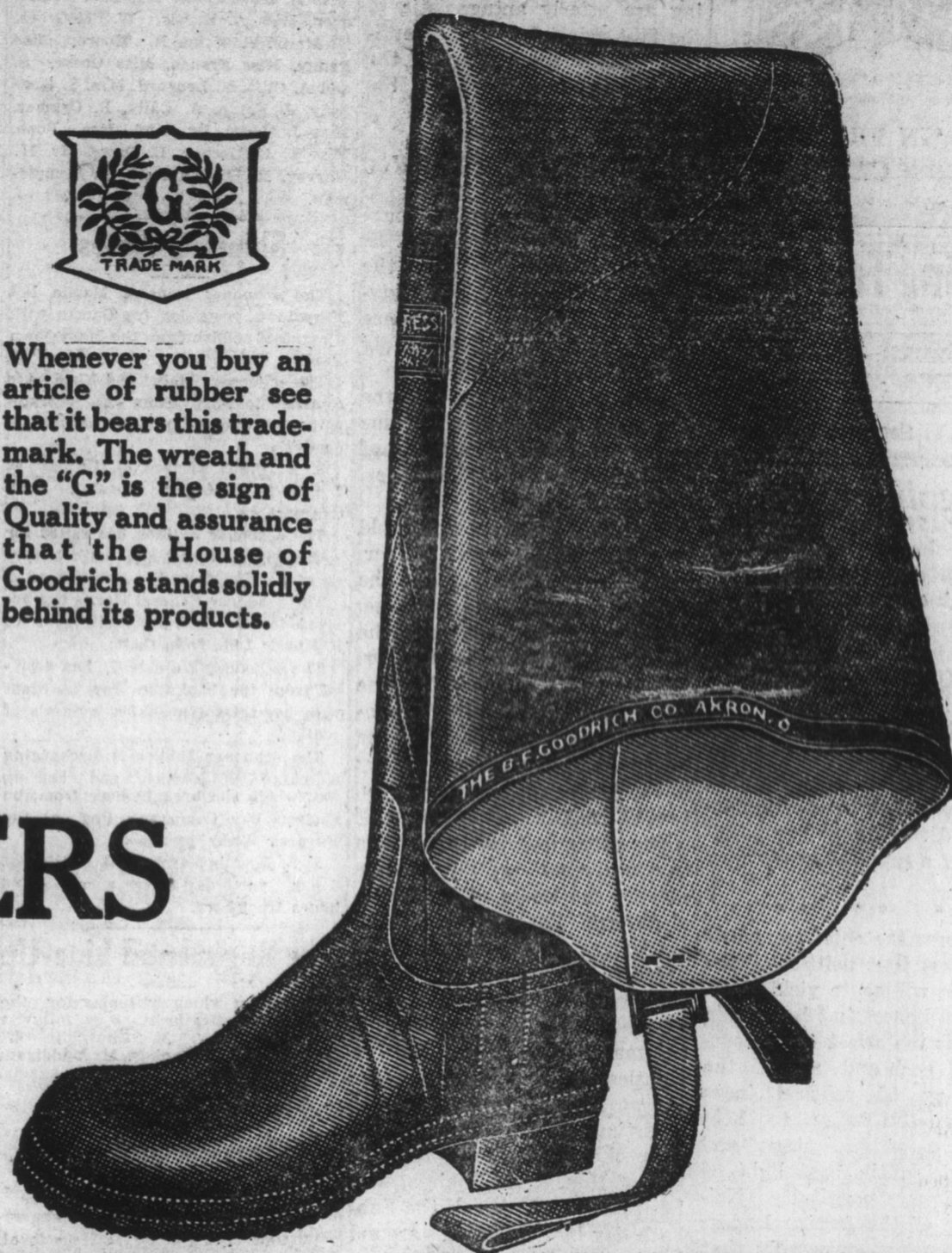

Keeping Apart.

The various factions expressing hostility toward the Government each of which styles itself the Opposition, are obviously having a hard time of it to keep apart. The force of mutual attraction is drawing them together, but diplomacy requires that, publicly, at least, there shall be no evidence offered that negotiations are being pursued, and that there are possibilities of a rapprochement very shortly.

Of course the chief trouble is in the fact that neither of the leaders is willing to yield place. The little honor that leadership confers is too sweet to be surrendered, each and all of the new orders of political incas possessing the desire to hold the centre of the stage and stand within the spot light of an imaginary popularity. Neither one of the faction leaders will give way,—outwardly that is,—but within the inner circle, where only the chosen few are admitted, and then only after strict trial, there are secret sessions and conferences, which if consummated have no other object but to bring disaster and ruin to Newfoundland, and place and pay to hungry office seekers and hangers on.

Mystery abounds within the closed doors of these meetings, and leaders are flirting with each other in order to gain time. That there is no cohesion between the two factions of the Opposition party already with leaders, and the leader of a prospective third who has not yet succeeded in rallying to his standard any following worth while, is testimony for the people of this dominion to consider. All three aspirants for the Premiership are big, strong, men in every way, but not one of them has developed that high courage which is the true test of the man who is desirous of serving his country honestly and capably. All that can be said of them is that they long for the "flesh pots" of which they have been deprived for so long and their slogan "The Crafters Must Go," is camouflage pure and simple, the same being to conceal their own rapacity and to hoodwink the people by their outward show of honesty and sincerity. They wear the broad phylacteries of the Pharisee and make long political prayers in the market places, their desire being to become known of men, disguising their ravening wolf shapes in the garb of political virtues.

At last night's meeting of the Squires party in the Casino Theatre, this was very much impressed on the majority of those who went there. The galaxy of speakers all metaphorically thanked God "that they were not as other men," thus exposing their hypocrisy and unfitness for the gift of the confidence of the people in the coming election. The "Public Endorsement" headline in the Morning Post is but another instance of the spirit displayed. If Public Endorsement means

no more than that which occurred at the meeting last night, then the people of Newfoundland have not given that endorsement which is requisite and necessary for the leader of a brand new party, the present members and leader of which by political teaching and training are utterly antagonistic to the first principles of Liberalism. The keeping apart of the factions is all a part of the game being played.

Vicious Depravity.

The Post, this morning, published a letter from Dr. W. E. Jones, of Avondale, under the caption "Absolutely False," giving the same special prominence on its first page. The Daily News also gives publicity to a similar letter. A copy of the document appears in this issue of the Telegram, the original of which, autographed W. E. Jones, is on our office file.

No reference whatever would have been made to this letter, were it not for the fact that the Post, to suit a base purpose, has deliberately changed the word SUNDAY which is in Dr. Jones' communication in the News and also, as will be noticed, in that published in the Telegram to-day, and as appears in the typescript now before us, to SATURDAY. This misuse of a signed communication shows to what lengths the Post and its master, the leader of the Liberal-Reform Party, (save the mark) are prepared to go, in order to deceive and blindfold their readers, and the hypocrisy of the master, likewise that of the man, is so plain that a sightless man could perceive it. It was done for the purpose of diverting public condemnation from the canvassing propensities of Hon. R. A. Squires, who hesitates not to break the Sabbath day by careering around in his motor, hunting supporters for a cause which has failure stamped all over it. The present deception will put people wise to the character of the man guilty of it, and will not add anything to their protests of inadvertence, should they begin to make them.

Squires Opposition Party Opens Campaign.

GOOD ATTENDANCE AT CASINO.

At 8.30 last evening a meeting of the Squires Opposition headed by Hon. R. A. Squires, was begun in the Casino Theatre, a full house being present to hear the various speakers and exponents of the latest political doctrine. Mr. John Nangle acted as Chairman, and on the platform, besides the party leader, were H. J. Brownrigg, Dr. Campbell, P. J. Shea, Alex. Grouchy (Pouch Cove), D. O'Neill (Bay de Verde), S. Bursell (Topsail), G. Rendell (Manuels), M. Colford, J. M. Devine, J. T. Phillips, Mr. Parsons and another—fourteen in all. Hon. R. A. Squires spoke first, stating that he had interviewed Rt. Hon. Sir Robert Bond, who stated that he did not intend to enter politics this year. Later, at a meeting comprising 70 or 80 he (the speaker) had been elected leader of a party formed amongst themselves, to be known as the "Liberal Reform Party." Mr. Squires then went on to some length in referring to the condition of the railroad and stated that it would be one of the party's intentions to make the Reid Nfd. Co. live up to its contractual obligations. He then dealt with the matter of graft and profiteering, stating that the L. R. P. would also seek to end both. These two things, in fact, make up the main platform of the new party. The outports are waiting for the call, said he, and you must all rally round the Liberal (?) banner. Three cheers for the leader were then called for and given, without much enthusiasm, however.
Mr. J. M. Devine followed next, recovering the ground touched by the previous speaker. He asked to have the remarks of the evening taken seriously. It is to laugh.
Dr. Campbell spoke next, delivering a witty speech in which he referred to the formation of the old People's Party which he had supported but was now against. Dr. Campbell made some other references concerning politics, spending considerable time in attempting to ridicule the member for the West End, Hon. J. R. Bennett.
Mr. D. O'Neill, of Bay de Verde, followed, stating that he spoke as a follower of Hon. R. A. Squires, to whom, he said, he had pledged himself.
Mr. H. J. Brownrigg was called upon by the mass of the audience for a speech, after some hesitation complying. He spoke as a citizen and not as a politician nor an aspirant for political honor or emolument.
Mr. Alex. Grouchy, of Pouch Cove, spoke as a young man who was opposed to the Government and is supporting the L. R. P.
Mr. P. G. Butler also delivered a few remarks touching on educational matters, labor questions and others. After Mr. Squires had thanked the speakers and the National Anthem had been sung, the meeting dispersed.
The C.L.B. band was in attendance during the evening, rendering certain lively airs, and there was no heckling at all. A spirit of orderliness pervaded the proceedings, and the speeches having more or less of a personal bent did not receive that applause for which the speakers had hoped. Altogether the demonstration was not what had been expected and there is disappointment in the Reformers' camp tonight. The majority of those attending undoubtedly came not as supporters of this wing of the Opposition, but as auditors only, and it is safe to estimate that not more than one-third of the voters present either admire or will sponsor the newly-born political child of Hon. R. A. Squires.

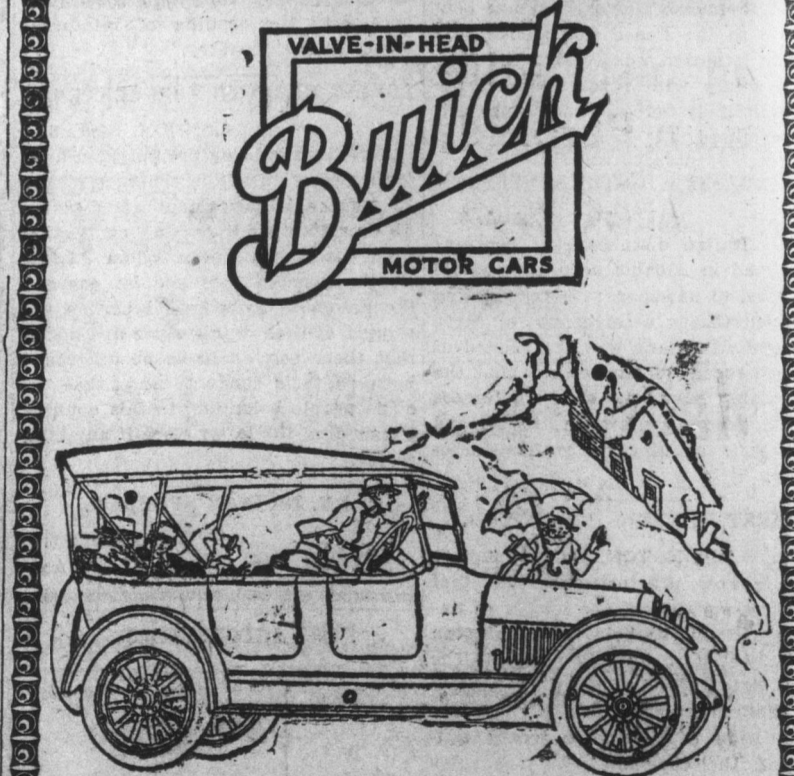

To-day's Messages.

BRITISH WILL LEAVE.

WASHINGTON, D. C., Sept. 8. The evacuation of Archangel by British forces has been expected here for some time. There is no information available, however, as to the disposition of the French, Italian and even Serbian forces, of whom at least accounts, there were a few remaining.

SENATORIAL DISCUSSION.

WASHINGTON, Sept. 3. Marked indication of a compromise in the Senate controversy over reservations to the League of Nations Convention came to-day from both democratic and republican sources, after republican leader Lodge had announced that the treaty would be reported to the Senate Wednesday, and probably taken up for consideration next Monday. Probably the most important development of the day was a statement to the Senate by Senator Simmons of North Carolina. Prominent in administration leadership, declaring "some concessions in the way of reservations will have to be made to secure its ratification," although "utterly" opposing some of the Lodge reservations, Senator Simmons said he was suggesting a compromise on "conservative reservations of an interpretative character."

FOR PASSENGER SERVICE.

NEW YORK, Sept. 8. With the arrival here to-day of the transport Leviathan, bringing home General Pershing and troops of the first division, the giant transport brought to a close her important service in helping win the war. According to information at the headquarters of the Troop and Transport Force in Hoboken, the big ship is now to be retired as a transport, and after being refitted for passenger service is to be turned back to the United States Shipping Board, the agency which seized her when the United States entered the war.

CLEARING NORTH SEA.

LONDON, Sept. 8. The North Sea will be cleared of mines before the rough autumn weather forces the mine-sweepers to quit work, according to a statement made to-day by a naval authority. Completion of the work this year had not been expected, a month ago, but the American mine-sweepers had far outstripped expectations, said the officer. Beginning with an average destruction of 200 mines daily, the Americans are now blowing up between 1,000 and 1,200.

MAKING RESTITUTION.

BERLIN, Sept. 8. Four hundred thousand German workers have volunteered for the work of restoration in Northern France, according to the Vorwaerts.

AND NOW IT'S COTTON.

WASHINGTON, Sept. 8. The lateness of the cotton crop, ranging generally from two weeks to more throughout the cotton belt, except where the plants are infected with boll weevil, has resulted in exceedingly small ginnings thus far this season, the census bureau announced to-day.

PROTECTING THE FIGHTERS.

SYDNEY, New South Wales, Sept. 8.—(Reuter's Ottawa Agency.)—The Government of New South Wales has introduced a bill, which has passed the first reading in the Legislative Assembly, compelling employers to reinstate employees who joined the forces at their pre-war or equally good positions, and makes it incumbent upon all employers, upon pain of heavy penalties, to employ returned soldiers before engaging others.

FORECASTS INCORRECT.

AUCKLAND, New Zealand, Sept. 9.—(Reuter's Ottawa Agency.)—Admiral Lord Jellicoe declares that the forecasts recently made of the contents of his report to the Commonwealth Government are quite incorrect.

WILL NEVER PERISH.

MELBOURNE, AUSTRALIA, Sept. 8.—(Reuter's Ottawa Agency.)—Premier Hughes in a speech here said Australia must have a Government that had a clear and direct mandate from the people. Referring to the General political outlook, he declared that whatever became of the other League of Nations, the League of the British Empire would never perish.

NEW ZEALAND'S PLAN.

WELLINGTON, New Zealand, Sept. 8.—(Reuter's Ottawa Agency.)—The House of Representatives has authorized the Government to borrow sixteen and a half million pounds sterling, to be used for the settlement of ex-service men in New Zealand. The interest of the loan will be free from income tax.

EMPIRE MUST PAY UP.

WELLINGTON, New Zealand, Sept. 8.—(Reuter's Ottawa Agency.)—Admiral Lord Jellicoe in an interview said that unless the people of the United Kingdom and the Dominions were prepared to put their hands in their pockets immediately, it would be impossible to retain British sea supremacy, which is vital to the existence of the Empire.

WANT BRITISH TO STAY.

LONDON, Sept. 8. The Archbishop of Canterbury has

received a despatch from Archangel signed by the Bishop and Clergy there, appealing to British Christians against the withdrawal of British troops, which they assert would leave Archangel to the horrors of Bolshevism.

MOB TAKES CHARGE.

LONDON, Sept. 9. Ferney, near Cork, was terrorized by a mob for an hour last evening, according to a despatch to the Exchange Telegraph Company. Fifty shops were damaged, one jewelry store being completely demolished. The loss is estimated at several thousand pounds sterling.

WANT MORE ASSURANCE.

PARIS, Sept. 9. The Supreme Council of the Peace Conference will to-day draft a note, to be sent to Germany, demanding the suppression of article sixty one of the German constitution, providing for Austrian representation in the German Parliament, according to newspapers here. It is stated that the Council considers the German answer to note of Council, relative to article sixty one, as insufficient.

NEW UNION STUNTS.

GLASGOW, Sept. 8. Among resolutions adopted to-day, by the Trades Union Congress, was one in favor of a policy of free trade. Another resolution pledges the Congress to support unionized actors in their efforts to unionize all British amusements.

CARDINAL MERCIER IN U. S.

NEW YORK, Sept. 9. Cardinal Mercier, Primate of Belgium, will reach New York to-day on the naval transport Northern Pacific. The Cardinal will be met down the bay by a committee, headed by Archbishop Hayes and there will also be a committee from Baltimore, representing Cardinal Gibbons. Cardinal Mercier will spend the night at the residence of Archbishop Hayes, and will leave to-morrow for Baltimore to spend a week with Cardinal Gibbons.

Sagona's Report.

S. S. Sagona arrived at St. Anthony at 3.30 o'clock this morning and the captain wired the Reid Nfd. Co. the following report:

"From Hopedale to Capé Harrison, fishery good; from there to Emily Hr., little improvement; Emily Hr. very poor; Pack's Hr. to Black Island, doing fair for past week; Indian Tackle to Bateau, good fishing with traps; also took line; Sandy Island to Square Island, nothing doing; Square Island to Battle Harbor, boats getting 2 to 4 qts. daily, hook and line. Hawke's Harbor, fishing steamer there has captured to date 41 whales."

Helpless.

The taxpayer is handicapped. It is difficult to unionize him. The great trouble is the lack of a common interest among enough men. In the abstract it is of course desirable to all men that taxes be kept down and that public money be wisely spent. In the concrete, so many other things enter in that this common bond fails to have its due weight. It is almost always outstripped by the eager interest which special beneficiaries find in the misuse of what money others contribute. Capital with its axe to grind, or labor with its payroll to fatten, has a more vital concern and acts with the greater vigor. The poor abused public merely groans and talks. It doesn't do anything.—Lowell Courier-Citizen.

Side Talks by Ruth Cameron

TEACHING CHILDREN TO HAVE "NERVES."

I don't suppose any thinking person in these days questions the theory that suggestion and auto-suggestion have a great deal to do with the development of our likes and dislikes, our habits, and, ultimately, with our character.

Why is it, then, that so many people will discuss a child in front of him in a way that cannot help giving him harmful suggestions?

For instance, I heard a little boy's mother give a long dissertation on his dislike of several kinds of fruit, at the table in his hearing. He didn't like bananas, she said, or strawberries, and lately he had even taken a dislike to pineapple which he used to eat. She thought he got it from his father's father who seldom ate fruit. "Queer how it should skip a generation—his father was very fond of fruit."

The next day there was ice cream which the little boy was eating with evident relish when some one happened to mention that it had pineapple in it. Immediately he stopped eating it and refused to eat any more. Just like his Grandfather Bartlett, said his mother.

I should place the blame much nearer home than that. And not on his father's side of the family either.

The Way the Modern Child is Encouraged to Pick and Choose!

The way the modern child is encouraged to like this and dislike that, and pick and choose what he will have and what he won't have, and change his mind and pick at his food, is certainly some contrast to the way children of two generations ago were told to eat what they were given and say nothing and be thankful that they had good food and a comfortable home.

Another example of harmful suggestion is the habit of talking in his presence about how nervous a child is. A child shouldn't know what nerves are, much less be given the idea that he has them.

"High strung" is another word which a child, hearing used of him, is quick to get the idea of—and if he is at all quick (which, presumably, he is, or he wouldn't have that adjective applied to him) to make good use of. Why try to control a fit of temper when yielding to it only proves that you are high strung?

She Ought Not to Question Their Sleeping Well. In a home in which a friend of mine sometimes visits, she says the mother (who is a light sleeper) always asks each child in the morning how he slept. And each one gravely answers "Pretty well" or "I had a bad dream" or something like that. Now just fancy a mother encouraging children to think that they would sleep other than well. Unique Salvage. CYLINDRICAL RAFT PICKED UP. Some fishermen belonging to Cape LaHue, in the district of Burgeo and LaPelle, saw a strange object floating on the surface a few weeks ago, when out on the fishing grounds. Pulling alongside it they discovered the derelict to be a pontoon raft, constructed by banding three 18 inch cylinders together, the outer tubes being closed and air tight, the centre one open at both ends to admit the water acting therefore as a stabiliser. The length of this raft or dockyard floating stage is about 80 feet and it has towing buffers at both ends, the after end one being constructed after the manner of a shock absorber with large spiral springs. The forward end compartment has no springs. A running board made of plank 3 inches thick and ten wide ran up and down both outer cylinders on top, while in the centre were uprights for the purpose of holding chains or life ropes. In the forward end the towing bollard held a shackle which had opened, and it is presumed that this queer craft was being towed by some steamer when the strain caused the shackle to open and the raft and the towing cable parted company. The probabilities are that this occurred in the night or during a heavy sea when no effort at recovery could be made. The raft or floating stage is painted dockyard red and has no identification marks whatever, neither could a close examination reveal anything more about it. At the time when picked up, an unlighted lantern was found hanging to a cross arm on a scantling upright about four feet in height, which was erected on the after end. The lantern and the opened towing link is conclusive proof that the structure was being towed by a steamer. The find was reported to the authorities at Burgeo, but whether anything of its ownership has been heard could not be ascertained. No report of such a loss, so far as could be learned, had been made by the Canadian Marine Authorities, and the mystery of identity has yet to be solved. The salvaging should be a valuable one for the lucky finder, as the cost of this marine structure must have been considerable.

How Detectives Catch Murderers.

The Wonderful Resources of Scotland Yard.

The number of murders in the country which have remained unsolved lately has made the authorities realize that unless an expert is called in at once, many a murder may remain unsolved through lack of training on the part of the local police.

The famous detectives of Scotland Yard, who of course have many murders to deal with each year, and are the greatest experts in tracking criminals in the world, have had no right up to the present to investigate a big murder in Sheffield, for instance. They are only called in by the local police when the latter are baffled, and that is often weeks after the murder has been committed, and valuable clues and time have been lost.

Now, however, in all cases which are likely to be complicated, a Scotland Yard man will be on the spot at once, and fewer murders than ever will escape the scaffold.

The real detective and the detective of fiction are as like one another as chalk and cheese. The Scotland Yard expert relies upon hard work and organization. The Criminal Investigation Department, in fact, is so successful in the great majority of cases it handles, because it is organized just the same way as a big business is organized.

Scotland Yard's Black Museum.

There are close on seven hundred detectives attached to Scotland Yard, and each man is trained and taught the ins and outs of criminals and their methods. Many of these detectives, of course, specialise, some on jewel robberies, others on murders, others on pocket picking, and so on, but each one is prepared in an emergency to tackle any job which comes along.

To Scotland Yard there is always available a number of experts who give advice on any subject wanted, experts in handwriting, in wounds, poisons, ink, and even tobacco ashes.

All the big police stations are linked up by private telephones, as well as by a private tape machine. Every man in the detective force is specially picked and tested before being put in charge of even the smallest crime.

Every one has some special accomplishment, most of them know at least one foreign language, and all have to pass severe examinations for promotion.

Part of the most useful training of a detective is that in which he visits the Black Museum, that grim private exhibition at Scotland Yard, where can be seen the instruments which have been used in big burglaries, the tiny clues which have brought murderers to the gallows, and the thousand and one things which reveal the methods of criminals of all countries.

ments of finger prints, and in a glass case a black mask. They are the clues which brought the brothers Stratton to the scaffold in 1905 for the murder of an old couple at Deptford.

In a glass case are shown forged notes, coiners' implements and spurious coins, and plaster moulds, and in other parts of the museum are firearms and other weapons, all of which have some grim tale of violence associated with them.

Each of these exhibits is an object lesson in itself to the budding detective, and each helps him to realize how the famous detectives of former days worked on their cases and brought their men to book.

Detectives Don't Often Fall. Attached to the Yard is a special staff of expert photographers always on duty. When any big murder is committed one of these experts is sent to the scene of the crime, and photographs are taken of the room or place in which it was committed from various angles, and from these photographs, when necessary, a model is constructed for use at the trial, or to help the detectives engaged on the case to reconstruct the actual murder.

Finger print experts carefully examine any weapon used by the murderer, or anything he is likely to have handled, from glasses to door knobs, in order to find his finger prints. The history of the dead man and the movements of all his associates are investigated by a few trained experts in an extraordinarily short time. Often in a few hours what seems an utterly baffling mystery is well on the way to solution when the reports from the various detectives are handed in and pieced together by the detective in charge of the case.

Capt. Kean's Defence.

LETTER TO ST. BARBE ELECTORS.

Dear Sir,—The latest piece of knavery in the Evening Advocate of the 2nd inst., affords me an opportunity of sending broadcast in the district of St. Barbe an open letter to defend myself against the oft repeated slanders of W. F. Coaker to saddle the name of the Newfoundland disaster on me. To lend strength to his argument he makes it appear that I was tried and condemned by the Supreme Court. Nothing is further from the truth, as I shall show before I am through.

On three different occasions I went to Court against W. F. Coaker for certain false and libelous charges which he made against me, and in each case a verdict was given in my favor by twelve jurymen of my country. The first charge was made on April 21st, 1915, which contained the following: "When I was master of the 'Wolf' some twenty years before that date, I took out of that ship two barrels of pork and replaced it by two barrels of beef, which came from a starving Government bull." On the 22nd of April, 1914, Capt. Abraham Kean began a libel action in respect of these words, alleging that they accused him of dishonesty. A defence was in due course placed on

file, and it was expected that the action would be tried next month, but the parties have agreed upon a settlement. The defendants have caused very careful enquiry to be made into the statement upon which the defamatory statement was based, and in consequence have been convinced that there is no evidence whatever to support the words complained of. The Mail and Advocate feels compelled, therefore, to express its sincere regret that the language referred to should have been allowed publication through its columns.

"Draft-Without Prejudice, January 23, 1915."

Another charge was the following: "Why did Capt. A. Kean lead the country to believe that he was telling the truth when he knew he had doctored a message in order to mislead the public?" I promptly brought an action for libel, and a verdict was given in my favor for eighteen hundred dollars. Coaker appealed, and the fine was reduced to one hundred dollars, but in every case judgment was in my favor, and the lie was given to Coaker. The following is the apology from W. F. Coaker: "In the Advocate on April 25th last, reference was made to evidence given by Capt. A. Kean and the wireless operator on the Florizel. The latter swore that, at the request of Capt. Joe Kean he sent a message to Capt. A. Kean on the Stephano, asking the latter to look out for the Florizel's crew and the Newfoundland. Capt. A. Kean said that the message he received read: 'Look after our men and I will take care of yours.' The Psalmist said: 'In my haste I said all men are liars.' In its haste and excitement the Advocate said, 'Why did Capt. A. Kean lead the country to believe he was telling the truth when he knew he had doctored a message in order to mislead the public.' The captain promptly brought an action for libel, but it has been decided to settle the matter amicably with an explanation and expression of regret on behalf of the Advocate. The wireless operator having kept no written record may not have sent the message as he believed he did. For the same reason, Capt. A. Kean may not remember the message as he got it, or his own operator may have given him the message just as he says he received it. In any case, it was not fair comment for the Advocate to assume that wilful deception was practiced by Capt. A. Kean, and, therefore, sincere regret is expressed on behalf of the Advocate, for which it can only be said that it erred through excitement and not with intent to defame Capt. A. Kean.

Mr. Coaker is made to say in the last words of this apology: "Sincere regret is expressed on behalf of the Advocate for which it can only be said that it erred through excitement and not with any intent to defame Capt. A. Kean." But where is the room for excitement to-day? Where is the connecting link between the Newfoundland disaster and my offering my services to the people of St. Barbe, as their representative? I have been in public life off and on for over thirty years, and the bare fact that Coaker can find nothing to

say against me but the sealing disaster is a good recommendation for the people of St. Barbe so far as my public record is concerned. For it is to be hoped that there is no other man so insane outside of a Lunatic Asylum, and no man so villainous outside of the Penitentiary who will stoop to such despicable conduct towards another as that contained in the Advocate against me.

Now in order to lend weight to his remarks, he says that I was found guilty of a grave error of judgment by the Judges of the Supreme Court. Now, Sir, what are the facts of the case. I was tried by a commission, which commission consisted of the three Judges of the Supreme Court, but they had to be governed by the evidence before them, and it is only fair to say that those three Judges did not agree, but Judge Johnson, differed from the other two, and brought in a minority report in which he entirely exonerated me from all blame.

And right here I think it is in order for me to give the opinion of W. F. Coaker upon the competency of the tribunal that tried this case. Here is what he said in the Mail and Advocate on October the 23rd, 1914. "Now we have every respect for the three Judges of the Supreme Court, but we unhesitatingly state in no way would such a commission be qualified to deal with this matter." So I would like for the people of St. Barbe to note that according to Mr. Coaker's showing that the verdict given by that commission that I made a grave error, was made by men unqualified to give an opinion. And to show how earnest he was about the unqualification, in the very next paragraph he says: "We therefore take this opportunity to inform the Premier that the F.P.U. will take no part in such an enquiry, nor will the fishermen come forward in any way to give information; if the matter is to be dealt with by the three Judges of the Supreme Court or any other Court."

But did Coaker stick to his word? Of course he didn't. Did the F.P.U. take part before the tribunal? Of course they did, and Coaker proved himself just as vacillating in that as he has in every other statement that he has made ever since he became prominent in public life. No name suits him better than Wobbling William. He is just the opposite one day of what he was the day before. The only thing he is consistent in is his abuse, but even in that he sometimes forgets himself, for I have here before me an extract of his journal kept on board of the S.S. Nascopie, in 1914. And here is what he says of myself: "From my observation closely taken I am of the opinion that every Captain closely watches the movements and actions of Captain Abraham Kean. I don't believe any Captain is content when he is not in a position to know or judge what Captain Abram is doing. I state this not because I have any kindly feeling towards Capt. Abram, but because I wish to give all concerned in this narrative their proper due."

Now, Sir, I would like to ask the people of St. Barbe to consider the remarks of W. F. Coaker concerning the rest of the sealing masters and myself if such a statement is true. Why are the rest of the sealing captains uneasy if they are not in the seals and in the hands of them? Because they know that I am a man of strong convictions, that I always steer my own course. What sort of a man do the people of St. Barbe want to represent them? Why a strong man, a man of conviction, who will look after them and cannot easily be brow-beaten. I trust I can fill the bill.

In conclusion, Sir, someone once said, "Oh that mine enemy would write a book," his belief, of course, being that there would be sufficient expression of opinion regarding persons and things in it to damn the author for ever. The leader of the F.P.U. has not written a book, but he has scribbled a bit in his time, and unfortunately he has never stopped to consider his expressions or to reflect that perhaps sometimes they may be quoted against him. The result is endless trouble for himself and many uncomfortable moments for those whom in his anger he anathematized, but now seeks to use.

So far as I am concerned, I would wish to run this campaign, having regard to the needs of the hour, rather than abuse of parties or individuals, but if my opponents are not satisfied to run it on these lines, and descend to abuse, they will have to learn the lesson that when neither kind words or gentle means will not reclaim the wicked, they must be dealt with in a more severe manner.
