

In accordance with the provision of the Constitution, the rules and regulations for the government of Grand Lodge at its sessions were read by the Grand Secretary.

The minutes of the Funeral Emergent Communication of Grand Lodge, held on the fifteenth day of July, 1876, (5876,) were read and confirmed.

The Grand Secretary was proceeding to read the minutes of the last Annual Communication, 27th and 28th September, 1876, (5876) when it was moved by R. W. Bro. Judge, seconded by R. W. Bro. Chisholm,—

That, inasmuch as the minutes of the proceedings of this Grand Lodge, held in the month of September, 1876, have been printed and distributed to the different subordinate Lodges under this jurisdiction, the same be held as read;

That the notice of motion given at the last meeting of this Grand Lodge by Wor. Bro. Woodford, of which the tollowing is a copy, viz. :

"That no Mason shall belong to more than one lodge at the same time "(except he be an honorary member, as provided for by the Constitution); "this, however, not to apply to brethren who are members of more than "one lodge at the time of passing this resolution;

"Any member of a lodge wishing to affiliate with another lodge must "present his application in the usual form, and if his application be ac-"cepted in said lodge, his membership shall remain in abeyance until his "demit from the former lodge to which he belonged is surrendered to the "last mentioned lodge, when he shall become a full member;"

Having been accidentally omitted in said printed report, the same be received and considered as part of the said minutes, and that the said minutes, as so amended, be and they are hereby confirmed.

The motion was put to Grand Lodge and adopted, *nem. con.* The Grand Secretary distributed to members of Grand Lodge in printed form the following correspondence, had with the Grand Lodge of Scotland :—

## To the Most Worshipful the Grand Lodge of Ancient, Free and Accepted Masons of the Province of Quebec :

BRETHREN,-Assembled at the eighth annual communication, you will all be glad to be informed of the growth in numbers and financial prosperity of this Grand Lodge. The Dominion, of which our jurisdiction forms part, this year celebrated the first decade of its existence, and when we shall be able to mark a similar period in our masonic history as a separate and distinct Province, the Craft will no doubt have equal cause of thankfulness for its share in the general success.

The increase of Freemasonry during the past few years has been very remarkable, and particularly in the United Kingdom, where, according to recent authority, it has been computed that nearly one out of every four or five men of the upper and middle classes is a Mason. The Grand Lodge of England has now three Princes occupying the three first chairs,-the Prince of Wales being Grand Master, the Duke of Connaught Senior Grand Warden, and Prince Leopold Junior Grand Warden.

In the month of May last the gratifying intelligence was received that at their previous quarterly communication, held at Edinburgh, the Grand Lodge of Scotland unanimously resolved to open fraternal relations with the Grand Lodge of Quebec. Regarding this resolution as extending to our Grand Lodge the recognition we asked for in the early part of the year, as a legally constituted and established Grand Lodge, having and exercising supreme Masonic jurisdiction in and over the Province of Que-bec, I cheerfully acquiesced in the suggestion, by the Grand Lodge of Scotland, of the name of Brother Robert Wylie, of Mother Kilwinning Lodge, as representative of this Grand Lodge near the Grand Lodge of Scotland; and Sir Michael Robert Shaw Stewart, Baronet, Most Worshipful Grand Master of Scotland, has honored me with a commission appointing me to be the representative in this Province of his Grand Lodge. The correspondence on the subject of this important recognition has been printed, and will be submitted for your consideration.

A copy of the proceedings of this Grand Lodge, at its seventh annual communication, was forwarded in February last to the Grand Lodge of England, but no action seems to have been taken with reference to the question raised by your resolutions.

Neither has the Grand Lodge of Missouri as yet receded from the position it assumed towards us, though I have every reason to believe that if Brother Gouley, the well-known Secretary of that Grand Lodge, who lost his life at the destruction by fire of the Southern Hotel, at St. Louis, had been spared, he would have endeavored to have secured for us a fair and satisfactory settlement, if not the full advantages of the North American doctrine as to exclusive jurisdiction.

Repeated inquiries having been made as to the attitude of this Grand Lodge towards the so-called "Grand Lodge of Ontario" and its members. I deemed it necessary to interdict all intercourse or masonic communication with the lodges under that organization, and the several members thereof, until you shall have taken action in the premises. This imperative step was justified by the proceedings of the Grand Lodge of Canada, at its 21st annual communication, officially brought under my notice, and I could not but respect its sentence of expulsion, pending your decision. A similar course was adopted by the Grand Lodge of Canada, Michigan, Louisiana and other States. I am not aware that the doctrine contended for by the so-called "Grand Lodge of Ontario" has been admitted by any regular body of Masons, nor that it has had recognition extended to it by any other Grand Lodge than that of Texas, which was soon withdrawn. The proceedings of the Grand Lodge of Canada will be laid before you, with a copy of my circular.

A petition for recognition has been received from the Grand Lodge of Cuba, already recognized by the Grand Lodges of several States. It will engage your attention, together with an application for information as to the establishment of a new Grand Lodge at  $\aleph_y$ dney, New South Wales.

For the relief of members of the craft who were sufferers by the great fire at St. John, New Brunswick, I caused \$200 to be promptly forwarded, and I rely upon the Grand Lodge to confirm the grant. I also authorized the issue of a circular to each subordinate. Lodge, soliciting pecuniary aid for our unfortunate brethren in that city, who have lost their library and nearly all the contents of the office of the Grand Sceretary. As Freemasonry is nothing without charity, I feel I have but to remind you of the calamity which has befallen our brethren in the sister Province to awaken your further sympathy and substantial assistance, if needed.

During my term of office I learned with regret that R. W. Bro. Edgar had resigned his position as Representative of the Grand Lodge of New York near the Grand Lodge of Quebec, and I had much pleasure in suggesting R. W. Bro. Tait, Deputy Grand Master, as his successor. I have given a commission to R. W. Bro. Calvin G. Shaw as our Grand Representative near the Grand Lodge of Dakota, and that Grand Lodge has named W. Bro. F. Sowden as its Representative here.

The Grand Lodge of Canada at its last meeting passed resolutions :--1. That the bequest of the late Bro. Edward Moss towards the erection of a Freemasons' Widow and Orphan Asylum, should be drawn and paid over to this Grand Lodge; and, 2nd That the amounts contributed to the Asylum Fund by the Lodges in this Province, then holding warrants from the Grand Lodge of Canada, should, with interest, be placed to their credit respectively. This honorable mode of dealing with both those benevolences cannot but meet with your admiration, and deserves, as it will doubtless secure, your warmest thanks.

I have granted disponsations for the establishment of three new Lodges : Rouville Lodge at Bougement, Onslow Lodge at Onslow, and Corinthian Lodge at Montreal. Before granting the praver of the applicants for Corinthian Lodge, I requested and obtained the repeated and unqualified recommendation of the R. W. District Deputy Grand Master of the Montreal District. If, by the reports to be submitted, it will be found that these Lodges are working well, and that it can be shown they will be of benefit to the craft generally, I recommend that charters be granted to them.

The Committee on Numbering Lodges made its report to the Board of General Purposes at the semi-annual meeting in March last, and the same will come before you for confirmation.

The proposed amalgamation of Lodges has succeeded in some instances I commend the subject to your further attention. only.

Among the notices of motion given for this Communication, is one to provide for the establishment of the office of Grand Lecturer. The requisite amendments to the Constitution have been prepared, and will be submitted to you.

To carry out the resolution of the Grand Lodge, "That it is expedient that so far as practicable the same ritual should be followed in the different Lodges under the jurisdiction of this Grand Lodge, and to that end the Grand Master be respectfully requested to appoint a Special Commit-tee to enquire into the matter and report thereon to the Grand Lodge at its next regular Communication." I appointed M, W. Bro, Graham, E, W. Bro. Bull, and V. W. Bro. Hobart Butler, whose report will merit your serious consideration.

I also desire to hear read the reports of the Committees on the Masonic Temple, forms and jurisprudence, &c.

As this Grand Lodge has had no report on foreign correspondence for some time, owing to the removal from Montreal of the Brother who had undertaken that duty, I cannot too strongly urge the desirability of having such a report, and I shall be glad if the Grand Lodge will procure the necessary outlay to secure it without delay.

The obituary for the year includes the names of W. Bro. T. G. Farmer, a well-known member of the craft in the District of Three Rivers, and three times W. Master of Milton Lodge; V. W. Bro. G. L. Kemp, of Pre-vost Lodge; Brother Colquboun, Past Grand Tyler; Bro. E. K. Patton, M.D., of Royal Albert Lodge; Bro. J. Gibson, Past Master of Montreal Kilwinning Lodge; Bro. G. Lynch, Senior Warden of Montreal Kilwinning Lodge, who lost his life at the St. Urbain street fire in Montreal, and W. Bro. Kemp, Past Master of Prevost Lodge.

Graham, in his address last year, so ably and elaborately expounded the principles of our craft that I need not refer to them further than to repeat that we do not allow any political or reli-gious question ever to intrude itself; that (to use the words of one of our beantiful public services), " we have proper respect to the established customs of the country in which we live; we have due deference for our superiors in Church and State, and unlimited good will to all man-kind. We publicly express our perfect submission to the laws of the lend, our unceasing devotion to peace and order, and our ardent desire, as far as in our power, to promote the welfare of our fellow men." You are thoroughly conversant with our tenets, and the rules that govern the Craft, under the British Constitution, and wherever masonry is rightly understood and properly practised; you know how excellent are the pre-cepts, how perfect the doctrines of our ancient and widely-spread institu-tion, and that he who is a really good meson cannot be a bad citizen. In retiring from office, after two years service as Grand Master and here years as Deputy Grand Master, I cannot but express to Grand Lodge my most sincere thanks for the honore conferred upon me, and for the assistance given me especially by the venerable Grand Secretary, whom I shall long remember after our official intercourse has ceased, for his kind

and invaluable support. The Grand Lodge of Quebec, at whose foundation I was proud to assist eight years ago, is now too firmly established to need further help from any one individual, but rest assured it has no more ardent well-wisher than myself. May it go on and prosper.

Grand Lodge was then called from labor to refreshment, to re-assemble at 2.30 p. m. this day.

## AFTERNOON SESSION.

Grand Lodge resumed labor at 2.30 p.m. this day, M. W. Bro. J. H. Graham, P. G. M., on the throne.

James Dunbar, M. W. G. M., as Grand Representative of the Grand Lodge of Scotland, R. W. Bro. Melbourne M. Tait, D. G. M., as Grand Representative of the Grand Lodge of New York, and R. W. Bro. Benjamin Burland, Past Pro. G. S. W., as Grand Representative of the Grand Lodge of Ireland, presented their Credentials and were received with Grand honors in compliment to the Grand bodies they severally represented. Other Grand Representatives, formerly introduced, were, in like manner, received.

Most Worshipful Brother Simpson, Past Grand Master of the Grand Lodge of Canada, here entered Grand Lodge and was received also with Grand honors.

The Grand Secretary read his report, which was as follows :

To the M. W. the Grand Master, Grand Officers, and Brethren of the Grand Lodge of Quebec, A. F. & A. M.:

M. W. SIE AND BRETHERS,—Conformably with the established practice, your Grand Secretary respectfully begs to present this, his report, for the year terminating, September, 1877.

There have been issued during the past Masonic year from this office, by the direction of Grand Lodge, three dispensations authorising the formation of subordinate Lodges under this jurisdiction: One for Rouville Lodge, at Rougement; another for Onelow Lodge, at Onelow, and the third for Corinthian Lodge, at Montreal.

Two Charters, viz., that of Hoyle, No. 14, and Evening Star, late No. 163 C. R., have within the same period been surrendered. The dispensation of Clarke Lodge, late No. 39 Q. R., heretofere reported as defunct, has been also geturned to Grand Lodge during the past year.

The number of subordinate Lodges, now on the roll of this Grand Lodge, is sixty-three, which have been regularly numbered as per report of Committee on numbering lodges.

The total amount of money received by me, since last Communication of Grand Lodge, is the sum of \$2,124.50, which has been paid over to the Grand Treasurer, his receipt being taken therefor; this sum shews a decrease on revenue for the past year, up to the 24th of September instant, date of closing accounts for the year, of \$89.00.

As directed, I have commenced the formation of a Masonic Library, on behalf of Grand Lodge, and by the kindness and liberality of sister Grand Lodges, have been enabled to make a very fair start; bound volumes and a large quantity of unbound matter being now on the shelves; to which it is to be hoped, that during the forthcoming year, and in the future, many useful and valuable additions will be made.

In regard to the directions given me by the Board of General Purposes, at its meeting, in March last, relative to the establishment under my charge of a Masonic journal in this city, I have to state that after giving the subject my serious consideration, and feeling that I could not devote the time requisite, I have judged it expedient, at least for the present, not to enter on the undertaking.

I cannot, however, dismiss this subject, without expressing my convic-tion, that, if some competent brother would undertake the establishment in Montreal, of a paper devoted to the interests of Free Masonry, and would give the necessary time, provide the proper ability, and push the venture with energy, the enterprise would in the end not only prove a very useful, but also a remunerating one.

In pursuance with the instructions received from the M. W. the Grand Master, I have obtained parchment sheets for the purposes of Grand Lodge Certificates, to replace paper ones complained of. Some delay occurred in the matter, owing to the fact that it was found to be very difficult to get sheets of the peculiar size and shape required for the plate from which the Certificates are printed.

Agreeably with a resolution of Grand Lodge passed at its meeting, held in September, 1876, I addressed communications to the following Lodges, viz.: Abercorn, No. 42; Sutton, No. 30; Burland, No. 51; and Dorchester, No. 4, in the terms directed. The three first named replied to my letters; the correspondence has been laid before the Board of General Purposes, and the result will, no doubt, be submitted to Grand Lodge.

I had the pleasure, in obedience to the order of Grand Lodge, of officially communicating to R. W. Bro. O'Halloran, P.D.G.M., the resolution adopted by this Grand Lodge, in September, 1876, recognizing the distinguished services of that R. W. Brother.

The correspondence of the office, during the past year, has been extensive, I have endeavored to respond promptly to all letters and communications received.

In many cases, information has been sought from me, as Grand Secretary, on questions of Masonic Jurisprudence, where the information asked for, has touched on questions settled by the action of Grand Lodge, I have at once given the information required; but, on all unsettled points, I have referred my correspondents to the Grand Master, or District Deputy Grand Master.

I desire to call attention to the unsatisfactory manner, in which as a general rule, the returns to Grand Lodge are made, from Subordinate Lodges. Not more than one-half make returns semi-annually, as directed by the Constitution, a large majority neglect to properly fill up the blanks in forms; some omit dates, others give only initial letters to the given names of members; many fail to affix the Lodge Seal, and not a few are forwarded unsigned by proper officers.

With respect to Lodge Seals, I would call the attention of Worshipful Masters of Lodges, to page 51, sec. 1 and 2 of the Book of Constitution, which under caption, "Of the Lodge Seal," reads as follows:

"1st. Every Lodge shall have a Masonic Seal, to be fixed to all docu--

"2nd. An impression of the Scal is to be sent to the Grand Secretary, "and whenever changed, an impression of the new Scal, shall in like "manner be transmitted."

A sum of \$500 was ordered by the Board of General Purposes at their last semi-annual meeting to be taken from the General Fund of the Grand Lodge and placed to the credit of the Benevolent Fund, to repair drawings

from that fund for charitable purposes and to keep intact the original fund, namely, \$4,000.

The Benevolent Fund expended since last Report, by order of the Board of General Purposes, at the last Annual Communication, \$305.00, and has added to its funds the \$500 grant of the Board of General Purposes from the General Fund of the Grand Lodge. It has also invested in Montreal Consolidated Bonds (six per cents) \$3,102.51; the balance, to make up the \$4,000 original grant, will be placed by the D. G. Master when similar securities may be purchased. The Treasurer was ordered to pay out of this fund the sum of \$200 towards the relief of distressed brethren in St. John, N.B., which leaves a balance (detailed statement rendered the Finance Committee) of \$935.56 in the Treasury, and Corporation Bonds; \$3,000 are held in trust by the D. G. M., G. S., and G. T.

### To the Most Worshipful the Grand Master and the Brethren of the Grand Lodge of A. F. and A. M. Quebec.

#### Most Worshipful Sir and Brethren,

In compliance with the Constitution, I beg to submit the following report on the state of Free-Masonry in the District over which I have the honour to preside.

The number of Lodges in the District remains unchanged, viz :--Eight. Certain Brethren residing at Rivière du Loup, (en bas,) forwarded to me in May last, a petition to form a Lodge at that place. The petition itself was not in form, and amongst other irregularities of less importance, did not conform to the Constitution in as much as the recommendation of the nearest Lodge was not obtained. I returned the petition for correction in form, with a request that the omission as regards the consent of the nearest. Lodge be supplied, to enable me to act upon it. For causes which I have no reason to doubt were good and sufficient the Tuscen Lodge, Levis, (the nearest to the proposed new Lodge) withheld its support, and therefore no further steps were taken by me in the matter. I am of opinion, however, that the time has not yet arrived when a strong and thriving Lodge can be formed at that point. At present the Brethren residing there are few in number, and the mass of the population being inimical to Free-Masonry, no considerable accession to the Craft can be looked for, so that were a new Lodge formed, it would commence weak in point of membership, probably drag on a sickly existence for a year or two, and then cease to exist.

During the year I have visited frequently all the Lodges in my District, with the exception of Milton No. 43, and Shawanegan No. 49, at Three Rivers. My intention was to visit the Brethren in that city, and with that. object in view I started overland in March last accompanied by W. Bro. Bowen, W. M. Lodge St. Andrew. After proceeding some 10 miles on the journey, a heavy snow storm set in, which rendered further progress inpossible, and I was relactantly compelled to return to Quebec. Since then, owing to the great pressure of my private affairs, I have had no opportunity of visiting those Lodges, which I much regret, particularly as I know that my failure to reach them on the occasion just referred to was a serious.

disappointment to the Brethren there, who had made every preparation to receive me, and for which I beg to tender them my warmest acknowledgements.

I am happy to state that the Lodges in my District continue to work harmoniously, and are in a fairly prosperous state. No Masonic complaints have been laid before me during the year.

On St. John's Day, 27th Dec. last, it was my privilege to install the Worshipful Masters and officers of the City Lodges, and at the regular communication in January the Worshipful Master and officers of Tuscaur Lodge, Levis. The Brethren composing the Lodges in Quebec and neighbourhood being desirons of celebrating the Festival of St. John the Evangelist, by giving a Masonic Ball, under the patronage of the Most Worshipful the Grand Master, I cheerfully granted a dispensation to enable them to attend in regalia. It affords me great satisfaction to report that the Ball was in every respect a success, tending, as I am convinced it did, to promote greater harmony and good feeling amongst the Brethren in this vicinity.

The District has to deplore the removal by death of W. Bro. Thomas G. Farmer, late Past Master of Milton Lodge, No. 43, Three Rivers. He was a zealous Brother, and one who was indefatigable in promoting the welfare of the craft in his own city, as well as an ardent supporter of this Grand Lodge. He was interred with Masonic honours.

In conclusion, it is my pleasing duty to acknowledge many acts of courtesy from the Brethren in this District, which have made the labours of my important office more than usually light and agreeable.

In conformity with the requirements of the Constitution, I beg to submit my report on the condition of Masonry in the District of Montreal.

At the present time there are, in the District of Montreal, Nineteen-Lodges working under Warrants, from the M. W. the Grand Lodge of Quebee, and two Lodges working under Dispensation from the M. W. the Grand Master. There still remain in the District, three Lodges under the Grand Lodge of England, and one under the Grand Lodge of Scotland.

The two Lodges working under Dispensation are, Richelieu Lodge, Soreland Corinthian Lodge, Montreal. In July last, I paid an official visit to-

Richelieu Lodge, accompanied by the Grand Secretary, R. W. Bro. Stearns, W. Bro. Ion, W. M. Victoria Lodge, and W. Bro. Newton, W. M. and Bro. Hutchinson of St. Andrew's Lodge, and Bro. Kay of Royal Albert Lodge. As a result of this visit, I have much pleasure in recommending to Grand Lodge the granting of a Warrant of Constitution to Richelieu Lodge. On the 4th of April last, ably supported and assisted by R. W. Bro. M. M. Tait, D. G. M.; the Grand Secretary, R. W. Bro. Murray, and a numerous assemblage of W. Brethren & Brethren of the District, I had the pleasure of inaugurating Corintina Lodge, by delivering the Dispensation, granted by the M. W. the Grand Master, to Bro. Henry Dunne, and the other Brethren named therein; since that date, I have, on several occasions, visited this Lodge, and can testify to the regularity and ability of the work as conducted by its W. M. and officers. I have therefore full confidence in recommending that a Warrant of Constitution be granted to Corinthian Lodge.

During my term of office, I have been called upon to constitute dedicate, and install the officers of two Lodges in my District, Warrants of Constitution, for which were granted at last annual communication of Grand Lodge. These two Lodges, are, Montaville Lodge, in Longneuil, now No. 58, and Hochelaga. Lodge, in Hochelaga, now No. 57, on the Registry of our Grand Lodge. I am glad to be able to report that both of those Lodges are continuing to work and progress in the most satisfactory manner.

I have to report official visits paid to Hoyle Lodge, in Lacolle, No. 14, and Chateauguay Lodge in Huntingdon No. 36, accompanied to the former by our Esteemed Grand Secretary, and R. W. Bro. Stearns, and to the latter by R. W. Bro. Stearns. Information had reached me that the present condition of Hoyle Lodge, was somewhat unsatisfactory. The attendance of members to receive us at the communication at Lacolle was very poor, and from the lack of interest exhibited, with the exception of the W. M., W. Bro. Daniel Salt, and two or three other very efficient Brethren, the outlook of the Lodge was not encouraging. Valuable suggestions as to the resuscitation of the Lodge were made by the R. W. Brethren who accompanied me, and hopes were expressed by the W. M. and other members of the Lodge, that success would crown their efforts. On my return to the City, R. W. Bro. Thos. Milton kindly agreed to visit Hoyle Lodge, and afford the Brethren the benefit of his advice and experience. I regret to have to report, that all his efforts were ineffectual to restore the Lodge to working order, and W. Bro. Salt, as W. M., was reluctantly compelled to surrender the Warrant of Hoyle Lodge; the same was in due course handed to me, and is now in possession of the Grand Secretary. The other properties of the Lodge are in the hands of W. Bro. Salt, who has promised to forward them to me at the earliest opportunity.

On visiting Chateauguay Lodge in Huntingdon, the state of matters there presented to us formed a pleasing contrast to that experienced at Lacolle. We found the Lodge in a most prosperous condition, and no want of life or interest amongst its members; this gratifying result I found was generally attributed by the members to the untiring care and attention of R. W. Bro. Daniel Boyd, whose Masonic knowledge and experience have been unsparingly devoted to the furtherance and support of Chateauguay Lodge. To this esteemed Brother are due my thanks, and also the thanks of the Grand Lodge for his exertions in recovering the Dispensation and property of Clarke Lodge Ormstown, to recover which T

was authorized to take the necessary steps by a motion passed at the last annual communication of Grand Lodge. I found, on enquiry, no warrant has ever been issued to Clarke Lodge. The dispensation and property returned to me, through R. W. Bro. Boyd, have been placed in the hands of the Grand Secretary.

All the Lodges in my District have been visited by me officially, with one exception, and I am glad to report that, generally speaking, they all appear to be working with good and efficient Masters and Officers. No one, however, I think, could visit the Lodge of the District, as I have done, without being forcibly struck by the want of uniformity in the various details of the work of the Lodges. I trust that the measures lately adopted, and the revision of the ritual by a number of the experienced brethren of the Province, will result in the production of a uniform system of work for the entire jurisdiction, which will be accepted and faithfully carried out, as far as circumstances will admit, by every Lodge on the registry of the Grand Lodge of Quebec.

While not presuming in any way to dictate a course of action to any of the Lodges in the District, I cannot refrain from expressing my opinion that the interests of Masonry in Montreal would be strengthened and benefited by the amalgamation of the Lodges severally bearing the names of St. George and Zetland, and though the proper time for such amalgamation may not yet have arrived, I would earnestly request the members of the Lodges interested to seriously consider the guestion.

I have to report having granted the following Dispensations :

To the W. M. and Brethren of Montarville Lodge, Longueuil, No. 58, permitting them to wear their Masonic Regalia at a reception held in their own Lodge Room, on the 21st November last.

To the W. M. and Brethren of Prince Consort Lodge, Montreal, No. 52, permitting them the use of their Masonic Regalia at a Festival given by them on the evening of St. John's Day, in December last.

The conduct of the brethren on both of these occasions fully justified the indulgence granted them.

I have also, in terms of the Constitution, granted a Dispensation to the W. M. and Brethren of Hochelaga Lodge, Hochelaga, No. 57, to pass and raise at a less interval than one month from receiving a preceding degree, a sea-going mariner, Brother Alexander Crowe Vance.

In accordance with a motion carried at the last annual communication of Grand Lodge, the purport of which was conveyed to me by the Grand Secretary, I on the 24th of October last, proceeded to Prince Consort Lodge, No. 25, and there re-obligated Bro. Ward in the first and second Degrees, and, in the name of the Grand Lodge, declared him to be a regularly passed unafiliated Fellow Craft Freemason. As the application of this brother for affiliation, and the conferring on him of the third Degree in Prince Consort Lodge, was on ballot rejected, the brother finds himself in a peculiar position, and the W. M. of the Lodge has addressed to me a communication, which I now produce with this report.

I desire to call special attention to the continuance in my District of four Lodges still working under the jurisdiction of foreign Grand Lodges.

It appears to me that the period has now arrived when it is due, not only to the Grand Lodge of Quebec itself, but, in a greater degree, due to the sister Grand Lodges of the world who have acknowledged our supreme jurisdiction in this Province, that pressure should be legitimately brought to bear on the two Grand Lodges interested, in order that the present anomalous condition of affairs should no longer be allowed to exist. With reference to this question, I would like to call attention to the following remarks, taken from the last-issued proceedings of the Grand Lodge of the State of New York; they occur in the review of the proceedings of our Grand Lodge, when referring to the position taken by us, and run thus:— "The Grand Lodge; therefore, under the American doctrine, it has sole and exclusive jurisdiction in the territory in which it is located, and we hope, as we said last year, that it will stand up for its rights to the very end of extremity."

I have also to express a hope that the question of dual membership, which has caused so much trouble and irritation amongst our various Lodges, will be so disposed of at the approaching Communication of the Grand Lodge as materially to tend to the increase of harmony, strength and prosperity throughout our entire jurisdiction. fo

## BEDFORD DISTRICT.

## To the M. W. Grand Master, Officers and Brethren.

In conformity with the requirements of the Constitution, I submit my report on the condition of Masonry in the Bedford District.

During the year I have instituted one Lodge, constituted one, and have withdrawn the charter from one, granted two dispensations, and visited quite a number of Lodges.

On the 30th of October last, I visited the brethren at Rougemont, and opened Rouville Lodge under what I considered, very favorable circumstances. W. H. Code, W. M.; Samuel Vineburgh, S.W.; A. Dame, J.W.; W. McKerness, treasurer; E. Gullett, secretary; James Ashton, I. G.; John Ashton, tyler. Since then I have written twice to the secretary that I would meet the Lodge, but in both cases have been requested to postpone my visit.

In the month of December last, I visited the two Prevost Lodges at Dunham, and used what influence I could to effect a reconciliation or an amalgamation, but was unsuccessful.

I have made several unsuccessful attempts to effect an amalgamation with Royal Canadian and Corner Stone Lodges at Sweetsburg and Cowansville, but local feeling being so strong I can see but little prospect of union at present.

To the M. W. Grand Master and Grand Lodge of A. F. & A. M. of Quebec.

## OTTAWA DISTRICT.

In conformity with the requirements of the Constitution I submit my Report on the condition of Masonry in the Ottawa District.

It affords me pleasure to report that Peace and Harmony prevail thoughout this District. A fair share of prosperity has been enjoyed by the different Lodges during the past year, and with one or two exceptions, they are in good working order.

I granted two Dispensations, one to Eddy Lodge to wear Masonic clothing and attend a Concert held in Ottawa under the anspices of the Craft for the relief of Local Charities, another to Pontiac Lodge to change their night of meeting from the second to the first Tuesday in each month. Also had the honor of forwarding the M. W. Grand Master's Dispensation for formation of Onelow Lodge, Quio. Would recommend thata Warrant of Confirmation be granted to this Lodge by the M. W. the Grand Lodge at its present session, same to take effect the 27th day of December next.

The number and names of Lodges in this District are as follows, viz :--Pontiac, No. 40; Onslow, U. D.; Aylmer, No. 22, and Eddy, No. 41.

The usual press of private business necessitating frequent absences from home prevented my visiting the several Lodges to the extent I would have wished for.

I examined the books of the above named Lodges and found them well kept and in good order.

There is a great diversity of work in the Lodges in this District which creates confusion, and is also detrimental to the proper instruction of the Brethren.

I most respectfully recommend this Grand Lodge to obtain with as little delay as practicable, a regularly authorized and established Ritual in order to secure uniformity in the several Private Lodges, all of which differ in this respect for the want of it.

I am sorry to report that the Messenger of Death visited our District and called from our midst after a lingering illness at Hull, on the 19th day of March last, Bao. Thomas Geones Boos, thereby adding another worker to that Grand Lodge above, where the wicked cease from troubling and the weary are at rest, therein to receive the rewards of their labor. He was buried with Masonic honors by the brethren of Eddy Lodge, No. 41, of which he was a charter member.

His presence is missed by a large circle of friends and Brethren who mourn his loss.

There are nine Lodges in this District, six of which I have visited during the year, three—viz., Mount Orford Lodge, at Georgeville; Doric Lodge, at Danville; and Excelsior Lodge, at Thyton—I have been unable to visit. I am very happy to say that I found the Lodges which I visited working in an efficient and constitutional manner, the officers thoroughly qualified for the discharge of their duties, especially Golden Rule Lodge, at Stanstead, Victoria Lodge, at Sherbrooke, and Ascot Lodge, at Lennoxville. I found the usual attendance of members fair, and the minutes of the several Lodges carefully and regularly kept. I have good reason to believe that the Lodges which I have been unable to visit are in a prosperous condition. I was sorry to find in the most of the Lodges that several brethren were in arrears for dues, in a few instances heavily so.

On the Festival of St. John, December 27th, I had the honour to instal the Officers of Victoria, Ascot, and Lake Magog Lodges, in the City of Sherbrooke. I have found that the members of all the Lodges in this District, with the exception of Golden Rute Mount Orford, and Lake Magog Lodges (which work the ancient York in c), are very anxious that uniformity of work should be established in this Province as soon as possible. I am sorry to say that if Golden Rule, Mount Orford, and Lake Magog Lodges are compelled to change their Ritual, it will very materially dampen their zeal for Freemasoury, as they are very warnly attached to their Ritual, which I am happy to say is thoroughly and efficiently worked by them; especially is this the cases with Golden Rule Lodge, which is the best worked Lodge I ever had the pleasure of visiting. I have also found all the Masters of the Lodges in this District very anxious that you would give them a Code of Masonic Law. They say the Constitution of the Grand Lodge of Quebec does not touch on many points; and, on referring to Grand Lodge rulings, they find such diverse and antagonistic decisions that it is impossible for them to know what course to pursue. They firmly believe that the prosperity of the order would be materially enhanced if a Code similar to that of the Most Worshipful the Grand Lodge of Ohio was established; and I must say that I heartily concur in their opinion.

These are the only deaths, so far as I have been able to learn, in this District.

During the month of January I received, from the Worshipful Master of Mount Orford Lodge, a complaint against St. John and Graham Lodges in Bedford District, for having encroached on the territory under their jurisdiction. This complaint I laid before the Board of General Purposes at its semi-annual meeting in March, when it was decided that the matter should be referred to M. W. Bro. J. H. Graham, for his explanation of the circumstances of the case, he being acquainted with the whole matter; and the complaint, with his opinion thereon, was to be submitted to the most Worshipful the Grand Master for his decision; and I trust the difficulty has by this time been settled.

During the past two years the membership of Victoria Lodge, in the City of Sherbrooke, has been largely increased, consequently the labours of the Master and officers have been very severe. Anticipating continued prosperity in the future, a number of the members of the Victoria have deemed it advisable to form a new Lodge in the City of Sherbrooke, to be called the "Prince of Wales Lodge." I shall present their petition at the present Annual Communication, and I have much pleasure in recommending that its prayer be granted, being firmly convinced that "Prince of Wales Lodge" will be an honour to the craft.

In conclusion, I am happy to be able to state that harmony and prosperity have attended all the Lodges in this District during the past Masonic year.

The Grand Chaplain, R. W. Bro. H. Nye, then delivered the following discourse :

## Most Worshipful Grand Master and Brethren of the Grand Lodge of Quebec :

In addressing you for the fifth time as your Grand Chaplain I cannot pretend to advance anything very new, as the field of Masonic ethics has been pretty thoroughly explored in previous discourses by myself and my worthy predecessors in this office. The utmost that I can hope to do is to clothe some of the old familiar truths in a new garb, and to re-awaken your interest in subjects which by reason of their frequent repetition, may, perhaps, have grown tame and wearlsome.

One of the most striking and attractive features of our order is its social character. It is its high privilege and duty to go forth into the midst of a dark and selfish world as the herald of a broader charity and more active benevolence. Freemasonry not only inculcates the principle of love and benevolence, it seems to give them an actual and living presence in all the occupations and intercourse of life, so that wherever the lot of a good Mason may be cast the invisible but helpful arms of his order may surround him to protect him from danger and to help him on his wanderings through this may world.

Like the fabled deities of ancient story, Freemasonry surrounds all her children with her fostering arms, watching over their struggling footsteps with maternal care, in the hour of peril, sickness or distress, revealing her heaven-born beauty and power. By her gracious ministration the weary pilgrim's load is lightened, his path cleared before him, and should death overtake him on his journey, away from kindred, home and friends, her soft hands smooth his dying pillow and wipe away nature's last bitter tear. This, my brethren, is no mere rhetorical picture conjured up by the speaker's fancy, of a Utopian institution such as the world has never seen;

it is the simple experience of many a worthy brother, who under the ægis of our order has passed from darkness into light. Such deeds of kindness seldom meet the public eye, or gratify the public ear, but they are being daily registered in imperishable characters in the records of the Grand Lodge above.

It is sometimes said that Masonry is selfish, that masons confine their b mefactions to themselves. Were this true to the fullest extent, it would be no serious imputation; for all will admit that our charities or benefits must be limited by our resources, and it is in no wise derogatory to the masonic body if their "charity begins at home." Freemasonry, undoubtedly, gives the first place in its regard and benefactions to its own children, but its principle is that of unrestricted philanthrophy: and, beyond its pale, many a heart has been made to throb with reviving hope, and many an eye to sparkle with joy by its timely aid. The true Mason's ear, while it is peculiarly alert to catch the faintest cry of distress that is rung from a brother's heart, is never closed to that cry from whatever quarter it may come. The spirit which animates our order, inspiring all its faithful members and controlling all their acts, is the spirit of love—love deep as the fatherhood of God and wide as the brotherhood of mán.

It is not only to each other, therefore, that we are to exercise the virtues of charity and *forbearance* (for the former includes the latter), but to all mankind, to all who need our sympathy, our kindness, and our assistance. And in a world so suffering as this, we are never at a loss to find an ample field for the exercises of those graces. In every corner of our cities, towns and villages we see honest poverty struggling with the most adverse circumstances. Everywhere we tread in the midst of indescribable misery, everywhere open before us the dwellings of hungry poverty, where oppressed and suffering virtue hides herself and weeps. The field for the exercise of our charity is unlimited, and it is the special glory of masons that they belong to an institution which is as widespread as the evils which it seeks to remedy.

There is another distinguishing feature of our Order, which although I have alluded to in former addresses, I cannot pass over on the present occasion. It is a glorious part of the mission of Freemasonry to seek to promote a true spirit of *brotherly kindness* among all ranks and conditions of men. Knowing no distinction but that of *merit*, and including in her fold men of all classes and creeds, she frowns upon all sectional and sectarian differences, and says to the angry disputants in politics or religion—" Sirs, ye are brethren !" May I be permitted to repeat on this point words which I adressed to the Grand Lodge four years ago, and to which recent, events have supplied a said and striking commentary ?

Freemasonry has ample work to do in all States and nations in hastening the brotherhood of man. In this Canada of ours there is sufficient need that it should spread the cement of brotherly love to connetract the sectional, political and sectarian tendencies to alienation and strife. In the religious world even, I am sorry to say, there is need of masonic labor to realize the unity for which every true worshipper of the great Jehovah ever hopes and prays. It ought not so to be, but it is true that in the Masonic circle there is a tie of brotherhood which makes religious men more truly fraternal, and not merely to express more of that union which is so essential to religious joy and usefulness than they are wont to have outside that circle. And surely if ever age or country has need of all the forces that can be made available for se great a result, our young Dominion in this, the hour

of her youth and danger, has that need. Here within our borders we have a community composed of races widely differing in origin and idiosynoracy, and the tide of emigration is constantly bringing in waves of population from the elder world to find a home and country under the broad shelter of our free institutions—our just and equal laws. To unite and assimilate these varied people is a task which requires Masonic cement and Masonic charlty. Let us each strive in his own sphere, faithfully to use the trowel and spread the cement of affection and kindness which unites all the members of the great Masonic family, wheresoever dispersed, into one grand union of brotherly love, relief and truth.

It was moved by R. W. Bro. James O'Halloran, P.G.M., seconded by V. W. Bro. W. Simpson,

That the discourse of the R. W. Grand Chaplain, just delivered, be entered in extense in the minutes of the proceedings of this Grand Lodge, and be also published in some of the newspapers of this city.

The motion was carried unanimously.

R. W. Bro. Melbourne M. Tait, on behalf of the Board of General Purposes, presented the following report on numbering Lodges on the roll.

R. W. Bro. Tait, for the Board of General Purposes, presented the following report on Masonic Journal.

#### " MASONIC JOURNAL."

The Board have had under consideration the question of a Masonic journal for this Province, which was alluded to in the address of the M. W. the Grand Master at the last Annual Communication of this Grand Lodge, and beg to report that at the last semi-annual meeting of the Board the following Report was adopted :--

#### To the President and Members of the Board of General Purposes.

The Committee on "Masonic Journal" begs leave to report :

That its members are of opinion that a Masonic journal, published under the control and superintendence of the Grand Lodge or its nominees, would tend much to forward the interest of the Craft in this Province by the promulgating amongst its members Masonic news which otherwise cannot generally be disseminated.

Your Committee are not prepared to advise any considerable amount of expenditure from Grand Lodge funds for the purpose of a yearly subsidy to a paper, nevertheless they think that at starting a small sum might be granted, which, with subscriptions and advertisements to be obtained, would guarantee the paper for at least one year.

Your Committee have made inquiries in regard to the cost of such a paper as would, in their opinion, be ample to answer the end sought after, and find that one of the size and general pattern of *The Masonic Token*, issued by Bro. Stephen Berry, of Portland, Me., and which is issued quarterly, could be established, and run at about the following rate of expense:

If this calculation is at all reliable, and your Committee thinks it is, enough money will be easily raised to carry out the project recommended.

Your Committee is alive to the fact that on the limited scale now recommended a very great deal in the way of editorial talent cannot be expected, indeed they are disposed to advise that at the outset the paper will not depend so much on original matter in the shape of editorials as a compilation of Masonic matter for dissemination amongst the Craft.

Your Committee would finally recommend that if arrangements can be made with the Grand Secretary, that that officer should take charge of the proposed paper for at least the first year of its existence, or until arrangements can be made with a competent person for permanent editorship.

The Board of General Purposes through R. W. Bro. Melbourne M. Tait, made the following report:

#### To the Most Worshipful the Grand Lodge of Quebec, A. F. & A. M.:

Your Board having had before them the case of Brother Ward, now or formerly a member of Prince Consort Lodge, No. 52, and having carefully investigated its peculiar circumstances, recommend that Prince Consort Lodge be instructed to confer the third degree on Brother Ward at a period suitable to all parties. Also that the said Lodge be directed to provide for that Brother after his "raising," a Grand Lodge certificate in the usual form.

On motion of R W. Bro. Thos. Milton, seconded by R.W. Bro. Renshaw, the report was received and adopted.

R. W. Bro. Melbourne M. Tait, for the Board of General Purposes, made the following report:

#### To the Most Worshipful the Grand Lodge of Quebec, A. F. & A. M.:

Your Board beg to report that they have considered carefully the complaint laid before the Board by Bro. G. N. Wilkinson, stating that at the Regular Communication of Golden Rule Lodge, No. 5, Q. H., Stanstead, held in the month of April last, he was initiated into the Mysteries of Free Masonry; that at the Regular Communication of the said Lodge, held in May last, he was "placed upon probation for six months;" that no complaint or charge had been preferred against him, and that further advancement in the Order, and even a formal trial, had been refused him.

Upon examination we find that the Brother was, after being duly recommended, ballotted for and accepted in open Lodge and initiated, as stated by him; that at the next Regular Communication of the Lodge, without any reason being assigned therefor, the following resolution was passed in open Lodge: "That Bro. George N. Wilkinson be put on probation for six "months," which resolution was communicated by the Secretary of the Lodge to the Brother, who demanded a reason, and received for reply the intimation that he "he was put on probation for unworthiness, but that the Secretary could not inform him who brought the matter before the Lodge."

The Brother, in consequence of the notification by the Secretary of the passing of the resolution in question, was prevented from presenting himself for further advancement in the Order, but has, instead, appealed to Grand Lodge for redress.

We are bound to say that we consider the action of Golden Rule Lodge No. 5 arbitrary and unconstitutional, and would recommend that the Lodge be ordered, at its next Regular Communication; or whenever the Brother "making the complaint presents himself for the purpose, to examine him, and if he be found sufficiently advanced to pass him to the Second Degree, and within the usual time thereafter, upon his undergoing a satisfactory examination and proving himself qualified, to raise him to the Sublime Degree of a M. M., unless, indeed, a distinct and sufficient charge has been previously preferred against him, and he be in due time tried and convicted thereupon.

On the motion of V. W. Bro. T. P. Butler, seconded by W. Bro. E. H. Johnson, the report was received and adopted.

That the Ritual just exemplified be not adopted.

The Grand Chaplain, R. W. Bro. Nye, seconded by R. W. Bro. J. T. McMinn, moved as an amendment to the amendment:

That the question of the adoption by this Grand Lodge of the proposed new Ritual be deferred until the morrow.

#### REPORT ON GRAND MASTER'S ADDRESS.

The Board to whom was referred the address of the Most Worshipful the Grand Master, begs to report as follows :

That the thanks of this Grand Lodge are due to the Grand Master for his able and interesting address.

<sup>•</sup> That the growth in numbers and financial prosperity of the Craft generally, not merely in this Province of Quebee in which we are more immediately interested, but also in every country, is the subject of sincere congratulation.

That the Board 'is pleased to notice that at the Quarterly Communication of the Grand Lodge of Scotland, held at Edinburgh, that Grand Lodge unanimously resolved to open fraternal relations with the Grand Lodge of Quebec, and that an interchange of representatives has been agreed upon, a proceeding which must of necessity further and increase the friendly relationship which already exists between the two Grand bodies, but your Board is still compelled to refer to the existence in the City of Montreal of a Lodge hailing from and recognized by the Grand Lodge of Scotland, a fact which seems inconsistent with the Supreme Masonic Jurisdiction in this Province, which is claimed by the Grand Lodge of Quebec, and which seems to have been practically admitted by the Grand Lodge of Scotland. Your Board hopes that by further correspondence between the two Grand Bodies this difficulty may be arranged. Your Board equally regrets that a difficulty of a somewhat similar nature with the Grand Lodge of England is still unsettled. The action taken by the Grand Master in reference to the so-called Grand Lodge of Ontario will no doubt be approved by this Grand Lodge, at all events until further information as to the objects of the members of the Craft who have undertaken to form and organize the said so-called Grand Lodge, and the propriety or necessity of such organization shall have been supplied. This matter, however, is referred to in a separate report of your Board.

The reference to the bequest of the late Brother E. Moss, and also as to the amounts heretofore contributed by the Lodges in this Jurisdiction to the Masonic Asylum Fund have been received with much satisfaction, and the Board recognises with thanks the efforts of R. With reference to the formation of the Grand Lodge of Cuba, and its claims for recognition by this Grand Lodge, the Board is of opinion that it would be desirable to await fuller information, as to the condition of Masonty in that jurisdiction before action be taken in this matter.

The Board, in conclusion, congratulates Grand Lodge upon the prosperity which the Craft now enjoys in this Province, and its future prospects of influence and usefulness.

The Board of General Purposes presented the following report :---

#### STATE OF MASONRY.

The Board is pleased to be able to report that the State of Masonry in this Province, as shewn in the reports of the District Deputy Grand Masters, the Grand Treasurer and the Grand Secretary, is most satisfactory; the report of the Grand Secretary shewing that nearly all the Lodges have made prompt and proper returns, and the accounts of the Grand Treasurer shewing a good and sufficient sum on hand to meet all the requirements of Grand Lodge.

The Board begs to draw the attention of Grand Lodge to the request of the Grand Secretary that the returns from the Subordinate Lodges should be made in the prescribed form, and in due time; and hopes that in future these details will receive the necessary attention from Worshipful Masters and Secretaries of Lodges.

The Board is gratified to learn the prosperous condition of the several Districts as shewn in the reports of the District Deputy Grand Masters, and hopes that in future each Lodge will receive at least one visit in the year from the District Deputy Grand Master of the District.

There is one exception, however, to the harmony which exists throughout the Craft in this Jurisdiction, and that is contained in the report of the District Deputy Grand Master for the Montreal District.

The Board regrets to learn from this report that there are still Lodges in that District working under Warrants from other Grand Lodges, and not acknowledging the Jurisdiction of this Grand Lodge.

In view of the fact that all possible means have been exhausted by this Grand Lodge, to bring about an amicable settlement with these Lodges working under Foreign Grand Lodges, without effect, the Board recommends that the proper steps be now taken to establish the authority of this Grand Lodge over all Subordinate Lodges in this Jurisdiction.

That it appears to the Board that the most practical and feasible mode of collecting the subscriptions of the several private Lodges for the purposes of benevolence would be to amend the constitution under the caption "fees," page 56, by inserting on said page, immediately preceding the last paragraph, the following words: "Every member of each Lodge shall "pay towards the General Benevolent Fund of the Grand Lodge, one dol-"lar per annum." Shoild, this amendment be carried, the Board suggests that the Boards of Relief for each District be organized as at present, and that the Executive Committee of each Board be authorised to draw on the Grand Treasurer to the extent, if necessary, of the amount received from the private Lodges in each respective District. In the opinion of the Board, this or some more efficient system of collecting general funds for mutual benevolence must be adopted, as the present organizations are falling to pieces for want of proper support.

On motion of R. W. Bro. M. M. Tait, seconded by R. W. Bro. J. T. McMinn, the report was received and adopted.

R. W. Bro. M. M. Tait, seconded by R. W. Bro. J. T. McMinn, moved:

That in the opinion of this Grand Lodge the form of Ritual for Lodges in this Jurisdiction so far reported, consisting of the Ritual of the first degree is satisfactory, and should be adopted, but that it is not expedient to enforce the same until the report is completed; therefore, the Committee on ritual be requested to continue its labor.


