

An Act to change the name of the Peterborough and Port Hope Railway Company, and to amend the Act incorporating the same.

WHEREAS the Peterborough and Port Hope Railway Company, Preamble. have petitioned that the Corporate name of the said Company may be changed, and that the Act incorporating it may be amended in the manner hereinafter mentioned, and it is expedient to grant the prayer 5 of their said petition : Be it therefore &c., as follows :

I.
