OFFICERS AND BROTHER REPRESENTATIVES,-

In presenting my annual Report, I have much pleasure in congratulating this Grand Division upon the increasing popularity and pros-

perity of our long cherished Order.

The increase in the number of New Divisions is perhaps unsurpassed by that of any one year since the introduction of our Order into this Province, and the consequent additions to our membership are far more numerous than those of former years; and in our congratulations upon the successful results of this year's work, let us ever bear in mind "That to Him who rules in Heaven and on earth" is all the honor and glory due. Let us therefore humbly crave that He will still vouchsafe His gracious presence, and continue to bless us in this our labor of love for "the good of all mankind," relying upon the promise "that every man shall be rewarded according to his works."

Since my Installation I have had the honor of signing no less than forty Charters for new Divisions in Nova Scotia, a number unheard of I believe in any Grand Division (with two or three exceptions) in the

jurisdiction of the National Division of North America.

During the year, little or nothing has occurred seriously to mar the

prospects of our Order, or retard it in its career of usefulness.

During this year I have been privileged to visit some 19 or 20 subordinate Divisions officially-in Halifax, Hant's, Kings, and Cape Breton Counties-making in all something like fifty official visits; these were paid to Mic-Mac, Howard, Mayflower, Chebucto, Athenæum,

Richmond, Day-Spring, Green-Vale, Ingraham, Marathon, Granite Rock, Avon, Vesper, Rechab, Kellogg, Canning, Archangel, Cape Breton and North Sydney, three of which I had the honor of Instituting, and the privilege of resuscitating one-"Green-Vale" at Musonode boit Harbor, from all of which I received a very cordial and gracious reception; and here I would record my sincere and hearty thanks to our Worthy Brother and co-worker P G. W. P. Avard Longley, Esq., and to Brothers B. B. Woodworth, C. C. Hamilton, George J. Creed, John McLearn, R. S. Blois, and I. B. Hamblin, for travelling facilities to and from localities in which the Divisions visited are located.

I also visited three Bands of Hope in an official capacity. They were these—the "Rose Bud Band" in this city, whose officers I Installed. 'The "Victoria" at South Rawdon, from which I received an address and a donation to the Agency Fund, and the other the "Moun-

tain Daisy" at the Gore. All were orderly and well conducted,

The Report of the Grand Scribe will be laid before you in due course, and will enter as fully into details and statistics as far as the Reports from County and Divisional Deputies will warrant-and I am sure you will be gratified to learn that these are more numerous and perfect than in any for ner year, and will undoubtedly shew the Order in a good and healthy condition. He will give details of increase and operations for this year.

I am also gratified to inform you of the increase in the number, and membership of these nurseries of our Order—the "Bands of Hope."-These branches of our Order, when properly and judiciously worked, will certainly tend to the increase of our ranks in the fature. Let us pray that the "Great Patriarch above" may largely bless the efforts and labors of those who are superintending and instructing our youth in these juvenile organizations; -they will, in due time, reap their reward.

Our Provincial Agents, Brothers McArthur and Barratt, have been constantly employed itinerating the Province. The number of new Divisions organized and resuscitated during the year, attest the diligence, faithfulness, vigor and vigilence with which this very important branch of our missionary work has been prosecuted. These Brothers are with us and will undoubtedly give you an interesting account of their stewardship sometime during this session.

The Treasurer's accounts will also be laid before you, showing the receipts and disbursements for the quarter.

The Agency Committee will also furnish a Report of this, perhaps the most valuable and important, branch of our institution. Their zeal, judgement and fidelity in a work so important is deserving the warmest commendation of this Grand Division. In connection with this Agency our G. S. has written no less than 327 letters.

I am glad to inform you that only one appeal case will be laid before you, which I think was wisely handed over to the Committee on Appeals at our last quarterly session at Sydney, C. B. The Report from that Committee will require your consideration. You will be glad that misunderstandings leading to appeals are happily of rare occurrence in our highly favored Order, showing very conclusively that Love, Purity, and Fidelity are better understood, and are active governing principles

in our widely extended organization.

As on former occasions I beg again to thank those of our County and Divisional Deputies for the attention and promptitude with which they have responded to the call of the Grand Scribe and myself for early Reports and Returns; -there is still room for improvementthere are still a number-both of County and Divisional Deputieswho fail in realizing the importance of the position they occupy in the Order. We have each our share of work to perform. We must all work and there is work for all. Let us see that in the future we take our share-and that we do it well and at the proper time.

#### ANNAPOLIS COUNTY.

The Order in Annapolis County does not occupy the position it did in former years. Deputy Ricketson states that "Olive Branch" has not done much since last report. One member has been added, and three Lady visitors. The same may be said of "Chrystal Spring" Division.

#### ANTIGONISH COUNTY. .

Our ever active and well tried Deputy, T. M. King, our Grand Conductor-says: "The state of the Order in this County is most encouraging and satisfactory; "St. Andrews" Division continues to occupy position in the front rank, and has reason to feel gratified at the result crowning the efforts put forth by her membership. Measures are now being adopted to make the meetings of our Division more interesting and attractive; and it is hoped that a successful winter's campaign will be the result. The watchword of the order in this Connty is "Prohibition," their intentions "Steady Progression," until our objects are accomplished."

#### COLCHESTER COUNTY.

County Deputy Dr. W. E. McRobert writes: The order in this County is in a healthy and prosperous condition. Deputy W. J. Corbett reports "Island Home" Division to be in good working order although not increasing in membership; yet it has been the means of

entirely suppressing the liquor Traffic in that locality.

Deputy Robinson Thomson reports "Arctic," to be in a flourishing condition; an increased interest on the part of Brothers is indicated by a more punctual and regular attendance at the stated meetings of the Division. Deputy J. C. Johnson, reports "Pleasant Valley" Division as still prospering; harmony and union among the members still exist: a strong desire for the prosperity of our much esteemed Order prevails among them, and their influence for good is felt in the community. "Scotia" Division is vigorously working for the suppression of the liquor traffic. "Iron Age" of which the worthy Doctor is Ottside Sentinel, is still in a healthy state." So tar as I have been able to hear, all the Divisions in this County are working well." Brother J. E. Balcom, says: "There has not been so much interest manifested by the members as should be. We however expect a change—now that the busy season with the Farmer is over; we are holding on firmly. Brother D. F. Layton says: Our Division continues to hold its own

against public opinion; we trust we shall soon see the day, when "Right not Might" shall rule—when Law and order will prevail. Bro. R. M. Davison, of Portaupique, writes very hopefully. They are increasing in numbers—and generally speaking, are working harmoniously, and keeping their own, although they have much opposition to contend with in some localities. Bro. Hitchins, writes of H. A. Taylor Division,—We have found it necessary to lop off some of the useless branches—but we are by no means discouraged by that, and although there are several "Speckled Temperance men" among us—on whom we cannot much depend—we hope soon to see our Division altogether composed of good men and true.

#### DIGBY COUNTY.

Deputy W. H. Taylor writing of "Union" Division, says: We have not progressed much during last quarter—rather I think retrograded;—the prospects since this quarter began are somewhat better, several having been proposed for membership. Our Clerk of License has been successful in all his contested suits in the Supreme Court against the Liquor-sellers here. It is a hard matter to prosecute successfully against those who should be our leading men, and who throw all their influence in favor of "The poor Persecuted Runseller."

Brother John S. McNeil in speaking of "General Inglis" and "Welcome" Divisions, says: I am happy to inform you that we are still holding our own; amidst all the opposition that can be brought to beer, our principles are taking daily a deeper hold upon the minds of the people, and I believe that "General Inglis," never stood better than at present, and its ally "Welcome," is earnestly at work, and promises to be A Welcome laborer in the field." "Western Star," on Long Island, is as usual in a healthy state;—no liquors on the Island. Bro. Deputy Nicholls writes from Hillsburgh, concerning "Royal:" our Division is still holding on the even tenor of its way, with now and then an addition to our numbers."

#### GUYSBOROUGH COUNTY.

We have lost one Division in this County, but four new ones have been instituted since our last quarterly meeting. The other three Divisions maintain their ground under difficulties.

#### HANTS COUNTY.

Brother Harris writes encouragingly of the Division in this thriving district; he says:—"We have not increased much this quarter, but, notwithstanding opposition, we shall gradually increase. A number of our old members have not yet returned from sea;—when they do we shall have their presence and influence again. We shall keep moving along and hope soon to see the day when we shall occupy our former standing."

Deputy D. Mosher of Windsor writes "Hantsport" and "Avondale" Divisions are working along. Brother Smith says: "Avon" is still progressing and working harmoniously. Its tide flows steady, and brighter days are dawning. A hall of our own is inevitable; operations are in progress, and ere two months hence a frame will be erected and covered in."

Bro. R. S. Blois, at the Gore, writes: We return seven members more than we ever did before. Our Division has been in good working order until very lately;—some of our brothers could not do as they

wished and they talk of leaving.

Bro. Rev. J. McLcod of Newport writes of "Brooklyn" Division: "During the greater part of the summer months our Division has been in a very low state, struggling for an existence. At one time we were so weak from loss of blood &c., extracted by Templars, that a proposition was actually laid on the table to surrender the charter. The proposition had the desired effect; Brethren and Lady Visitors who had been long absent returned—and the universal cry was "no surrender"—and now our Division Room presents again the appearance of life and prosperity, and I am in hopes that we will continue to flourish and bring forth good fruit."

#### HALIFAX COUNTY.

The Divisions in the city, Dartmouth, and at Richmond, are working well and harmoniously. They have much to contend with—but notwithstanding the opposition of the Rumocracy, they may be said to keep their own. The Authorities, generally, favour the Rum-o-crat,

although there are exceptions among the civic body.

Deputy John Parker, of Musquodoboit, writes: I am happy to inform you that our Division is in good working order. We have had no additions to our numbers for the quarter; three have withdrawn, and we are gratified at having no cause of complaint for any breach of the Rules of our Order, so far as known to the Division. Our influence has been powerful for good in this neighbourhood. Bro. Layton, writes, of "Rising Sun": Since our winter campaign commenced a very great deal of interest has been exhibited; the Division is in a very healthy state, good meetings, and business well atterded to. We work harmoniously, and the cause seems to be increasing in Musquodoboit-no Liquors sold on the River; - we bid fair to be a sober community in time to come. Bro. Forrest writes of "Tangier:" I am much pleased to Report our Division as holding its own, and in good working order. "Champion" Division, although somewhat decreased in numbers, is in good working order; -they complain of a dram shop Lept by a Justice of the Peace-although not on his own premises.

Brother P. R. Foster reports as follows from the St. Margaret's Bay district: "I cannot report much progress this quarter, yet we live and act. The Divisions are doing well; we have taken in a number and expelled a few. "Morning Star" is doing very good work; most of our members are reliable men.

"Ingraham" is moving forward with their New Hall; they expect to get into it before winter; they have a good foundation laid for a

complete Division.

"Marathon" is working well; they too have got their Hall under way.
"June Rose" is also doing a good work at the Plains; the folks there
begin to see the Division is bound to live, and are now flocking to the
standard; they have admitted 16 since they resumed work.

"Gibralter," at Gays River, is still deserving of its name! It has seventy members, and forty-five Lady Visitors. It is working well, and

its meetings are well attended.

"Green-Vale," at Musquodoboit Harbour is in good working order, and continues to maintain its position, in the face of much opposition

#### INVERNESS COUNTY.

Deputy John G. Crowdis, says of "Hart" and "Bruce" Divisions: "Our returns will speak for themselves; the Divisions are doing well, and I feel confident that all are true, and working as well as can be expected."

KING'S COUNTY.

Bro. W. C. Bill writing from Billtown, says: I have installed the officers of the six Divisions under my charge, and am glad to report them in good working order, except "Centreville" which is quite low.

"Fenwick" has had some trouble.

Deputy W. A. Tupper writes of his district, Scots Bay: "Temperance, he says, is silently extending—widening and deepening its influence all through this region; but for Canning we would drive out the enemy in one year; there are four runs shops in full blast, and there are men who would be willing half the County were drunkards if they could sell a few pounds more of tea and sugar to the rumseller. We are slowly increasing in numbers; our Division is in good working

order, and we wield an influence for good."

County Deputy Rev. Dr. Cramp reports ten Divisions in working order in this County; they are generally in a healthy state excepting the one at Hall's Harbour at which place the interest begins to flag—so says the Divisional Deputy; the Doctor adds "All the Divisions are struggling against opposition, and says it is a mortifying thought that professed friends of Temperance, organized avowedly to promote its interests, should employ their efforts to weaken another body, instead of uniting with it against the common foe. Notwithstanding this check and drawback, the brethren in this County are determined to hold on, and to prosecute the work before them with increasing vigour. They understand our principles thoroughly, they are strongly attached to them, and they are united in maintaining the Order, and seeking its extension.

The Wolfville Division No. 112 has been engaged during the year in active conflict with the illegal vendors of liquor. Five of them have

been brought under the lash of the law—two of them twice, one three times. Fines to the amount of \$95 have been inflicted; appeals to the Supreme Court have been unavailing. The members of the Division are encouraged by the result, and are resolved to use their best endeavors to root out the unboly traffic from their district. Bro. Geo. V. Rand has suffered for his zeal, a miscreant having set fire to his barn. This Division recently raised \$130 from a Bazaar for the liquidation of debt on their Hall.

#### LUNENBURG COUNTY.

County Deputy Rev. I. J. Skinner writing from Chester of the Division under his charge, says "Chester" is as usual plodding along, holding its own, and I think gaining ground; there are a number of its members always at their post, and I may say generally that the meetings are well sustained. We hope for an increase during the winter.—"Phænix" at Bridgewater, says Deputy Randall, "is progressing in a very favorable and satisfactory manner We have initiated quite a number both of Sons and Lady Visitors during the quarter past. The meetings have been held regularly and well attended, our new room being pretty well filled every night of meeting. Deputy Drew of "Noble" Division says: our Division seems rather on the decline; our greatest trouble is the non-attendance and indifference of members. We hope however soon to see better and brighter days."—Deputy Fayle at Vogler's Cove, states: "It has been hard work to keep "Cloumel" up during the summer—but hopes for an increase of interest, of numbers and strength during the coming quarter."

"Sherbrooke" is hanging its head; the people are so scattered in that locality that to keep the Division up great sacrifices have to be made on the part of a few. I hope, says Bro. Skinner, that the visits of our indefatigable Agents to our County will have a tendency to arouse the sleeping Divisions—awaken those that have ceased to live—and be the means of establishing new Divisions wherever practicable."

#### PICTOU COUNTY.

Deputy Roderick McGregor, of New Glasgow, says: 'We arehold ing our own—we have lost nothing the past six months. Summer is the season when brothers are most apt to withdraw from us. I however look forward to a good time this winter. We have the illegal Rum-Traffic doing all the mischief it can, but the Sons and Good Templars are at their post, holding up the Standard of Love, Purity and Fidelity."

Brother H. McKenzie, at Albion Mines, says, of that large Division: "We still hold our own notwithstanding all the Rum power it has to

contend with."

Bro. John Gauld, of River John, writes, of "Mainmast" Division: "We are lopping off unfraitful branches—for non-payment of dues.— Have initiated two; the careless indifference of members is much to be regretted. I hope for letter times in the future."

#### QUEEN'S COUNTY.

Bro. D. O. Parker, of Arbordale, writes pleasingly of "Bethesada" Division; we have, he says, voted Four Dollars to the Agency Fund, and we remain as from our first existence, enjoying peace and prosperity.

Bro. Wm. Jackson, says: "New Era" Division is working well. We have not had as many initiations of late as we could wish, but hope to have a prosperous time during the two coming quarters.

#### RICHMOND COUNTY.

Arichat, No 261, is in a healthy and flourishing state. The work in this Division goes bravely on. Its numbers have been greatly increased; many absent at sea have signified their intention of joining on their return, the majority, of the inhabitants being sea-faring men.

#### SHELBURNE COUNTY.

Brother Howard Locke writing from Locke's Island says: "I am very happy to inform you of the prosperity of our Division. We never had better attendance and the spirit of the Brothers is alive to the work. -

"Rockland" is progressing favourably."

Bro. S. K. Mood, says: "Palmerston" Division at Woods Harbour is in good working order—Initiated five since last Report, and hope to have a large accession to our Fraternity during ensuing quarter. We deeply regret the loss of five worthy Brothers who perished at sea during the late gales. "Guiding Star" at Shag Harbour, not so active as formerly.

#### YARMOUTH COUNTY.

County Deputy Bro. Rev. G. Christie gives encouraging information concerning this County. He states that Bro. McLarren says the work in "Mariner's Guide" is progressing slowly, at the same time it is adavncing; not only are they able to keep up better meetings of the Division, but they have organized a Band of Hope with 20 male and 25 female members. Brother Spinney of "Home of the West" also speaks encouragingly of his Division; that and the one last referred to contain many members who are obliged to be absent from home during the summer, but in both cases they have still been able to keep their meetings regularly. "Sailor's Guide" is equally satisfactory with the two already mentioned. These three Divisions are all in exposed places, and many of the members in their absence from home are frequently exposed to strong temptation. The Division however becomes a shield and protection from "the all pervading destroyer." The other Divisions in this County so far as heard from are in a state of efficiency; members are occasionally being cut off for non-payment of dues, - and a few prove unfaithful to the pledge. "Pittacus" is plodding along; so says Bro. B. B. Moses, and although made up principally of farmers and fishermen, our meetings have been well attended throughout the summer; a good degree of harmony, union and interest prevail.—"Ohio" has held no meeting for the past five months. I hope for better times. Heman Gardner speaking of "Central" says we have had a number added to the Division this quarter, and there has been considerable interest manifested by the members; that interest still continues, and we hope for a large increase to our membership in the coming quarter. Temperance seems to be gaining ground with us in the town and County too.

Bro. Abijah Hurd writes: "I have reason to believe that "Arcadia" is in good working order—the members faithful to her; our numbers are small, we make our meetings interesting, the community here is sober and industrious, and the cause of Temperance is progressing favorably among us."

#### THE BERMUDAS.

The four Divisions in the Bermuda Islands have many difficulties to contend with; yet they occupy their ground, although some of them have had their membership considerably reduced. Better times are hoped for when leading men will see it to be their duty to lend a helping hand in the work.

Such my Brothers is a somewhat hurried and imperfect sketch of the doings of our Order in this jurisdiction.

#### BANDS OF HOPE.

The Bands of Hope are increasing in numbers and I believe in efficiency.

The one at Scot's Bay has increased from 28 to 52.

Deputy McNeill of Digby County, writing from St. Mary's Bay, says we have a Band of Hope called the "Crystal Stream," organized in August by Bro. Barratt with 37 members. We have since added 32 making 69 in all. It is in good working order and the little folks are much interested. It is destined to become a nursery for the Division; already, three members have joined us, being now over 14 years of age.

Deputy McGregor of New Glasgow, says, we have just opened a fine Band of Hope, and adds, what strange infatuation that parents should stand aloof from us, and see their sons falling a prey to the Rum Traps.

Deputy Jackson, says: Our Liverpool "Band of Hope," which was organized in May 1866 is working well, and now numbers 74—48 boys, and 26 girls.

The Lady Visitors are also increasing not only in numbers but in usefulness to the Order. They have been the means of much good to many of our Divisions, who owe at least a debt of gratitude to those able and willing workers. When the finances are low and want replenishing, they are the first to lend a helping hand to increase it, and their sympathy and co-operation has done much to gladden the hearts and strengthen the hands of those who were ready to despair, and who could not of themselves devise the ways and means of attain-

ing a much desired or laudable object.

I will mention only one instance of their aid and comfort; The Lady Visitors of Athenaum Division initiated the practice of taking up what they termed "a Basket Collection" on every night of meeting—and the result of these collections for the year amounted to the very handsome sum of thirty dollars and sixty-eight cents, the whole of which was very generously handed over to the Agency Fund of this Grand Division, to carry out the good christian work in which we are now fairly embarked. "Mic-Mae" Division followed the example, but with what success I have not yet heard. Let me advise all the Representatives present to initiate "The Basket Collection" on their return to their several places of abode; none will be the poorer for the effort at our next annual session.

I would earnestly recommend the re-appointment of the old Committee who had charge of the subject of "The Inebriate's Home" or the appointment of a new Committee to bring that matter before our Legislature.

I would further recommend the appointment of another Committe to memorialize the City Council on a change in the mode of granting

Licenses to "All Comers."

This Grand Division might also, with great propriety, take into consideration the subject of County Temparance Conventions of the various Temperance organizations in our Province, or a Provincial Convention to devise ways and means whereby our Representatives may be operated upon, so as to give a greater prominence and a heartier and warmer support to Temperance principles when legislating on the subject in

our Provincial Parliament.

In closing my annual Report, it only remains for me to acknowledge the great assistance and encouragement I have received from Grand Worthy Associate Murray, and our ever active and untiring Grand Scribe. I have found the latter a most efficient and attentive officer, ever ready and willing to aid me by his experience and advice in the discharge of the duties devolving upon me. With these two Brothers I have been in almost daily conference on the state of the Order; and emergencies have arisen when it was of the utmost importance that prompt measures be taken. With these Brothers as advisers I have been enabled to take such action as has frequently been of service in the promotion of our much loved Order, and in preserving peace and harmony within our jurisdiction.

Finally, Brother Representatives, sustain our Agency operations by your prayers and your contributions; much remains to be done; thousands are yet outside our fold of safety; work to bring them in. Subscribe for, and circulate our organ "The Abstainer." It is deserving

your patronage.

Receive my sincere and heartfelt thanks for your kindness and forbearance with my many shortcomings. Attribute the errors I may have committed to over and ill judged zeal, rather than to caprice or

bad design.

Trusting that your carnest and best attention will be given to all matters that may be brought before you during our present session, and that the results of your present labors may redound to the glory of God, your own honor, the advancement of the interests of our social circle, and the temporal and eternal well being of never dying souls,

During the year the accessions to our membership have been large. and the additions to the number of our Divisions greater than in any previous year. In connection with this increase in our own institution, it is pleasing to know that the cause of Temperance has, through the efforts of other organizations, made good progress in Nova Scotia during the past twelve months.

For the success that has attended the efforts of temperance men engaged in the good work, and the associations with which they are connected, we have good reason to exclaim "Glory be to God in the highest," and to rely on His gracious assistance for further progress

during the year upon which we are about to enter.

STATE OF THE ORDER.

The G. W. P. having, in his Report, given full details of the State of the Order, it is unnecessary for me to repeat particulars, further than to add that our organization never had a more prosperous year than the past—never had so many working Divisions within the boundaries of its jurisdiction—and never had so large a membership of good, faithful working Sons and Lady Visitors as at the present time. The aggregate total of our numbership, Lady Visitors, and children in the Bands of Hope, is, in round numbers, about 16,000, a power that ought, and I trust will be felt in the land.

#### OPERATIONS OF PAST YEAR.

Since the last annual meeting of this body FORTY new Divisions have been instituted, viz.:—7 in Halifax County, 6 each in Colchester and Shelburne Counties, 4 in Guysborough, 3 each in Cape Breton and Kings, 2 each in Antigonish, Inverness and Yarmouth, and one each in Digby, Hants, Pictou, Lunenburg, and Richmond.

The new Divisions enumerated have a membership of 1720, with 916

Lady Visitors-two Returns wanting.

Our Agents have been in every County of the Province. Conjointly they have travelled 7,300 miles, addressed 300 public meetings, visited 100 Divisions.

During the year 22 Bands of Hope were instituted.

Nine Divisions have been resuscitated, and several that were about giving up their work reconsidered their intentions of surrendering their charters and are now prospering.

Ten Divisions were reported dead during the year, one of which, however, have resumed work. Of this number one only had held meetings since last annual session.

This brief summary of the year's operations, will, I trust, be both pleasing and satisfactory to the Grand Division.

#### AGENCY.

The Agency department of our organization has been prosecuted with vigor during the year, as the Report of the Agents and Agency Committee will show. A little more effort and liberality on the part of individuals and Divisions would make the Agency self-sustaining. To Brothers McArthur and Barratt the Order and the friends of temperance in this Province are much indebted for their zeal, energy, and indefatigable labours. To their exertions, and addresses to the people, may be attributed the greatest portion of the success of the cause during the year.

The monies received by me since last annual meeting towards the Agency Fund, amounted to \$749.37—being collections at meetings addressed by the Agents, and donations from Divisions and individuals. [This does not include collections, &c., by Bro. McArthur since July,

as he has not had time to make up his quarterly statement.]

#### VARIOUS MATTERS.

I would recommend that a form of quarterly, or half-yearly Returns be prepared for the purpose of obtaining statistical information from Bands of Hope at stated periods.

Since last quarterly meeting the Journal of Proceedings of National Division at last annual session were received; the supply not being sufficient to furnish each Subordinate Division with a copy, 50 additional copies were procured from the M. W. S., at a cost of \$7.50

In accordance with instructions given at April quarterly meeting, an edition of 1,000 copies of the Constitution and Bye-Laws, and Rules of

Order of this G. D. has been printed.

Canning Division, No. 196. having lost nearly all its property, including Ritual, &c., by the disastrous fire which destroyed Canning in June last, the Grand Officers supplied that Division with a sett of Ritual, Lady Visitors Ritual, T. and W. and Ode Cards, and blank Returns, without charge, trusting that the Grand Division will sustain their action in the matter.

It is with much satisfaction I have to acknowledge that Divisions have been more prompt in forwarding their Returns, a larger number having been received previous to my commencing this Report than in any previous term. There is yet room for improvement. I am in

hopes that all the Returns due for past quarter will be at hand before the Journal of this session is printed.

The grand gathering of Representatives at this annual meeting—the largest ever yet held—is not only an indication of our forces being alive and active in the cause, but a pleasing realization of the fact that our "ancient institution," as it has been called, is not "dying out on account of its old fogyism," but is yet full of life, and more vigorous than ever, with a greater supply of the "sinews of war" to battle with the common foe of mankind.

Brethren we are assembled in annual meeting in greater numbers than ever before. Let it not be your boast when you return to your homes merely that you had the privilege of heing present at such a grand meeting; but rather that on this occasion you adopted such measures for the advancement of the cause as will tend to extend the principles of total abstinence more widely, and rescue many from the paths of intemperance that are now either on the road to ruin or all but lost. We have a work to do this Session. Let us do it, and do it well.

Before concluding this Report I feel it a duty incumbent upon me to allude to the services of the Brother who last year you placed at the bead of this body. I dislike flattery, and it is not now my intention to flatter that officer. During my official relations with this Grand Division for the period of nearly eleven years, I can bear testimony to the zeal and ability of the worthy Brothers you have from time to time placed in the G. W. P's. chair, and with whom my intercourse was as harmonious as it was pleasing. But I must be allowed to say that Brother H. A. Taylor, during his term of office, has devoted his energies, and a large portion of his time, as well as means, in visiting Divisions and encouraging the Order. I must claim that a portion of the success of our Order during the year is due to his promptness and diligence. Now that he is about retiring from the chair, he can truly say—"I have done my duty faithfully." G. W. A. Murray has also rendered good service to our organization during his term of office.-With these officers I have been in almost daily communication on the affairs of the Order, and have received much assistance from them in discharging the duties of my office, the business of which has largely increased since the last annual meeting.

In conclusion, brethren, I pray that the Almighty will be with us during the labors of this Session, that He will favor us in the future as He has in the past, and that in the year upon which we are about to enter He will bless our efforts with success; and hoping that our meeting will be a harmonious and profitable one, I submit my eleventh annual report,

#### REPORT OF AGENCY COMMITTEE.

To the Grand Division Sons of Temperance in Annual Session.

The high importance of the trust committed to the Agency Committee need not be adverted to at any length in this annual report.

Your Committee is impressed with the consideration of the greatness of our enterprise, and cherishes a deep anxiety that the interests of the cause of Temperance, and of our Order especially as the foremost and most influential instrumentality in that cause, should by the agency employed under the auspices, and by the liberal assistance of this Grand Division, be stendily and continuously advanced.

We are justified in regarding the maintenance of the Agency work of this Grand Division as highly essential to the progress and prosperity

of the cause of total abstinence in our Province.

We feel persuaded that there is a strong necessity for unremitting effort to keep the public mind awake on this subject, and to endeavor to instil those principles of opposition to the use of strong drink and to its legalized sale, which we may strongly hope will ere long predominate and prove mighty in the removal of this evil entirely from our country.

To accomplish this result, Temperance missionary labor, by the employment of efficient agents and lecturers, cannot be dispensed with.

This Committee is happy in being able to report that the two brethren who, during the previous year, occupied the field with so much encouragement and success-P. G. W. P. Rev. Alexr. McArthur and P. W. P. R. M. Barratt-have been employed for the year past with equal, if not with even more gratifying results.

Through their instrumentality every County in the Province has been visited, and in all the principal towns and villages public meetings held for the advocacy of our principles-while many retired localities have been favored with addresses on Temperance that had never before enjoyed such a privilege.

These wide-spread and zealous endeavors on the part of our agents cannot but be fraught with the best results, even beyond what we can now estimate; but the more palpable benefits of their efforts are found in the healthy condition of the great proportion of our Divisions, the increase of our membership, and the large number of new Divisions formed during the year; all of which must be mainly attributable to the labors of these brethren.

So confident are we that the Agency Fund of this Grand Division is employed in a good and benevolent work, that we think it ought to be more generously sustained by members of this organization, and by those not of our Order who are friends of sobriety and of social and moral progress.

Looking to the means which have been employed, the Committee feel confident that the increase of our Order is to be mainly attributed to the zealous labours of our agents. The Brethren McArthuu and Barratt have devoted themselves to the work with untiring assiduity, and have manifested no small degree of prudence in the management of affairs, under circumstances of trial and difficulty. Their continuance in the field is greatly to be desired, The brethren of the Order, it is hoped, will exert themselves to the utmost to secure the necessary funds. A

wiser and more profitable outlay cannot be imagined.

It would be unpardonable in this connection to omit to notice the praiseworthy activity of the Grand Worthy Patriarch. That he has been able, in addition to the ordinary duties of his office, in a remarkably busy year, to visit officially so many Subordinate Divisions, for the purpose of inspection, encouragement and counsel, is a very gratifying fact. It has doubtless tended materially to promote the welfare of the Order. In discharging those duties the Grand Worthy Patriarch received very efficient aid from the Grand Worthy Associate, to whose zeal and diligence the first named officer bears grateful testimony in his

report, which the Committee feel is well deserved. The full details comprised in the Grand Worthy Patriarch's report, respecting the state of the Divisions, is of a highly interesting character, and will, no doubt, be perused with much satisfaction. It was not to be expected that the Divisions would exhibit uniformity of condition, the circumstances in which they are placed being so various. Obstacles and opposition may be looked for by every organization which aims at the moral improvement of man, and they should be encountered with firmness, and in a "meek and quiet spirit." The Committee beg to suggest to the members of the Order that they will best conduct its true interests by pursuing "the even tenor of their way," without allowing themselves to be diverted from duty by engaging in angry disputes.-And they further observe, that it is of the highest importance, especially in the present state of temperance affairs, that the Subordinate Divisions should use their most diligent endeavours to obtain the co-operation of intelligent and influential members of society in their respective districts. There are many in all neighbourhoods who admit the truth of our principles, and embody them in their practice, but still stand aloof from our organization. The enlistment of such persons in our ranks is peculiarly desirable.

The communication from the Most Worthy Patriarch contains information respecting the probable restoration of the Order in certain States in which it had lain dormant during the late war, which will be received with great pleasure. It may be hoped that ere long the Order will regain its influence in those States, and not only so but that throughout this continent of North America the principles which we advocate will prevail in all their elevating and purifying power.

It is a pleasing thought that by means of this Grand Division the Order has been introduced into New South Wales, and the brethren have doubtless listened with thankfulness to the letter read at this meeting, showing that the good cause has met with encouraging sucess in

that country.

The notices and recommendations contained in the reports of the Grand Worthy Patriarch and the Grand Scribe are eminently worthy of consideration. The following may be particularly mentioned:—The Asylum for Inebriates, which the Committee trust will be shortly established in this province; the desirableness of taking action in order to procure from the Legislature the separation of the sale of liquors from the sale of other articles on the same premises; the formation of county conventions, which would, in all probability, considerably promote the welfare of the cause; and the Abstainer newspaper, the organ of this Grand Division, which, although it has attained a respectable circulation among subordinate Divisions, which it well deserves, ought to be more extensively supported by individual members of the Order.

In conclusion, the Committee suggest the propriety of addressing a circular to the elergy of all denominations in this province, requesting them to bring the subject of Temperance before their respective congregations, and to encourage an habitual reference to it at meetings for prayer, in order that the blessing of God on our efforts may be continu-

ally and systematically invoked.

The time to separate has now arrived. Such seasons are to me very affecting. We are never sure of meeting again. Indeed it is probable

that we shall not all meet in another annual session.

This has been to us all a most satisfactory, and, I trust, profitable meeting. I have been pleased with the discussions, and much gratified with the result of our deliberations. I am pleased to see you, Grand Worthy Patriarch, in the honourable position which you now occupy. I am also pleased with the selections made by this Grand Division for the other officers.

Some of our discussions have been pretty lively, and for a while, exciting; but I am happy to know that all ill-feeling that had sprung up soon passed away, leaving us in the enjoyment of harmony—such as should ever prevail among brethren. I like discussion. There may be momentary irritations, but it soon subsides—leaving only such beneficial effects as the storm which purifies the atmosphere. Our discussions have done good by bringing into the strongest possible view the arguments on both sides of the question—thus preparing us to give up opinions that are untenable, and by furnishing us with the arguments of opponents, enabling us to prepare to meet them at the proper time.

We will all, I trust, return to our homes, prepared to labor with still greater zeal in this great and noble cause. Our spirits are refreshed by the cheerful tidings of success brought to us from various sources, but especially by the Reports of the late Grand Officers. We feel that we are not laboring in vain—and a consciousness of this never fails to urge the strong to greater efforts and to encourage the timid to put forth

more strength.

The year just closed has been remarkable for the progress of our cause. The Officers upon whom the responsibilities and labours now especially devolve, may, possibly, not see such abundant fruit of their labours. But, Grand Worthy Patriarch, you must remember that success cannot always be measured by the results which we witness. The cause may still be prospering when we cannot point so triumphantly to the tokens of success. When the tide is rising, we often see a great wave sweep far up upon the beach, to be followed by another that does not reach so far. But we do not therefore conclude that the tide has ceased to rise. Wait a little longer and you will see another wave advance beyond any that preceded. Just so is it in moral reforms. We must not only judge by appearances. If we do our duty, the work will go forward. Diligence will secure success, even though there may be circumstances in which this success may not be so apparent.

We now part. Let us do so, thanking God for past success, and anticipating the future with ealm confidence. Let us end avour to do our duty—and then we may hope to hear at last the words of our master

saying," well done good and faithful servants."

The Minutes of this sitting were read and approved. The Grand Division closed at 1.15 o'clock P. M.

The attendance of members at this Session was larger than ever before, and more Subordinate Divisions were represented than at any previous meeting. The Session was harmonious and very interesting throughout.

#### Worthy Brothers :-

The following table contains a statement of my labours as your agent and lecturer during several months, ending with October 1866, from which it will be seen that I have visited and lectured in 66 places in the Counties of Picton, Antigonish, Guysboro', Inverness, Richmond, Victoria, Cape Breton, Halifax, Lunanburg and Queens. In the prosecution of my mission I have travelled 1318 miles, and collected to the Agency Fund \$160.11. There has been a revival of the Temperance cause during the present year—very cheering to the heart of the philanthropist. My meetings have been large and interesting. I lectured in places where before the voice of the temperance lecturer had never been heard. I have received assistance from clergymen all denominations, causing twenty of them to deliver good addresses.—Want of time prevents me from going into detail, but you are respectfully referred to my published "notes" for all the facts connected with my mission.
