An Act to amend the Dominion Elections Act.

HER Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:—

- 1.** Section 22 of *The Dominion Elections Act*, chapter 8 of the Revised Statutes, is amended by striking out all the words after the word “paper” in the sixth line. R.S.C., c. 8,
s. 22 amended.
- 2.** Section 28 of the said Act is amended by inserting the words “standard time” after the word “o’clock” in the third line, and inserting after the word “it” in the fourth line the words “and in electoral districts containing, comprising, or being part of a city of upwards of ten thousand inhabitants, the polls shall be kept open until eight o’clock, standard time, in the afternoon.” Section 28
amended.
- 3.** Section 35 of the said Act is amended by inserting the words “standard time” after the word “clock” in the third line, and by inserting after the word “afternoon” in the fourth line the words “and in electoral districts containing, comprising, or being part of a city of upwards of ten thousand inhabitants, the poll shall be kept open until eight o’clock, standard time, in the afternoon.” Section 35
amended.
- 4.** Section 46 of the said Act, as enacted by section 4 of chapter 13 of the statutes of 1895, is amended by striking out the word “circular” in the fourth line. Section 46
amended.
