The foregoing particulars I trust may be found satisfactory, as I have endeavored to give all information which will be found necessary to form an intelligent opinion of the working of the institution for the year (889).

In conclusion, I wish again to draw the attention of Council to the great importance of procuring water supply before another season. There are now 30 or 40 or more men in Jail being kept at the County expense, when they could be laying water-pipes from the Home, and pipe can now be bought very, reasonably; besides having a supply we could have fire protection. It would be a very sad matter

sfactory, as 1 ound necesc institution

f Council to other season, the County Home, and ng a supply sad matter indeed to have a fire occur at the Home, and no means of helping ourselves ; and with so many old people as are there, it seems to me at least the County are morally bound to protect them.

I also wish to draw the attention of the Council to the importance of defining more particularly the class of inmates to be admitted, otherwise it will soon be an asylum, which as I understand it was not the intention. There are several persons now in who should be at a Provincial Asylum, for which the County pays their proportion.

There is no reason why, if the County see proper to keep this class of persons, they should not do so; but to do so some provision will have to be made by way of separate cottages, where they can be confined and cared for. The man Ward, sent by Niagara Falls, was admitted upon condition that the physician reported that he was a fit and proper person to be admitted. The physician reported adversely that he was a fit and proper person; the Town was notified accordingly, and they object to remove him. It would be well to know who governs the Institution, so that we will not be running into contact with any person in trying to fulfil our duty. The Bylaw governing says that admission from Niagara Falls shall be by arrangement by the Committee, for the time being, and the Town of Niagara Falls.

On behalf of myself and those who have to go frequently to and from the Home, Iask that we may have a one or two-plank walk, as it has been almost impossible to get to the Home during the Fali and this Winter thus far. The walk can be put down by the inmates : the expense would simply be the planks.

After the experience of the last year, I can only add to my good opinion of the Keeper and Matron of the Institution, and would recommend an increase of salary for the Matron, as I think she justly deserves it.

As many new members are in the Council this year, I would respectfully extend an invitation to all to visit the Institution, which would enable them to speak with more precision when matters relating to the Home are brought forward before Council than they otherwise could. I subjoin the Financial Statement and Balance Sheet of the Institution.

The tender of R. F. Carter & Co. for heating the Turnkey's residence, being the lowest, was accepted by your Committee, and they were ordered to proceed with work at once.

Your Committee at same time gave Carter & Co. orders to heat bath-room, which has been done at a cost of \$17.00.

Mr. Carter being present advised your Committee to have main steam pipes and return pipes under the floor felted and covered with asbestos paper, which would materially save fuel and heat, and that the cost of such work would be saved this season. He gave your Committee an estimate of the cost thereof, and they considered it would be economy to carry out Mr. Carter's suggestions, and therefore they concluded to have the work done.

There has been covered with asbestos, felt and canvas about 500 lineal feet, running from 1.12 inches to 4 inches in diameter. There yet remains about 30 feet of 2-inch pipe to be done in Turnkey's room in basement, also return pipes under the floor of main building. The return pipes under Turnkey's residence are covered with asbestos, felt and gauze-wire instead of canvas, to prevent rats from tearing off the felt.

In the opinion of Mr. Thomas Mains, the person who did the work, and who has been employed around the jail at various times, there is saving of fuel since pipes were covered, notwithstanding the





For present information I might say that the north-east corner of Gainsborough was located at a very early date, and from this point as located a line was run south to the Chippawa. The Township of Gainsborough was laid off, abutting on this line, and a road allowance provided for east of it. The Township of Pelham was laid off at a later date.

From this same starting point, the north east corner of Gains-

borough, a line was run north. The Township of Louth was first laid out abutting on this line, and a road provided to the west. Clinton was subsequently laid out, and in doing so, provision for a road was made west of the originally surveyed line, thus leaving a jog to the west of one chain at the Gainsborough corner.

Aubrey White, Esq., Assistant Commissioner of Crown Lands, Ontario:

SIR : -1 have the honor to submit the following report of a survey made in obedience to instructions received from your department, dated the 21st of September, 1886 : "To survey the Town take between the Townships of Pelbam and Clinton, and to plant stone monuments at the ends of each concession line in the said. Township abutting thereon."

Previous to commencing this survey, due public notice was given of the time and place of commencing operations, and all parties interested were requested to produce such evidence as they might be in possession of regarding the original survey.

The amount of verbal evidence so obtained is quite limited.

The written intormation regarding the first surveys made in this locality go to show that the north-east corner of Gainsborough was located at a very early date. The east boundary of Gainsborough was run from this corner, of which survey the field-notes are of record. The Township of Pelham was surveyed from the east at a later date, and closed on this line. Provision was made for a road between the townships, east of the Gainsborough line, or out side of the lands first surveyed.

There was also from the north-east corner of Gainsbo ough a line run north at a very early date. Access to field notes of this line are not to be had, but a sketch by Abraham Iredell of a retrace of this line is of record, and the few measurments written th reop are sufficient to connect it with lines now found on the ground.

On this sketch is noted the position of "two posts, one chain apart, and number twenty-three on the east side." The last or west tiez of lots in Louth is numbered twenty-three. This fact goes to show that when the Township of Louth was surveyed, it was bounded by this line, and no provisions made ter a read to the east of it. The Township of Louth was surveyed before the Township of Clinton, and, as in the case of Guinsborough, it appears the intention was to place the road outside or beyond the land highs surveyed. The dimensions of the lots on either side of the line also bear out this view, the width of those in Louth varving but little from that intended in the original survey, while those in Clinton contain a large surplus.

It does not appear from any source that more than one line was run in the original survey, and that line as now marked on the in the said

one line was rked on the ground and is undisputed. It started from the Gainsborough corner, and forms the west boundary of the Township of Louth.

The only dispute or difference existing between residents in the neighborhood is with reference to the position of the road in relation to the surveyed line. From in Pelham claim the road should be west, and those in Clinton that it should be east, of that line.

In 1832 George Rykert, deputy provincial surveyor, under in structions from William Chewitt. Esquire, acting Surveyor-General, etc., made a survey of the "gore and adjoining lands in Clinton," A report of this survey, with sketch and field-notes, are of record in the Department. On the sketch is an indication apparently of the stone at the Gainsborough corner, and were no reference made to the location of this road in the report, the conclusion would bethat Mr. Rykert found that it should be placed east of that stone, but reference to his report shows this view to be erroneous : the apparent indication of the position of the score on the sketch must have been unintentional. The following paragraph is taken entirely from Mr. Rykert's report of this survey :

"There appears to be a doubt existing with some whether "the allowance for road between the Township of Louth and "Clinton should be to the east or west side of the marked line. "There is only one marked line to be found, and the road now open "is to the west, which I am inclined to think is correct, on the "ground that Louth must have been completed before Clinton was "commenced, and the roads being generally outside of the stakes "governing the townships : besides, it is evident that the first range " of lots in Clinton have still more than their usual width."

Enclosed herewith is a copy of an affidavit by George C. Bradt, who was born and brought up in the vicinity (on lot one, cone ssion ten, Ciniton). H + speaks of a survey made by Mr. R kart some twelve years after that made by him of the gore and adjoining lands in Clinton. It was made for the purpose of establishing the bound try between lots one and two in the tenth concession of Clinton. The division that made by Mr. Rykert is now to be found to conon that occasion he placed the road allowance west of the surveyed line.

The affidavit of John Moot, senior, is also herewith. He employed Mr. Rykert to locate lines for him, and the position of those lines as now found show that the road allowance was placed west of the surveyed line.

That the road should be west of the surveyed line is plainly the opinion of residents, as they have opened it in that position, and encroachments on the limit of the road allowance are small.

Having failed to find any evidence going to show that the road should be east of the surveyed line, and esteeming the reasons above given sufficient to warrant its location to the west of that line, I have parated stone monuments measuring from three and a-half to four feet in length, cut from Queenston limestone, squared eight inches at the top, and beyeled, to mark the limits of a road to the west of the surveyed line, in the manner laid down for my guidance in the instructions I have had the honor to receive from the Department.

No dispute is found regarding the position of either of the concession roads on which monuments are to be placed. The one in Pélham is marked by a stone, which probably indicates correctly the position of the concession road, as the distance from the Gainsborough corner to it closely corresponds to the distance given on Iredell's sketch before referred to. Many years ago, however, when making a survey in the tenth concession of Clinton, it came to my knowledge that this stone had been heaved out by frost, and lay on the surface for a time. It had then been replaced, but did not range with other monuments marking the township line. I have therefore, in planting the stones for this road, put them on the line of monuments known to be reliable.

The southerly of two stones marking the road between the ninth and tenth concessions of Clinton, planted on the surveyed line between the townships by Mr. Rykert, has evidently been tampered with, or was incorrectly planted. The letter (R) which should indicate the concession road and be placed to the north, is turned east. the surveyed

No. I.) designating the number of lot in Clinton, and which should be placed west, are turned north, and the letter (X) for tenth concession, Clinton, which should face south, is turned to the west. The length of the tenth concession in Clinton is given by Mr. Rykert in his report of 1832 as fifty chains. To this stone it lacks six links of that distance, whereas to the north stone the distance corresponds to that laid down by Mr. Rykert. The stokes marking this road, therefore, have been planted, using the northerly stone.

William Pysher, who lives on lot 22, concession 8. Louth, is the only witness from whom information was to be had regarding the south-west corner of Louth. He knew of a stone when he was a boy going to school standing at this corner, but it has been gone for a very long time. Mr. Pysher's father and his neighbor to the east bought from Fretz, the owner of lot 23, a strip of land two rods wide, taken from the south end of this lot for a road. This two rods had been measured from the stone referred to. By reversing this measurement from the fence to the supposed position of the stone, it was found builted three or four inches below the surface, evidently having been lifted by the frost and fallen over. It stood on low and mucky ground, and had gradually sunk in the soft soil, being outside of the fence ; as the road was improved it became covered to the depth at which it was found.

I feel justified in regarding this stone as marking the original corner of Louth, from the fact, as shown by Pysher's affidavit, that it was so regarded by his father. It was also so regarded by Fretz' father, who owned lot 23, as the corner of this lot. Pysher and Fretz are now both old men.

No road is opened between the townships of Louth and Pelham excepting on the rear of lots three and four of Louth, it is there opened outside the limit of Louth. As might be expected, no information can be got on the ground regarding a road between these townships. The maps of record show that a road allowance is contemplated. There is, I think, no doubt that it should lie outside the limits of Louth.

The stones here have been planted in accordance with this view.

Enclosed Herewith is a plan of the survey, with field notes and copies of the evidences of the witnesses examined, all in triplicate.
