An Act to legalize By-law number one hundred and sixteen of the Corporation of the Township of Bayham, and to declare the Debentures issued under the said By-law legal, valid and binding on the said Corporation.

An Act to legalize the By-law number one hundred and sixteen of the Corporation of the Township of Bayham, and to declare the Debentures issued under the said by-law legal, valid and binding on said Corporation.

WHEREAS doubts have arisen as to the legality of the by-law number one hundred and sixteen of the Municipal Council of the Township of Bayham, intituled: "By-law granting a loan of money to the Bayham, Richmond and Port Burwell Road Company;" And whereas debentures have been issued under the said by-law, and the holders of the said debentures have petitioned to have such doubts removed, and the said by-law and debentures made and declared to be legal and valid: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts and declares as follows:—

1. The said by-law, for and notwithstanding any irregularities or defects in the passing of the said by-law or in the proceedings preliminary thereto, or any insufficiency at law therein in substance or in form is hereby legalized and made valid, and shall be held to have been valid from the time of the passing thereof; and all debentures, with coupons thereunto attached, issued, and proceedings and dealings heretofore made and had, or hereafter to be made or had, under the said by-law, are also hereby declared legal and valid.

Certain by-law of Bayham declared valid and proceedings in virtue thereof declared legal and binding.

2. This Act shall be deemed a Public Act.
