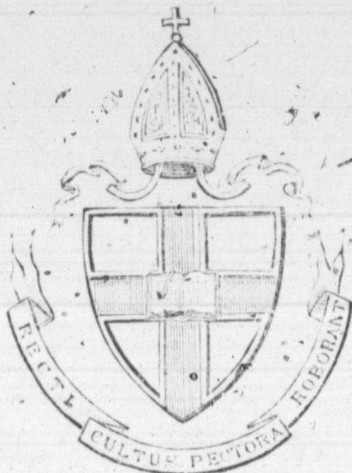

THE COLLEGE.

The administration of Bishop's College is in the hands of a Corporation, consisting of the Bishops of the Province of Quebec, the Trustees and the College Council. Each Bishop of the Province has the right of appointing three Trustees and three members of Council on his own nomination, and five Trustees and five members of Council out of a larger number of persons nominated by the Synod of the Diocese for that purpose.

The members of Corporation are appointed for three years. The term of the present members expires on June 30th, 1899.

MATRICULATION.

SUBJECTS FOR EXAMINATION.

Greek.—Xenophon, Anabasis I. and Grammar.

Latin.—Caesar, Book I., Virgil, Aeneid I., Grammar and easy Composition.

English.—Dictation, Grammar, Composition.

English History, as in Robertson's Public School History of England, or, Collier's Advanced History of England.

Mathematics.—Euclid, Books, I., II. and III.

Algebra to Quadratic Equations (inclusive).
Arithmetic.

In the Latin and Greek papers, easy sentences for translation into those languages, based on the prose author, will be given.

A paper in French will also be set on the Grammar and easy sentences, English-French and French-English.

It will not be necessary to pass in this paper, but the marks gained, if over 33 per cent., will be counted for rank and scholarships.

Free Tuition, worth \$50 a year for three years, is offered to the best candidate who shall obtain a two-thirds aggregate and passes in all subjects, (resident students preferred).

DEGREES IN DIVINITY.

WITHIN THE ECCLESIASTICAL PROVINCE OF CANADA.

In pursuance of Regulations adopted by the Convocation in 1889, Degrees in Divinity (apart from those conferred *Jure Dignitatis*) are for the present granted only in accordance with the system proposed in the Canon of the Provincial Synod on this subject.

LICENTIATE IN SACRED THEOLOGY.

Graduates in Arts of this University, or of other Universities recognized by it, and such other persons as shall have been accepted as candidates for Holy Orders by the Bishops of Quebec and Montreal, or have been approved by them, or either of them, as worthy of admission to the course, may become students in Divinity, and, after a period of two years of residence, may proceed by Examination to the title of Licentiate in Sacred Theology.

Such students are required to pass the Examinations at the end of every term during the two years.

During and after the year 1900, students in this department will be required to pass the "Preliminary Examination" under the Canon of the Provincial Synod, as (*pro tanto*) qualification for the title of L.S.T.

PROCEEDINGS IN ARTS.

BACHELOR OF ARTS WITH HONOURS.

The Honour Courses each consist of three grades, the first or highest extending over three years, the second over two years, the third over one year.

Information as to the requirements for the Honour courses may be had on application to the Principal or the Registrar.

All candidates for Honours and options, except Theological, are required to take as Theological subjects in the year 1899:

1. Hebrew, as in L. S. T. Course. [Alternative, Exodus, as in Third Year (ord.), or Genesis, as in Theological Honours, with Book of LXX.
2. Acts in English.

FOR THE DEGREE OF BACHELOR IN MUSIC (MUS. B.)

The candidate for this Degree must be either:

- A.—A Graduate of this or some other recognized University; or
- B.—A Clergyman in Priest's Orders; or
- C.—A Barrister-at-Law; or
- D.—One who can produce a certificate, signed by a Graduate of this or some other recognized University, or by a known Teacher of Music, testifying that the applicant has employed at least five years in the study and practice of music.

The Degrees are open to women qualified under A. or D.

The examination consists of Four Parts, viz.:

- Part I.—The First Examination.
- Part II.—The Second Examination.
- Part III.—The Exercise.
- Part IV.—The Final Examination.

These Four Parts can be passed only in their proper order.

Part I.—The First Examination, held on the first Tuesday in May, will comprise:—

- (a) The Rudiments of Music.
 - (b) Harmony in Four Parts, and
 - (c) Counterpoint in Three Parts.
- (Combined Counterpoint not required.)

Any candidate intending to present himself for examination must give notice to the Registrar, not later than February 1st, on a printed form, which will be supplied on application.

A candidate, on passing this examination, will be entitled to receive a Testamur, signed by the Dean of Arts, the Registrar, and the Examiner in Music. His name will also be inserted in the University Calendar.

Part II.—The Second Examination, held on the day following Part I., will comprise:—

- (a) Harmony, in Five Parts.
- (b) Counterpoint, in Four Parts.
- (c) Double Counterpoint in the octave; and
- (d) Fugue, in Two Parts (particularly subject and answer).

Any candidate intending to present himself for examination must give notice, and send his Testamur, received for Part I., to the Registrar, not later than February 1st, on a printed form, which will be supplied on application.

A candidate may be examined in Parts I. and II. on consecutive days by obtaining special permission from the Registrar, when he gives notice of presenting himself for examination. Without this *special permission* from the Registrar, there will be an interval of at least one year between Parts I. and II.

A candidate on passing this Part will be entitled to receive a Testamur, signed, etc., as before.

Part III.—Consists of an Exercise, which must be a sacred or secular choral work, occupying from twenty to twenty-five minutes in performance. It must have an accompaniment for a string orchestra (also, if desired, an organ), and be written for the occasion.

It must contain at least four movements:—

- (a) A Five-Part Chorus.
- (b) A Solo or Duet.
- (c) An Unaccompanied Quartet; and
- (d) A Four-Part Choral Fugue.

This exercise must be in the hands of the Registrar by January the 1st, with the Testamur received from Part II., and a Declaration signed by the candidate, and witnessed by a magistrate, certifying that the work is his own unaided composition.

Part I.—The Exercise must be a sacred or *secular* choral work written for the occasion. It must be scored for a full orchestra, and occupy from forty to sixty minutes in performance.

It must contain an overture, written in the "form" of the first movement of a symphony; some portion for one or more solo voices; at least one specimen of Canon for four voices; also of Fugue; and at least one movement written in eight-part counterpoint.

(Instead of writing this Special Exercise for Part I., a candidate may submit not less than three works of his own—published or unpublished—upon which he would found his claim for a Doctor's degree; such works must include either a cantata, or an opera, or an oratorio, or an example of chamber music, or a concerto, or a symphony for full orchestra.)

This exercise (or its equivalent referred to above) must be in the hands of the Registrar by January the 1st, with the Diploma received by the candidate on his taking the Mus. B. Degree. A candidate on passing Part I. will be entitled to receive a Testamur, signed, etc., as for the Mus. B., which Testamur will be in the hands of the Registrar by the last day of February.

Part II.—The Final Examination will be held on the first Tuesday in May, will consist of:—

PROCEEDINGS IN MEDICINE.

The Faculty of Medicine has its seat in Montreal (Ontario and Mance Streets). Convocations are held annually for the conferring of Medical Degrees in that city.

The Degrees of this Faculty are those of Master of Surgery (C.M.) and Doctor of Medicine (M.D.), the former being conferred only upon those who at the same time obtain the Degree of Doctor of Medicine.

The College building contains large lecture rooms, several smaller lecture rooms for Practical Chemistry, Practical Physiology, Histology, Bacteriology, etc., and large, airy, well-lighted dissecting rooms at the top of the building, isolated from the rest of the class-rooms. Under the new Anatomy Act of the Province of Quebec, ample material for dissection is provided at moderate rates.

The Histological, Physiological and Bacteriological Laboratories are supplied with a complete outfit of Microscopes, Microtomes and of Bacteriological and other modern apparatus. The Pharmacological Laboratory, besides possessing a very complete cabinet of drugs and their preparations and alkaloids, has all the necessary appliances and means for the working of B. P. preparations and every facility for practical dispensing. Recently the Faculty has expended another large sum for apparatus in several departments, to facilitate practical teaching.

The 29th session of this Faculty will commence on Monday, 2nd October, 1898, and will be continued regularly until June, the usual Christmas vacation intervening.

The course leading to the degree of C.M., M.D., extends over four years, and consists of four sessions of six months each, and three Summer Sessions. Students who require the Quebec license will be given an extended course in order to comply with Quebec laws.

The lectures and demonstrations in each Annual Course are given during a period of nine months, beginning in October.

The Faculty of Medicine of Bishop's College aims at imparting a thoroughly practical medical education, and its facilities for doing so are in many respects, unequalled in Canada. In addition to the regular course of didactic lectures, students have the advantage of extensive and varied hospital privileges.

2. Latin, including Grammar. Translation from Cæsar de Bello Gallico, Books I and II, or Virgil's Aeneid, Book I, and Translation of easy passages not taken from such authors.
3. Mathematics, comprising (a) Arithmetic, (b) Algebra as far as Simple Equations, inclusive, (c) Geometry, the sub-

ject matter of Euclid, Books I, II and III, with easy deductions.

4. Botany, as in Gray's School and Field Book of Botany.

5. One of the following optional subjects:—(a) Greek, (b) French, (c) German, (d) Italian, or any other modern language, (e) Logic.

NOTE.

The General Medical Council of Great Britain will only register students whose certificates show that all the above subjects (Botany excepted) have been passed at the same time.

BISHOP'S COLLEGE.

By an Act of the Legislature of the Province of Quebec passed in the year 1843, Bishop's College was constituted a body corporate, consisting of the Lord Bishop of Quebec (or in case of the division of the Diocese of Quebec, of the Bishops of the Dioceses into which the Diocese of Quebec should be divided), the Trustees of the College, and the College Council.

By a subsequent Act of the Legislature of the Province of Quebec, passed in the year 1870, the governing body of the College was materially altered, with the object of bringing the College into more immediate connection with the Synods of the Dioceses of Quebec and Montreal. According to the terms of this Act, three Trustees and three members of the College Council are appointed by each of the Bishops of the two Dioceses now contained within the Province of Quebec, and five Trustees and five members of the College Council are selected from a larger number in each case nominated by the vote of their respective Synods; members of the Corporation hold their seats for three years and are eligible for re-appointment.

Bishop's College, which owes existence to the earnest and untiring efforts of the late Bishop Mountain, of Quebec, was designed in its foundation to satisfy a two-fold need: first, to provide the Church of England in the Province of Quebec with a suitable place for educating her ministry; and, secondly, to offer to the Province at large the blessing of a sound and liberal education based upon religious principles.

The village of Lennoxville was selected as its site, on the grounds of its central position, in the midst of the English-speaking population of the Province of Quebec, and the prospect it afforded of moderation in the scale of expense to individual students, and in consequence of the efforts of Rev. L. Doolittle and other local churchmen.

Residence within the College is the rule and characteristic of the system of Education in Bishop's College, the common Collegiate Life, after the model of the great Universities of Oxford and Cambridge, being regarded as a training of great importance. The work of the College began in October, 1845.

Among the benefactions made to the College may be mentioned:—

1845. Liberal donations from friends of the Church in Quebec, Montreal and the neighborhood of Sherbrooke and Lennoxville, and \$5,000 from the S. P. G., and the same from the S. P. C. K.

1847. More than \$10,000 raised in England by the Rev. J. H. Nicolls, D.D., Principal of the College, including \$5,000 from S. P. C. K. About the same time \$30,000 was given to Bishop Mountain by a munificent friend, Thomas Churchman Harrold, Esq., of Little Horkesley Park, Essex; Miss Leeds, of Ipswich, Suffolk, giving \$1,000.

In 1848 the S. P. G. offered an annual grant of \$1,200, shortly afterwards commuted for a sum of \$16,000.

1849. Professor Hellmuth (afterwards Bishop of Huron) collected \$4,000 in England.

1861. Numerous donations towards new School Building erected on site adjoining College.

1862-3. Endowment Fund, \$10,000, carrying free tuition, subscribed by various friends in shares of \$500.

1865. Rev. Dr. Nicolls, Principal, collected funds in England to supplement endowment.

1874. Large subscriptions obtained by Rev. C. H. Badgley, Rector, and others, towards rebuilding school.

1884. In this year and about this period the Harrold Fund for Professorship of Divinity (\$25,000) was raised by the untiring efforts of Professor Roe, D.D., (now Archdeacon of Quebec), and begun by noble gifts from two friends of the College in the Diocese of Quebec; also by the same initiative a fund now reaching \$11,000 was raised towards the endowment of the Principalship, since raised to the neighborhood of \$20,000.

1886. The sum of \$29,000 was left to the College by two ladies of Quebec, Mrs. Davies and Mrs. Davidson, for a Professorship and Divinity Exhibitions. Part of this has been applied to the Professorship of Mathematics.

1886. Fund of \$6,000, raised by subscription, begun amongst the Alumni and Old Boys at the Alma Mater Dinner, to build the Bishop Williams Wing, on the suggestion of the Principal; the insurance of this was applied towards the present Bishop Williams Hall, which is used as the Convocation Hall of the University.

1888-9. Fund of \$15,000 raised by subscription to build the Divinity House, collected by the Principal.

1888-90. A sum of \$11,000 raised by efforts of Archdeacon Roe towards the endowment of the Jacob Jehoshaphat Salter Mountain Professorship of Pastoral Theology, and \$4,000 was given to endow the Divinity House by Dr. Mountain, in addition to a liberal donation to the endowment of the Professorship.

1891. Special grant from Provincial Government, \$10,000, in consequence of disastrous fire of February, 1891. About the same time \$15,000 or more was raised to supplement the insurance money (\$41,000), and to provide for improved and more substantial buildings. Most of this was raised through the efforts of the Principal, Dr. Adams, and the Head Master, H. J. H. Petry, Esq.

The school has cost about \$57,000, and no debt remains on the building.

Of the \$15,000 raised in 1891, Mr. R. Hamilton gave \$4,000, and Colonel Charles King, of Sherbrooke, \$1,000, which was devoted to the Chemical Laboratory bearing his name.

Many friends have aided in the above benefactions, amounting to not less than \$100,000, during the years 1884-94. Amongst those who have rendered aid on a large scale may be mentioned the late R. Hamilton, Esq., D.C.L., Rev. Dr. J. J. S. Mountain and Hon. E. J. Price.

The College Chapel, originally built (1857) through the exertions of the late Principal, Dr. Nicolls, was enlarged

(1875-8) in memory of Fulford, the benefactors of the College. The chapel is now altogether unworkable. Chapels of the College were opened for worship in the stalls, floor and all the windows were set being from the roof and carried out.

Memorial windows were placed in memory of another of Rev. Dr. Nicolls, in memory of Bishop Mountain, in memory of the Rev. Dr. J. J. S. Mountain.

The system of the College completed owing to the efforts of the Rev. Lord Bishop of Montreal, more than \$300 towards the building.

Some of these benefactors, Colonel Charles King, Mrs. Nicolls, Mr. Hamilton and W. Osgood.

The College has adopted an improved plan. There are three classes of Professors and Lecturers.

In 1890 a Library was provided for the students, a Conference Room, a Comptroller's Office, and room for the Registrar in 1893. It has since subscribed \$6,000.

(1875-8) in memory of the late Bishops Mountain and Fulford, the Rev. L. Doolittle, one of the earliest benefactors of the College, and finally Dr. Nicolls himself. The chapel is well adapted for its sacred uses and not altogether unworthy to be compared with some of the Chapels of the great English Universities. It has been opened for worship since January, 1893. In January, 1898, the stalls, floor and western wall screen were completed, and all the windows are now fitted with stained glass, the whole set being from designs suggested by the Bishop of Quebec, and carried out by Messrs. Spence & Sons, of Montreal.

Memorial windows have been given by Bishop Dunn, one in memory of Rev. Dr. Lobley, the second Principal, and another of Rev. L. Doolittle; by Chancellor Heneker, to the memory of Bishop Williams; by the ladies of Lennoxville, in memory of the first Principal, Dr. Nicolls; by the late Mrs. Nicolls, in memory of Bishop G. J. Mountain; and by Rev. Dr. J. J. S. Mountain, in memory of members of his family.

The system of windows in the Chapel has been lately completed owing to the generous gifts of Hon. E. J. Price and the Lord Bishop of Quebec, and through the persevering efforts of the Rev. T. L. Ball, M.A., who has collected more than \$300 towards the windows.

Some of these windows commemorate: the first four Chancellors, Colonel Morris, Rev. Dr. Reid, Hon. David Price, Mrs. Nicolls, Mrs. Williams, Edward Chapman, A. D. Nicolls, and W. Osgood.

The College Buildings were restored in 1875, on an improved plan. Besides the Students' rooms and a dining hall, there are three lecture rooms and a reading room for the use of Professors and Students.

In 1890 a Divinity House was erected, containing a residence for the Professor of Pastoral Theology, two Lecture Rooms, a Common Room, a room used for devotional offices, and rooms for Students. The building was completed in 1893. It has cost \$15,000, of which Mr Robert Hamilton subscribed \$6,500, Hon E. J. Price \$3,000, S. P. C. K. £300

In May, 1897, Mr. J. H. R. Molson, who had already subscribed \$5,000 to the Jubilee Fund, bequeathed the sum of \$10,000 for the benefit of Bishop's College School.

Later in the same year Mr. A. D. Nicolls bequeathed \$3,000 to establish Scholarships in memory of his father, the Rev. J. H. Nicolls, D.D.

The Library has been to a certain extent replenished, and now contains upwards of 8,000 volumes, including many most valuable modern works in Theology, General Literature, Mathematical and Physical Science, Classical and Philological Research, but requiring much liberality to keep it adequately equipped.

A small Museum of Geological and other specimens has been collected, and it is to be hoped will be greatly increased by contributions from Students and other friends of the College.

1895-8. The institution began its work in 1845, and celebrated its jubilee in 1895. To mark this event, and to meet the continued demands of an ever-advancing standard of education, it was resolved to raise a Jubilee Fund, the sum intended being Fifty thousand dollars, at least.

The following objects have been aided by the Jubilee effort:

- A. The Headmastership of the School. \$25,000 (including residence).
- B. The Professorship of Classics in the College, at least \$20,000 is required for this, of which \$10,000 has been subscribed.
- C. J. J. S. Mountain Professorship of Pastoral Theology, raised to \$25,000.
- D. Professorship of Applied Science. (\$1,200 in hand).
- E. Principalship Endowment raised to \$20,000.
- F. Restoration of the Chapel and gifts of windows, nearly \$5,000.
- G. For a new Gymnasium, \$4,500.

Bishop's College.

The College offers an Academic Course in Arts and Divinity. The Course is modelled on the lines of Oxford and Cambridge. The College resembles the Colleges of those Ancient Universities in that the Students are resident within its walls. Mathematical, Classical and Theological Honor Courses are open to Students who pass a required standard.

ADMISSION.

Candidates for admission into the College are required to present testimonials of good conduct, and may be admitted either as matriculants or as candidates for matriculation in the Preparatory Class, the members of which attend Lectures on the Subjects of Matriculation Examination.

Members of any other recognized University are admitted to the same standing on presentation of the necessary certificates under certain conditions, and payment of Registration Fee.

Casual students, and such as cannot keep continuous residence, may, with the approval of the Principal, attend particular courses of instruction, without becoming regular students; but must pay the Registration Fee.

RESIDENCE.

Terms are kept by residence in the College, with regular attendance at Chapel and Lectures, and the punctual performance of all exercises required by the various Professors and Lecturers. No Student is allowed to count any term as a term of residence of which he has not kept at least three-fourths. In the case of Students whose parents or guardians reside at such a distance from the College as to admit of regular attendance at Chapel and Lectures, actual residence in College may be dispensed with.

All students will be supplied with a copy of Rules, etc., on entrance, and must apply at once on arrival to be registered.

All students are expected to have College Cap and Gown; and if candidates for holy orders, a surplice as well.

Regular attendance at chapel services on Sundays and week days is required of all. Non-members of the Church of England may obtain exemption on written request of parents or guardians and guarantee of regular attendance on Sundays at other Churches.

Lectures are given in the College to the Students of the several years, on the work appointed for their respective yearly examinations. The progress of all the Students is further tested by an examination in the subjects of Lectures at the end of each term.

All Students are required to write Essays during Term on Subjects appointed by the Principal, and to perform such exercises in Reading and Public Speaking as he may think desirable.

All Students, whether holding a Free Tuition or not, must pay the Library Fee of \$2.50 per annum included in the above; (Michaelmas, \$1.00; other Terms, 75c. each.)

All Students taking Science are required to pay a Laboratory Fee of \$1 a term.

Each room is furnished by the College with ordinary furniture, but each Student provides his own bedding and towels. These, however, are provided by the College to such Students as desire them, at a charge of \$2.50 per term. The Students have the use of the College Infirmary under due

regulations. The charge for the use of Electric Light is \$1 a term.

Every Student pays a deposit of \$30 at the beginning of each Term, and the balance of his account at Mid Term.

2. The REID SCHOLARSHIP, value \$80.00 per annum, founded by the late Rev. C. P. Reid, D.C.L., Sherbrooke, tenable for three years from entrance, with an extension in case of candidates for Orders of two years. Open in the first instance to sons of clergy in the Dioceses of Quebec and Montreal, and, failing such candidates, to pupils of the Sherbrooke Academy, or sons of citizens of Sherbrooke. The subjects are the same as those for Matriculation, and the Scholars must be approved by the Rector and Wardens of St Peter's Church, Sherbrooke, who are Trustees for the Fund.

3. The EASTERN TOWNSHIPS, the WALKER and the ST. MATTHEWS CHURCH, Quebec, SCHOLARSHIPS, value about \$50 each, are given one each year, to boys entering the College from Bishop's College School, as Students in Arts. They are awarded as a result of the Matriculation examination and are tenable for three years, subject to maintaining a certain standard throughout.

4. Three JASPER NICOLLS SCHOLARSHIPS, founded by the late A. D. Nicolls in memory of Dr. Nicolls, the first Principal. These Scholarships are funded for the present, until the capital is sufficient to produce \$50.00 per annum each.

5. The DOOLITTLE SCHOLARSHIPS, founded by bequest of the late Rev. Lucius Doolittle, to assist in the education of candidates for the Ministry. The conditions on which these Scholarships are to be awarded have not as yet been decided.

PRIZES.

1. The PRINCE OF WALES' MEDAL.—A bronze medal, founded from gift of H.R.H. the Prince of Wales on the occasion of his visit to this country, open to all undergraduate members of the College, is offered annually for the best examination in certain Classical subjects.

A Gold Medal is given to the candidate who wins the prize a second time.

The subjects for examination for 1900 are:—The subjects for Classical Honours with the addition of Sophocles, Electra (Jebb), Propertius (Postgate's selections).

2. The MACKIE PRIZES.—The late Rev. Dr. Mackie, formerly an official in the Diocese of Quebec, founded two annual Prizes, about \$12.50 each, one for an English, and one for a Latin Essay, open to all undergraduate members of the College.

5. The HARRISON PRIZE.—A Prize of about \$10.00 in value, for a Theological Essay, open to all Students of the College.

EXHIBITIONS.

Besides the Scholarships mentioned in the former section, Exhibitions for the assistance of Candidates for Holy Orders have been provided by the S. P. G. and S. P. C. K., and are available during the Arts' course, as well as during the post-graduate course in Divinity; with the understanding, however, that those who enjoy the benefit during the former period are bound in honour to complete the whole term of their training for Holy Orders.

Eight of these are granted by the S. P. G. (four for the diocese of Quebec, and four for that of Montreal), and are assigned by the Bishops of Quebec and Montreal respectively.

Six are granted by the S. P. C. K., the holders to be Canadians by birth, and of a standing enabling them to present themselves for ordination at the end of three years, from the date of their first reception of the exhibition.

The College also offers endowed exhibitions, in its own gift, of the same value as the above:

THE ART OF TEACHING.

During the year just concluded (1898-99) the proposal announced in last year's Calendar of a course of lectures on the Art of Teaching, with the view of qualifying the graduates of the University for Academy Diplomas, was carried into effect. A scheme representing a course of fifty-two lectures on this subject, similar in character to that which is authorized for the University of McGill, was drawn up and submitted to the Protestant Committee of Council of Public Instruction for its approval, together with the proposal to secure for the candidates opportunities for supervised teaching in the academies of Sherbrooke and Lennoxville. The approval of the Committee was readily granted, and the course of lectures duly delivered by members of the College teaching staff, assisted by other experienced educationists, including Mr. G. W. Parmalee, M.A., Secretary of the Protestant Committee, who kindly paid us a visit for the purpose of giving a series of lectures on the Teacher's relations to the School Law. The subjects having special reference to discipline and class-management, were chiefly undertaken by the Head-master, and by Principals Keller and Donnelly, of the Sherbrooke and Lennoxville Academies.

The course was attended in its completeness by seven students, who are to be examined partly by the Central Board of Examiners, partly by the College staff. It is hoped that the course will be resumed during the coming academical year, 1899-1900.

THE HAMILTON MEMORIAL.

Robert Hamilton, D.C.L., the munificent benefactor of this University, as well as of the Diocese at large, entered into rest in September, 1898.

This is no place to recount his benefactions in detail, but it may be well to recall some conspicuous instances which have occurred within less than ten years past; namely, \$6,500 towards the Divinity House, \$4,000 towards the rebuilding of the School, \$20,000 towards the Jubilee Fund, of which \$10,000 was a contribution to the endowment of the Headmaster's salary. In addition to this, he left to the College by his will a bequest of \$25,000. Dr. Hamilton's benefactions to the Diocese of Quebec have been (as is well known) on a still larger scale than those to the University.

Hence the question which naturally presented itself as a matter of course, after his departure, was that of a permanent monument to his memory, of such a character as might seem to be in nearest accord with those aims and principles, by which his own life was evidently actuated. It was finally agreed that this memorial should take the shape of an addition to, and to a great extent reconstruction of, the main building of Bishop's College. In view of the steady increase in numbers, as well of students as of the staff, so manifest under the *regime* of the present Principal—in view also of the extended scope of the courses of study undertaken—the building in its present condition is wholly inadequate for the purpose it is intended to fulfil. There is need for more lecture-rooms,—increased residential accommodation, including separate dining-rooms for College and school, as well as sleeping-rooms for a larger number of students,—an enlarged and more conveniently planned Library,—an extension and improvement of the kitchen and its offices, bath-rooms, etc. Again, from an aesthetic point of view, the external aspect of the building in its present state leaves much to be desired. All these advantages, together with that of an improved Principal's Lodge, are combined in the plans drawn out by Messrs. Cox & Amos, and accepted by the Corporation. The total cost is estimated at from \$15,000 to \$20,000; but it is said that one (and the most important) section of the

To raise this sum, therefore, the members and friends of College and School are now straining every nerve, and it is earnestly hoped that the work may be set about during the coming summer. It is surely not too much to expect that every friend of the institution in either or both of its departments will recognize the duty of taking some part, large or small, in the prosecution of an undertaking so distinctly essential to its continued prosperity and usefulness.

Besides large and generous donations from the Bishop of Quebec, Hon. Senator Price, and Mrs. Reid, of Sherbrooke, other friends have already given liberally of their means. The students, too, as a body, have risen manfully to the occasion, and have, by their own efforts, raised contributions to the amount of \$600.00 among themselves and the members of the staff.
