## BILL.

An Act for the further amendment of the Laws  
relating to the Public Works in this Province.

**W**HEREAS it is expedient and necessary further Preamble.  
to amend the Laws relating to the Public Works  
in this Province ;

Be it enacted, &c., That so much of the third So much of 10  
& 11 Vict. c.  
24 s. 3 as re-  
lates to costs of  
arbitration in  
L. C. repealed.  
Section of the Act of the Parliament of this Province  
passed in the Session thereof held in the tenth and  
eleventh years of Her Majesty's reign and intituled,  
"An Act to amend the Act intituled, an Act to amend  
"the Law constituting the Board of Works" as pro-  
vides that in Lower Canada the costs and expences of  
arbitration therein mentioned shall be taxed by the  
proper officer of the Court of Queen's Bench shall be  
and the same is hereby repealed.

II. And be it enacted, that in Lower Canada such Such costs to  
be taxed in L.  
C. by a Judge  
of the Superior  
Court.  
costs and expenses of arbitration shall be taxed by a  
Judge of the Superior Court ; and that in every case  
in which the claimant has been represented or assisted  
by an Attorney in the proceedings before the Arbitra-  
tors the fees of such Attorney shall be taxed and  
allowed to him as in a contested case of the first class  
in the said Superior Court.

III. And be it enacted, that the fifth Section of Sec. 5 of 10 &  
11 Vict. c. 24  
and sec. 4 of  
13 & 14 Vict.  
c. 13 repealed.  
the said Act, and the fourth Section of the Act passed  
in the Session held in the thirteenth and fourteenth  
years of Her Majesty's reign, intituled "An Act to  
"amend the laws relating to the Public Works of this  
"Province" shall be and the same are hereby repealed.
