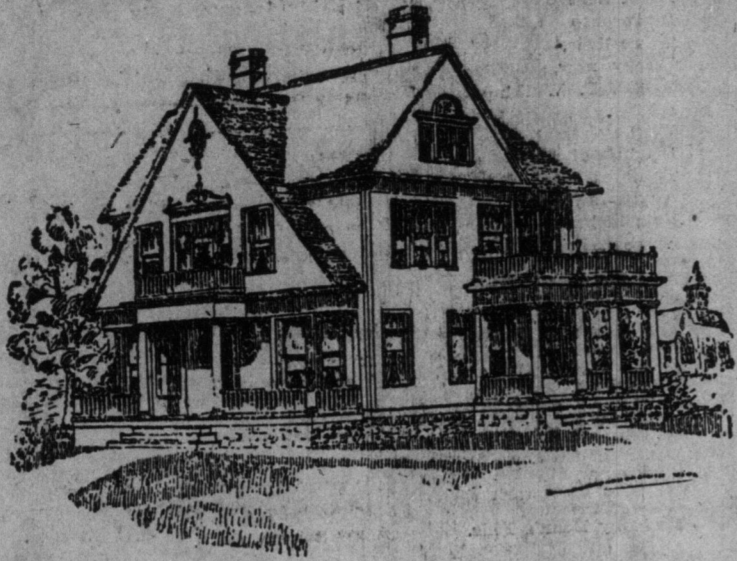

IN RE PATERNALISM IN THE GLOBE.

Globe editorial of yesterday: "Should this hope (a settlement of the C. P. R. strike by concession on the part of both the company and the men) be realized, and should the country be brought face to face with a national calamity, such as a general strike, involving the cessation of all traffic on the C. P. R., would there be an opportunity for the display of the statesmanship and the generosity of Mr. Laier and the members of the Government. The fact is, to put it bluntly, that the stoppage of traffic on the C. P. R. system cannot be permitted in the public interest. Government will be justified in stopping in and practically forcing both parties to the dispute to accept its arbitration on a fair basis. If the disputants could fight it out without hurting other people, Government will interfere. Every hour's delay in moving the stock and the loss to the west, who can ill afford it. Here, in Ontario, the disturbance is not so great, but in the aggregate the loss must be very great. Under the circumstances that may arise to-morrow or next day Government intervention will be a duty. The Railway Committee of the Privy Council might very properly ask both parties to accept arbitration on a fair basis. If the men shall at once return to work, they will have the Government's approval. If they refuse to do so, the Government will have to take action. It is a happy issue out of the trouble it members will have the satisfaction of having done all Canada splendid service."

Again is the Globe committing itself to paternalism. For years it has preached the doctrine of the "least government is the best," "no interference by government," "let the parties concerned settle it themselves," and all the other dicta of the free trade school. "Paternalism," "national government," were denounced in round terms.

Now our contemporary is in favor of a vigorous, almost high-handed action on the part of the Government to settle the strike. It is certainly a violation of the so-called "freedom of contract."

We have no objection to the method suggested by The Globe for the settlement of the strike; we simply content ourselves with saying that The Globe is rapidly coming round to the methods and views of "the paternalists." It has already in substance said that it is something of a pro-tectionist. On Saturday it was in favor of the province going into the iron industry. After a while it will be in favor of an export duty on pulp, wood, nickel and gold matte, sawlogs and a tariff for home manufactures.

1875—Switzerland declined to coin the quota of silver under the Latin Union.
1875—Suspension of silver coinage on account of Dutch colonies.
1876—France suspended the coinage of silver.
1877—Finland adopted the gold standard.
1878—Spain suspended the free coinage of silver.
1878—The Latin Union (France, Italy, Belgium, Greece and Switzerland) suspended the coinage of silver, except subsidiary coins.
1878—Austria-Hungary suspended free coinage of silver.
1885—Egypt adopted a gold standard.
1886—Roumania adopted a gold standard.
1891—Tunis adopted a gold standard.
1892—Austria-Hungary adopted a gold standard.
1893—Mint of India closed to the free coinage of silver.
1893—Russia decided to coin 100,000,000 gold rubles.
1893—Chili adopted the gold standard.
1896—Cost Rica adopted the gold standard.

MAKE A BIG SNAKE UP

Ald. Bell Prefers Charges Against a Colleague.

ANOTHER INVESTIGATION

Which Will Put Many People in the Civic Service on Nettles.

A General Enquiry Will be Made Into All Charges of Nepotism—Ald. Dunn Makes a Statement to the Council Regarding a Purchase of Corporation Property—Strong Criticism by Aldermen—Conservatives Kept Off the Civic Deputations Who Jant to Ottawa?

The meeting of the City Council yesterday afternoon was protracted for upwards of four long hours, a large portion of the time being occupied in discussion of the social matters. Ald. McMurich opened the ball in this line by making a frank apology for his share of the unpleasantness which characterized the previous meeting, and the Mayor also made the same apology.

Ald. Dunn also rose to a question of the privilege respecting a certain transaction, the particulars of which appeared in the World of Saturday. He challenged investigation, and said he would submit charges which would be investigated by the Board of Control.

Then another question of privilege was raised by Ald. Dunn, who read attention to an article which appeared in Saturday's World, under the heading of "Profitable Deal." In that article, he said, his name was brought before the people of Toronto as having been able chairman of the Property Committee, a party to the purchase of two buildings belonging to the city, the purchase being made at a price which was a very high one.

Another question of privilege was raised by Ald. Dunn, who read attention to an article which appeared in Saturday's World, under the heading of "Profitable Deal." In that article, he said, his name was brought before the people of Toronto as having been able chairman of the Property Committee, a party to the purchase of two buildings belonging to the city, the purchase being made at a price which was a very high one.

A COMMITTEE TO INVESTIGATE. Ald. Boustead moved, seconded by Ald. Scott, that a special committee be appointed, consisting of the following members: Ald. Boustead, Ald. Scott, Ald. Sheppard, Ald. Spence, Ald. Preston, Ald. Gowanlock, Ald. Hunter, and Ald. Anderson, with full power to investigate the charges that have been made against the Mayor, and report thereon to the council.
