#### PREFACE.

CINCE the consolidation of the Statutes of New Brunswick in 1887 the Legislature has passed a large number of Acts, some affecting subjects not referred to in the Consolidated Statutes, others repealing or amending laws then in Some fifteen hundred Acts have been enacted since force. that time, and there being many subjects relating to which Acts have been passed in different years, considerable time and labor is often lost in searching through the several years to find a required law or amendment, as the case may be, and it has occurred that errors have been made involving no little expense and annoyance because some alteration or amendment has been casually overlooked. For these reasons it has been thought that a general alphabetical index of all the-Statutes passed since the Consolidated Statutes to the present time would be of service to all persons having occasion to refer to our local laws. In the following compilation will be found a complete index, alphabetically arranged, covering all Statutes, public and private, passed by the Legislature of this Province, from the time of the consolidation in 1877 down to and including 1890. Pains have been taken to make this index as correct as possible, and it is believed that it will prove to be a useful and labor saving work.
