## 81ST ANNUAL GENERAL MEETING OF THE SHAREHOLDERS

### HELD AT THE BANKING HOUSE,

ON

### Monday, 5th June, 1899.

## HON. GEORGE A. DRUMMOND, IN THE CHAIR.

On motion of Mr. John Crawford, Hon. Geo. A. Drummond, Vice-President, was unanimously voted to the chair in the absence of the President, The Right Hon. Lord Strathcona and Mount Royal, G.C.M.G.
