# Circular Letter. 1 ... vol ed

To the Churches comprising the Eastern Baptist Association of Nova Scotia and Prince Edward's Island.

DEAR BRETHREN,

Received and adopted. In the providence of God we are permitted to present you our Circular Letter. In taking a review of the past year-what cause for gratitude, and deep humiliation of Snirit is at --- presented to the mind.

In this Western World temporal blessings have marked the generality of individuals; the Churches of Christ, in different sections, have been favored with more than an ordinary increase. The Holy Spirit has been given to both ministers and people, so that the word preached has not been in word only, but in demonstration of the Spirit and with power. In the Old World, the churches of the dear Redeemer, in many instances, have been called to pass through deep waters of affliction, in the bereavement of their families, those whom they loved having fallen victims to the ravages and cruelty of war. good, brad, Hall, caned, vet, llimed

It is true, some aged or parent in the midst of his years, in these Colonies, may have parted with his child, to tread a strange land, and meet a foreign foe-where life may have been sacrificed on the altar of his country-and that parent been led experimentally to feel what so many hearts have realized, both in Britain and in Europe.

How gloriously does the Great Head of his Church fulfil all his covenant engagements with his people. And he who hat said, "On this rock will I build my church, and the gates of hell shall not prevail against it," also claims the submission of his people when

he saith, "Be still, and know that I am God."

Dear Brethren, suffer the word of exhortation. We live in an age when infidelity and scepticism appear to have taken possession of the minds of men, from whom, at one period, we had a right to look for a different state of things. Perhaps there never was a period when the church of Christ stood more in need of true and devoted men, than at the present. The darkness of ages which are past in some measure seems to be revived, under the name of Puseyism; the vitality of the church of the Redeemer is threatened, and the simplicity of the gospel superceded by men who claim to be "the only ministers of the cross."

But, brethren, we hope better things of you, that is, you will not be tossed, as a wave of the sea, with every species of doctrine that men may present to your view. We repeat it, "Ye have not so learned Christ" to be satisfied with a form of godliness, but, destitute of its power, hold fast whereunto you have attained, and see that no man take

your crown."

It may with propriety be said, "God hath done much for us, whereof we are glad." And the work of the ministry and the perfecting of the saints, not only rest, under the blessing of God, with your ministers, but the gospel presents its broad claim upon the different sections of the church. The Mosaic economy bound the Jews to a periodical series of acts that would counterwork their selfishness, foster the feeling of dependence, and cultivate in them love to God and man.

The clear light of the gospel made the design of this law more apparent as Christianity broke down its previous limits, and laid open the world to its efforts. The manifestation of Christian benevolence and philanthropy, which followed the day of Pentecost, was the natural development of the christian spirit, under the influences of the Holy Ghost; and no more would be required, of all christians, under the same circumstances. augle as though they possessed not. Each felt he had no claim to his own, that could interfere with the claim of Christ.

Under this principle the believer will acknowledge that Christ has a right to his houses and lands, and whatever earthly possessions he may have claim to. As far as the need of his people would carry him,—freely, yes freely would he bestow. This, brethren, is the germ of the principle of Christian benevolence, which makes every holder of property a Steward. And if the righteous claim of this principle was fully re-asserted in every Christian's heart, both the Church and the world would soon be transformed.

In that ever memorable season—the outpouring of the Spirit on the day of Pentecost—recognized the spread of the Gospel as an object not second to the temporal wants of God's people. It was to enable the converts to remain in Jerusalem, and obtain that instruction which should qualify them to preach or teach that gospel to distant nations.

Thus in the spring time of Christianity, in the first expansion of its glorious principles, we behold the grace of

charity occupying its due place and influence.

Dear Brethren, we call your attention to the apostolic precept, (1 Cor. xvi. 1, 2,) the direction enjoined the weekly deposit. The reason which can be assigned for this is, that there might be an established rule. It was to be, a sabbath work, that it might be performed when the heart was under its most, sacred and tender impressions. This action steadily and habitually sustained, assails the very citadel of our selfishness, which is the great adversary of our sanctification in the work of the Lord. But let a systematic benevolence be produced, and gifts so oft repeated secure a large amount.

The rule enforced by the apostle brings each one periodically to a reckoning with himself, as to the improvement of the talent or talents entrusted to his care. In the order of divine providence it has a powerful tendency to draw out the varied gifts, for the use of the ministry or the extension of the Redeemer's Kingdom, leaving the disciple of Christ, in the language of Peter, "To forsake all and follow him."

Upon this view of Scriptural beneficence, we may look upon God, as it were taking every believer aside on the return of the holy day of rest, and putting to him or her the important question—how have you prespered—and how

Dear Brethren, the injunction is addressed to every one of you, and it is not a burthen, but a privilege, for it is written, "It is more blessed to give than to receive, and the Lord loveth a cheerful giver." Now this privilege is so adapted as to meet the wishes of the poor as well as the rich; no one is excluded from being a participator in the glorious work. Yes, the Divine Saviour has so arranged it that the poor are not excluded, for the poor must have a

share in the blessedness of giving.

How emphatically this shews that the grand work of the grace, is not in the receiver, but in him that imparts. Your copper coin is as acceptable as the gold of others. And who can tell when the widow's or the orphan's mite is cast into the treasury of the Lord, that, carrying a special blessing with it, and guided to its results by the partial regards of the Redeemer, it may not actually produce more than the larger gifts with less sacrifice and prayer—"Give as the Lord hath prospered you." Let not your contributions be of an occasional character. The zeal, the love, the faith of the Christian should be ever active: not like the meteor's glare, shedding a luminous ray of light for a short period, on all surrounding objects, and then enshrouding them in thick gloom or impenetrable darkness.

But the light of Christian benevolence should shine brighter and brighter unto a perfect day, until the darkness which enshrouds the church, the manifest spirit of covetousness which at times is so apparent, shall have vapished from our view, and we shall behold the light of *Truth*, through the beneficence of the church of Christ, spreading its glorious influence, its benign rays over lands now sitting in

darkness and in the shadow of death.

Brethren, from the past we take encouragement for the future. We cannot harbor the thought, "that having tasted of the good word of God," you will sit down in ease, and enrich yourselves with every temporal good, and at the same time turn a deaf ear to the Macedonian cry,—"Come over and help us."

Most of you are fully aware of the destitution west and east of these Provinces of the Word of Life, and the scarcity of laborers to meet the wants of a people who are, in many instances, "perishing for lack of knowledge." The

claims which the Home Missionary Society have upon your sympathies, are of paramount importance. The sacrifices many of your dear brethren are called to experience in going to the scattered inhabitants of these provinces, are of no small account. Upon the faith of the vital benevolence of the church, we send them—they resting upon the promise of the Divine Redeemer, "go forth bearing precious seed." We say to you, in concluding this Epistle, shall they toil for nought, shall they return to their families destitute of the means to meet their just demands—must you, of necessity, send them empty away? No brethren "Give as the Lord hath prospered you."—then in the dispensation of Providence, instrumentally the benevolence of the church will be the salvation of the world.

Dear Brethren.-We would not be unmindful of the work of the Foreign Missionary, especially the sacrifices made by our beloved brother, A. Crawley, as well as others abroad in the Missionary field. In the second place it is, in a peculiar manner, a Baptist institution. It is at least an outgrowth from Baptist principles. One of these principles is that every man is under a solemn obligation to study and to teach the word of God as the only repository of truth, the only guide in duty. Another of these principles is that which is opposed to infant baptism, that sound religious instruction, and spiritual regeneration alone can qualify the young to become members of the Church of Christ. The support of such institutions is in a special manner incumbent on all who profess these principles. To neglect the one is to prove recreant to the other.

In the third place, the Sabbath School is an institution stamped with the broad seal of the divine approval. Many in heaven and many now on earth have been blessed by it. Many of the most eminent servants of God at home and abroad are children of the Sabbath School. Among these we may number many now labouring in heathen lands. Some in the tropics and some in frozen climes. Some on mountains and plains of India and some on the islands of the sea.

We would therefore most carnestly urge upon the brethren of the Eastern Association to establish these institutions in every settlement, and to send annual statistics of such schools to the Association. We also urge the formation of bible-classes in every school and congregation.

Some of the appointments made in July last year, were not fulfilled—the funds not justifying such amount of labour. This was the case with reference to the Mission on southern and eastern shores—a balance being due for the Mission performed the last year.

Brother Shields was appointed to fulfil a part of the Mission assigned Bro. Hobbs in Cape Breton, Bro. Hobbs having left for another field of labour, this Mission Bro. Shiels is now performing—an account of part of which has appeared in the C. Messenger. During the three weeks he spent, Bro. Shiels states that he preached nearly every day, to very interesting congregations—visited about fifty families—and distributed about 3000 pages of tracts.

Brother Shaw spent about ten weeks in Pictou county, visiting Tatamagouche and vicinity. Brother Richardson two weeks in Tracadie. Brother Lawson six weeks in Little River Musquodoboit, and baptized six persons. Eight weeks were spent by Bro. Hall in P. E. Island, the mission sustaining itself. In Pictou he laboured sixteen weeks. Bro. R. McDonald six weeks over the nothern part of Cape Breton—brother C. Jost sustaining him.

The Gaelic Mission has been in operation as the Board is informed during the year, and a House of Worship commenced; also a small Church has been organized by the Missionary, composed of persons, some of whom had been previously baptized, and others by the Missionary himself.

The Board has only to repeat what almost every one feels, and which in various ways has been remarked, that the existing organization for Domestic operations, is too inefficient to hope for any great results.

With the hope of seeing some more efficient plan, the Board, through its Secretary wrote to the Central and Western Boards, more than a year ago, to which no reply, however, has been received; but from the action taken at the Central Association, with reference to Domestic operations, there is reason to hope, that soon we shall realize something more in accordance with the importance of this department of Christian labour.

The Board have also to report an empty Treasury. As

the sums received at this Association will be exhausted to pay the amount due to Missionaries for the year just closed.

The cry for Missionary labour is meanwhile increasingthe labours of our brethren have been blessed-duty is before us-how can we slacken our hand! Souls are perishing, and will not their blood be required at our hand. Promising interests have to be abandoned, and weak churches requiring help dwindle away.

Brethren it ought not so to be. May we all awake to

the work of the Lord.

These societies ask no exhorbitant sum from our church members. They present to notice the various benevolent enterprises of our denomination in proportion to their importance, they can be put in operation, and effectually worked with very little care and oversight. No reason exists why the end designed by them should not be accomplished. It is pleasant, though perhaps idle, to

reflect on the work which might be done, even by the feeble and scattered churches of our Association, were these Union Societies properly organized and faithfully worked.

When however these Societies exist only in name. Where one seeks almost in vain for any influence which they exert on our contributions. When one searches over the Minutes of past Associations, or listens to the annual letters from the churches, and can descern but faint traces of any attention to Union Societies then we must conclude that the notice given to them by our Associations is a mere formality. The nomination of a committee and the presentation of a report, may well be despensed with. The churches cannot well give less without such formalities then they now do with them. These Union Societies have not failed on account of our poverty, or because of our peculiar avarice and hardness of heart. When agents for the Bible Union and similar societies go through the country, they find abundance of money and liberal hearts. It is a little singular that money is only wanting when our dearest interests are at stake, when funds are required for the support of superannuated ministers, the education of our own flesh and blood, and the evanglization of this comparatively destitute section of the province.

The Union Societies have failed because men will not take the trouble to keep them in working order, or give them that attention necessary to the working of any system. We suffer for want of a system, yet when one is presented to our notice we let it die a natural death. Many of the churches seem to think that they have discharged their duties when a hasty collection has been taken up, perhaps on the very Sunday preceding the meeting of the Association. Let such remember the exhortation of the Apostle. "Now concerning the collection for the Saints, as I have given order to the churches of Galatia even so do ye, upon the first day of the week let every one of you lay by him in store as God hath prospered him that there be no gathering when I come."
