## BILL.

### An Act to amend an error in the Act 18 Vict., cap. 112, relating to the building of Churches in Lower Canada.

WHEREAS there is an error in the second section of the Act passed Preamble. in the eighteenth year of Her Majesty's Reign, intituled "An Act "to amend the Acts and Ordinances concerning the civil erection of "Parishes, and the building and repairing of Churches, Parsonage Houses 5 "and Church-yards;" Therefore, &c.

1. The said second section of the said Act is hereby so amended, as to Amended reading of 2nd section of 18 Vict. c. 112. read as follows : " Whenever the sums of money to be so levied shall *not* exceed three pounds currency, they shall be levied and payable in equal and quarterly payments and not otherwise, any law to the contrary notwithstanding ; but when they exceed that sum they shall be levied in the manner prescribed by the first section of the Act passed in the Session held in the fourteenth and fifteenth years of Her Majesty's Reign, and chaptered one hundred and three ;" and the said section, as hereby amended, shall apply to pending cases or suits for any such sums of money, except only that the defendant in any such case shall remain liable for any costs incurred before the passing of this Act, and for which he would have been liable if it had not been passed.
