### MEETINGS.

The Regular Meetings of the Seciety are held quarterly, on the 25th March, or Lady Day; 24th June, or Midsummer Day; 29th September, or Michaelmas Day; and the 26th December.

Annual Election of Officers and Committees take place on 5th January.

The Members meet also on 23rd April-St. George's Day.

The Meetings of the Committee of Management are held on the second / Monday in every month.

The Meetings of the Sub-Committee of Charity are held weekly.

### RELIEF.

Application for Relief should be made on a Printed Form, stating the particulars of the case, &c., signed by any two members of the Society as a recommendation, and handed to the Sub-committee of Charity.

There are six beds, with the necessary bedding, all the property of the Society, in the Finlay Asylum for the use of persons who may be sent to that institution by the Society.

### REPORT

OF THE

COMMITTEE OF MANAGEMENT

### TO THE MEMBERS OF THE SOCIETY

### FOR THE YEAR 1882.

The Committee of Management have the honor to lay before the members the forty-seventh Annual

Report.

The calls upon the Society's charitable fund during the past twelve months have been numerous, and the records of the cases relieved will prove, in the opinion of your Committee, that this fund has been wisely administered, and that much necessary aid has been afforded to many deserving persons. Your Committee desire to mention in this report the case of the late Miss Horsington, which will be still fresh in the memory of all, and to express their regret that it did not occur to anyone with whom she came in contact to send her to one of the officers or members of this Society, as, had this been done, her life would in all probability have been saved, or, at least, she would not have died alone, by the roadside. When Your Committee found that she was a native of England they asked that the body might be handed over to them, and it was interred in the Society's lot at Mount Hermon Cemetery, for which action the Society have since received the thanks of the friends of deceased. Your Committee also desire to advert to the case of Thomas Roberts, who arrived here on the 29th of last month, very ill from lung disease, and who now lies at the point of death in the Marine Hospital, whither he was sent by the Society. The man reached here on a very cold day, very poorly clad, and he avers that he was sent from Brooklyn, N. Y., to Quebec, on the plea that he had originally landed here, the parties who sent him knowing at the time that he desired to

go to his family in England, and being aware, as they must have been, that in December navigation at Quebec is closed. Your Committee were quite unable to learn from the poor man the name of the person of persons who shipped him to Quebec, and they would fain hope that there has been some mistake on his part in the account he gave. His appearance however was in favor of his entire credibility and Your Committee would recommend that the matter be investigated with a view of arriving at the facts. Sixty-two cases in all have been relieved, the total amount expended in Charity, including \$50 each voted to the Ladies' Protestant Home and the Finlay Asylum, being \$419 45. Details of this expenditure will be found in the report of the Sub-Committee of Charity annexed.

One ordinary member was elected to become a Life

member during the year.

St. George's Day last year having fallen on a Sunday, and there being moreover no organ in the Cathedral at that time, it was resolved to hold the Anniversary service on the evening of the 30th May, when a sermon was preached by the Reverend M. M. Fothergill, one of the Chaplains to the Society, the Rev. G. V. Housman Chaplain to the Society and Rev. C. W. Rawson taking part in the service, and the musical portion being as usual kindly undertaken by E. A. Bishop, Esq., Organist, assisted by the Ladies and Gentlemen of his choir and others to all of whom the Society is much indebted The collection amounted to \$68 93

The Society has to mourn the loss by death of Messrs. Benson Bennett, a Life Member since 1859, John J. Nesbitt a Life Member since 1845, Weston Hunt a Life Member since 1851, and Joseph Fielding, an Ordinary Member. Mr Hunt was President from 1853 to 1855 and always took a great interest in the Society.

Some years ago the North America St. George's Union was formed, and this Society was asked to be-

come affiliated, but, as it did not appear very clearly at that time what object the Union was intended to serve, no action was taken on our part. Since then however the Union has been growing in strength, a large number of St. George's Societies in Canada and the United States have become affiliated with it, and it appears, to Your Committee that considerable benefit may flow from its existence. Your Committee were again approached on the subject of affiliation in June last, and they informed the Union that they would recommend the matter to the favorable consideration of their successors.

The new Committee will therefore have to deal

with this matter.

The Right Rev George Jehosaphat Mountain, D.D., D.C.L., Lord Bishop of Quebec, was the second son of Bishop Jacob Mountain, the first Anglican Bishop of Quebec. He was born 27th July, 1789, at Norwich, England, came to Canada with his father, 1793, and died after a brief illness at Bardfield his country seat, on the 5th January, 1863. Nineteen years Rector of Quebec, consecrated Bishop of Montreal 14th February, 1836. He was a diligent visitor among his flock, and in the dreadful visitations of cholera in 1832 and 1834 he literally lived night and day among the dying and the dead, while in 1847, when the province was visited with the plague of typhus fever, and the poor immigrants were dying by thousands at the Quarantine station, the Bishop took his turn at Grosse Isle regularly with the rest of the clergy; and again when the cholera visited Quebec in 1849 and 1854 he was diligent in visiting the hospitals. During many years and up to the time of his death; Bishop Mountain, besides his life membership, contributed regularly to the Society a donation equal to four annual subscriptions, and at all times took a great interest in its proceedings.
