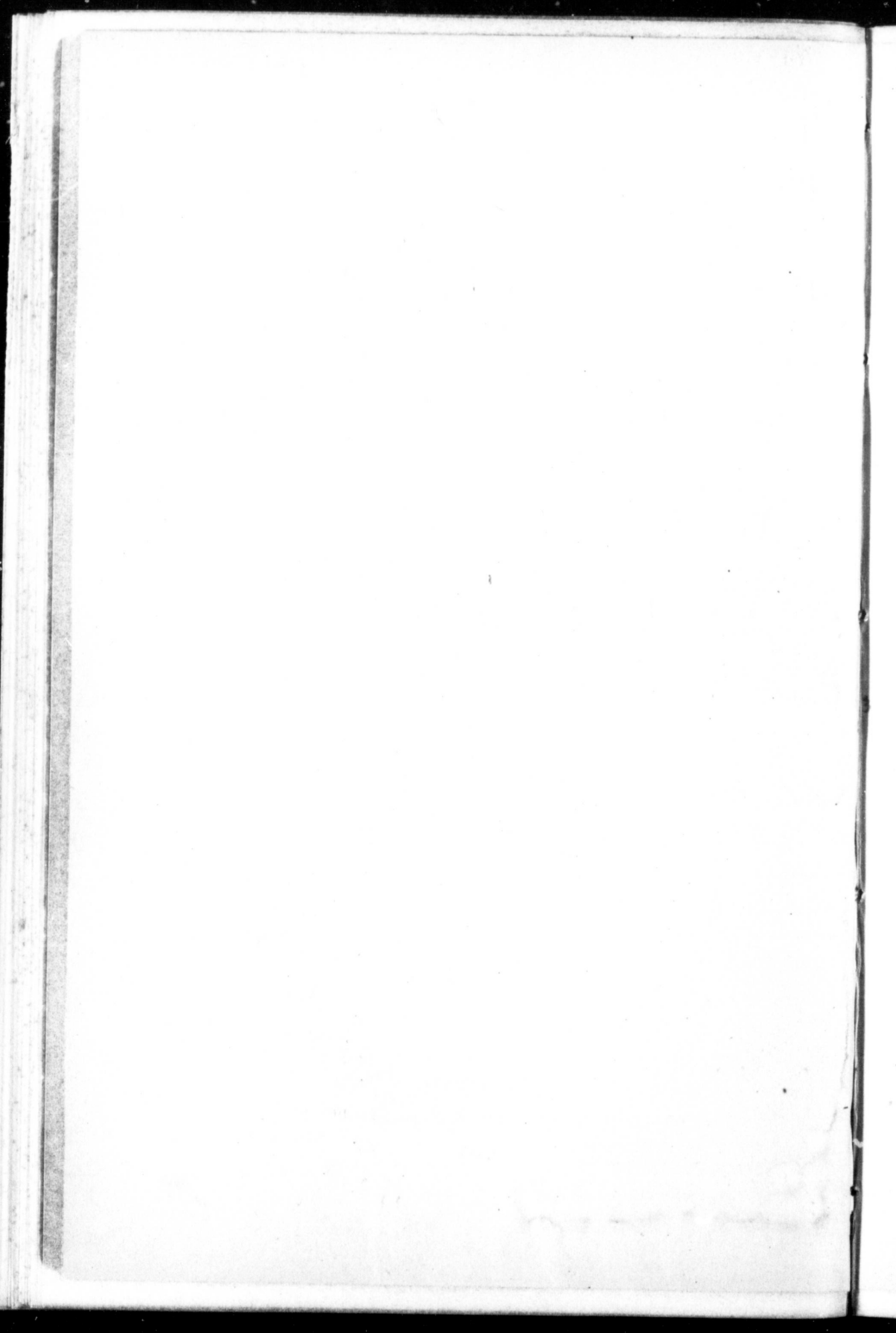

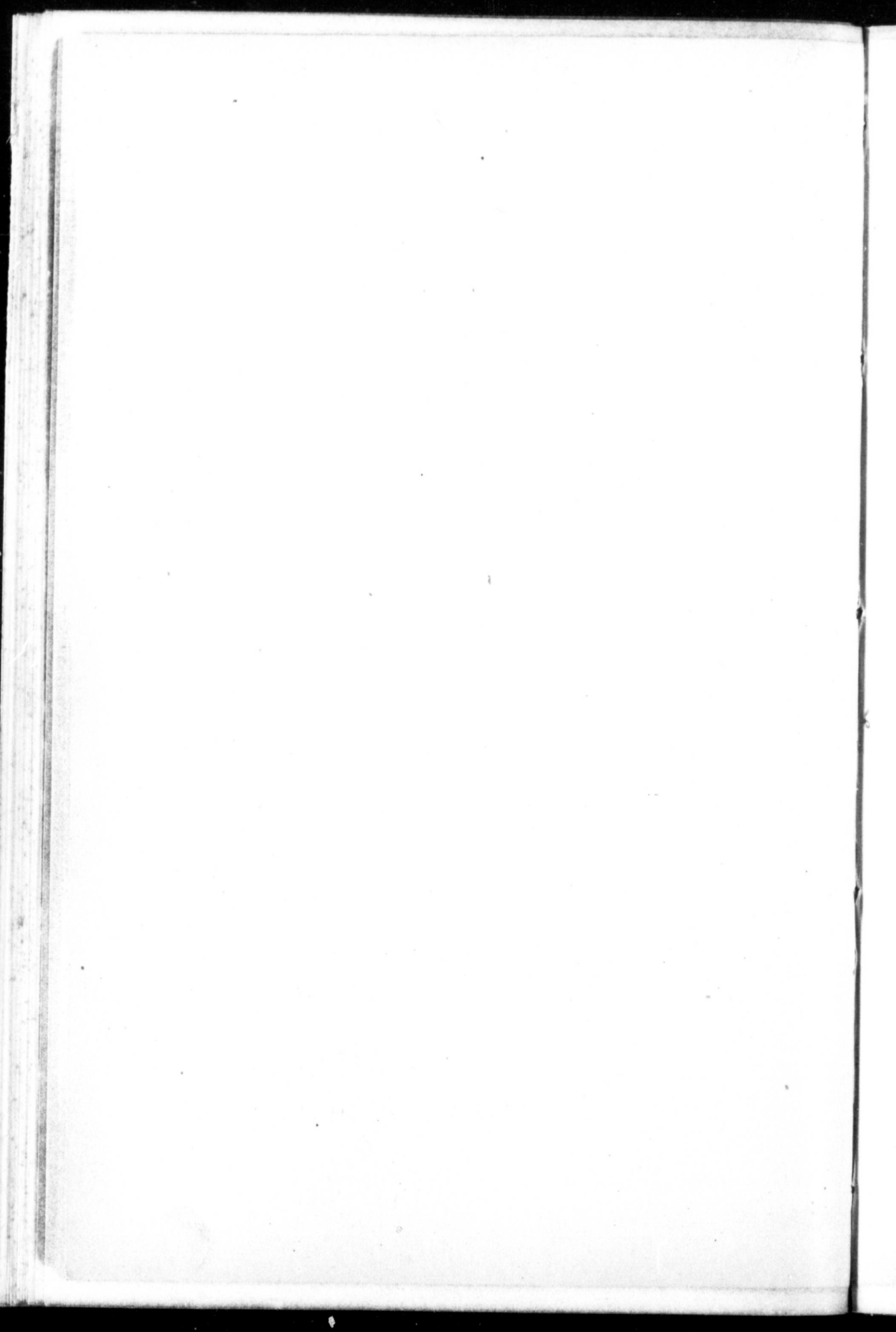

# MINUTES OF CONFERENCE

HELD IN THE

WALL STREET METHODIST CHURCH, BROCKVILLE.

THE FIRST SESSION of the MONTREAL ANNUAL CONFERENCE of the Methodist Church was opened in the Wall Street Methodist Church, Brockville, on Thursday, the 5th day of June, 1884, at 10 a.m.,—the Rev. A. CARMAN, D.D., General Superintendent, in the Chair.

The General Superintendent announced the 1st hymn, read the 131st Psalm and part of the 14th chapter of St. John, and led the Conference in prayer, after which Revs. DR. POTTS, J. E. MAVETY, J. LIDSTONE, and W. R. DYRE engaged in prayer.

The General Superintendent then delivered an address replete with information and instruction, and directed the attention of the Conference to the business immediately before it.

The Rev. J. E. MAVETY and GEO. BISHOP, Esq., were appointed Secretaries, *pro tem*.

The General Superintendent directed the Secretaries to call the roll, which is as follows:—

The Conference proceeded to the election by ballot of a President, whereupon the Rev. WM. GALBRAITH, LL.B., was chosen.

The Conference next proceeded to the election by ballot of a Secretary, whereupon the Rev. WILLIAM BLAIR, B.A., was chosen.

On nomination, the Rev. JAMES ALLEN, M.A., and GEO. BISHOP, Esq., were elected Assistant Secretaries, and the Rev. WM. JACKSON, Journal Secretary.

## RESOLUTIONS.

## DR. RICE'S ILLNESS.

Moved by the Rev. Wm. Scott, seconded by Dr. Lavell and carried unanimously:—

That this Conference has heard with profound sorrow of the continued serious illness of the Rev. Dr. Rice, General Superintendent of the Methodist Church, and therefore of his inability to be present with us on this auspicious occasion, the first Annual Conference of the Methodist Church under the Basis of Union.

The remembrance of the deep and fervent piety of our much-beloved friend and brother, his ardent zeal and courageous perseverance in the cause of missions, his earnest and successful prosecution of the work of superior education, and his special interest in the promotion of Methodist union, renders his absence all the more regretful to this Conference in that we are deprived of the benefit of his wise suggestions and judicious counsels.

The Conference finds itself unable in any suitable form of words adequately to express its affectionate sympathy and condolence with our estimable ministerial fellow-laborer in the painful affliction he is called to experience. To this inscrutable dispensation of Divine Providence we bow in humble submission, accompanied with most sincere prayer to Almighty God that the Holy Spirit, the Comforter, may be largely imparted to the Christian sufferer, and the God of all power and love may lay His restoring hand upon our afflicted brother, to the end that he may be long spared to aid by his wisdom and experience in carrying forward the purpose of our compact organization—the complete evangelization of the whole Dominion.

## DR. SUTHERLAND'S ADDRESS.

On motion of the Rev. W. Scott seconded by Geo. Bishop, Esq —

*Resolved*,—That this Conference has heard with great satisfaction the statements made by the Rev. Dr. Sutherland in reference to the mission work of the Methodist Church, appreciating the very clear and forcible manner in which the position and requirements of the missionary enterprise have been set before us. The Conference rejoices in the fact that the income has been sustained during the past year, and have no fears in regard to the additional amount required to reinforce and extend our missions, being persuaded that a united Methodism will beneficially affect the income and awaken increased interest in our mission work, and we hereby pledge ourselves to renewed effort to do our share in this department of Christian enterprise.

## DR. BURWASH'S ADDRESS.

Moved by the Rev. Wm. Scott, seconded by the Rev. J. W. Sparling, M.A., and

*Resolved*,—That this Conference is alive to the great importance of all our Educational Institutions especially those which are designed to secure for the rising ministry of our Church an education adapted to the times, at the same time maintaining their spiritual power and efficiency. This Conference presents its thanks for the stimulating address just delivered, and pledges itself to increased effort in support of all our Connexional Institutions of learning.

## STUDY OF CATECHISM.

*Resolved*,—That in the opinion of this Conference a more thorough and general study of our catechism in our Sabbath-schools is very desirable, as by this means the children will be instructed in the doctrinal system of our Church.

## FRATERNITY.

Moved by T. G. Williams, and seconded by George McRitchie—

That inasmuch as in many parts of the Dominion of Canada the Protestant population is unable to maintain in each locality the Ministers necessary to supply each separate denomination there represented with the Gospel without aid from the mission funds of the Churches; and whereas in many places one Minister could supply the Gospel ordinances to people now divided into separate congregations, thus avoiding unnecessary expenditure of missionary money and a waste of ministerial force, therefore

*Resolved*,—That this Conference appoint a Committee whose duty it shall be to confer with any Committee or Committees which may be appointed by the other Conferences of the Methodist Church, or by the Courts of other Protestant Churches, for the purpose of preparing a plan to submit to the General Conference of the Methodist Church and the proper Courts of the other Churches appointing such Committees, by which the consolidation of the forces of our common Protestantism may be effected and our resources husbanded for the more economical and, at the same time, more extended prosecution of the work of God among the people residing in those sections of our Dominion where the denominations there represented are not able separately to support the Minister among them.

On motion the above was adopted.

## REV. A. HARDIE, M.A.

*Resolved*,—That this Conference hereby recommend the Rev. A. Hardie, M.A., agent of the Stanstead College—an important institution in connection with the Methodist Church in this Dominion—to the kindly consideration of the Secretaries and Committee of the Missionary Society; and also to their beloved fathers and brethren, the President and members of the Conference, and to all the friends of Methodism who feel an interest in its important mission in the Province of Quebec.

## DISTRICT CONVENTIONS.

Moved by the Rev. W. I. Shaw, LL.B., seconded by the Rev. L. N. Beaudry—

That in the judgment of this Conference it is desirable that the President, and one or two other Ministers who shall be appointed by the Conference, shall hold a two days' Convention on each District during the months of August and September, for the purpose of promoting activity and uniformity in the prosecution of our Church work; if convenient, the Financial District Meeting might be held at the same time.

## OFFICE-BEARERS.

*Resolved*,—That in the organization of new circuits and missions, all stewards and other officers retain their offices until their year of office expires, when elections to these offices may be made in the regular way.

When there are no stewards or an insufficient number in any newly-formed circuit or mission, the Superintendent may at the earliest period call together the officials found on his circuit or mission for the purpose of appointing the requisite officers provisionally until the regular time of election.

REV. WM. SCOTT.

*Resolved*,—That as there is a great deal of work to be done on the French and Indian District other than official acts, this Conference recommend the consideration by the President of the position of the Rev. Wm. Scott, who has received an appointment on that District, as to the service he may render to the Missionary Board toward the advancement of evangelization.

## OUR "TRADITIONAL POLICY."

On motion of the Rev. L. Hooker, it was

*Resolved*,—That the Conference hereby declares its loyal adherence to the traditional policy of Methodism in regard to education as enunciated in the Basis of Union, believing that the best interests of the Church and of education imperatively demand that our Colleges and Universities shall be under the fostering care of the Church.

## CIRCUITS RE-ARRANGED.

*Resolved*,—That it is the duty of the Superintendents of Circuits affected by the amalgamation to prepare and send to the Superintendent of the Circuit in which the several appointments may after this Conference be situated, the names of the members of the Church at such appointments; also all papers, books, and documents relating to them.

## WOMAN'S CHRISTIAN TEMPERANCE UNION.

Moved by the Rev. A. Campbell, seconded by the Rev. J. Grenfell—

That having heard with great pleasure the Address of the Woman's Christian Temperance Union of the Province of Quebec, this Conference

desires to express its sympathy with and appreciation of their noble work, and do rejoice in the success which has attended their labors.

We would assure them of our most hearty co-operation in all departments of this great work, and would earnestly recommend all our churches and Ministers to use only the pure unfermented wine at the sacrament of the Lord's Supper.

#### CONNEXIONAL DOCUMENTS.

Moved by the Rev. S. Bond, seconded by the Rev. J. M. Hagar, M.A.—

That it is desirable to collect and preserve all books and documents relating to Annual District Meetings, Annual Conferences, and Connexional documents that are full or now cease to be used.

To carry this into effect the Rev. W. Scott be appointed for the purpose of receiving them for the Montreal Conference, and all Ministers or others having these in their possession are requested to send them to the person appointed to receive them.

#### PREACHERS RESPONSIBLE.

*Resolved*,—That all the Superintendents removing from one Circuit to another be responsible for the supply of the pulpit on the Circuit they are leaving two Sundays following the rising of Conference.

#### THEOLOGICAL UNION.

Moved by W. Jackson seconded by W. McGill—

That this Conference endorses the action of the Montreal Conference of the late Methodist Church of Canada in regard to the Theological Union, and accept the arrangements for next year except that the lecture is to be delivered on the evening preceding the opening of Conference and the sermon is dispensed with.

#### SABBATH DESECRATION.

On motion of W. Jackson, it was

*Resolved*,—That we earnestly recommend our people to observe the greatest care in regard to the desecration of the Lord's Day in connection with our Camp-meetings.

#### ALMA COLLEGE.

Moved by Prof. Shaw, seconded by A. B. Chambers, LL.B.—

That having heard the gratifying statements given to this Conference relative to the educational and financial interests of Alma College, St. Thomas, Ont., we cordially commend the said institution to the support and patronage of our Church.

#### WHITBY LADIES' COLLEGE.

*Resolved*,—That the Secretary be instructed to acknowledge the receipt of a communication from the Ontario Ladies' College, Whitby, and

in return to assure the Principal and Directorate of our great pleasure at the growing success of this institution, and of our earnest desire for its continued prosperity.

#### FRENCH WORK.

*Resolved*,—That this Conference re-enact the regulations adopted by the late Conference of the Methodist Church of Canada last year in relation to French evangelization.

#### EVANGELISTIC SERVICES.

Ordered that among the regular services of Conference next year there shall be held one or more evangelistic services under the direction of the President.

#### REGISTRATION IN THE PROVINCE OF QUEBEC.

*Resolved*,—That the attention of Ministers stationed in the Province of Quebec be respectfully drawn to the observance of all legal requirements in the Registration of Births, Marriages, and Burials, as shown in the report of Prof. Shaw, M.A., and J. J. McLaren, Esq., late of Montreal, the said report being kept for sale at the Methodist Book Rooms in Toronto and Montreal.

#### EXPEDITE BUSINESS.

Recommended that hereafter the District Secretaries be appointed as the Committee on Statistics with a view to closing the work of that Committee earlier in the sessions of the Conference, which will facilitate the Committees dependent upon the report of the Committee on Statistics.

#### THANKS.

1. Moved by the Rev. A. B. Chambers, LL.B., seconded by A. A. Smith, That the cordial thanks of this Conference be presented to the members and friends of the Methodist Churches and other Christian denominations of Brockville for their very great kindness in extending the rights of hospitality to its members during its sessions.

## REPORT OF COMMITTEE ON CONTINGENT FUND.

## CONSTITUTION.

I. *Name.*

This Conference shall have a Contingent Fund, as required by Article 479, Sec. 4, of the Discipline, to be called the Contingent Fund of the Montreal Conference of the Methodist Church.

II. *Object.*

The objects of this Fund shall be :

1. To defray the extraordinary expenses incurred in the service of the Church.
2. To relieve cases of special affliction on Circuits.
3. The surplus, if any, to be used as the Conference may direct.

III. *Sources of Income.*

1. Collections to be taken up on all Circuits and Missions in the month of September in each year.
2. The public collections taken up at each Annual Conference.

IV. *Committee.*

This Conference shall elect seven Ministers and seven Laymen, who shall be the Contingent Fund Committee for the Conference.

1. It shall be the duty of this Committee to consider all claims properly presented to it, and appropriate to their proper objects the funds placed at their disposal, and report the same in full to the Conference.

2. This Committee shall meet annually at the seat of Conference at such times as the Conference may direct, and appoint a Chairman and Secretary from among themselves, and recommend a Treasurer and Auditors to be appointed by the Conference.

3. It shall be the duty of the Secretary to keep a book in which he shall record the proceedings of all meetings of the Committee, and sign all orders upon the Treasurer, which have been authorized by the Committee.

4. It shall be the duty of the Treasurer to receive all moneys contributed to this fund, and make such disbursements as have been authorized by the Committee and signed by the Secretary of the same.

5. It shall be the duty of the Auditors to examine the accounts of the Treasurer annually, and present their report to the Committee.

V. *Regulations.*

1. The Financial Secretaries shall pay over the moneys of this fund to the Annual Conference Treasurer on the day before Conference.

2. All applications for grants from this fund shall be presented to the



Committee by the Chairman of the District from which the claim is made, or by such other person as he may appoint to represent his District.

3. No application for special claims shall be entertained by this Committee unless they have passed the Fourth Quarterly Official Meeting of the Circuit or Mission, have been signed by the Recording Steward of the same and recommended by the District Meeting. Such claims shall be entertained only from men in the active work.

4. All applications for expenses incurred in the general work, or for claims not otherwise specified, shall be submitted to the Committee in detail for their investigation and approval.

5. In cases of ministerial supply on account of affliction, where the Circuits are competent the expenses of such supply shall be paid by such Circuits, and in no case shall the Committee consider any claim for more than the salary of a single Minister.

MODE OF EXAMINATION FOR THE MONTREAL  
CONFERENCE.

Candidates of our ministry and Probationers shall be examined by means of papers prepared by the respective Examiners.

There shall also be an oral examination if required.

In addition to the usual thorough Theological Examination of Candidates before the District Meeting, the Chairman shall examine each Candidate as to his Studies and General Reading for the year, with a view to giving advice as to his course and method of study. No Candidate shall be allowed the year of probation until the studies for that year are completed.

The examination of Candidates shall be held in each District, under the supervision of the Chairman and the Examiners resident on the District, on the third Wednesday in April in each year; and at such place as the Chairman shall appoint. All papers shall be sent by the Examiners to the Chairman not later than the second Wednesday in April in each year. The answers to the papers shall be sent by the Chairman to the respective Examiners, who shall forward to the Secretary of the Board the valuation. The Secretary shall prepare the certificates, and forward them to the Chairman of the District, to be presented by him to the May District Meeting. The Secretary of the Board shall send the Chairman of each District the name of any Candidate or Probationer who may have taken part of the subjects in any given course, and the standing he has attained, but shall not issue the certificate in any year's course until the Candidate or Probationer has completed it; and, further, no certificate shall be issued unless the Candidate has reached the passing point of thirty-five per cent. in all subjects, except in cases where the papers have failed to come to hand.

That the Conference direct that existing regulations relating to the time and manner of examinations be imperatively observed, and more especially that it be deemed absolutely peremptory that the examinations be held on the same day throughout the whole Conference, and that all the young men in any District writing on any given subject write at the same hour.

### REPORT OF TRUSTEES OF STANSTEAD WESLEYAN COLLEGE.

The Trustees of Stanstead Wesleyan College beg leave to report,  
This institution comes as a possession of the Methodist Church, from  
the Methodist Church of Canada.

The College buildings and property are situated in the village of Stan-  
stead, Province of Quebec, near the line separating Quebec from the State  
of Vermont.

The College edifice is a large brick-cased building of five storeys, built  
on a granite foundation, capable of accommodating 150 boarders, and  
school accommodation for about 250 pupils.

The building, along with eight acres of land connected therewith, are  
valued at a moderate estimate at \$40,000. The buildings are insured for  
\$28,000.

The object in view in founding the institution was to provide facilities



for a liberal education to the youth of both sexes of the Province of Quebec, many of whom were destitute of such facilities and were attending Roman Catholic schools and convents, or institutions of learning in the United States. The institution was opened in January, 1874, and the work accomplished since then has fully justified the enterprise and liberality of its founders, and supplied the want so long and sensibly felt.

The College was originally built and owned by a stockholders' company; but because of financial difficulties endangering its existence, it was delivered over to the Methodist Church of Canada, which holds the property under charter obtained from the Legislature of the Province of Quebec.

The Conference, in adopting the institution in 1879, found it oppressed with a debt of about \$30,000. This debt has since then been reduced about \$20,000, and an endowment pledged of about \$25,000.

The following is a statement of the present condition of the debt and endowment funds respectively:

The present debt amounts to \$9,754.25. To meet this there is an unpaid subscription list of \$5,670.60, which is estimated variously to be worth from \$1,000 to \$5,000, the true value lying probably midway between the two.

In addition to this the Secretary-Treasurer is now in England making collections in behalf of the Debt Fund, having obtained at last accounts about \$900.

The Principal's report of the present year is encouraging, showing an attendance of 169 pupils, 52 of whom received instruction in the higher departments.

The Governor's report shows that a healthy moral and religious influence has pervaded the family life of the Institution.

There is, however, a deficiency of \$592.50 in the running expenses of the College for the present year. This has been met by a Government grant of \$300 and interest accruing from Endowment Fund.

In view of a probable withdrawal of the Government grant and a determination on the part of the Trustees to bring the yearly expenditure of the College within its income, the Trustees recommend,

1. That a Committee, consisting of the President of the Conference, the Rev. T. G. Williams, Rev. C. A. Hanson, Rev. W. Blair, B.A., and Rev. L. Hooker, be appointed to enquire, about the Christmas holidays, into the working expenses of the College; and if it be found that there is

a prospect of a deficiency at the end of the year, they shall be empowered to make arrangements for combining in one person the office of Governor and Principal for the following year.

2. That the charge per week for board be \$3, instead of \$2.75 as heretofore for weeks of seven days, and \$2 per week for five days.

### THE CENTENNIAL CELEBRATION COMMITTEE.

*Whereas* our General Conference, held at Belleville, in September last, responded very heartily to the proposal of the Methodist Episcopal Church to join in the celebration of the Organization of Methodism on this Continent; and further agreed to join therewith the celebration of the Unification of Canadian Methodism, and appointed a Committee to direct in the arrangements; and

*Whereas* said Committee have presented "Plans" for holding Memorial

Religious Services, Soliciting Collections and Subscriptions, and for constituting a General Board, representing all the Annual Conferences, to administer the "Methodist Union Fund."

Be it therefore *Resolved*—

1. That the Montreal Conference most cordially accepts the "Plans" aforesaid as indicated in a communication from the Rev. Dr. Carman, General Superintendent, and also pledges its hearty co-operation.
2. That a Committee be appointed on each District—composed as provided for in the adopted report of the Committee on Church Property—in order to give practical effect to the Plans of the General Committee.
3. That out of the Methodist Union Fund raised within the Montreal Conference there shall be paid a fair proportion to the Educational Fund, in lieu of the usual Educational Collections for next year; that another portion *may* be applied to the erection of a suitable monument in memory of the venerated name of Barbara Heck; and that the far larger portion of said Fund be devoted to the relief of embarrassed Churches—*i.e.*, the Churches named in the adopted report of the Church Property Committee, and in other extremely embarrassed Churches as may be reported to the next Financial District Meetings, and made claimants on the Fund by the Conference Special Committee.
4. That subscribers to the said Fund shall have the option of determining to which of said objects the subscriptions shall apply.
5. That the Conference elect one of its members to serve on the General Board for administering the Methodist Union Fund.
6. That the Rev. T. G. Williams be Treasurer, and Rev. Stephen Card be Secretary of the Fund for this Conference.

## REPORT OF COMMITTEE ON TEMPERANCE.

Your Committee are deeply impressed with the thought that the present is an eventful period in the history of the Temperance reformation in Canada. The efforts of interested parties to form Licensed Victuallers Associations, to secure the services of lecturers, to circulate anti-temperance literature, to avail themselves of the aid of certain newspapers to advocate the traffic in ardent spirits, all combine to give significance to any plans formed to save society from the ravages of a vice that more than any other destroys human hope and happiness.

Your Committee are glad to know that the various divisions of the Temperance army are working harmoniously along the line of total abstinence for the individual, and total prohibition for the State. Along with many other enterprises to this end, we notice with pleasure that the Women's Christian Temperance Union have sent in petitions, and sought interviews with distinguished officials of the Educational Department, with a view to the introduction of lessons from Dr. Richardson's "Temperance Lesson Books" into the common schools of the country. We look for great results from the agitation on this point. Informed in early life by high scientific authority of the evils resulting from intemperance, the young will grow up to hate a vice that more than any other strikes at the root of personal, domestic, social, and national prosperity.

It is also worthy of note that the Temperance pledge is being largely introduced into our Sabbath-schools. Throughout our Dominion there are thousands of obligated total abstainers among the boys and girls of our homes, whose influence upon the future legislation of the country and upon our social institutions must tell powerfully in behalf of Temperance reform. In the early French Revolution the school boys of Bourges formed themselves into a Band of Hope. They wore a uniform, were drilled, and carried a banner bearing the motto, "Tremble tyrants! we shall grow up." Such is the voice going forth from our Sabbath-schools to the tyrant liquor traffic of the age. As one has well said, "We are learning the Chameleon's philosophy, to destroy crocodiles in the egg; we are recognizing the fact that it is easier to form childhood aright than to reform manhood."

Your Committee rejoice in the growing disposition of the Churches to banish alcoholic wine from the Lord's table. That sacred and refreshing solemnity should not be made an occasion of stumbling to a weak brother. True to the Pauline idea of denying self for the good of others, we trust the day is not far distant when our Christian brethren of every name, will, in the administration of this ordinance, give only the cup containing "the pure blood of the grape." Deut. 32: 14.

In view of the many and grievous evils of intemperance so common in our country, your Committee recommend the members of Conference to re-affirm their purpose to wage earnest and untiring warfare against the liquor traffic in all its forms; to co-operate with Temperance workers to secure the adoption of the Canada Temperance Act in every county, town, and city throughout the bounds of our Conference territory; and to

aid in all reasonable ways the enforcement of the law wherever made operative by the votes of the people. Thus shall we be true to our Church as a great Temperance organization, to the public teaching of the man who declared the world was his parish, to the declarations of Holy Scriptures, to the claims of humanity and of God.

All of which is respectfully submitted.

#### REPORT OF COMMITTEE ON MISSIONARY ORGANIZATIONS.

---

The Committee to whom was referred the subject of Missionary Organization beg leave to Report as follows :

*Whereas* the Constitution of the Methodist Church declares each Annual Conference shall appoint a Local Missionary Board, constituted as it may determine.

Be it therefore, *Resolved*,—That the following shall form “The Constitution of the Local Missionary Board of the Montreal Conference.”

1. The Missionary Board of the Montreal Conference shall consist of the President and Secretary of the Annual Conference, the Superintendents of Districts, and a Treasurer to be appointed by the Conference, one layman from each District to be appointed by the May District Meeting as the Discipline directs, and any additional laymen required to make the number equal to that of the ministers, shall be appointed by the Annual Conference.

2. The Board shall meet at the call of the President as early as practicable after the meeting of the General Missionary Board, and shall appropriate to the missionary work of the Conference the money placed at its disposal by the General Missionary Board.

3. The Board may appoint sub-Committees to transact any special business which may arise between the Annual Meetings of the Board or to carry out any decisions of the Board in regard to missionary work. All sub-Committees shall report their proceedings to the Board of the Conference for approval or otherwise, but the sub-Committees shall not set aside or interfere with any of the officers in charge by appointment of the Conference, but shall act in concert with such officers.

4. The Treasurer shall remit to the Treasurer of the General Missionary Board all moneys coming into his possession for missionary purposes, or pay the same under direction of the aforesaid Treasurer to persons employed in the missionary work of the Conference.

## REPORT OF COMMITTEE ON CHURCH PROPERTY.

Your Committee beg to report as follows :

Memorials were presented respecting the financial condition of four of the churches of the late Methodist Episcopal Church—namely, Ottawa, Prescott, Morrisburg and Kingston—asking the Conference to make provision for immediate and pressing indebtedness.

We find the debt upon the Ottawa church to be \$13,308; Prescott, \$7,000; Morrisburg, \$7,000; Kingston, \$17,000.

The Committee recommend—

1. That a sum of not less than \$25,000 be raised to place these churches in a position by which they can be relieved of the financial embarrassment which now rests upon them; that this amount be distributed as follows: Ottawa, \$7,000; Prescott, \$4,000; Morrisburg, \$4,000; Kingston, \$10,000. Further, we recommend that \$25,000 more be raised for a general scheme to aid other embarrassed churches within the bounds of the Montreal Conference.

2. That for the purpose of raising these sums there should be an appeal made to our people, utilizing the celebration of the centenary of the organization of Methodism, and also of the consummation of the union.

3. We recommend the Conference to appoint a committee of five on each District, composed of the Superintendent of the District, two ministers, and two laymen, to prepare a programme and carry it into effect.

4. We recommend the Conference to appoint a Secretary and Treasurer of this fund, who shall receive all sums as collected, and disburse them from time to time among the specified churches *pro rata*.

5. We recommend that this scheme be completed before the 1st of January, 1885.

6. We recommend that the pastor of the Wall Street Church, Brockville, be the Treasurer, and the pastor of the George Street Church, Brockville, be the Secretary.

7. Whereas the Basis of Union provides for the appointment of two ministers and two laymen by the District Meeting on each District, to act with the Superintendent in determining what church property not required for use shall be sold; and whereas some districts may have been divided by the Stationing Committee, and others may have omitted to make such appointment, this Committee recommend the Conference to direct all Superintendents of such Districts, with a view to give effect, conjointly with the Trustees, to the provisions of Section III., Clause 2, of the Basis of Union, to bring this special matter before the next financial District Meetings.

### REPORT OF THE SUNDAY SCHOOL COMMITTEE.

---

Owing to the difficulty of obtaining full returns, the report of your Committee is necessarily incomplete; yet we have much pleasure in calling attention to the very gratifying returns made by the uniting Churches.

We find that there are reported 435 schools and 24,361 scholars, with 2,490 teachers and officers.

We beg to call the attention of the Superintendents of circuits, and all others interested in Sunday School work, to the important provisions contained in the discipline of our Church relating to this work. We take the liberty of specifying the following:—The study of our catechism; the circulation of the temperance pledge; the keeping of schools open all year round wherever practicable; and also, in the formation of libraries and in the supply of papers, the importance of patronizing our own Book and Publishing House.

Your Committee suggest that, as far as possible, special sermons be preached in connection with all our Sunday Schools. In some places this is done by setting apart a day for this work, which is known as the "Children's Day."

We invite the attention of the Superintendents of districts to the provisions of the discipline for the holding of district conventions connected with our Sunday School work.

We furthermore call the attention of our ministers and people to the Sunday School Parliament of the Methodist Church, which will be held on the St. Lawrence Central Camp Ground, commencing on Thursday, August 21st, 1884, and continuing ten days. It is under the management of a committee appointed by the Conference, which will spare no pains to furnish a programme of lectures, sermons, addresses, etc., equal to that furnished by any similar gathering in the Dominion.

### REPORT OF THE CHILDREN'S FUND COMMITTEE.

---

The Committee on the Children's Fund beg leave to report:

#### CONSTITUTION.

The fund shall be denominated "The Children's Fund of the Montreal Conference of the Methodist Church," and is established for the purpose of providing more effectively and uniformly for the payment of the disciplinary allowances of the children of our ministers, and of equalizing the claims for this object of the several circuits and missions of our work.

## COMMITTEE.

The Committee for the management of this fund shall be composed of the Financial Secretaries, together with a Secretary-Treasurer, to be annually nominated by the Committee and appointed by the Conference. The Committee shall meet annually at the place of holding the Conference one day previous to its commencement, and at such other times as may be deemed necessary.

It shall be the duty of the Committee,

1. To appoint annually a Chairman to preside at its meetings.
2. To appoint annually two auditors to examine the accounts and report to the Committee.
3. To prepare an annual report of the state of the fund, which, with the Treasurer's report, shall be published in Minutes of Conference.

## INCOME.

1. The income of this fund shall be raised upon the several circuits and missions, according to a vote recommended by the Committee and approved by the Conference, and this amount shall be the first claim upon the income of each circuit or mission.

2. The number of members for which each Circuit or District shall be responsible shall be that returned to the previous Conference, with such alterations only as are caused by the change of boundaries previously sanctioned by the Conference, or such as are exempted by Conference.

3. The Financial Secretaries shall be the treasurers of the Children's Fund for their respective districts, and shall make a correct record in their district books at each May district meeting, of the name, age and date of birth of each claimant upon the fund for whom payment is made, a similar record of those whose claims are prospective for the coming year, and the number of members on each circuit for the past year, and the number of members to be reported to the ensuing Conference.

4. A schedule containing suitable columns for these records, which have been furnished by the Secretary-Treasurer, shall be filled by each Financial Secretary and handed to the Secretary-Treasurer the day previous to the opening of Conference.

5. The Financial Secretary shall not, at the May District Meeting, place upon the list of prospective claimants the name of any child born after the 15th day of May in the then current year; nor shall any such child be included in the estimates for the ensuing year, nor be paid for by any Treasurer; nor will the claim of any child be admitted whose name was not reported to the Financial Secretary at the previous May District Meeting; nor shall any claimant receive more than eighteen payments.

6. Each minister having children claimants upon this fund shall, at the Financial District Meeting, furnish the Financial Secretary with a list of their names, ages, and dates of birth.

## I.

The Committee recommend that the fund be raised by a *per capita* assessment of thirty cents per member, of 16 years of age and above.



## II.

The Committee further recommend that the fund thus raised be divided among the claimants, according to the regulations existing previously in the Methodist Church in Canada, less any necessary expenses.

## III.

We recommend that the members' list of Anticosti, and the French work and Bourg Louis be exempted from this assessment.

## IV.

We recommend that the Rev. T. G. Williams be the Secretary-Treasurer of this fund.

REPORT OF THE COMMITTEE ON THE STATE OF THE  
WORK.

---

Your Committee rejoice to learn from the reports of the uniting churches within the bounds of this Conference that a measure of prosperity has characterized every department of our work. Our educational institutions are in a hopeful condition. Our people never took a more lively interest in the cause of education. However, the demand for culture was never in our country so great as at the present time. And while in the Province of Quebec there are so many nominal Protestants who are sending their children to Roman Catholic institutions, we would respectfully urge upon both pastor and people a greater vigilance as to the interests not only of Methodism, but of Protestantism, and that an ever-increasing interest may be manifested in our own schools of learning.

The evangelistic efforts of the past year have been honored by the conversion of large numbers of precious souls, and many a drooping cause has received new inspiration.

Your Committee respectfully recommend that this evangelistic agency be strengthened and augmented as far as may be practicable.

The conversions in the Sabbath-schools and the blessing that has rested upon the camp-meetings in the past year give cause for profound gratitude to the gracious Giver of all good.

We are gratified to learn of the success which has attended the work in our Foreign and Domestic Missions.

In our French work we recognize the fact that its true success is not measured by tabulated results, but that the circumstances in which our French Canadian brethren are placed, surrounded as they are by those who persecute them by various methods, causing many of them to seek for homes in the United States, thus preventing the increase in tabulated

results. Knowing that the work is of God, and that it cannot come to naught, we urge that every effort be made to increase the efficiency of this, which makes demands upon our patience, our purse, and our prayers.

Our Domestic Missionaries are inadequately supported, and as new fields are opening in our own land, we hope to see the suggestions of our Missionary Secretary relative to a systematic liberality, carried out at as early a period as possible.

That the time-honored Class-meeting may still be a distinctive feature, and in the future an honored means of grace, as it has been crowned with blessing in the past, we commend an unswerving fidelity to this institution of our Church; and while we desire to see our institutions sustained, we would remember that it is only by the presence and power of the Holy Spirit that they can be successful in the future, as they have been blessed in the past.

Your Committee deem it especially important that a greater interest be taken in our Church literature.

And now that God has been pleased to bring about the union of the bodies of a common faith and practice, may He graciously baptize us into one Spirit, and "speak to the people that they go forward."

All of which is respectfully submitted.

THE ANNUAL ADDRESS  
OF  
THE MONTREAL CONFERENCE  
TO THE  
CHURCHES UNDER OUR PASTORAL CARE.

DEAR BRETHREN—"Grace be unto you, and peace, from God our Father, and from the Lord Jesus Christ." We devoutly pray the "Father of our Lord Jesus Christ, of whom the whole family in heaven and earth is named, that He would grant you, according to the riches of His glory, to be strengthened with might by His Spirit in the inner man; that Christ may dwell in your hearts by faith; that ye, being rooted and grounded in love, may be able to comprehend with all saints what is the breadth, and length, and depth, and height; and to know the love of Christ which passeth knowledge, that ye might be filled with all the fulness of God." And this is our divinely assured confidence that He is "able to do exceeding abundantly above all that we ask or think, according to the power that worketh in us." "Rooted," as the fibres of the tree grasp the soil,—"grounded," as the foundation of the building rests upon the rock,—"in love," that property which is the essence of God and the perfection of the man,—"know the love of Christ which passeth knowledge," know in essence what in fulness can never be known either by man or angel,—"filled with all the fulness of God," not as the seaweed when left on the beach by the tide, soiled, draggled, and flabby, but as the seaweed waving its graceful arms in the clear depths below, while the tide fills with its fulness every part of its living organism. So may you and we, as partakers of your joy, be now and always "filled with all the fulness of God!" Above, beneath, around, within, every power and capacity of our being filled with the joy-giving fulness of the interpenetrating presence of the Triune God.

Human love, in its ordinary form of expression, is soon fathomed,—all that it can give us is readily expressed. A certain European Queen, writing to a friend, said, "Why cannot I give you

my experience? Why cannot I make you sensible of that uneasiness which preys upon the great, and the difficulty they labour under to employ their time? Do you not see that I am dying with melancholy, in the height of fortune which once my imagination could scarce have conceived? I have been young and beautiful, have had a high relish of pleasures, and have been the universal object of love. In a more advanced age I spent years in intellectual pleasures; I have at least risen to favour, but I protest that every one of these conditions leaves in the mind a dismal vacuity." This favoured lady had been the universal object of love,—she had known it,—she had fathomed it, and she had found it very shallow and unsatisfactory. But "the love of Christ passeth knowledge." "I am pained," said holy Samuel Rutherford on one occasion, "with wondering at new opened treasures in Christ."

What God can do for us comes within the limit of neither our *asking* nor *thinking*. He is the Infinite, we are the finite; and what the Infinite can do for the finite, only the Infinite One Himself can say. A somewhat poor organ-player in a certain church being one evening laid aside by sickness, a stranger took charge of the instrument, and played the simple airs required by the service. This over, he felt his way along the keys with such strange and hitherto unknown power, that the instrument seemed to those who listened to be something different from what it had ever been before. The musician, forgetful of himself, went on opening sweeter and sweeter harmonies until every one was amazed. So when God's fingers touch the keyboard of a willing and yearning soul, "ear hath not heard" the music that He can bring out of it. We do not know what we are, nor what we are capable of, until the symphonies of our restored humanity are touched by the finger of God. "It doth not yet appear what we shall be." "He is able to do above all we can ask or think,—abundantly, yea, exceeding abundantly." The music which God can bring out of the soul to-day is only a step toward the still higher music of to-morrow, for the instrument develops beneath the touch of the musician, and that only a preparation for the still grander symphonies of the future.

This normal type of Christian experience,—this being filled with all the fulness of God in a degree subjectively ever enlarging, is the richest possession, and ought to be the constant aim of the Christian Church. Devoutness of spirit, sweetness of temper, consistency of life, beauty of character, superiority to worldly allurements, earnestness of evangelistic effort, are all secured by it.

The outlook, evangelistically, is hopeful. Earnest piety has borne fruit. The "wilderness and the solitary place" have been gladdened, and many a "desert" has rejoiced and blossomed as the rose. The Churches, in gratifying numbers, have been "edified," and "walking in the fear of the Lord and the comfort of the Holy

Ghost, have been multiplied." A spirit of revivalism has been extensively cultivated. And this onward movement has not been confined to the Methodist Church. Agencies and methods, formerly regarded as peculiarly Methodistic, have been successfully adopted by others. "Ephraim and Judah" have been mutually and legitimately stimulant. And this we devoutly hope will increasingly mark the "signs of the times."

But while hopefully and persistently cultivating the spirit and practice of revivalism,—while seeking with a laudable ambition the transformation of the many, let us not underrate single instances of conversion,—let us not attach small importance to the conversion of the *ones*,—let us not reserve ourselves for some great effort in which the multitude shall be converted, and overlook the importance of a succession of smaller efforts in which the individual may be won. It is certainly cheering to see a great evangelistic movement,—to see the thousand "pricked in the heart," and added to the Church,—to see a whole valley full of dry bones live,—and possibly these great movements will become increasingly numerous as the latter glory approaches; but desirable as are great revivals of religion periodically felt, a silent, ceaseless, saving addition to the Church, is not less healthy, and in the long run may be more successful.

Christ compares the kingdom of heaven to the growth of a tree. When the trunk has been smoothly cut through with a saw, how distinct are the annular rings indicative of its age! Some of them are a little broader than others, but each year has left its circular mark. In the most inauspicious season there has been growth and enlargement; slowly but surely the tree becomes more bulky, until the feeble sapling has grown into the stalwart tree, lifting its head majestically toward heaven.

The same authority compares the kingdom of heaven to leaven which a woman hid in three measures of meal, and which gradually assimilated the mass until the whole was leavened. The leavening of the whole implied that each individual particle was leavened. Atom after atom was penetrated and pervaded until the whole substance of the meal was quickened. So, after this manner, will the salvation of the world be secured. The conversion of one man is a step toward the conversion of every other man. He is one of the rings of the Church's growth,—one of the particles of the mass which has yet to be leavened. He is only *one*, but he *is* one. Christ died, not merely for the race as such, but for each individual member of the race. He died for the sinner, and wherever we find a sinner we find one for whom Christ died. The salvation of one man is an important step toward the salvation of every other one.

Let not the patience and perseverance needful to secure the single fish be lacking, and while using the drag net at suitable seasons, let us not eleven months out of the twelve sit down satisfied

with our gains. In primitive times the disciples went everywhere preaching the Word, and the "Lord added to the Church *daily* such as should be saved." Aim at the *one man*, the *one woman*, the *one child*,—especially the last, and having instrumentally brought him into the light of God's countenance, then go to another, and then to another, that "God's way may be known upon the earth, and His saving health among all nations."

The salvation of the young has special claims upon your sympathy and co-operation. There is a beautiful and attractive fittingness between the service of God and the springtime of our existence. Childhood ties, the strongest of all ties, need to be carefully and prayerfully woven to Christ and Methodism. Let the Sabbath-school be the nursery of the Church,—*not its substitute*. While maturing Sabbath-school agency and appliance, on no account suffer the "little ones" to be absent from the Sanctuary. Take them regularly to the House of God, and when spiritually cultured have them formally recognised and enrolled in the membership of the Church. Then shall "thy children be taught of the Lord, and great shall be the peace of thy children." It is a most monitory fact, that only about one-eighth of our Sunday-school young people are ostensibly connected with the Church. Adults are sought after, and when found rejoiced over,—be equally solicitous for those more youthful ones who are still under the Church's wing. A young man of respectable parents was sent to jail for forgery. Sabbath-school ladies visited and prayed and sang with him in jail. "Do you remember when I left the Sunday-school," said the young man, "if you then had expended a tithe of the enegy upon me that you do now, I should never have been here."

The well-being of Methodism requires that Class-Meetings should be made increasingly attractive. A sunny, cheerful classroom, rippling with the smiles of sanctified friendship and Christian joy, wonderfully contributes to the strength and influence of a Church. Prosy, restrained, funeral Class-Meetings lead to non-attendance, and very seriously feed that sad item in our annual returns, the membership leakage. It has been recently stated that English Methodism loses through leakage "every quarter twice as many as were saved on the day of Pentecost."—*Joshua Bush*.

It is scarcely necessary that we should say that the theatre, the opera, the ball-room, the dancing party, card playing, gambling in all its forms, amusements and books of an impure and injurious tendency are not tolerated, but strongly denounced by the Church to which we have the honour to belong. "Whatsoever things are true, honest, just, pure, lovely, and of good report," in literature, amusements, or social intercourse generally, we cordially commend. True love to Christ and true loyalty to the Church will not do doubtful things,—that which is sure and safe will invariably have the preference.

Methodism has been missionary from the beginning, and in this respect as in all other living issues, will be true to her tradition. The Foreign, the French, the Indian, the Domestic will be vigorously maintained.

Education and Temperance are receiving special attention, and deservedly so.

Sabbath authority and obligation must continue to be guarded with unslumbering vigilance.

The tide of Christian liberality is rising, and the joy of the Church is proportionately replenished.

The new era upon which we have entered, in which the Methodist Church of Canada, the Methodist Episcopal, the Primitive Methodist and the Bible Christian Churches are legally unified, specially imposes responsibilities and inspires hopes. In the working of the new economy, forbearance, loyalty and brotherly love will be needed, and will not be withheld. The sessions of the Union Conference have been marked by great harmony and Christian brotherliness.

In conclusion, let us urge the daily practice of *Christian retirement*. The bustle and worldliness of the times need it. Without it, our income will not equal our expenditure. We shall lose vitality, and our activity become a lifeless, soulless service. The real fire will become a painted fire. The living Christian will cool down into a mere piece of Church mechanism, coming in and out, going hither and thither according to Church usage and requirement. And this will be the case with all of us, unless we maintain habitual communion with a reconciled Father in the holy stillness of the closet. This alone can replenish our lamps, and make our public lives a flame of love! This alone can make the members of a Church mighty through God in the field of downright conquest over sin and Satan. "Thy Father which seeth in secret will reward thee openly."
