WHEREAS it is expedient to make ^{preamble.}

all writs, orders and proceedings to the She-

dant, or one of the Defendants, has his
domicile, or in which the real property is
situate, as the case may require, and such
30 Sheriff or Bailiff to whom any such writ or
order shall be addressed shall execute
the same as if it had issued from the
Court of Queen's Bench for the District in
which he is Sheriff or Bailiff, and shall make
35 his return to the Court out of which it issued.
