RATEPAYERS WILL VOTE MARCH 23 ON THE STREET RAILWAY BY-LAW

By-Laws Given the Necessary Readings at Meeting Last Night.

It is Now Up to the People of This City to Decide--Extensions Provided for.

At the meeting of the City Council last night the Street Railway purchase by-law went through with flying colors and the ratepayers will vote on the proposition on March 23.

Naturally it is asked what does the by-law mean in the way of expenditure, actual and otherwise and what are the people to get for their money.

Assumes the Mortgage. Thus far no mention has been made of the \$125,000 gilt edged mortgage held by the Canadian General Electric Company against the Brantford Street Railway proper.

The ordinary ratepayer will also ask what the purchase of the Street Railway means in the way of increased taxation. If the Street Railway purchase by-law is carried, and there seems little doubt but that it will be carried, it will mean that in interest and sinking fund every year for 30 years the city will be required to pay \$16,064.

The Street Railway proposition looms up at once as the biggest municipal question Brantford has faced in many years. It might be asked whether a mill on the dollar in the tax rate would more than compensate the interests of the city in general for good service to several thickly populated districts such as Grand View, Eagle Place and West Brantford, which have been cut off from communication quick and easy with the heart of the city for years past.

SIX NATIONS RESERVE MIGHT BE REMOVED

Legislation Introduced at Ottawa in Regard to Indian Reserves Has Important Bearing on This County.

LABOR LEADERS WILL NOT LEAVE THE SHIP

Those Deported From South Africa Arrive In England To-day.

Sympathizers Had Arranged to Celebrate Their Arrival.

GRAVESEND, Eng., Feb. 24.—Nine of the ten labor leaders deported from South Africa on board the Umgeni on January 27, after the general strike had been broken by the government, declared their intention of refusing to leave the vessel when she arrived here to-day.

When seen this afternoon Mayor Spence said he was quite satisfied with the issue, as Brantford would not have to raise the money required for the purchase of the bonds.

Arthur Henderson, a labor member of parliament, and other British labor leaders went out in a tug down the Thames to meet the deported labor leaders from South Africa, but the captain of the Umgeni refused to allow any one to come on board.

BISHOP'S LENTEN LETTER TO PEOPLE

Lent a Time for Self-Examination—Questions Are Submitted for Answers.

Bishop Williams of Huron has issued the following Lenten pastoral: Dear Brethren:

The time of spiritual stock-taking is once again at our doors. It is a time of visitation and of testing. All such times leave us either better or worse—never the same. For forty days we are called by God through the Church to consider our ways and to mend them. There is none so good but that he may and ought to be better, and none so bad but that the way of amendment and renewal is still open. Therefore the call is to all and to everyone; and therefore, brethren, "take ye heed betime, while the day of salvation lasts; for the night cometh when no man can work. But let us, while we have the light, believe in the light, and walk as children of the light; that we be not cast into utter darkness, where is weeping and gnashing of teeth. Let us not abuse the goodness of God, who calleth us mercifully to amendment, and of His endless pity promiseth forgiveness of that which is past if with a perfect and true heart we return unto Him. Wherefore make you new hearts and a new spirit. Wherefore will ye die, Oh ye house of Israel, seeing that I have no pleasure in the death of him that dieth, saith the Lord God? Turn ye, then and ye shall live!"

Such is the call of God through the Church to all in this season of Lent. Will you heed it?

There are two perils or tendencies, beyond all others, that beset the people of this Province at this time. The first is the peril of plenty—the spiritual numbness that comes to people when prosperous and filled with the good things of this life. It makes them satisfied with this life, and causes them to lose appetite for spiritual and eternal things.

The second is the peril of self-satisfaction in religion. It is a peril that always grows in times of peace and plenty. Because we are so favored in our outward life, we think that it is because we are good. We assume that because we are prosperous, therefore we are good as good as we need to be. And so we fall asleep, and while men are asleep, the enemy comes and sows tares. Hence it is that we pray:

"In all time of our wealth, Good Lord deliver us,"

Moreover these perils are insidious like an epidemic. Everybody is influenced by them, even when he does not think so. Hence the inestimable value of the Lenten season when we are periodically summoned to consider how we stand in relation to God and the unseen—how we stand in relation to Christ.

Three questions I suggest for self-examination and I ask everyone to put them seriously to himself this Lent.

1. Is Christ the centre of my life? Its central motive and its central goal?

2. In my estimate of things and of life, which comes first with me—the seen or the unseen?

3. Is Church attendance, Church work and Church giving a pleasure or a duty? Bring yourself inexorably to these tests; and if in the ordering of your life you discover an absence of reference to Christ, a preference of the visible and the present over the unseen and eternal, and an apathy or weariness as to the use of the means of grace and the fulfilment of your Christian obligations, then, be assured, the tendencies or perils, to which I have referred, have taken hold of you.

Now therefore is the time to shake ourselves free from them, when God calls us and the Church gives us help. Let us apply ourselves to the way of amendment with all our might, with prayer, with the reading of God's Word, and the doing of His will. Let us during these forty days resolutely give up the ordinary social distractions that absorb time and energy, unfit people for work, and give a distaste for religious thoughts and duties, without accomplishing any good; and let us concentrate upon the one thing that will count when we stand before God, and God will do things from God, and God will do "Christ"—wherever we have His mind and walk in His steps.

All the additional services and opportunities for Holy Communion which the Church affords during Lent are meant for our help. Come to these services, looking for great things from God, and God will do great things for you—even to the giving of a great heart and renewing a spirit within you. Such things if we do will go far to rid this part of Ontario of the spiritual numbness and self-satisfaction that now lie as a blight upon the religious life of its people.

"O House of Israel, come ye, and let us walk in the light of the Lord." Believe me yours faithfully in Christ,

TOOK HIS OWN LIFE
Coroner's Jury Finds That Alex. McKinnon Committed Suicide.

The jury which investigated the death of Alexander "Jimmy" McKinnon, who took strychnine last Tuesday, while walking near the village of Stoney Creek, returned a verdict on Saturday evening of suicide, while in a fit of despondency. The inquiry was conducted by Coroner Thompson at Stoney Creek. Eight witnesses were called, including William Brett, who was accompanying McKinnon at the time. His evidence was similar to the story he told the police about meeting McKinnon at the Salvation Army metropole. McKinnon requested him to walk with him to Thorold in search of work. George Skinner of the city, who knew McKinnon, and was aware of the fact that his family was looking for him, said he tried to persuade McKinnon to return home.

Constable A. C. Springstead, W. B. Smith, the Hamilton druggist from whom McKinnon procured the poison; Dr. Green, E. Vandusen, Fritz Jensen, and J. Horton also testified.

Mr. Smith said McKinnon told him he wanted to use the strychnine to poison a dog. He at first refused to give it to him, but McKinnon claimed his dog had bitten a child and that he would be prosecuted if he did not kill it. Mr. Smith gave it to him.

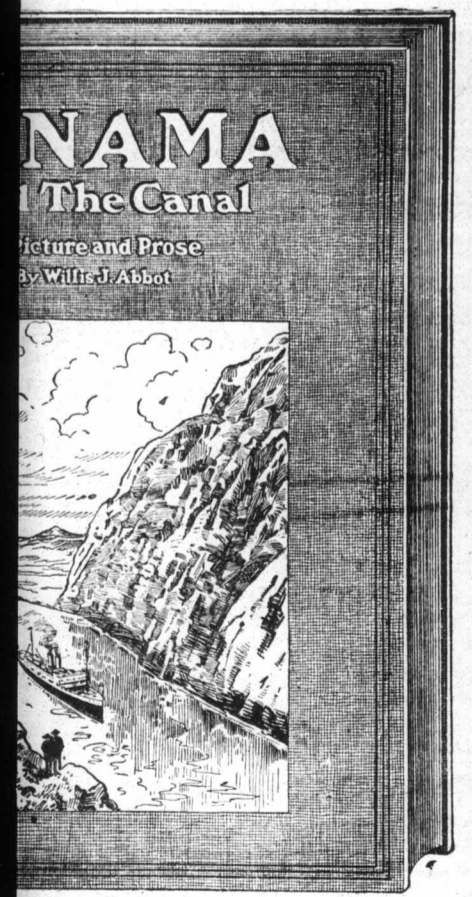


Illustration Shows the Large Volume, Double the Dimensions of the Usual Edition.

Ald. Bragg rather took objection to Mr. Strickland's nominating a man for the position. Mr. Strickland might as well make the appointment himself.

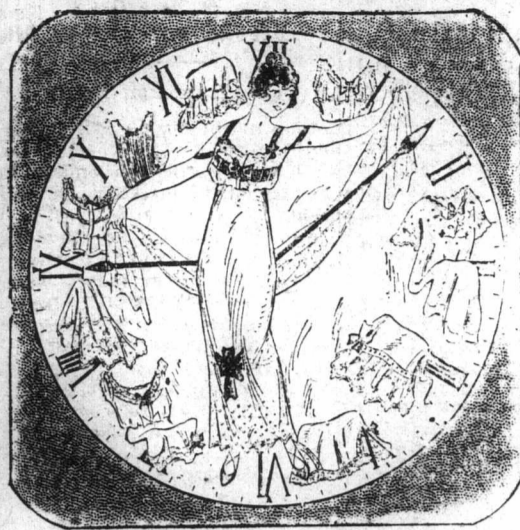

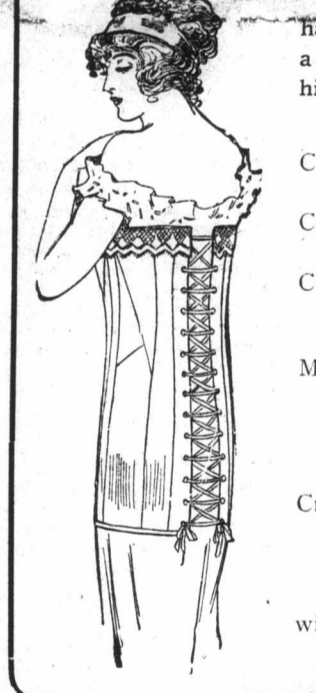

RATEPAYERS VOTE MARCH 23 ON STREET RAILWAY BY-LAW

(Continued from Page 1)

It will probably be worth a million dollars in a few years, and that the city is also taking a step for its own development, the by-law will look like a gilt-edged proposition. As a matter of fact it is believed by the civic authorities that Brantford has got to this population stage when a street railway is necessary for future growth, and in the ordinary course of events, a necessity pays its own way with something to spare.

Brantford's Debt

In the preamble of the by-law last night it was mentioned that Brantford's debt amounted to \$1,790,000. Let no one tremble at this somewhat staggering figure. Mayor Spence announced that while the amount looked big, the city treasurer had some three-quarters of a million put away, which sum would take care of debentures which were maturing in due course.

Another Feature

Mayor Spence made it plain that it was up to the ratepayers now of never to wipe out the 38-year franchise. The franchise having been wiped out there were three courses open to the city. First, Brantford could own and operate the railway itself; secondly the city could own the railway and pass it over to some other company to operate; thirdly, the city could sell out at a profit to other interests and grant another franchise. These courses were open only if the by-law went through. It had to go through if the litigation of two years would be ended; if present distressing conditions were removed and if the people wanted to wipe out the \$1,790,000.

The Mayor held to his ruling, stating that the Finance must go to the finance committee when it comes to by-laws affecting the tax rate, and railroads to railway committee.

Ald. Pitcher also took a hand in the argument. He thought the Mayor was fair in his ruling. In getting the proposition submitted to the people he thought the railway committee should handle it. When it came to raising money, it was up to the finance committee.

Ald. Hutcherson remarked that the street railway was going rough enough already, "without getting rough up here."

The By-Law

Thereupon Ald. Hollinrake introduced the first by-law. With Ald. Ward in the chair, in committee of the whole, the measure was read clause by clause. It called for the raising of \$270,000 for the purchase, improving and equipping of the Grand Valley Railway Company, he debentures will have life from June 30, 1914, and will bear interest at 4 1/2 per cent, until 1944.

The Mayor Speaks

Mayor Spence took occasion to explain things to the aldermen in reference to the situation. The city had fought the railway in the courts for two years. The company during that time had been in a state of bankruptcy, and for several years before that, although not legally bankrupt. The city suffered from this condition of affairs, the stage was reached when it became unbearable both from the viewpoint of the City Council and the people in general. Proceedings were finally launched in the courts, and the city won at every angle. Finally the point was reached where the company was in a corner with their backs to the wall and they were surrounded. But what judgments the city had secured were entirely against the Grand Valley Company. They did not affect the holders of the first mortgage of \$125,000, the Canadian General Electric Company, which was willing at all times to assume control of the road. The judgments of the court could not jeopardize their position. As advised by the City Solicitor two weeks ago, it was thought that the time was opportune for the city to take action. Accordingly a representative committee was appointed but a figure was never arrived at until the sub-committee met in Toronto. The city's offer proved the most acceptable. He city was to pay \$200,000 to the G. V. bondholders, as well as paying off the minor mortgages on car barns, etc. The \$200,000 due the city in tax arrears had to be paid off. Ten new cars would cost approximately \$50,000 and the balance of the \$270,000 would be devoted to rebuilding present worn out lines and making extensions. It was desired that the road be made to pay during the coming year and the Mayor believed that this would eventuate. If it was necessary, financial arrangements could be made with the Bank of Montreal so that the city could take the road over at an earlier date than June 30, if necessary.

The present council, said his Worship was elected on a municipal ownership platform. He had been elected on that himself. Now it was up to the people to say whether they were in earnest or not when they elected this council to represent them. He had faith in the people that they would carry the by-law.

The Mayor said he understood of typewritten reports emanating from certain well known quarters were being circulated, showing how much Brantford would go in the hole in the operation of the street railway. There was a motive behind these.

For himself, as a ratepayer, he had sufficient information to show that it was in the interests of the city of Brantford to take over the road and run it. If the people did not want to operate it, it could be turned over to a private company very easily at a profit to the city on the price at present offered.

The Mayor's remarks were listened to with interest, and the council was unanimous in endorsing the same.

Ald. Ward wanted to know if the resumption of the service to West Brantford was considered. The Mayor replied that the by-law took care of it. To Ald. Charlton, the Mayor said that it was on the advice of the City Treasurer that the debentures were made to bear 4 1/2 interest. It was a question of saving money on the disposition of the debentures on that basis.

ALL PEOPLE VIEW SCOTT'S JOURNAL IN THE MUSEUM

Women in Crowd Declare Dead Hero's Writing Is So Pretty

LONDON, Feb. 24—In a room in the British Museum, among acres of cases filled with historical manuscripts, the last journals of Captain Scott are on view. The very quiet group of sight-seers always includes a few sailors, who stare with unmovable faces at the opened pages covered with neat pencil-written script; the women in the crowd usually say, "What pretty writing," or something of that kind, and there is almost a feminine delicacy in the thin writing, always legible, and flowing easily within bounds.

This passion for precision seems to have still governed this explorer's stiffening fingers as they wrote the last words of all. Differing opinions have been given about the last entry. Does it or does it not show the distress of agony? Down to the last paragraph the writing is uniform, close and neat, and then, isolated on the page, are these three short lines: "For God's sake Look after Our people."

These words are larger than the rest, but they are perfectly plain, the letters scrupulously formed, as if Captain Scott had nerved himself to the effort to let there be no doubt about his dying message. The same precision is seen throughout in the arrangement of the books, which resemble a schoolboy's copy books in shape, except those small volumes which Captain Scott carried with him to the pole in a wallet which he wore at his side.

Were Two By-Laws.

Two by-laws were necessary for the street railway business. One was a straight money by-law to raise \$270,000, and one was a by-law calling for a vote of the people. The money by-law was sponsored by Ald. Hollinrake, chairman of Finance, and the other by Ald. Charlton, chairman of the Railway Committee. It required a ruling of the Mayor to set things right at first.

Ald. Hollinrake wanted to know which committee had the right to handle the problem. He said he had the by-law prepared, but it had disappeared from his desk.

Ad. Charlton also asked the Mayor to decide. "As far as I can see" said His Worship in an Abe Lincoln sort of manner, "What pertains to finance and the raising of money must come through the finance committee; what pertains to the railway proposition going to the people must come from the railway committee."

Ald. Hollinrake raised the question of money being voted at some future date to the railway. What committee would handle the issue.

The Mayor pointed out that if the city operated the street railway it would be done by a commission of three. If they wanted money they would have to come to the finance committee.

Ald. Charlton—"Well then, Mr. Mayor, the railway committee had better resign. As chairman, I feel that I ought to resign rather than to fill an office the work of which is usurped by some other authority. We want to do our share and I have had a tremendous amount of kicking in my committee about this."

The Mayor held to his ruling, stating that he wanted to be as fair as he knew how. Finance must go to the finance committee when it comes to by-laws affecting the tax rate, and railways to railway committee.

Ald. Pitcher also took a hand in the argument. He thought the Mayor was fair in his ruling. In getting the proposition submitted to the people he thought the railway committee should handle it. When it came to raising money, it was up to the finance committee.

Ald. Satch hereupon remarked that the street railway was going rough enough already, "without getting rough up here."

The By-Law.

Thereupon Ald. Hollinrake introduced the first by-law. With Ald. Ward in the chair, in committee of the whole, the measure was read clause by clause. It called for the raising of \$270,000 for the purchase, improving and equipping of the Grand Valley Railway Company. He debentures will have life from June 30, 1914, and will bear interest at 4 1/2 per cent, until 1944.

The Mayor Speaks.

Mayor Spence took occasion to explain things to the aldermen in reference to the situation. The city had fought the railway in the courts for two years. The company had failed, time had been in a state of bankruptcy, and for several years before that, although not legally bankrupt. The city had suffered from this condition in affairs. The stage was reached when it became unbearable both from the viewpoint of the City Council and the people in general. Proceedings were finally launched in the courts, and the city won at every angle. Finally the point was reached where the company was in a corner with their backs to the wall and they were surrounded. But what judgments the city had secured were entirely against the Grand Valley Company. They did not affect the holders of the first mortgage, \$125,000, the Canadian General Electric Company, which was willing at all times to assume control of the road. The judgments of the court could not jeopardize their position. As advised by the City Solicitor two weeks ago, it was thought that the time was opportune for the city to take action. Accordingly a representative committee was appointed but a figure was never arrived at until the sub-committee met in Toronto. The city's offer proved the most acceptable. The city was to pay \$90,100 to the G. V. bondholders, as well as paying off the minor mortgages on car barns, etc. The \$30,000 due the city in tax arrears had to be paid off. Ten new cars would cost approximately \$50,000 and the balance of the \$270,000 would be devoted to rebuilding present worn out lines and making extensions. It was desired that the road be made to pay during the coming year and the Mayor believed that this would eventuate. If it was necessary, financial arrangements could be made with the Bank of Montreal so that the city could take the road over at an earlier date than June 30, if necessary.

The present council, said His Worship was elected on a municipal ownership platform. He had been elected on that himself. Now it was up to the people to say whether they were in earnest or not when they elected this council to represent them. He had faith in the people that they would carry the by-law.

The Mayor said he understood typewritten reports emanating from certain well known quarters were being circulated, showing how much Brantford would go in the hole by the operation of the street railway. There was a motive behind these-

For himself, as a ratepayer, he had sufficient information to show that it was in the interests of the city of Brantford to take over the road and run it. If the people did not want to operate it, it could be turned over to a private company very easily at a profit to the city on the price at present offered.

The Mayor's remarks were listened to with interest, and the council was unanimous in endorsing the same.

Ald. Ward wanted to know if the resumption of the service to West Brantford was considered. The Mayor replied that the by-law took care of it. To Ald. Charlton, the Mayor said that it was on the advice of the City Treasurer that the debentures were made to bear 4 1/2 interest. It was a question of saving money on the disposition of the debentures on that basis.

Ald. Hollinrake said it should be thoroughly understood that the \$270,000 covered improvements and equipment for the present road.

Mayor Spence informed Ald. English that the \$270,000 provided not only for new equipment, but for rebuilding the old road and also making considerable extensions.

Second By-Law

Ald. Charlton's by-law called for the vote of the people on the issue. It was given the necessary readings, the 23rd of March being set aside as voting day.

Ald. Hollinrake suggested that an organization be launched to make sure the by-law was carried.

Ald. Ward also thought that the real facts should be given to the people so that no mistake be made.

The matter was left to Ald. Charlton and his committee, who will see that things are presented properly. "As things appeared," said Ald. Charlton, "the by-law looked unanimous. Ald. Calbeck wanted to know if any move was made to keep tab on street railway assets, pending the purchase. To this the Mayor replied: "They can't take away the cars because they could be traced over the Dominion of Canada."

\$37,500 for Hydro

Ald. Ryerson introduced a by-law to provide for borrowing \$37,500 to pay for the construction of electric light standards, underground conduits and wires on certain streets. The by-law covers payment for the ornamental system in the business section, which is now in operation.

BRANT NOW HAS 17 RURAL ROUTES

Borden Government Has Opened Up 920 New Routes.

OTTAWA, Feb. 24.—Since the Borden government came into power in 1911 rural delivery has become something real. In the two years and a half of office there have been opened in Ontario no less than 920 new rural routes, serving a total of 46,677 homes.

The figures of new routes in the various counties of Western Ontario follow:

The total of new routes in these Western Ontario counties is 517. Prince Edward Island is now almost completely served, there having been established under Hon. Mr. Pelletier's direction 83 new routes serving 3914 families.

In the other provinces the following number of routes have been established: Quebec 125; Nova Scotia 42; New Brunswick 66; British Columbia 21; Alberta 5; Manitoba 9, and Saskatchewan 5.

EMILY STILL ACTIVE.

LONDON, Feb. 23.—Mrs. Emmeline Pankhurst, the militant suffragette leader, will personally head a deputation which will visit the Bank of Montreal and the Bank of Toronto and Political Union purposes to send to interview King George. In making this announcement at the weekly meeting of the militant organization today Mrs. Dacre Fox added that Mrs. Pankhurst would be accompanied by her bodyguard. The leader will first write a letter to King George and subsequently proceed to the palace where she has appointed to meet his Majesty.

DROPPED DEAD.

OTTAWA, Feb. 23.—Joseph Ethier, aged 35, dropped dead in his seat while attending a performance in the Franco Theatre here Saturday night. He had entered the theatre about twenty minutes earlier with three friends and appeared to be enjoying the show when his head suddenly fell forward and the body tumbled back in the seat. He was dead when picked up.

ALL PEOPLE VIEW SCOTT'S JOURNAL IN THE MUSEUM

Women in Crowd Declare Dead Hero's Writing Is So Pretty

LONDON, Feb. 24.—In a room in the British Museum, among acres of cases filled with historical manuscripts, the last journals of Captain Scott are on view. The very quiet group of sight-seers always includes a few sailors, who stare with unmoved faces at the opened pages covered with neat pencil-written script; the women in the crowd usually say, "what pretty writing," or something of that kind, and there is almost a feminine delicacy in the thin writing, always legible, and flowing easily within bounds.

This passion for precision seems to have still governed this explorer's stiffening fingers as they wrote the last words of all. Differing opinions have been given about the last entry. Does it or does it not show the last paragraph of agony? Down to the last close and neat, and then, isolated on the page, are these three short lines: "For God's sake Look after Our people."

These words are larger than the rest, but they are perfectly plain, the letters scrupulously formed, as if Captain Scott had nerved himself to the effort to let there be no doubt about his dying message. The same precision is seen throughout in the arrangement of the books, which resemble a schoolboy's copy books in shape, except those small volumes which Captain Scott carried with him to the pole in a wallet which he wore at his side.

C. P. R. DEAL DENIED.

MONTREAL, Feb. 23.—The directors of the Canadian Pacific Railway Company have never discussed or indeed given a thought to the acquisition of the Canadian Northern Railway by purchase, lease or otherwise," said Sir Thomas Shaughnessy, president of the C.P.R., this morning when asked for a statement in regard to the rumors now being circulated in London and on the continent to the effect that the C.P.R. was to be forced to take over the C. N. R., which, stories are, blamed for the weakness of C.P.R. stock today.

HALIFAX, N. S., Feb. 23.—The body of Claude Foener, a young man who recently arrived at Brookfield, Lunenburg county, from Cobalt to spend the winter with his father-in-law, Howard Martin, was found in the woods near the settlement yesterday. Foener lost his way in a snowstorm.

A SECOND DEATH.

KINGSTON, Ont., Feb. 23.—Death entered the home of John S. Landbury, a well known Kingstonian, for the second time in three days. Wednesday last his son, George, aged 22, died after two weeks illness from typhoid fever, and on Sunday, his daughter, Miss Sarah, passed away, a victim of tuberculosis of the throat.

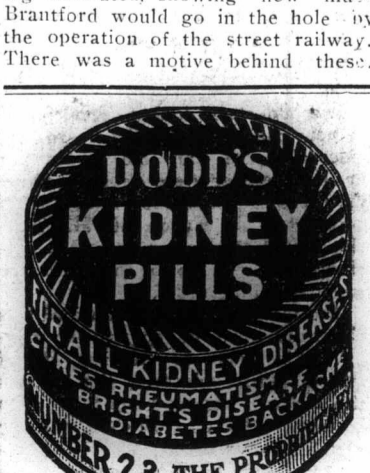

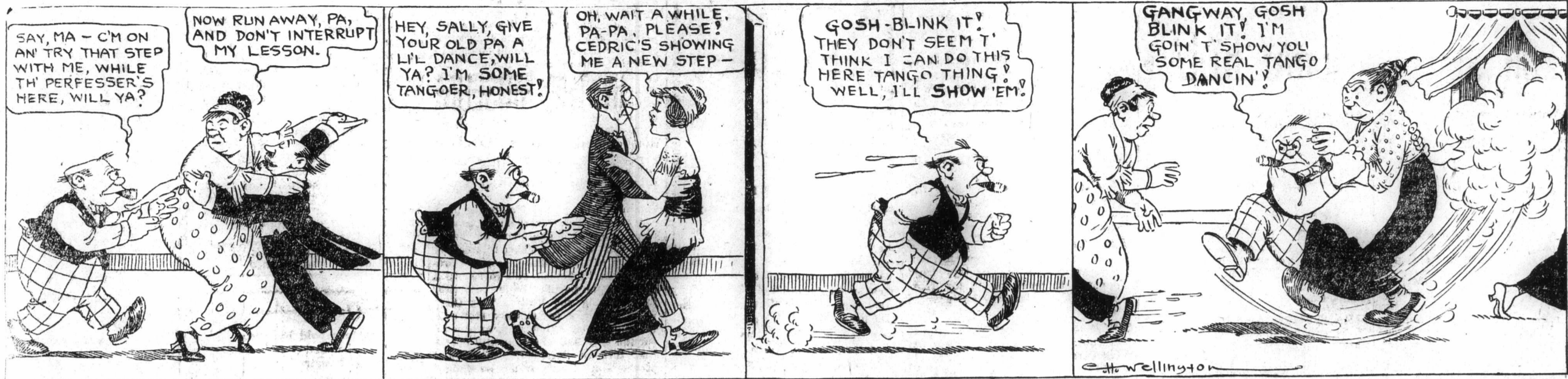

FOOTBALL GUESSES ON GAMES SATURDAY

Four Were Tied For the Consolation Prize—Fourteen Correct Scores Was Best Mark—Breezy Comment on the Games.

Interest continues unabated in the Courier football competition. This week the entries were larger than ever and competition was naturally very keen. As a result four coupons for the prize with fourteen correct answers. They are: I. T. Aspin of 43 Walnut street; I. Scanlon of 36 Brighton Avenue; E. Stover of 15 Gordon St.; and H. B. Magill of 65 Mohawk St. Each of these four competitors had four correct results in the English first division which included Saturday's English Cup ties, and each had the three second division games correctly marked, making seven each out of a possible eight. In the Southern League each had four correct markings, only Magill differing in his method of marking the winners. Again, in the Scottish League, including cup ties, these four winners marked three answers correctly, but the marking for this last

division was much varied, and although each got three correct, no two were alike. Thus in this week's competition a curious coincidence is noted four competitors have the same number of answers correct in each of four divisions and only in the last or Scotch division was there much difference in the selection of the winning teams. Excluding the second division results, in which there were only three games and many guessed correctly, there was not a single division guessed right in its entirety, with one exception, and that was sent in by Mrs. R. Hallard of Durham St. East, city. She got the whole of the Scotch results correct, and in that respect she beat every competitor, for she was the only person who got a complete division correct. The division that undoubtedly gave the most trouble in last week's competition, was the

English cup tie games in the first division. Very few competitors gave more than three correct. Not one in a hundred marked Manchester City to beat Blackburn at Elwood Park, yet this the citizens accomplished and gave coupon fillers a bad knock. Bolton were not thought good enough to turn the tables on Burnley at their home, but they managed it and caused the second falling of competitors. West Ham and Liverpool was fairly evenly marked both ways, and very few counted upon a draw. This result caused the third knock. Aston Villa were favorites to beat West Bromwich at Villa Park and they did not disappoint, whilst Sheffield United made good at Millwall, although they were not too strongly backed and Millwall favored quite a little. Sheffield Wednesday were pretty sure things against the second league, Queen's Park Rangers, despite their lowly position on the table. The Wednesday team have a way of rising to the occasion. The averages correct for the first division was three and in view of the unexpectedness of some of the results, it was not a bad average. It needed an element of luck and "inside" knowledge to do much better. The second division was the softest thing for some time and the home teams came in with a vengeance, and it was not a great deal to stop them. Nearly all coupons scored three in that section. Some were not sure of Fulham's ability to beat Bradford, but their fears were unfounded. The Southern League was not hard to fill in last week, the only thing that drew against the score markings being the draw at Plymouth where Southampton brought about that result. They were plentifully marked to lose, but they made a tie and caused a blot on the coupon. The other games in this division were pretty straight goods, and the majority of competitors marked the home teams to win and were not incorrect. Some doubt was noticeable with regard to Exeter overcoming Gillingham, but being of their own ground favored them and they pulled through. A few put Portsmouth down to draw against Southampton, who are doing well, but they managed to gain the two points. Apart from these two there was little difference in the coupons, and an average of four correct was good for the Southern League. Not a single person gave 5 correct in this division. Next to the first division, the Scotch Cup tie and league gave no small amount of trouble. There was not one result which was stereotyped, and yet not one of the results could have been overlooked for, because anything is likely to happen in a Scotch Cup tie. A team might be three goals to the good in 15 minutes from time and then be robbed of victory. It happens infrequently. Clyde put it over Dumbarton neatly by three goals to one and were expected to do so by many coupon markers. Raith Rovers were easily overcome by Third Lanark to the extent of 4 goals to 1, and they surprised their supporters with their easy defeat. Aberdeen chanced against St. Mirren were greatly favored by many, but in vain, for the Saints are still in the Scottish cup and Aberdeen are no more—till next season. OSHAWA'S PROTEST ALLOWED BY O.H.A.

Kingston Player's Certificate Is Cancelled and Game Ordered to Be Re-played

TORONTO, Feb. 24.—At the meeting of the sub-committee of the O. H. A. yesterday the protest of Oshawa against Kingston Frontenacs was allowed and the teams were ordered to play a sudden death game at Belleville on Wednesday night. Kingston won last week from Oshawa by three goals at Belleville after the teams had tied up on the round. Oshawa protested Rupert Milan of the Kingston team on the ground that he was ineligible under the residence rule, having worked in the mines at Cobalt for a few days last December. Milan when examined yesterday by the committee admitted that he had worked ten days for his uncle, who is an assayer at the Nipissing mines and then returned to Kingston, where he took up a course at Regiopolis College in mining. The committee decided that he had broken the residence rule and cancelled his certificate. Kingston were to have played in Orillia to-night in the semi-finals. Manager Sutherland of the Frontenacs, said after the meeting that his team would probably withdraw. The verdict was a great surprise to him and to hockey fans generally.
