

An Act to incorporate the Kingston and Newburgh Railway Company.

WHEREAS Quenton Smith Gildersleeve, John Watkins, William Preamble. Wilson, David Shaw, John R. Dickson, John R. Forsyth, James Harty, Archibald J. McDonald, AlexanderCampbell, Thomas Kirkpatrick, George Davidson, and Horatio Yates, of the City of Kingston, Esquires, band others, have petitioned the Legislature to incorporate a company to construct a railway from the City of Kingston through Clark's Mills to Newburgh, with power to extend the same to the Valley of the Madawaska or some point on Lake Huron as may be decided upon by such Company, and it is expedient to grant the prayer of the said petitioners; 10 Therefore Her Majesty, &c., enacts as follows:

I. The above named persons, together with such persons, corporations, Incorporamunicipalities and companies, as well foreign as provincial, as shall under tion of Comthe provisions of this Act become Shareholders in the Company pany. hereinafter mentioned, shall be and are hereby ordained, constituted and lideclared to be a body corporate and politic in fact by and under the name and style of the "Kingston and Newburgh Railway Company."

II. The several clauses of "The Railway Clauses Consolidation Act" Certain clauses with respect to the first, second, third, and fourth clauses thereof, and also, of 14 & 15 V., the several clauses of the said Act with respect to "interpretation," c. 51, incorpo-rated with this M"incorporation," "powers," " plans and surveys," "lands and their valua- Act. tion," "highways and bridges," "fences," "tolls" "general meetings," "Directors, their election and duties," "shares and their transfer," "municipalities," "shareholders," "actions for indemnity, and fines and penalties and their prosecution," "working of the Railway," and "gen-Is eral provisions," shall be incorporated with this Act, and shall be included by the expression " this Act " whenever used therein.

III. The said Company and their servants or agents, shall have full Line of Railpower under this Act, to lay out, construct, make and finish a double or way defined. single iron Railway or Road at their own cost and charges, on and over

VI. Within three months after this Act shall be passed, a General First general meeting. Meeting of the Shareholders shall be held at the City of Kingston, for the purpose of putting this Act into effect, which Meeting shall be called by 15 any five of the persons named in this Act, ten days public notice thereof Notice. being given by being published in any one of the newspapers of the City of Kingston; at which said General Meeting, the Shareholders present. Election of having paid five per cent on their Stock subscribed, shall either in person Directors. or by proxy, choose nine Directors in the manner and qualified as herein. 20 after mentioned, who together with the ex officio Directors as provided by Term of office. the Railway Clauses Consolidation Act, shall hold office until the first Annual General Meeting for the election of Directors, and until others are elected in their stead.

VIII. The number of Directors which shall form a quorum for the trans-Quorum. action of business may be regulated by the By-laws of the Company, and 4 until such By-laws shall be passed, a majority of the Directors shall form Paid Director such quorum; Provided that the Directors may employ one of their number as a paid Director.
