

An Act to incorporate the South Bolton Cemetery Company:

JHEREAS the undermentioned persons, by their petition to the Preamble. VV Legislature, have shown that for a number of years past they have been in possession of a piece of land in the Township of Bolton, in the County of Brome, under a supposed title, for use as a public Cemetery, 5 and that many interments have taken place therein, and the same is in constant use, and is on public grounds needed, as such Cemetery, but that they are advised that, in order to render certain the perpetual keeping up of the same for the use aforesaid, it is needful that they be incorporated in due course of law; and whereas it is expedient to grant 10 their prayer, to be incorporated to that end;

Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

Greene, Ivory Sweet and Otis Wadleigh, and all other persons who may, by virtue of this Act, replace or be united with them, shall be and they are hereby constituted a body politic and corporate, under the name of the "South Bolton Cometery Company," and under that name Corrorate 20 may acquire and hold for themselves and their successors, under any name. legal title whatever, such real estate in the said Township of Bolton as Powers.

they or any of them now have in possession for the use aforesaid, or as they may have occasion hereafter to acquire for such use; and may sell or otherwise alienate any part thereof wherein no interments have taken. 25 place, and acquire other instead thereof for such use.

2. The Corporation may administer their affairs by such and so many D rectors and Directors and other officers, and under such restrictions as touching officers. their powers and duties, as by by-law in that behalf they may from time to time ordain, and they may assign to any of such officers such remu-30 neration as they may deem requisite.

3. The corporation may make all such by-laws, not contrary to law, Br-Laws of as they shall deem expedient for the government thereof, the mainte-teroporanance and due regulation of their Cemetery, the ordering of interments tion for certherein, the raising of such funds as they may require, whether by issue 35 of transferable shares or otherwise, the conditions under which such shares shall be issued and may be transferred or forfeited-the defining and regulating of all manner of rights of the corporation, and of the members thereof, and of all other persons in the premises—the imposing and enforcing any penalty or forfeiture in connection therewith-and 40 the administration of their affairs generally; and may from time to time amend or repeal such by-laws, observing always, however, such formalities of procedure as by such by-laws may have been prescribed to that end; and generally, shall have all needful corporate powers for General the purposes of this Act.

Application of property and funds.

4. All land held and to be held by the corporation shall be so held and used for the purposes of such Cemetery only; and no part thereof wherein any interments have been made shall be diverted to any other use whatever, or in any wise alienated by the corporation; and all funds and revenues of the corporation, from whatever source derived, shall 5 be devoted to the maintenance of the Corporation, and to the acquisition, improvement and repair of the buildings and other real estate thereof, and to no other purpose whatever.

5, The Corporation shall, at all times when thereunto required by Government, the Governor, or by either brauch of the Legislature, make a full re- 10 turn of its property, real and personal, and of its expenditure, for such period and with such details and other information as the Governor or such branch of the Legislature may require.

Public Act. 6. This Act shall be deemed a Public Act.
