An Act to amend the Assessment Act of Upper Canada, so far as relates to the time of redemption of all Lands sold for Arrears of Taxes.

WHEREAS great hardships have been caused by the sale of lands Preamble. for unpaid taxes, while the owners of such lands were unaware that such taxes were in arrear, and it is therefore desirable that further time should be given for the redemption of lands so sold; Therefore, 5 Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—
