The origin of the Rhode Island settlement is one of the most interesting events in the history of America. It was founded by Roger Williams, an Englishman, who had emigrated to Massachusetts, not merely to obtain freedom of conscience for himself, but to assert the right of every human being to possess it. This doctrine was the control of every human being to possess it. This does to preached boldly, and declared himself "re to be bound and panished, and even to die to be bound and banished, and even to die? in defence of it. For holding these opinions the General Court of Massachusetts pronounced against him the sentence of banishment. After enduring great hardships in the forests of Massachusetts, he embarked in a small Indian cance, with five companions, and landed in Rhode Lisland, at a spot to which he gave the name of Providence. "I desired," said he, "it might be recovered that the companion of the control Providence. "I desired," and ne, "things of for a shelter for persons distressed for con-science." Here he was soon joined by others who fled to this saylum of religious liberty. The great civil war broke out in England soon after, and the settlers in Rhode Island, thinking the opportunity favorable, sent Roger Williams to and the continuity favorable, sent Roger Williams to England, to ask a charter for the new settlement. His detinguished merits induced "both houses of parliament to grant unto him and friends with him, a free and absolute charter of civil government for those parts of his abode." Rhode Island thus owed its existence, as a separate community, to the Long Parliament, and more especially to Sir Henry Vane, the younger, the friend of Milton. Roger Williams was received with transport of delight on his return to America, and, under his wise influence, and the noble principles of civil and religious freedom established by him, the settlement continued to flourish. "From the first beginning of the Providence colony," said the inhabitants, in an address presented to Sir Harry Vane, "you have been a moble and true friend to an outcast and despised people; we have ever reaped the sweet fruits of your constant loving kindsess and favoar. We have long been free from the iron yoke of the wolfish bishops: we have sitten dry from the streams of blood spilt by the wars of our native country. We have not felt the new chains of the Presbyterian tyrants: nor, in this colony, have we been consumed by the over-zealous fire of the (so called) Godly Christian magiarates. We have not known, what an excise means: we have a simost forgotten what tithes are. We have long drunk of the cup of great liberties as England, to ask a charter for the new settlement. have almost forgotten what tithes are. Mr. Dark's waggon and two horses separated a month since, and have not travelled since together; the y have left 2 or 3 days since, but we saw them in the valley before leaving, and all in good health. We have had mostly through these Prairies very good roads, but have had to ford several wide streams, such as the North Platte, South Platte, Green River and a number of other smaller streams, but from the lateness of the season they were all more fordable than they would have been earlier, and we were informed that many persons lost their lives fording some of these rivers, not the least accident happened to us or our teams. I will but merely attempt at giving you a description of this valley the great forlorn hope and inexpressible joy of the Mormon refuge. These singular people number far more than I had an idea of, and it is supposed they will number in the fall when all emigrants have arrived, about 50,000. We did not find the climate so congenial as we anticipated, the days being exceedingly warm until 12 or 1 o'clock, and then improves by a nice breeze the rest of the day. the nights uncomfortably cold. It never or rarely rains, but there is springs sufficient from the mountains to irrigate the land under cultivation, and excellent crops have been raised this year. In that letter he animadverted somewhat strongly on the favour shown by Lord Clarendon to the Roman Catholic bishops of Ireland, speaking of his having, auctoritate sua, given them precedence over the "nobility and dignitaries of the National Church." Grenville, Secretary to the Privy Council, grapples with Mr D'Israeli, and in a letter addressed to the Times, shows that if Lord Clarendon did wrong, he only followed the example set by the Peel Government of 1845.
