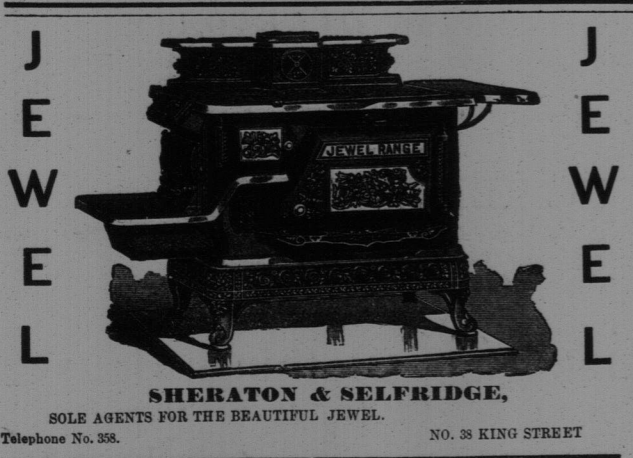

THE ARRIVALS OF MONTREAL AND QUEBEC.

Two Big Flims at Mercier's Disposal—Customs Emigrants not Wanted in the Northwest.

MONTREAL, April 8.—The deaths of Sheriff Chauveau, Minister and Ally of Quebec, have placed two very valuable berths at the disposal of the Mercier government. There is considerable speculation as to who will be the candidates for the vacant positions. For Quebec it is generally believed the Hon. C. A. E. Gagnon the present provincial premier, will be the lucky man. Mr. Gagnon has always been a turbulent element in Mercier's cabinet. It was him that forced on the Premier the bringing of the motion for the expulsion of Le Blanc which did so much harm to the Nationalists cause. By solving Gagnon, Mercier removes a disturbing factor from the ministry and places a man to whom he is much beholden in a comfortable position for life.

For Montreal the candidates are Hon. Arthur Lucotte, attorney general, and L. O. David, M. P. P., with the chances in favor of the latter. The appointment of no settlers would be much weakened Mercier's following.

HEARS TAKING HIS MEDICINE. Fleck's Medico thinks it best to go to Jail for the Part He Took in Securing That Famous Divorce.

NEW YORK, April 7.—Reference to Joe Meeks decided today to take his medicine for his share in securing a fraudulent divorce for ex-Sheriff Fleck's wife. Judge Barrett sentenced Meeks to six months in jail for a month and to pay a fine of \$100. Fleck called upon Meeks and told him that Meeks had come to the conclusion that he wanted to serve on the order of imprisonment to which he had been sentenced and to pay his fine. Mr. Fleck was slightly surprised.

Another Toronto in Illinois. HIGHLAND PARK, Ill., April 9.—A fierce storm swept over this place at 11 last night, doing heavy damage to property. Only one person was injured, but a number had narrow escapes. The wind was from the west and the rain was heavy. Destruction was about half a mile wide, the storm entering a clean swath through the town.

THE TARIFF WILL BE PASSED. AN ACT TO AMEND THE TARIFF. NEW YORK, April 9.—A special from Washington to Tribune says: "The tariff bill will be passed by this congress at the present session notwithstanding the statements to the contrary, put forth for political purposes."

It will be passed, too, after a thorough debate, even if it should require congress to remain in session through the greater part of the summer and away into September.

Exhibition of the Year. WASHINGTON, D. C., April 9.—In the House today the session adjourned to the House bill to admit free of duty articles intended for St. Louis exposition in 1890, which may be imported from the Republic of Mexico and other American republics and the Dominion of Canada, was introduced.

McCann engaged in grappling with the wharf. Mr. Kelly was a native of Glasgow and has lived in Portland most of his life. His disappearance is a very strange one.

THE PROBATE COURT. In the matter of the will of the late Thomas Harrison, in respect to which a caveat was filed on behalf of Thomas McDevitt and Rose Fair, the next of kin of the deceased, and testimony as to the capacity of the testator taken by the Probate Judge, B. C. Skinner gave judgment this morning. The judgment was delivered in the City Police Court, where the case has been principally heard and which had been placed at the service of the Probate Judge.

His Honor in a lengthy judgment wherein he reviews and analyzes the testimony on behalf of the caveators and the next of kin, and decides in favor of the estate.

The conclusion of Judge Skinner is a reasonable one and based principally on the evidence of Dr. Travers, who attended the deceased in his last illness and was also one of the witnesses of the will.

A Cool Way to Promenade. About half past nine last evening quite a commotion was raised about the foot of Main street by the strange actions of a young man, who was observed walking about near Mr. F. A. Young's hardware store. When first seen the man had nothing on but a close fitting garment which he pulled down to his knees. He was lying in the alley between Mr. Young's establishment and Mr. Doherty's furniture store. A crowd soon gathered around but every body was afraid of the man who acted so strangely and spoke not a word. He soon retired to the shadow of the furniture store and in the presence of the crowd removed the shirt and stood before them, on a pile of sashes, stark naked. Mr. Young notified the police and in a few minutes officers Corbett, Laskey and Moore were on hand but the young man in South African costume had disappeared and so had his clothes. Officer Moore secured a dark lantern and a search was made about Long wharf and Fisher's Pond but the officer could discover no one and some of them think they were hoaxed. The same party, however, who had been promoting in the manner described above was on the Long wharf when the 9:30 train went up and running against the engine as if attempting to stop it, he was thrown backwards and had his head and face badly bruised.
