BILL.

[1865—2nd Session.

An Act to enable the Trustees of the Congregation of St. Andrew's Church in the Township of Ramsay, in connection with the Church of Scotland, to dispose of the glebe thereto, belonging and for other purposes.

WHEREAS the Trustees of the Congregation of St. Andrew's Church Preamble.
of the Township of Ramsay, in connection with the Church of Scotland, have by their petition represented, that they are desirous of selling and disposing of the north-east quarter of lot number fifteen in the 5 seventh concession of the Township of Ramsay, in the County of Lanark, which forms the glebe of the said church, and of applying the proceeds thereof to the acquisition of a site and the erection of a Manse in the Village of Almonte, to be held by the said trustees, for the use and benefit of the Minister of the said congregation; and whereas it is expedient to grant their prayer: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. The present Trustees of the Congregation of St. Andrew's Church of the Township of Ramsay, in connection with the Church of Scotland, 15 or their successors duly elected as such, or a majority of them or either of them, shall have power to sell, alienate, dispose of and, by a good and sufficient title or titles under their hands and seals, to convey the north-east quarter of lot number fifteen in the seventh Concession of the Township of Ramsay, in the County of Lanark, and that in one lot or 20 in more lots or portions to any person or persons willing to purchase the same, and to apply the proceeds of such sale or sales to the acquisition of a site and the erection of a Manse in the Village of Almonte, to be held by the said Trustees for the use and benefit of the Minister of the said Congregation: Provided always, that the said Trustees who join 25 in the sale and conveyance of the said lot of land or of any portion or portions thereof, shall be personally liable to see to the application of the moneys arising therefrom to the purposes contemplated by this Act, but the purchasers shall not.

2. This Act shall be deemed a Public Act.
