NOTICE IS HEREBY GIVEN THAT THE UNITED STATES GOVERNMENT IS REQUESTING THE GOVERNMENT OF THE SOVIET UNION TO APPROVE THE PROVISIONS OF THE AGREEMENT, DATED AT MOSCOW ON 28 JUNE 1944,

BY WHICH THE UNITED STATES AND THE SOVIET UNION AGREE TO ESTABLISH A JOINT COMMITTEE FOR THE COLLECTIVE SECURITY OF THE EASTERN BLOC. THE AGREEMENT IS PRESENTED AS FOLLOWS:

"AGREEMENT BETWEEN THE UNITED STATES OF AMERICA AND THE SOVIET UNION FOR THE COLLECTIVE SECURITY OF THE EASTERN BLOC, DATED 28 JUNE 1944."

"The United States and the Soviet Union, desirous of maintaining the peace and security of the Eastern Bloc, have agreed as follows:

"1. The United States and the Soviet Union shall, through their respective Foreign Ministers, establish a joint committee, which shall be known as the Joint Committee for the Collective Security of the Eastern Bloc. This committee shall consist of one representative from each government.

"2. The Joint Committee shall have the power to decide all questions concerning the collective security of the Eastern Bloc, and to take such measures as may be necessary to insure the fulfillment of the purposes of this Agreement. The Joint Committee shall also have the power to propose to the governments of the United States and the Soviet Union any measures which it deems necessary to insure the fulfillment of the purposes of this Agreement.

"3. The Joint Committee shall meet at least once every six months, or more frequently if either government so desires. The Joint Committee shall also meet whenever either government so desires.

"4. The Joint Committee shall have the power to decide all questions concerning the collective security of the Eastern Bloc, and to take such measures as may be necessary to insure the fulfillment of the purposes of this Agreement.
