GAME WARDEN DEAN HAS CASE IN COURT

Three Young Men in Fredericton Court are Charged with Hunting Game in Close Season.

Fredericton, N. B., Sept. 8.—(Special.)—Three young men, Oscar Carlson, Thomas Ryott and Henry Landry of McAdam, were before the police court this morning on complaint of Game Warden Dean, charged with hunting game in the close season. R. B. Hanson appeared for the prosecution and Cyrus F. Ingham for the accused.

The evidence of Albert Hurd and William Haworth was taken and the case was stood over until the afternoon and the accused remanded to jail. Hanson swore that he heard a shot in the woods near McAdam, and five minutes later saw the three defendants emerging from the woods carrying a Winchester rifle. He also saw the three defendants and identified it. It is said that the defendants are strikebreakers and that the employees of the C. P. R. shops at McAdam gave the warden the information.

A THREAT TO THE MASONS Socialist Leader in Glasgow Says he will Make all Masonic Secrets Known Unless Help Comes to the Unemployed.

Glasgow, Sept. 8.—The Socialist leader in the agitation among the unemployed which has been going on here for several days past, said today in a threatening attitude, necessary to maintain a large extra force of police. Last night one of the leaders, after making a speech in the streets, threatened to make a series of midnight marches into the wealthy sections of the city, after the manner of the threat that unless a municipal council did something practical for the unemployed within a month, he would reveal all the secrets of the masonic organization and put every man, woman and child in Glasgow in possession of the order, tokens, grips and words of the order.

MORE DISCOVERIES IN JORDAN MURDER CASE Boston, Mass., Sept. 7.—Several parts of the body of Mrs. Chester Jordan, known as the vaudeville star, who was murdered on September 1, at her home in Somerville, were found in a sewer about a quarter of a mile from the Jordan house today. Jordan told the police last week that after cutting up the body of his wife, he disposed of several of the parts by sending them into the sewer from the bathroom, before he placed the torso in the trunk which was found in Boston last Thursday evening.

Jordan, who is at the Cambridge jail, will be given a hearing in the Somerville district next Friday.

BOY KILLS HIS SISTER Exeter, N. H., Sept. 7.—Allen E. Hall, the 14 year old boy, charged with killing his sixteen year old sister, Flossie May, with a shotgun, in North Danville, Saturday afternoon, will be given a hearing Wednesday afternoon at two o'clock. Hall was arrested Sunday morning and lodged in the Exeter jail, but was released today under the delinquent children law. Under this law, children under 17 years of age may not be confined in jail or given a trial in a court room. Hall was therefore placed in custody of Probation Officer Andrew Irvine and given considerable freedom.

LASKER WINS CHESS MATCH Munich, Sept. 8.—The seventh game in the chess match for the championship of the world between Dr. Lasker and Dr. Tarrasch, which was begun here Saturday, had adjourned on the 64th move and was won yesterday by Dr. Lasker in 12 additional moves, 76 in all. The score now stands: Lasker, 5; Tarrasch, 1. The match is eight games up.

TRANSFERRED TO VIENNA London, Sept. 8.—Eene William Howland, counselor of the British Embassy at Washington, was transferred from Washington to Vienna, where he will act in the same position.

SIX WEEKS OLD BABY FROM RAT BITES

A NOTED SPECIALIST TAKES HIS OWN LIFE

Dr. C. H. Brooks, Cancer Specialist, of Portland, Me., Poisons Himself in New York Hotel.

New York, N. Y., Sept. 7.—A man, believed to be Dr. C. H. Brooks, a noted cancer specialist of Portland, Maine, committed suicide today in the Mills Hotel, No. 3, by taking a subtle drug, the nature of which could not be determined, and tonight it was learned that the suicide was the same man who last Saturday night tried to end his life in the rectory of the Church of the Holy Innocents in West 20th street. Two priests at the rectory saw the man trying to cut his throat with a razor and held him until a detective arrived.

In establishing the fact that the Mills Hotel suicide and the man who tried to take his life in the church rectory were the same person, a most tragic story was revealed. After being prevented from taking his life on Saturday, the man, who said his name was Dr. C. H. Brooks, of Portland, Maine, confessed to the priests the causes which led him to attempt such a rash act. He said he had come here to seek work, that he had left his family in Maine in a penniless condition and it was worry over their sufferings that had made life unendurable.

Rev. Father O'Farrell and Father O'Keefe, to whom this confession was made, had sent a call for the police, but when a policeman arrived, Dr. Brooks had promised not to end his life and so the priests did not believe that it would be wrong to arrest him. They refused to reveal the identity of the would-be suicide to the policeman.

Daniel Madden, a hotel detective, had been called in by the priests, accompanied Dr. Brooks to the Mills Hotel and paid for a room for him for two days. The priests gave Mr. Brooks some money to pay his living expenses and believed that he had resumed him out of his desire to commit suicide.

When the police learned today that a man who registered at the Mills Hotel as Dr. C. H. Brooks, of Portland, Maine, had died it was not known, of course, that he was the same man who had attempted his life in the church rectory. The death, which had been reported by a hospital doctor as due to hemorrhages of the lungs, seemed to the police worth while investigating and the coroner was called as a result.

The investigation led to the find of letters in the pockets of the dead man which showed, among other things, that he was a doctor, that he had been in the rectory, and that he had killed himself, and the coroner confirmed this conclusion by stating that he had found traces of poison on the lips of the man, but could not tell what kind of poison had been used.

Brooks, of Portland, Maine, confessed to the priests the causes which led him to attempt such a rash act. He said he had come here to seek work, that he had left his family in Maine in a penniless condition and it was worry over their sufferings that had made life unendurable.

Rev. Father O'Farrell and Father O'Keefe, to whom this confession was made, had sent a call for the police, but when a policeman arrived, Dr. Brooks had promised not to end his life and so the priests did not believe that it would be wrong to arrest him. They refused to reveal the identity of the would-be suicide to the policeman.

Daniel Madden, a hotel detective, had been called in by the priests, accompanied Dr. Brooks to the Mills Hotel and paid for a room for him for two days. The priests gave Mr. Brooks some money to pay his living expenses and believed that he had resumed him out of his desire to commit suicide.



LUMP ON HIS FOOT GAVE HIM AWAY

Irvin Earle Stole \$82 From his Employers but Detective Killen Found it Hidden in His Boot.

Irvin Earle, a fifteen year old lad was arrested this morning at nine o'clock by Detective Killen on suspicion of stealing \$82 from O. H. Warwick & Son, his employers. To Magistrate Ritchie this morning he pleaded guilty and was remanded. The theft was committed on Saturday night in the office of the store the money being pilfered from the cash drawer where it had been deposited.

Earle had been employed in the store for some time and had access to the office at all times. Being aware that some amount of money in the drawer was quite large he took a most opportune occasion to enter the office when the clerks were all occupied in the store and the cashier was engaged in another section of the building. When it was discovered later in the night that the money was missing Earle was questioned regarding his complicity in the theft but he emphatically denied being connected with it claiming to be attending to customers at the time the robbery must have occurred. The services of Detective Killen were secured last night and when the boy entered to resume his duties after the holiday he was subjected to a minute cross-examination by the detective who was convinced that Earle was the man. Some of his queries were not answered satisfactorily and he determined to search thoroughly the boy's clothing for a portion of the money or some clearer evidence of guilt. Nothing that would implicate him in the robbery was found in his pockets but when an examination of his boots was made an unnatural lump was perceived on the sole of one his feet making the stocking an investigation \$82 dollars in crisp bills were brought forth. When confronted with such evidence Earle confessed and was immediately taken into custody by the detective and lodged in jail. His father was notified of his son's predicament and appeared in court. He is desirous of having the boy incarcerated in the reformatory for a term of four years in an effort to reform him and being a man of integrity he feels badly over the affair but sees the only remedy for his wayward boy is the one stated. When asked by the magistrate to plead to the charge he replied between sobs "I'm guilty." When informed that he would be liable to term of seven years in the penitentiary and admonished for his act he cried bitterly. It is not certain that Earle will be accepted at the reformatory as he appears to be at least two years older than the age he gave.
