





PROVINCIAL PARLIAMENT  
HOUSE OF ASSEMBLY  
EXTRACTS FROM THE JOURNALS

February 24.  
Mr. Hill presented a Petition from Lucien L. Copeland, praying and to continue the running of a Weekly Stage on the Road between Fredericton and Saint Andrews; which was received and referred to the Committee on Internal Communication to report thereon.

Mr. Brown presented a Petition from James Brown and Josephus Moore, Trustees of Schools for Saint David for a grant of money to remunerate Thomas Haverly for teaching a School in 1841; which was received and referred to the Committee on School Petitions.

February 25.  
Mr. Parnell from the Select Committee appointed on the 15th inst. reported, that the Committee having the subject of negotiating a Loan to meet the existing demands against the Province, under their consideration had prepared a Bill, under the title of "A Bill to facilitate the negotiation of a Loan of Money in England to pay off the Public Debt." Ordered.—That the Report be accepted.

On motion of Mr. Wilmot.—Ordered.—That the Bill be forthwith printed, and fifty copies thereof be furnished for the use of the Members of this House.

Mr. Hazen brought in a Bill to amend the Law relating to the Practice in the Inferior Courts of Common Pleas, and render the same uniform in the several Counties; which was read a first time.

Mr. Parnell presented a Petition from John Kerr, of the City of Saint John, Merchant, setting forth, that he was one of the Sureties for James Campbell, his Deputy Treasurer at St. Andrews, in the County of Charlotte, who absconded; that a suit was instituted against him, as such surety, for the recovery of a sum of money due to the Crown from the said James Campbell; that upon the trial of the cause, a verdict was given for a sum of \$530 secured from the effects of the said James Campbell; through the instrumentality of the Petitioner, but a verdict given for the whole amount of the legal liability; the Petitioner therefore prays such relief in the Premises as the House may deem meet; he having read the Petition, which was received and referred to a Select Committee, to examine and report thereon.

Ordered.—That Messrs. Parnell, Fisher, and Boyd do compose the Committee.

Mr. Fisher, pursuant to leave granted, brought in a Bill relating to the sale of Crown Lands; which was read a first time.

On motion of Mr. Brown.—The House went into Committee of the whole on a Bill to authorise the Justices of the Peace in the several Counties of this Province to make regulations for the markets.

The Chairman reported, that the Committee had the Bill referred to them under their consideration and agreed to the same.

Ordered.—That the Report be accepted and the Bill engrossed.

Mr. Wilmot presented a Petition from Edmund Ward, proprietor and publisher of the "Sentinel" Newspaper, published in Fredericton, complaining of certain exactions by the Postmaster at that place, on the transmission of the Paper, and praying relief; which was received.

On motion of Mr. Wilmot.—The House went into Committee of the whole in further consideration of a Bill to amend the Charter of King's College.

The Chairman reported, that the Committee having the Bill again before them, had agreed to the same.

Ordered.—That the report be accepted and the Bill engrossed.

Mr. Hill brought in a Bill relating to Grand and Petit Jurors; which was read a first time.

February 27.  
The Hon. Mr. Simonds, by command of His Excellency, laid before the House the following Document.

Copy of a Letter from H. M. Watson, Esq. Acting Deputy Postmaster General at Halifax, relative to the transmission of the Journals of the Legislature; the same being communicated under an Address of the House of the 23d instant.

POSTAGE OF JOURNALS.  
General Post Office, Feb. 13, 1843.

(Copy).  
SIR.—I have to acknowledge the receipt of your letter of the 1st instant, stating you had deemed it advisable to fix on the sum of forty pounds for sending the Journals of the House of Assembly through the Post during the Session, an arrangement which you trusted would meet with my approbation; but after the repeated communications you would have taken such a step.

If a Post Master, conducting one of the largest offices in the Province, is to pay so little attention to his instructions, as to consider he is at liberty, on his own responsibility, to enter into any arrangements of this description, it will be impossible to introduce system or regularity in the proceedings of the Department.

All matter sent through the Post Office in these Provinces is legally liable to full Postage; but the Deputy Post Master General has for many years been permitted to pass under his franking privilege, newspapers and other printed sheets. The amount which was fixed upon to be received by him for the exercise of this privilege, has been more than once brought under the consideration of the Post Master General of England and has received His Lordship's sanction. I can therefore allow no departure from this established charge on all printed sheets under his privilege; and I desire the arrangements made by you, may be immediately put an end to.

and I have further to point out, that, should you, on any future occasion, disobey your instructions in a similar manner, I shall remove you from the service.

February 28.

Mr. Parnell presented a Petition from Stephen Wiggins and Son, Robert Rankin, and Company, and others, Ship owners of Saint John, praying that an Act may pass to reduce the Light and Hospital dues; which was received and referred to the Committee on Light Dues to report thereon.

Mr. Palmer, from the Committee appointed on the 23d day of February instant, to enquire into any claims that may be made by the several Sheriffs for holding the late Elections throughout the Province, submitted their Report.

Your Committee are therefore of opinion, that the following sums should be allowed to the Sheriffs of those Counties where the Poll was kept open the whole number of days directed by Law, namely:—To the Sheriffs of Charlotte, Carleton, York, Queen's, King's, Westmorland, Kent, Northumberland, and Saint John, £20 each; City of Saint John, £15; Sanbury, Poll open one day, £10; Gloucester and Restigouche, no Poll deemed, £10 each.

HOUSE OF ASSEMBLY.—We have copied into our paper this day a part of the debate on the question of Mr. BAILEY'S reinstatement to office. This subject appears to have been a standing dish in the House for the last seven years, served up during a goodly portion of each session, in order, as it turns out, to blind the eyes of the constituency to the iniquitous conduct of the late House of Assembly. After all the outcry against this gentleman we now seriously ask, where do we find ourselves?—It is here. After all the time and money wasted by the House in abusing and persecuting Mr. Bailey, he is now, by those who were most loud in their condemnation, acquitted of all the charges they have so unceremoniously handed about the house, and reinstated in his office. The fact is, we have been juggled by our own representatives; the agitation on this subject alone has cost the country nearly one thousand pounds each session; no small portion of which has gone into the pockets of members themselves in the shape of daily pay, portion of delegations; and one beautiful item alone is £700 pocketed by three members for specially reporting whether or not the Commissioner owned the country double that amount. And further, what has availed the boasted cry of retrenchment, that was to be carried into the Crown Land Department when Mr. Bailey was got rid of? It is now stated that the most lavish expenditure of Mr. Bailey's time was nothing in comparison to the late "extravagance;" witness a few items charged against the Civil Revenue:—Travelling expenses of Executive Council, £231; Dr. Genser, ex account of survey of Tobique Valley, £75; £200 additional salary *a la Harrey* to the late Commissioner of Crown Lands; another £75 to Dr. Genser towards exploring the Mechanic's settlement; £200, (including £517 4s 10d for His Excellency's postage) for Provincial Secretary's and other public postages, &c. &c. &c. If these and the like, *additionals* are the *bona responsible* men would confer upon us, the less we have of them the better.—*Chronicle.*

Wednesday, March 1.  
A Bill to authorize the Justices of the Peace in the several Counties of this Province to make Regulations for the Markets, passed the House, and was taken to the Council by Mr. Brown.

Mr. Taylor, from the Committee appointed

to wait upon His Excellency the Lieutenant Governor with the Address of the House of yesterday, relative to the extending the time for payment of the Stampage Duty on applications for Timber and Lumber cut from Crown Lands, reported that the Committee had attended thereto, and that His Excellency was pleased to say, that the subject should be immediately brought under the consideration of the Government.

Mr. Boyd presented a Petition from Robert Doherty, proprietor of the Mail Stage Coach on the Road between Saint Andrews and Saint Stephen, in the County of Charlotte, praying that a grant may pass to aid him in continuing the establishment on that Line, which was referred to the Committee on Internal Communications to report thereon.

On motion of Mr. Brown.—The House went into Committee of the whole in further consideration of the State of the Province.

The Chairman reported, that the Committee having the subject referred to them again under their consideration, the following Resolution was moved:

"Resolved, As the opinion of this Committee, That a statement of the Finances of the Province should be made up before the opening of the annual Session of the Legislature, under the direction of His Excellency the Lieutenant Governor or other person administering the Government, and laid before the House of Assembly; the statement to contain an estimate of the probable available amount of Revenue for the ensuing year; and that the amount of money granted in Supply during such Session, with other sums payable by existing Laws, should not exceed the amount of Revenue so set forth in such Financial statement."

That an amendment was then moved to the said Resolution.—To exchange the whole thereof, and substitute the following:—

"Resolved, As the opinion of this Committee, That nothing has transpired from its recorded opinion on the subject of the Institution of Money Grants, when in consideration of the Messages and other Documents communicated by command of His Excellency the Lieutenant Governor, relating to the Financial affairs of the Province, on the 9th day of February, 1842."

An amendment was then moved to the said proposed amendment.—To expunge the whole thereof, as well as the original Resolution, and substitute the following:—"Resolved, As the opinion of this Committee, That nothing should induce the House to surrender its undoubted and inherent right to initiate all Grants of Money for the Public Service."

Upon the question for adopting the last proposed amendment, the Committee divided as follows:

Yeas.—The Hon. Mr. Speaker, Messrs. Brown, Thomson, Wark, S. Esle, J. Esle, Gilbert, Frezer, Perley, Payne, Connell, Burns, Hazen, Scoullar, Parnell, Hainington, Botsford, End, Allen, Palmer, Stewart, Smith, Taylor, Barbaree.

Nays.—The Hon. Mr. Simonds, Messrs. Hill, Rankin, Boyd, Fisher, Wilmot, Barker. Whereupon it was carried in the affirmative.

That the following Resolution was then moved.—Whereas it is expedient that the annual Expenditure of the Province shall not exceed its annual Income; therefore

"Resolved, That an Estimate of the probable Revenue for the current or ensuing year shall be made up by the Treasurer of the Province, under the direction of the person administering the Government for the time being, and laid before the House at the commencement of every annual Session of the Legislature, at as early a day as practicable; and that the amount granted in Supply during such Session, together with other sums payable by existing Laws, shall not exceed the estimated available Revenue set forth in such estimate."

And upon the question for adopting this Resolution, the Committee again divided as follows:

Yeas.—The Hon. Mr. Simonds, Messrs. Brown, Hill, Rankin, Boyd, Wilmot, Fisher, Payne, Barker.

Nays.—The Hon. Mr. Speaker, Messrs. Hazen, Parnell, S. Esle, J. Esle, Scoullar, Hainington, Botsford, End, Palmer, Allen, Stewart, Smith, Taylor, Barbaree, Thomson, Wark, Gilbert, Frezer, Perley, Connell, Burns. Whereupon it was decided in the Negative.

That the Committee then passed the following Resolution:—"Resolved, unanimously, as the opinion of this Committee, That the House should not resolve itself into a Committee of the whole for granting Supplies, until a statement of the Finances of the Province should first be made up, exhibiting the amount of its disposal; and further

"Resolved, As the opinion of this Committee, That it should be a Standing Order of the House, that the Appropriations for the Public Service should always be strictly confined to the sum so at its disposal, and the probable estimated amount of the Revenue for the coming year."

And the Chairman then further reported that he was directed to ask leave to sit again.

Ordered.—That the Report be accepted, and the last Resolution reported from the Committee, as also the amendment to the amendment proposed to the first Resolution, and carried on a division, be adopted by the House; and further—Ordered, That leave to sit again be granted.

LEGISLATIVE COUNCIL.

February 24.

The Hon. Mr. Peters from the Select Committee appointed to examine and report upon all Bills relating to Corporations, presented a Report.

The Committee to whom were referred all Bills relating to Corporations, report, that they have had under consideration a Bill to amend an Act, intitled "An Act to incorporate the Saint Stephen Marine Insurance Company," and they consider the present capital or joint stock of the said Corporation quite as small as it should go into operation with. They therefore cannot recommend the Bill to the adoption of House.

The Hon. Mr. Wyer, presented the following Petitions:—

A Petition from Asineh Moore, of Charlotte County, praying an allowance for teaching a School in the Parish of St. David; and A Petition from Lucien L. Copeland, of St. Andrews, praying a Provincial Bounty for the Coach between Fredericton and St. Andrews, which were received.

Pursuant to the Order of the Day, the House was put into a Committee of the whole to take into consideration the Bill to abolish imprisonment for Debt for sums under five pounds in certain cases.

The Chairman reported that the Committee had gone into consideration of the said Bill, and recommended that the further consideration of the said Bill be postponed for three months.—*Resolved*, That the further consideration of the said Bill be postponed for 3 months.

Pursuant to the Order of the Day, the House was put into Committee of the whole, to take into consideration the Bill to amend an Act, intitled "An Act to incorporate the St. Stephen's Marine Insurance Company," and the report of the Select Committee thereon.

The Chairman reported that the Committee had gone into consideration of the said Bill, and recommended that the further consideration of the same be postponed for three months.—*Resolved*, That the further consideration of the same be postponed for three months.

February 28.  
Pursuant to the Order of the Day, the House was put into a Committee of the whole to take into consideration the Bill to incorporate the Bolton Brook Navigation Company, and the report of the Select Committee thereon.

The Chairman reported that the Committee had gone into consideration of the said Bill, and recommended that the further consideration thereof be postponed for three months.—*Ordered*, That the report be received.

From the Provincial Reporter.

February 25.

The House then went into a Committee of the whole, on a Bill to amend the College Charter. (Mr. Parnell in the Chair.)

Mr. Wilmot said, it was highly necessary that a modification of the Charter should be effected. The establishment cost the country a great sum annually; this exclusiveness was a subject of general complaint; the Lord Bishop was the visitor—that was wrong, it should be one of the Judges. The President is also compelled to be in holy orders. The test of the thirty nine Articles for Teachers should also be dispensed with; no religious test should be required of them. It was said that the College Charter was so strong that it could not be effected. In 1840 the College Council found it necessary to send a Bill to yield to public opinion; he wished no Bill to be brought in to effect the present Charter; he wanted an entire new one—the College had consented to it, but none had yet arrived. A great many obstructions had been thrown in the way of obtaining it. The Attorney General and Solicitor General said a new Charter could not be obtained unless with the consent of the Principals and the Students, and that no student could vote unless he was of age. The Home Government did not bear them out in this; Lord John Russell said the House must move in the business by Address, and not by Bill. He would ask the Committee shall the House provide by Bill or by Address; he would say by Bill. The pay for the support of that College came out of the Treasury of the country, and it was right it should be regulated by the country. Was it right that education should be denied to the mass, while such large grants were made for the few; some fourteen or fifteen scholars. That was indeed inverting the order of things; fifty thousand pounds had already been absorbed by that establishment, and a very disproportionate amount of benefit had been derived. The obstruction must be removed, it must be made available to the whole country, thrown open to all denominations. The College Council have acknowledged the necessity of doing so; he would not go for a repeal of the endowment, that would be a last resource; no, he wished it to be what it ought to be, a real benefit to the country at large. (Here the hon. Gentleman read a Despatch relative to the College Council, which was sent out in Sir Howard Douglas's time,—in 1839, before the Bill passed,) which, he said laid it open to all denominations, except for professors; this liberal scale had not been what it was then stated it should be. In Canada a similar Charter was granted, by the same King, that Charter had been altered and sanctioned too, by the Home Government; all the establishments of this Province must be put under the control of the Assembly; boasting of the liberality, it was stated that a degree could be obtained by a three years examination being had at the College, but all this would not do; he contended for the removal of all exclusiveness, make it provincial—make it general—that House would furnish a large majority in favour of such alteration. The Executive Council too, would go with it. The Theological Chair

might remain as it was; he would never consent to any alteration in that respect, there was a system of favouritism existing in the Grammar School, he would put down that, (here the hon. gentleman described his plan of arrangement for the future; a part of which was offering annually prizes of from ten to twenty pounds, to be contended for by the boys of the Grammar Schools throughout the Province.) That House, he said, must have a voice for its future regulation; they must put down all exclusiveness—cut down the expenses and take away all fees; the establishment owes the country a large debt; and he hoped the day was not far distant when it would be paid back by its general usefulness.

Mr. Payne said, the professors were not of the established Church; he had been looking into a former despatch sent out upon the subject, in which he found a very large sum of money; he believed £1000 had been given to the establishment from the old country (a laugh, and oh! no, no.)

Mr. Fisher said, he should like to see in future that none should hold offices in the College Council ex-officio; he would so construct the Bill, and thus leave the hands of the governor untied; he would leave only three—the Chancellor—the President of the Legislative Council, and the Speaker of the House of Assembly.

Hon. Speaker said, he wished the thing placed on a solid and permanent basis. The ex-officio members, he thought, from their respectability, and standing in society, &c. were fully entitled to fill these offices.

Mr. End wished to know why His Honor the Speaker thought it necessary that those gentlemen should be ex-officio members of the College Council; it was quite possible there might be among them narrow minded and bigoted men, and these were not qualities suited to College Councillors, he thought the Speakers of the two branches of the Legislature should be ex-officio Councillors, but he would leave the choice of the rest to the good sense of the Governor. He would not say the present Councillors were men of this stamp, he said the little fellows, which the hon. member for York (Wilmot) contemplated, came up to contend for the prizes they would tremble in the presence of such men, they would be browed down and withered by their stern looks.

Mr. Rankin then spoke at some length on the bill, but from the noise in the House and the low tone in which the hon. gentleman spoke we could not hear what he said.

Mr. Wilmot hoped Mr. Fisher would not press the exclusion of ex-officio members; the establishment would be under the control of three branches of the Legislature and they would alter and amend the Charter when they pleased.

Mr. Fisher said it might happen that the ex-officio officers might be fully engaged in their respective offices as suitable persons, the Governor would have it in his power to appoint them if he pleased. Public opinion must be met, the whole system must be liberalized; he would press that point; it had all been his opinion that it should be so regulated, and he had frequently asked for and received it.

His Honor the Speaker said, men appointed to high offices, should fill the situations of College Councillors; their talents and standing demanded it. "The House," he thought should be consistent, or it would be thought they had no fixed principles to govern them. The home government had been consistent & that House should be so too; he could not think such narrow minded men as hon. gentleman appeared to apprehend would fill those high offices; he thought the Bill might pass without such cavelling.

Mr. Brown felt proud that there existed such a disposition in the House, to amend the College Charter; he would like the House to be consistent in their amendment, and not change it from what had previously passed the House, or that might furnish an excuse to the Council to throw it out altogether; he thought if the ex-officio officers remained, there were still plenty of vacancies left. The Country generally approved of the Bill as it then stood. If the House was too strict in their Bill (he thought) it might be the means of creating opposition, where it would not otherwise exist. In Nova Scotia, in consequence of a much contention on the same subject, three establishments were split up, and nearly useless. Their differences had been a stumbling block in the way of the usefulness of those establishments; he therefore hoped no such barriers would be presented here, as it would go to frustrate the Bill.

Mr. Boyd said if the hon. Member for York pressed the point, the bill would fail.

Mr. End said it did not follow, because they were not to be ex-officio officers, that they would not be members of the Common Councils; His Excellency could appoint them if he thought proper.

Mr. Wilmot said the ex-officio members would be liberal, if the Governor was a liberal man, but if otherwise, why it would be the contrary.

Mr. Wark said he did not wish to oppose the College Council. He would wish the House to accept what they formerly asked, it was out of the question to ask for a new Charter, that would cost £500, while a Bill would cost little or nothing. The Bill if passed would make it more generally useful, while it will not render it less available or less efficient for the members of the established church.

Mr. Fisher said the establishment of ex-officio officers has for years past, been carried by a large majority of the House, and he hoped that part of the bill would be allowed to stand as it did before.—The bill was then passed as amended, but was not to go into
