DISASTROUS FIRES ABROAD.

THE PETROLEUM STORES AT PILLAU BURNING FIERCELY.

The General Offices of the Paris, Lyons & Mediterranean Co. at Lyons Destroyed—An Immense Plantation Wrecked in Paris—Burning With Several Other Buildings.

BERLIN, Jan. 8.—A despatch from Pillaus says the immense petroleum stores there have taken fire and there is a great conflagration. All efforts to quench the flames have proved fruitless.

Pillaus is a seaport of Germany in the Province of Prussia on the Baltic. It is the port of Königsberg for large vessels, a fortress, a favorite watering place and one of the most important Prussian seaports.

PARIS, Jan. 8.—A planifactory warehouse in the Boulevard-St. Martin is burning. Four stories have already been gutted and it seems likely several others will be.

The general offices of the Paris, Lyons & Mediterranean Railway Co. in Lyons are on fire and the flames are spreading rapidly. The flames being hampered by scarcity of water.

WITH A FUSILLADE OF STONES.

RAILWAY STRIKERS WHO RESUME WORK HOOTED AND FELTED.

The Police Charge the Mob and Arrest Six of the Ring-leaders—The Officials of the Caledonian Railway Will Consider the Grievances of All Who Return to Their Employment.

GLASGOW, Jan. 8.—A largely increased police force was on hand to-day at Coatbridge, where the strikers resumed work, to suppress any outbreak of the strikers who returned to work. 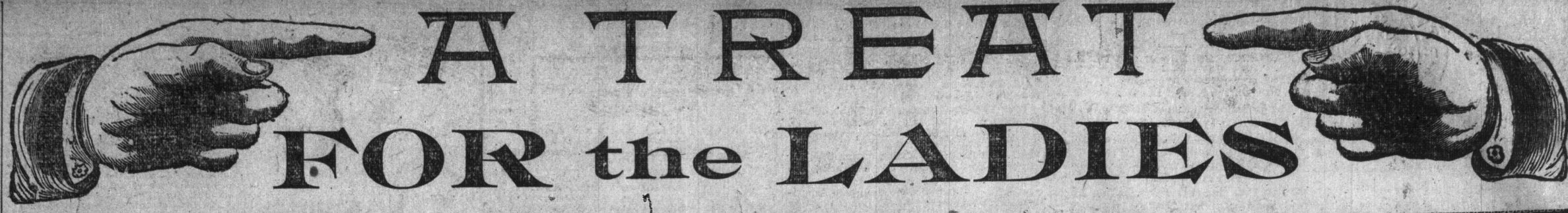
