



FIRST SEDERUNT.

At the City of Toronto, and within Knox Church there, Tuesday, the third day of November, one thousand eight hundred and seventy-four years, at half an hour after seven of the clock in the evening, the Fifth General Assembly of the Canada Fresbyterian Church met in accordance with a resolution of adjournment adopted at the ordinary meeting of Assembly, at the City of Ottawa, on the tenth day of June last. The Moderator, Mr. Thomas MacPherson, of Stratford, opened the meeting by giving out for praise the 67th Psalm, which b ing sung, he read the 17th chapter of the Gospel according to John. Mr. Scott, of London, by request, then led in prayer. The Moderator followed in prayer. Praise was offered in a portion of the 132nd Psalm.

The Moderator briefly addressed the house as to the objects of this adjourned meeting, and then declared the Assembly constituted for business.

The returns to the Remit on Un'on, and also the returns to the Remits-Remit in relation to the change in the Constitution of the next Returns pro-General Assembly, proposed at the meeting at Ottawa, were laid seuted. on the table by Mr. Reid, Corresponding Clerk of the Assembly.

On motion of Dr. Proudfoot, seconded by Dr. Thornton, it was Returns reagreed,—That the Returns to the Remit on Union be referred .o ferred. a committee to be now named by the Moderator, with instructions to report thereon at the commencement of the afternoon Sederunt to-morrow.

The Moderator then named the committee, composed of the Committee. same members as that on Returns to Remits at the meeting at Ottawa in June last, as follows :--Prof. McLaren, Convener; Prof. Gregg, Messrs. W. Moore and D. H. Fletcher, Ministers; and T. W. Taylor, J. Durie, and George A. Pyper, Elders.

BILLS, &C., COMMITTEE ON, TO MEET.

It was moved by Dr. Burns, seconded by Principal McVicar, Bills, &c., and agreed to, That the Committee on Bills and Overtures is meet, instructed to meet, and report on the order of business.

LEGISLATION-ADDITIONS TO COMMITTEE.

On motion of Dr. Topp, Professor McLaren, Mr. John McTavish Legislation, additions to and Mr. A. D. Ferrier were added to the committee appointed Com. by the General Assembly at Ottawa, to obtain necessary legal advice, and to take steps for making application to the several Provincial Legislatures for such legislation as may be necessary for the conveyance of property to the United Church.

The Assembly then adjourned, to meet at eleven o'clock tomorrow—the first hour to be spent in devotional exercises. The diet was closed with the Benediction.

SECOND SEDERUNT.

KNOX CHURCH, TORONTO, Wednesday, Nov. 4, 1874, 11, a.m.

The General Assembly met according to adjournment last night, and, as then agreed upon, the first hour was spent in devotional exercises. Prayer was offered in succession by Dr. Taylor, Mr. Carrick, and Mr. John Ross, with the singing of psalms and the reading of the Scriptures in the intervals. The Moderator then offered prayer, constituting the Assembly, and closing the devotional exercises with praise.

The minutes of the first Sederunt were read and sustained.

TEMPERANCE.

The Assembly proceeded to consider the Report of the Com-Temperanco Report and mittee on Temperance, delayed at the meeting of the Assembly at Communication of the connection with a communication from the Ontario and Quebec Temperance and Prohibitory League.

The report of the Committee was read.

It was moved by Dr. Burns, seconded by Principal McVicar, as follows :- The General Assembly receive the Report, adopt its recommendations, return thanks to the committee and especially to the convener, and hereby renew the testimony which, for a succession of years, they have borne against the enormous evils of intemperance. Every year gives increasing force to their convicpoverty, do. tion that it is the chief cause of poverty and crime throughout our land; that it is the principal occasion of discipline in our Church, and that there exists no more formidable obstacle to the spread of the Gospel amongst us.

The General Assembly hail every well designed and well directed effort to arrest the progress of intemperance ; counsel the employment of moral suasion, and the exhibition of a consistent example, with this view, on the part of all office bearers and members of our Church, and earnestly deplore the sanction given by the licensing system; in its present form, to a traffic fraught with effects so disastrous.

The General Assembly would express approval of the passage of a Prohibitory Liquor Law, and authorize the Moderator and clerks to prepare and forward memorials to the Legislature to this effect.

The General Assembly would also authorize memorializing the Dominion and Local Legislatures for any lesser measure which may seem likely to abridge the evils of intemperance, re-appoint

The General Assembly further recommend to Synols, Presby-Bynols and teries, and Sessions to have special regard to the sources of Presbyteries intemperance within their bounds, and to use every legitimate instructed. means for their removal.

It was moved in amendment by Principal Caven, seconded by Amen'ment Dr. Thornton, That it be remitted to a committee, of which Dr. to refer to Burns shall be convener, to take into consideration the subject Committee. of temperance as brought before the Assembly by the Report on that subject; to report to the Assembly, at its meeting tomorrow forenoon, a deliverance on the whole question, which may be adopted by the Assembly.

A vote being taken, the motion of Dr. Burns was carried by a Decision. very large majority, and the Assembly decided in accordance therewith.

TEMPERANCE COMMITTEE.

The Committee on Temperance, re-appointed in terms of the Temperance above resolution, is as follows :---Mr. John Smith, of Bowmanville, convener: Dr. Thornton, Dr. Taylor, Messrs. J Pringle, J. McTavish, W. Meikle, Walter Inglis, J. M. Cameron, J. A. F. McBain, J. Rennie, J. McMechan, Ministers; Dr. Holden, James Hossack, A. C. Singleton, W. N. Hossie, David Durie, Elders.

On motion of Mr. R. H. Warden, it was ordered that an ex-Extraot tract from the record of the above proceedings on temperance be forwarded to the Secretary of the Ontario and Quebec Temperance and Prohibitory League.

The hour of adjournment having arrived, the diet was closed, the Moderator pronouncing the Benediction.

THIRD SEDERUNT.

TEMPERANCE COMMITTEE-NEW CONVENER.

At the request of Dr. Thornton, the Assembly relieved him of Temperance the convenership of the Committee on Temperance, and appointed Mr. John Smith, of Bowmanville, convener of the comwener. Mew Convener.

UNION.

The Assembly called for the Report of the Committee on the Union. Returns to the Remit on Union, sent down to Presbyteries, Ses-Returns to sions and Congregations in Jane last. The Report was presented and tead by Professor McLaren, the convener of the committee, and set forth in terms,—That returns had been received from 19 Presbyteries, 226 Sessions, and 238 Congregations; that

all the Presbyteries approved of the Remit : that in the case of one Presbytery, that of London, the motion to approve simpliciter was carried by the casting vote of the Moderator, over an amendment taking exception to the resolution on modes of worship; and that in the Presbytery of Guelph the motion to approve simpliciter was carried by a vote of 16 to 6; that 217 Sessions approved and 9 disapproved ; one Session only distinctly disapproving of the Remit generally, the others dissenting from the resolution on modes of worship; that 231 Congregations approved simpliciter, and, as in the case of Sessions, one disapproved the remit generally, and six disapproved on the ground of the resolution on modes of worship.

aris Return

The Committee called attention to the terms of the return from the Presbytery of Paris, and recommended that it be read to the Assembly. The return from the Presbytery of Paris was accordingly read, stating in substance that the Presbytery approved simpliciter of the Remit on Union, Mr. McTavish alone dissenting from the resolution on modes of worship, but advising that, inasmuch as, in the opinion of the Presbytery, the adjourned nieeting called to meet on the 3rd of November was incompetent to deal regularly with the new matter introduced into the Basis of Union, final action be not taken in the matter of Union until the regular meeting of Assembly in June, 1875.

The committee reported also on the Returns to the Remit Constitution of next As-anent the Constitution of the next General Assembly, in terms,sembly. That 15 Presbyteries approved simpliciter ; and one Presbytery, that of Paris, disapproved of the course proposed as unconstitutional.

There was here presented a letter, addressed to the Moderator synoa of, ac, of the Assembly, from the Clerk of the Synod of the Presbyterian Church of the Lower Provinces, covering an extract minute of proceedings of said Synod on the Remit on Union. At the request of the Moderator, these papers were read by Dr. Topp. The extract minute was ordered to be engrossed in the minutes, and is as follows :-

> "At New Glasgow, and within James' Church there, the twenty-first day of October, one thousand eight buildred and seventy-four, the Synod of the Presbyterian Church of the Lower Provinces met and was constituted.

> Inter alia: The Synod, finding that all the Presbyteries of the Presbyterian Church of the Lower Provinces, with one exception, not yet heard from, have reported, in terms of the Barrier Act, in favour of Union with the Canada Presbyterian Church, the Preshyterian Church of Canada in connection with the Church of Scotland, and the Presbyterian Church of the Maritime Provinces in connection with the Church of Scotland ; and that one hundred and seven congregations, and one hundred and seven Sessions have also reported in favour of said Union; desires to express its gratitude to God for the unanimity and harmony which have prevailed, and the happy issue which has been reached; and

UNION.

It was here moved by Dr. Topp, seconded by Dr. Thornton, as Union. follows :- The General Assembly, finding, from the returns to the Motion. remit containing the preamble, basis and resolutions on the subject of Union, that all the 19 Presbyteries of the Church have approved of the remit; that of 226 Sessions 217 have approved simpliciter, 8 with dissent from one of the resolutions, and only one has disapproved; and that of 238 congregations 231 have approved simpliciter, 6 with dissent from one of the resolutions, and only one has disapproved-does now adopt the said preamble, basis, and resolutions as the articles of Union between the four negotiating churches, viz. :- the Presbyterian Church of Canada in connection with the Church of Scotland, the Presbyterian Church of the Lower Provinces, the Presbyterian Church of the Maritime Provinces in connection with the Church of Scotland, and the Canada Presbyterian Church, and does resolve to consummate the Union on the ground of these articles at the close of the meeting of the Supreme Court of this Church in June next, in the event of the other Churches agreeing to the same : and further, the General Assembly, in coming to this resolution, does express its thankfulness to the God of all Wisdom and Grace, who has guided the Church to the harmonious termination of the negotiations carried on for several years, and its fervent prayer that the Union about to be consummated may by His blessing be made eminently conducive to the advancement of the cause and kingdom of the Lord Jesus Christ in this and in other lands.

It was moved in amendment by Mr. John Ross, seconded by Amendment. Mr. James Middlemiss, that the remit be disapproved.

SABBATH SCHOOLS-DELIVERANCE ON REPORT.

The Assembly called for the Report of the Committee to frame Sabbath a Deliverance on the Report on Sabbath Schools, delayed at the strong-De meeting of Assembly in June.

The report was presented and read. The report was received, and it was agreed to consider the several clauses thereof seriatim. The consideration of the draft-deliverance was proceeded with clause by clause to the end, and amendments adopted. The deliverance, as amended and adopted by the Assembly, is as follows :--

1. Renew the recommendation of former Assemblies to Presbyteries to hold an annual conference on the subject of Sabbath schools.

2. That Presbyteries be urged to give more attention to Sabbath school work, within their bounds, to collect statistics, and send tabulated returns to the convener of the Assembly's committee.

3. That Synods be recommended to give one Sederunt in the course of the year to the consideration of Subbath school work, and kindred subjects.

4. Recommend with increased urgency the need of making certain of our Church services more adapted to the capacity of children; that occasional sermons be preached to the young; that the relative duties of parents and children be kept prominent, and especially the need of parents co-operating with Sabbath school teachers in the training and instruction of the young.

5. That it be recommended to the superintendents and teachers of Sublath schools to endeavour, as far as possible, to direct the missionary contributions of the children of the Church to our own Home and Foreign Missionary enterprises, and to encourage with this view the formation of Juvenile Missionary Societies.

6. Renew the recommendation for the general adoption of the International Series of Sabbath School Lessons.

7. Remit to the Sabbath School Committee to examine manuals on Sabbath school teaching, and report to the General Assembly, with the view of one being recommended by the Assembly to the Sabbath schools of the Church.

8. That the lists of books for Sabbath school libraries, prepared by the committee on that subject, be printed in the *Record*.

After explanation from the Corresponding Clerk of the Presbytery's Assembly, on motion, the Assembly sanctioned the action of the sanctioned. Presbytery of Chatham, in the premises.

MANITOBA PRESBYTERY---CO-OPERATION, OVERTURE ON ...

2. The said decision, in accordance with the terms of the resolution on the mode of worship, contained in said remit, practically legalizes any irregular practice that may have crept, as such practices almost invariably do, into congregations previous to the contemplated Union.

Dissent-Reasons of-Mr. J. Ros.

There were further presented and read reasons of dissent by Mr. John Ross, from the resolution of the Assembly on Union. The reasons were received and ordered to be engrossed in the Minutes, and are as follows :-

"1. Because there is, in my view, in the first article of the basis a departure from sound doctrine regarding the Word of God as the sole rule of faith and obedience,

2. Because there is not in the basis a satisfactory recognition of the rights of the Lord Jesus to the submission and obedience of civil rulers, while, by the terms in which the reception of the Confession of Faith and the Larger and Shorter Catechisms is qualified, the statements of said documents concerning the Headship of Christ over the nations stand stripped of their authority.

3. Because the preamble of the basis involves an acknowledgment of the Church of Scotland as at present constituted, thereby going far to nullify the testimonies given to the truth by the Disruption Protests, and damaging the statement given in the same preamble on the sole Headship of Christ over his Church.

4. Because the resolution on modes of worship practically legalizes any irregular practice that may have crept into any congregation prior to the Union, and especially demands of all entering the Union a pledge to allow, in all time coming, the use of instruments of music in public worship to all congregations following that practice at the time of the Union.

NISBET, REV. JAMES.

The attention of the General Assembly we further directed to Nisbet, the fact, that Mr. James Nisbet was removed by death, at Kildonan, in the Province of Manitoba, on 30th September last, and agreed to place on record the following deliverance :--

Mr. Nisbet was one of the first fruits of Knox College. For a period of twelve years, from 1850 till 1862, he made full proof of his ministry in one of our home charges, and was abundant in his evangelical labours throughout our Home Mission field. In 1862 he was selected by the Foreign Mission Committee to proceed to the Red River, and for two years was associated with Mr. Black in ministerial work there. In 1864 he was designated as a Missionary to the Indians of the Saskatchewan, and founded the Prince Albert Mission. For the past ten years he has laboured there, with unflagging zeal and self-denying devotedness, amid many difficulties and discouragements. The General Assembly would place on record their high estimate of his worth as a man and his faithfulness as a missionary. They would recognize the hand of the Lord in his sudden removal, following so closely after that of his estimable partner. They would affectionately commend the orphan children to the practical sympathy of the Church, and to the tender care of a covenant-keeping God. They would sympathize with the mission thus deprived of its head, and pray the Lord of the harvest to send forth more labourers into the hopeful and necessitous field from which this earnest worker has been removed.

LEGISLATION-REPORT ON.

The Assembly called for the report of the committee appointed Legislation in June last, to obtain necessary legal advice, and to take such — Report on. steps as might be deemed proper for making application to the several Provincial Legislatares, for legislation necessary for the conveyance of property to the United Church, and who were to report to this meeting of Assembly.

Mr. T. W. Taylor, the convener of the committee, presented Report. and read an interim report, embodying the draft of an act which it was proposed to complete by the addition of other sections mentioned, and to submit to the Legislatures of the Dominion and of the several Provinces.

It was moved by Professor McLaren, seconded by Dr. Proud-Resolution. foot, and agreed to, that the interim report be received, and generally approved of; that the thanks of the General Assembly be tendered to the convener of the committee for his valuable services; and further, that the committee be empowered to perfect their work, and to take the proper steps to secure the necessary legislation, in the Dominion and Local Legislatures.

Dissent-Answers to Reasons.

The Assembly called for the report of the committee to frame answers to the reasons of dissent from the action of the Assembly on Union, submitted last night by Messrs. Middlemiss and Ross. The answers were presented and read by Dr. Topp, the convener of the committee. On motion, the answers were received and adopted, and are as follows :-

1. The first reason of Mr. Middle miss, which is the same substantially as the third of Mr. Ross, is simply answered by the counter statement that the preamble and basis do not involve the acknowledgment of the identity of this Church with the Church of Scotland as at present constitute 1, and that, consequently, the dissentients are not warranted in making any statement which scems to indicate the acknowledgm.ent of such identity.

2. The other reasons have been presented and answered at other Assemblies, and therefore there is no occasion for repeating former satisfactory answers to the same reasons.

CANADA PRESBYTERIAN CHURCH.

MANITOBA-REPORT ON OVERTURE, &C.

The Assembly called for the report of the committee to whom Manitobawas referred the overtures from Manitoba. The report, embodying Report on overture, addiversation of the committee, by Dr. Topp, &c. the convener, and was read. On motion, the report was received, and it was agreed to consider the several clauses of it seriatim. The three clauses of the deliverance were read and considered, one by one, and were severally adopted ; and then, ion motion of Dr. Topp, duly seconded, the deliverance was adopted as a whole, and is as follows :---

1. That the *status* of a professor in Manitoba College be accorded to the Rev. Thomas Hart, M.A., it being understood that Mr. Hart's salary will continue to be paid, as at present, by the Presbyterian Church of Canada in connection with the Church of Scotland.

2. That in accordance with the memorial of the Presbytery of Manitoba, ministers of the Presbyterian Church of Canada in connection with the Church of Scotland, appointed by the Synod of that Church to labour in Manitoba, shall have the same *status* accorded to them in the Presbytery of Manitoba as other members of the Presbytery.

3. That the Assembly expresses its gratification at the brotherly feeling manifested by elders and ordinary members of the Presbyterian Church of Canada in connection with the Church of Scotland, in connecting themselves with the congregations of the Canada Presbyterian Church in the Province of Manitoba; but, inasmuch as by so doing they are entitled to the privileges of membership, it deems it unnecessary to make any further declaration regarding their position.

ASSEMBLY, NEXT MEETING OF.

The Assembly, on motion of Dr. Prondfoot, duly seconded, Assemblyresolved, That the meeting of the next Assembly be held at the next meetcity of Montreal, and within Erskine Church there, on the second Tuesday in June, 1875, at half-past seven o'clock in the evening.
