

# ACTS AND PROCEEDINGS

OF THE

Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, begun at Kingston the 13th day , of July, and concluded the 19th day of July, 1853 years.

#### SESSION XXIV.

#### DIET I.

At Kingston, and within St. Andrew's Church there,-Wednesday, the Thirteenth day of July, One Thousand Eight Hundred and Fifty-three years :

The which day, after Sermon by the Rev. John McMorine, Minister of Ramsay, Moderator of the Synod for the preceding year, from Psalm exxvi. 6, "He that goeth forth and weepeth, bearing precious seed, shall doubtless come again with rejoicing, bringing his sheaves with him,"--the Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, met, according to appointment, and was by him constituted with prayer.

Presbytery Rolls having been given in, the Synod Roll was made up and read over.

#### MINUTES OF SYNOD, KINGSTON, WEDNESDAY, JULY 13, 1853.

The Synod then proceeded to the election of a Moderator for the ensuing year, when the Rev. Alexander Spence, Minister of Bytown, was unanimously elected, and, at the Synod's desire, took the Chair.

The Synod next proceeded to the election of three Trustees for Queen's College, at Kingston, in room of the Rev. Hugh Urquhart, the Rev. Alexander Spence, and the Rev. John Barclay, who retire from office at this time, according to the terms of the Royal Charter of Queen's College, when the Rev. Hugh Urquhart, the Rev. Alexander Spence, and the Rev. John Barclay, were unanimously re-elected, and their names placed at the top of the Roll; and the Clerk was instructed to intimate the same to the Board of Trustees.

The Synod next proceeded to the election of two Clergy Reserve Commissioners, in room of Hugh Allan, Esq., and Dr. Alexander Mathieson, who retire from office at this time, according to the Regulations of the Synod of 1848, when Hugh Allan, Esq., and Dr. Alexander Mathieson, of Montreal, were unanimously re-elected, and their names directed, in terms of the aforesaid Regulations, to be placed at the foot of the list of Commissioners; and the Clerk was instructed to certify the above appointment to the Board of Commissioners, and also to the Government.

The Synod appointed the following Committee of Bills and Overtures, with instructions to meet to-morrow morning, at Nine o'clock; and all papers to come before the Synod were ordered to be given in to the said Committee, viz :—the Moderator and Clerk, Dr. John Machar, Professor Williamson, Mr. Peter Ferguson, Mr. James George, Mr. John Barclay, Dr. Alexander Mathieson, Dr. John Cook, Mr. James Thom, Mr. Hugh Urquhart, Mr. Thomas McPherson, Mr. John McLaurin, Dr. Hugh Mair, Mr. George Bell, Mr. Daniel McNee, Mr. Alexander Mann, Mr. William Bain, Mr. John McMorine, *Ministers*; and Mr. William Ferguson, the Hon. Thomas McKay, and Judge Malloch, *Elders*.

Leave was granted to Presbyteries to meet in Kingston, for all competent business, during the meeting of the Synod, at such hours as the Synod may not be sitting.

The Synod agreed that, during their present Session, they shall meet at Ten o'clock, A.M., and that there shall be an interval of an hour from One till Two; and it was further agreed that the first part of each morning's Sederunt be devoted to devotional exercises.

The Synod then adjourned till Ten o'clock to-morrow morning, and was closed with prayer.

#### DIET II.

At Kingston, and within St. Andrew's Church there,— Thursday, the Fourteenth Day of July, One Thousand Eight Hundred and Fifty-three Years:

The which day, the Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, met, according to adjournment, and was constituted with prayer.

The Rev. George Bell, on the call of the Moderator, conducted the devotional exercises of the Synod, in praise, reading the Scriptures, and prayer.

Sederunt as before.

The Minutes of yesterday were read and approved of.

It was, on motion, agreed that the thanks of the Synod be given to Mr. McMorine, their late Moderator, for the very excellent and seasonable sermon with which he opened the Synod; and that he be requested to publish the same; the which was done by the Moderator accordingly.

The Committee of Bills and Overtures made a Report of the business to come before the Synod.

The Records of the Commission of Synod were called for and produced, and the Synod had read the proceedings of the Commission during the past year.

The Moderator laid before the Synod an extract Minute of the General Assembly, in reference to the Minute of Synod of last year, and the Moderator's letter to the Colonial Committee founded thereon, as to the terms of the appointment of Missionaries to this country in consequence of the application of this Synod. The same was read, distinctly stating that, in all cases of Missionaries sent out to this country by the Colonial Committee, they were placed under the direction of the Presbyteries in which they were labouring.

The late Moderator laid before the Synod a communication from one of His Excellency the Governor General's Aids-de-Camp, conveying the answer of His Excellency to the Address of the Synod presented to him last year, and intimating that the Addresses of the Synod to Her Majesty the Queen had been transmitted to the Secretary of State.

The Synod appointed the following Committee to draft an Address to Her Majesty the Queen, viz.:-Dr. Cook, Mr. Urquhart, Mr. George,

It was then moved by Mr. Mann, seconded by Professor Smith, and unanimously agreed to, That the Report now read be received and approved of, and that the thanks of the Synod be given to the Managers of the Fund, for the faithful and admirable manner in which they have managed the Fund entrusted to their care.

The Synod then proceeded to the election of Three Trustees for the management of the Ministers' Widows' and Orphans' Fund, in room of the Rev. James C. Muir, William Edmonstone, Esq., and W. Gordon Mack, Esq., who retire from office at this time, in conformity with the provisions of the Act of Incorporation, when the said Rev. James C. Muir, William Edmonstone, Esq., and W. Gordon Mack, Esq., were unanimously re-elected, and their names directed to be placed at the head of the lists of ministers and laymen respectively composing the Board.

The Synod had laid before them a Statement from the Clergy Reserves Commissioners, in regard to the state of the Fund. The accompanying documents were referred to a Committee consisting of Mr. Barclay, Mr. George, Judge Malloch, Mr. T. A. Gibson, and Mr. William Ferguson, who thereafter reported "That they had examined said documents, and found ample evidence that the whole business has been managed with the greatest care and prudence, and obviously with an earnest desire not only for the advancement of the temporal interests, but also for the future spiritual efficiency of the Church;" whereupon the Synod, in accordance with the recommendation of the Committee, "Agreed to express their entire confidence in the wisdom and fidelity of the Commissioners, and tender to them the hearty thanks of the Church."

The Synod appointed the following Examining Committee, in terms of the Act anent the Examination of Ministers, Preachers, and Students, coming from other Churches not in connection with this Church, viz.: the Moderator and Clerk, Dr. Machar, Professor Williamson, Professor Smith. Mr. George, Mr. Barclay, Dr. Cook, Dr. Mathieson, Mr. McGill, Mr. McKenzie, Mr. Urquhart, Mr. J. B. Mowat, Dr. Mair, Mr. McNee, Mr. Mann, Mr. Bain, and Mr. McMorine.

It was intimated to the Synod, on behalf of the Presbytery of Kingston, that it was their intention, with leave of the Synod, to take Mr. Peter Lindsay, Student of Divinity, of Queen's College, on trials for license:—when, it having been ascertained that the circular letters issued by the Presbytery had been received in due time, and that no objections were offered, the Synod directed that Mr. Lindsay appear before the Examining Committee, and appointed a meeting of the Examining Committee to be held this evening at Half-past Seven o'clock.

The Synod had transmitted to them, by their Committee of Bills and Overtures, a recommendation from the Presbytery of Hamilton in favour of the Rev. John Skinner, D.D., stating that "the Rev. John Skinner, D.D., lately a Minister in connection with the General Assembly of the Presbyterian Church (old school) of the United States, appeared, and expressed his desire to be received as a Minister of this Church. The Presbytery, having examined his literary and Theological attainments, his reasons for joining this Church, and his views of its Constitution and Government, together with his College and Presbyterial Certificates, and being satisfied therewith, agreed to recommend him to the Synod for admission into this Church as a Minister thereof, and, in the meantime to employ him as a Missionary within the bounds." The Synod directed that Dr. Skinner appear before the Examining Committee.

The Synod had transmitted to them, by their Committee of Bills and Overtures, an application from the Presbytery of Toronto for leave to take Mr. David Watson, Student of Divinity, of Queen's College, on trials for license, of the following tenor :-- "Mr. David Watson, Student in Divinity, applied to be taken on trials for license. Mr. Watson's Certificates were produced, read, and duly considered. It appeared that, although the prescribed number of terms had elapsed since Mr. Watson commenced his College course, his actual attendance at Queen's College lacked one year, in consequence of his absence from the Divinity Hall for one Session, and that not the last. The Presbytery, considering the high standing of Mr. Watson at Queen's College, as testified to in said certificates, and verbally by the Rev. James George, Professor of Systematic Theology, a member of this Presbytery, -considering that the deficiency of one Session from the full Theological Course was occasioned by his absence for cause assigned, while his studies were not laid aside, but his private readings were continued,considering more especially Mr. Watson's qualifications in the Gaelic language, and the great want of Gaelic Ministers, particularly in this Presbytery, in which there are several very important Gaelic charges that have for many years been destitute of public ordinances and whose urgent calls for Ministers have met with so many disappointments,--therefore the Presbytery would, for all these reasons, respectfully request the Synod, in the special circumstances of the case, to authorize their taking Mr. Watson on trials for license."

College, from which it appears that he has attended the Literary and Theological Classes of said College five full Sessions and one partial Session, and that he highly distinguished himself in all the classes. On the call of the Moderator, the Rev. Frederick P. Sim conducted the devotional exercises of the Synod, in praise, reading the Scriptures, and prayer.

Sederunt as before.

The Minutes of Saturday were read and sustained.

The Synod agreed to continue, for the present year, the suspension of the Act anent the training of Licentiates for the Pastoral work,—and instructed those Presbyteries, within whose bounds there are Students who have been permitted to be taken on trials for license, to meet as soon as possible, for the purpose of taking said Students of Divinity on trials for license, at such time and place as they may deem convenient.

The Synod called for the Report of the Committee appointed to draft an Address to Her Majesty the Queen, when the Committee gave in a Draft, which was read, and, having been fully considered and adopted, was ordered to be engrossed for the Moderator's signature.

There was also given in and read a Draft of an Address to His Excellency the Governor General, which, having been considered and adopted, was ordered to be engrossed for the Moderator's Signature.

The Synod appointed the following Committee to attend to the interests of this Church in regard to the Clergy Reserves, and take whatever steps may appear to them to be necessary towards the protection of the same, and in particular to watch over the progress of legislation thereanent; to call the attention of Presbyteries and Congregations to what may be the proper course of action as indicated by circumstances; and, if necessary, to take steps to be heard at the Bar of the Houses of Parliament; viz., Dr. Cook, Dr. Mathieson, Mr. McGill, Mr. Urquhart, *Ministers*; Mr. John Thomson, Mr. Alexander Morris, and Mr. Thomas A. Gibson, Elders; and the Hon. Wm. Morris, and Hugh Allan, Esq., were requested to act as members of this Committee.

The Synod called for the Report of the Committee appointed to consider the Overture from the Presbytery of Hamilton, anent the Status of retired Ministers, which was given in and read by Mr. McGill, the Convener, and duly considered, and on the recommendation of the Committee, the Synod adopted the following as an Interim Act, and ordered the same to be transmitted to Presbyteries, that they may send up their opinions thereon to the next meeting of this Synod,--which they are hereby strictly enjoined to do. "The Synod, having fully considered the Overture anent the status of retired Ministers, decree that, agreeably to the views of this Church respecting the permanency of the Pastoral relation, when a Minister becomes unfit, through age

or infirmity, for the discharge of his pastoral duties, the case shall be referred to the Presbytery of the bounds for examination and judgment, and, if it shall appear that the facts are as stated, the Presbytery shall meet with the congregation, and declare its duty to make such provision as may be within its power for the maintenance of their Minister, until God shall be pleased to restore his health, or remove him to the inheritance of a better life. But in the meanwhile his name shall remain on the Roll of the Presbytery as the Pastor of that Church, and as such he shall retain authority to perform all the ministerial duties for which he is competent, yet so as not to interfere with the rights and duties of the Pastor that may be ordained to fill his place; and in all the Church Courts, except the Session, of which he shall cease to be the Moderator, he shall retain full liberty, to counsel and advise, though not to vote, on all matters that shall come up before them.

The Synod called for the Report of the Committee appointed to revise the Records of the Synod, and the Records of the several Presbyteries. A Report on the Synod Records was given in, read and sustained; and the Synod ordered the Records to be attested by their Moderator, as carefully and correctly kept. Reports were also given in on the Records of the Presbyteries. The same were read and sustained, and the Synod ordered their Clerk to attest the Records of these several Presbyteries as carefully and correctly kept.

The Synod then adjourned until to-morrow morning at Ten o'clock,and was closed with prayer.

## UNTO THE QUEEN'S MOST EXCELLENT MAJESTY,

### May it Please Your Majesty,-

We, the Ministers and Elders of the Presbyterian Church of Canada in connection with the Church of Scotland, now in Synod assembled, embrace the opportunity, thus afforded us, of again most heartily testifying our warm attachment to your Majesty's person, and to the government of that Empire on the throne of which an All-wise Providence has placed you.

It is to us no small pleasure that we can again congratulate your Majesty on the birth of another prince. This auspicious event, while it must add to your Majesty's domestic felicity, is hailed by us with peculiar satisfaction, as furnishing an additional security for the perpetuation of a family under whose sway the British Empire has enjoyed a larger portion of liberty and prosperity than has fallen to the lot of any other people.

In approaching the Throne at this time it would have afforded us the highest gratification, had it been in our power to have uttered nothing but the language of esteem, loyalty, gratitude, and hope. But, painful as it must be to your Majesty as well as to us, we cannot, as the ardent friends of civil and religious liberty, forbear adverting to certain unhappy occurences which have lately taken place in two of the principal cities of this Province. Peaceable Christian people, lawfully assembled in Protestant places of worship, have been assailed by infuriated mobs. While no government is to be held responsible for a sudden burst of popular folly or malice, yet in these cases there has been manifested indeed openly acknowledged an alarming inability on the part of the public authorities either to restrain violence or sustain the power of the law. Had this weakness or want of inclination to restrain violence and vindicate the majesty of the law been manifested on a violent conflict arising out of merely secular matters we should nevertheless have felt much uneasiness and grief: but, when we remember that these deplorable events, which have brought disgrace upon the Province and filled many bosoms with poignant sorrow, can be clearly traced to the avowed determination of a great number of persons to put down freedom of speech in our very churches, and by consequence to deprive us and our fellow Protestants of liberty of conscience, we cannot but feel extreme alarm. The British constitution secures many precious blessings to those who live under it, but none so valuable as entire liberty of conscience. Indeed, if this should ever be lost little would then remain in that constitution to which the enlightened friends of liberty could look with veneration, or which they would care to defend. The religion which we profess, the doctrines in which we have been nurtured, as well as the whole history of our Church so entirely identified as it is with the struggles and triumphs of liberty of conscience, render it impossible for us to contemplate that principle in peril with any other feeling than that of intense anxiety. As Presbyterian Protestants, we hold this principle to be sacred, and we shall by all lawful means calmly but firmly defend it Our forefathers have left us no more precious inheritance. We are determined to transmit it to our children. Nor can we for a moment doubt that our Most Gra-

cious Queen fully sympathises with us in this sentiment. And what we demand in reference to this for ourselves we heartily accord to all our fellow colonists, of what Christian denomination soever they may be.

Entertaining, as we do, the hope that the majesty of the law shall yet be fully vindicated, and the sacred principles of the constitution fully preserved, so that Christian men can in conformity with the law meet in safety to express and inculcate their own religious views and sentiments, we forbear at this our present session to do anything that would produce agitation among our people as to the above matter.

Our wish has ever been to make the preaching of the Gospel of peace our great business. For we are well assured that by teaching its principles fully and faithfully to our people we shall not only lead them, through the Lord Jesus Christ, to the Heavenly inheritance, but also fit them for being quiet, orderly, and loyal subjects to their sovereign, and forbearing and just to their fellow-men.

Our prayer is that your Majesty may share largely in the choicest earthly blessings, and that, after you have reigned long and happily over a religious, prosperous, and ioyal people, you may be raised to that crown that fadeth not away.

We continue to take a warm interest in the promotion of a sound, moral and religious education among all classes of the people, and we are making our best exertions to increase the efficiency of the University in connection with our Synod, for training young men for the Ministry, in our Church, as well as for general usefulness.

It is a matter of extreme regret to us, that an act has been passed by the Imperial Parliament, by which the subject of the Clergy Reserves, is liable to be opened up anew to public discussion, and to fresh legislation. As a Church deriving benefits from this Function the maintenance of our ministers, and regarding the settlement thade in 1840, as a final settlement, to which the faith of the British Crown was distinctly pledged, we must enter our decided protest against any interference with it; and we shall consider it our bounden duty to contend most zealously for the maintenance of our rights and privileges.

In common with all true Protestants and Christians, and with all who venerate the British Constitution, we cannot but express to your Excellency the deep shame and indignation which we feel at the events which have lately taken place in Quebec and Montreal, whereby the reputation of this country has been seriously injured, the lives of many innocent persons sacrificed, and public order and tran-

While we look to the Executive and Legal authorities of the Province, for the redress of these outrages, and while we disclaim all personal recrimination, as tending only to promote further discord and disturbances, we cannot refrain from avowing our determination, in so far as lies in us, to resist temperately, yet firmly, all encroachments on the freedom of conscience and liberty of speech, which we have ever been tanght to regard as part of the sacred birth-right of every British subject. We feel confident that your Excellency and your advisers will use the powers of Government to vindicate the majesty of the Law, and to maintain, unimpaired, the fundamental principles of the constitution, by which course alone we believe that good order will be restored, and a spirit of unity and concord fostered among the people of this Province.

That Almighty God, the Sovereign Disposer of all things, may bless your Excellency and your Excellency's family, with all temporal blessings, and make you partakers of His Heavenly treasure in Christ Jesus, is our ardent wish and fervent prayer.

#### DRAFT OF & FORM OF PROCEDURE ANENT THE CALLING AND

#### SETTLING OF MINISTERS IN CONGREGATIONS, &C.

Whereas, it is highly expedient that the form of Process in the Calling and Induction of Ministers, into the Congregations of this Church, should be clearly defined, both for the preventing confusion in said congregations, and securing uniformity in the manner of procedure throughout the Church ;- Be it therefore enacted, &c., &c., &c.

1. That no Congregation shall be received as a Congregation of this Church, and entitled to have a Minister set over them in Holy Things by any Presbytery of this Church, until, through means of Elders, Trustees or other adhering Members, duly authorised thereunto, they shall have first solemnly declared their willingness to adhere to the faith, government, worship, and discipline of this Church; and, in all cases, submitting to the jurisdiction thereof,-which said declaration shall be subscribed and presented to the Presbytery ; and, farther, said Congregation shall satisfy the Presbytery of the bounds, of the security of church property by good and sufficient title to the Presbyterian Church of Canada, in connection with the Church of Scotland. The said Declaration shall be of the following tenor :--

#### Humbly Sheweth,-

On the day appointed for moderating in the Call, the Minister officiating, by order of the Presbytery, having ended sermon and dismissed the congregation, shall call on the Elders, and Heads of families, being communicants, (or, in case of a new congregation of the Heads of families solemnly declaring their adherence to the church), to remain as parties concerned, and, after prayer, shall request these present to Call, by subscribing a form thereof, some fit and qualified person to be their Pastor. The form of which shall be as follows :--

VIII. We, the Elders and male Heads of Families, being Members of the Congregation and Communicants in the Church of

According to the standing rule of this Church the following Act requires to be read over and assented to by the Intrant :---

WHEREAS, this Synod has always, from its first establishment, possessed a free and supreme jurisdiction, over all the congregations and ministers in connection therewith; and although the independence and freedom of this Synod, in regard to all things spiritual, cannot be called in question, but has been repeatedly and in most explicit terms affirmed, not only by itself, but by the General Assembly of the Church of Scotland, yet as in present circumstances it is expedient that this independence be asserted and declared by a special act:—

It is, therefore, hereby declared, That this Synod had always claimed and possessed, does now possess, and ought always, in all time coming, to have and exercise a perfectly free, full, final, supreme and uncon-trolled power of jurisdiction, discipline and government, in regard to all matters ecclesiastical and spiritual, over all the ministers, elders, church members and congregations under its care, without the right of review, appeal, complaint or reference by or to any other Court or Courts whatsoever, in any form or under any pretence; and that in all cases that may come before it for judgment, the decisions and deliverance of this Synod shall be final. And this Synod further declares, that if any encroachment on this supreme power and authority shall be attempted or threatened, by any person or persons, Court or Courts whatsoever, then this Synod, and each and every member thereof, shall, to the utmost of their power, resist and oppose the same. And whereas, the words in the designation of the Synod, " In connection with the Church of Scotland," have been misunderstood or misrepresented by many persons, it is hereby declared, that the said words imply no right of jurisdiction or control, in any form whatever, by the Church of Scotland over this Synod, but denote merely the connection of origin, identity of standards, and ministerial and church communion.

### TRANSLATION OF MINISTERS.

I. In the event of an ordained minister having a pastoral charge, and accredited as a regular constituent member of this Synod, being called from his present charge by any other congregation to be their minister, the same rules regarding Probationers shall be followed, viz: that he shall have previously preached to the congregation calling him, that the Call shall be moderated in by the Presbytery, within whose bounds the congregation calling him lies, and, through the Moderator, presented to

communicate, by letter or commissioners, with the Presbytery within whose bounds the minister called resides,—lay before it the Call, their own proceedings thereon, the grounds for transportation and craving deliverance on the subject of said Call, in the matter of acceptance thereof, and concurrence in his transportation.

III. Before any Presbytery shall be empowered to concur in sustaining a Call from any congregation in favour of a minister having a pastoral charge, it shall be required that notice shall have been given to the congregation of which the person called is minister, at least *ten* days before the meeting of Presbytery, for adjudicating on the case, that said congregation may have opportunity of objecting and showing to the Presbytery, satisfactory reasons why the said minister should not be loosed from his present charge.

IV. If no sufficient objections are made to the transportation of the minister called, the Presbytery shall accordingly concur in releasing him, from the day of his admission as minister of the congregation calling him, and shall appoint him to wait for and obey the orders of the Presbytery within whose bounds he is to be transported, as to the time of his Induction to his new charge. Extracts of these proceedings shall be forthwith sent to the Presbytery where the vacant congregation lies, by whom the necessary steps for Induction shall be taken, the forms of which shall be, in all respects, the same as in the Ordination of Probationers, excepting there is no re-imposition of hands, nor any trials, as in the case of Probationers, required.

#### CONGREGATIONS APPLYING TO OTHER CHURCHES FOR MINISTERS.

I. That in the event of any Congregation of this Church applying, through means of their Elders, Trustees, or Committee, appointed for that purpose, for a Probationer or Minister, being sent them from any other church in communion with this church, the said application shall first be presented to the Presbytery of the bounds where the vacant congregation lies, by which Presbytery the same shall be adjudged, homologated, and transmitted to the proper quarter,—parties being allowed to be heard in case of a difference amongst the members of the congregation.

II. On the arrival of said Probationer or Minister, the nomination of whom by said other church in communion with this church, proceeding upon the faith of said congregation, having determined and pledged themselves to adhere to the choice made for them, no new Call shall be necessary, but, previous to his becoming a member of the Presbytery or of the Synod of this church, he shall be required to be Inducted by the Presbytery of the bounds, as Minister of the said Congregation, according to the rules for the Ordination and Induction of Ministers.

The Synod, having had their attention called to the subject of Sabbath Observance, agreed to express their regret of the failure in Parliament, of the measure for relieving the servants of the Public, from Sabbath labour, agree to declare anew their determination to use every effort to promote the better observance of the Sabbath, and renew their injunction to Ministers, to urge the observance of the Fourth Commandment, on their people ; and, further, the Synod recommend the Congregations under their care, anew to petition Parliament for the abolition of all Sabbath desecration, in the various departments of the Government.

Presbyteries were again enjoined, in terms of the minute of last year, without delay, to take such steps for securing the public property of the Church, within their bounds, as may be considered necessary.

Several of the Clergy Reserve Commissioners being present, the thanks of the Synod were publicly given to them, by the Moderator, for the ability, faithfulness, and diligence with which they have managed their important trust, for the benefit of the Church.

The Synod called for the Report of the Finance Committee, which was given in, and read, showing the amount paid in, towards the expenses of the Synod, and by what congregations. Accounts were directed to be paid ; and all arrears due to the Fund, were ordered to be remitted to the Treasurer, without delay. On the suggestion of the Committee, the Synod agreed to recommend "that in all cases, the contribution from a congregation, with a settled Minister, Le not less than One Pound, Currency ; and that the sum of One Pound, Currency, be added to the amount assessed, on each Presbytery, for every congregation with a settled Minister, additional to the number of such congregations, when the present rate of minimum assessment was made." And, further, the Synod, finding from the Report of the Committee, that but few of the Ministers have paid the separate contribution, towards the expense of printing the older Records of the Synod, agreed to call their attention again to this important matter.

The Synod, having had their attention called to the circumstance, in connection with the Report of their Deputation to Scotland, to procure an additional number of Preachers, that several Ministers and Licentiates had been sent out to this country, from Scotland, during the past year, agreed to embrace the present opportunity, to express the feelings of deep gratitude they entertain towards the Church of Scotland, for the affectionate interest she has always taken in the well-being of the Church, in this Province,-for the exertions made by the Colonial Committee of the General Assembly, in regard to procuring and sending out Preachers,-and for their liberality in pecuniary grants for various purposes connected with the Church ;--and at the same time, earnestly to request that there may be a continuance of the same.

And this Commission is to continue until the next meeting of Synod; and members are required to attend the Diets of the said Commission: And such members of the Presbytery within whose bounds the Commission meets, as are on the Commission, are required, all of them, to attend,-and other Presbyteries are to take care that at least two of their members, who are named on the Commission, shall attend.

It was unanimously agreed, that the thanks of the Synod, be given to Dr. Machar, and the members and friends of his congregation, for the kindness and hospitality extended to the members of the Synod, on this occasion.

The Synod appointed their next meeting to be held in St. Andrew's Church, in the City of Toronto, on the last Wednesday in May, One Thousand Eight Hundred and Fifty-Four Years, at Eleven o'clock in the Forenoon.

The Moderator then addressed the Synod; when, after prayer, and singing the last half of the CXXII Psalm, the Synod was closed with the Apostolic Benediction.
